





Place on baking sheets coated with cooking spray. Bake at 375° for 10 to 12 minutes or until cookies are light golden brown. Makes 2 1/2 dozen cookies.

· When measuring biscuit and baking mix, gently spoon mix into nested (dry) measuring cup. Use a metal spatula or straight-edged knife to level off the top.

• After measuring the brown sugar, crumble it between your fingers for uniform texture. Pack the brown sugar firmly in the jar to prevent the baking mix from sifting down through it.



A person may use *DPS when they are stranded with car problems, notice suspicious activity at a rest area, or need to report hazardous road conditions. Calls are answered 24 hours a day, everyday. When dialing the new number, a person will be asked to give their highway location, such as a mile marker, the county they are in or the city if they are within city limits. Should more information be needed, the caller may be asked for their cell phone number. *DPS is a free call for which a person will not accrue any air time charges provided their service provider is one of the companies participating in the program. The companies taking part in *DPS are ALLTEL, Nextel, Southwestern Bell Wireless, GTE Wireless, Houston Cellular, Cellular One of Amarillo and Verizon Wireless.
