# On The DIVIDE SO GOOD-AND YET SO BAD!

# In a course of conversation the other day, a local citizen

made a remark referring to a certain group of people in which was said: "We're so good, and yet so bad!" We thought at the time that this remark can very well apply to Schleicher county as a whole, and especiaally to our law enforcement officers.

We're so good that we hate to see some of our citizens suffer for their misdeeds-so good that we let them commit law violations and get away with such acts just because they're friends and we hate to see them pay the penalty. One day last week, two members of the Texas Highway Patrol made two arrests for drunkenness in Schleicher county. As we understand it, these patrolmen did not intend to file charges against these men, but confiscated their liquor in an effort to keep them from getting drunker than they were. But the men, it is reported, began using abusive language, cursing the patrolmen.

**Eldorado To Get** \$8,200 From W. P. A **To Caliche Streets** SAN ANGELO VISIT REVEALS

THAT PROJECT APPROVED AT WASHINGTON Eldorado is to receive \$8,200 in W. P. A. money for the purpose of placing caliche on the principal streets of the city. Ap-

plication for this project was made some 18 months ago, and it was revealed only Monday that the project had been approved. Mayor A. T. Wright and Judge

C. S. McKinney went to San Angelo last Monday afternoon and met with district W. P. A. officials. In the conversation, it was revealed that this project had already been approved, although local city officials has received

The project calls for caliche to be placed on some 20 miles of the principal streets of Eldorado. The \$8,200 is being furnished from W. P. A. funds, while the city will put up some money for truck hire, etc.

Work is scheduled to begin on this project as soon as the present W. P. A. road project in the Reynolds community is completed. It is estimated that another month will be required to complete this project.

It is believed that this project is sufficiently large to caliche all principal streets in Eldorado.


