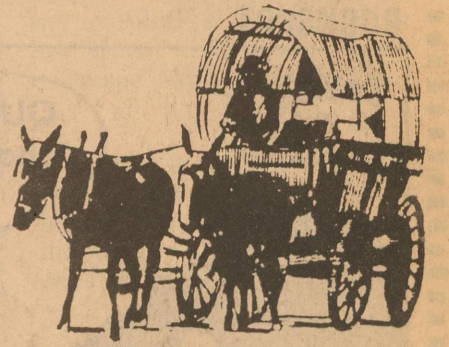

### Headlines From Around The World

#### Arlington, Virginia

Jacqueline Kennedy Onassis, 64 was buried next to her husband, John F. Kennedy in Arlington National Cemetery Monday. Mrs. Kennedy Onassis died last week of cancer at her apartment in New York City. Her family was with her at the time.

Following President Kennedy's assassination in 1963, the widowed First Lady shunned the national spotlight. In the late '60s she married to Greek shipping magnate Aristotle Onassis.

#### Washington, D.C.

House Ways and Means Committee Chairman, Dan Rostenkowski (D) of Illinois, negotiated with federal prosecutors this week in an attempt to maintain his position as one of the most powerful members of Congress. The charges against Rostenkowski stem from the House Post Office scandal which prompted numerous members of the legislative body not to stand for re-election.

Rostenkowski, a staunch supporter of President Clinton's Health Care package would be able to hold his seat if plea bargaining succeeds and the charges are reduced to misdemeanors.

#### New York City, New York

Each of the four Islamic fundamentalists convicted in the terrorist bombing of the World Trade Center were sentenced to 240 years in prison. The four sat silently as the sentence which effectively eliminates any possibility of parole was read aloud in the New York courtroom.

Six persons died in the explosion which ripped through a parking area in the twin towered office building. The bombing was the worst terrorist attack ever on U.S. soil.

#### Washington, D.C.

White House Chief Counsel, Lloyd Cutler asked the U.S. Justice Department for a ruling this week to determine if President Clinton is exempt from civil lawsuits arising out of claims predating his presidency. Courts have held that sitting presidents can not be sued in civil court for claims arising while they are in office. The request stems from the sexual harassment suit filed against the President by Paula Jones, a former Arkansas state employee.

Speck of Kerr County took the Buckle as Overall High Individual in the Wool and Mohair Judging Contest.

Douglass Buchholz and Roy Gene Lloyd prepared the barbecue that was enjoyed by all at lunch. ### Joy Is Finalist

Miss Madolyn Joy age 13, daughter of Kerry and Debbie Joy of Eldorado, has been selected to be a Finalist in the 1993 West Texas National Teen-Ager Scholarship Program, to be held on the campus of Wayland Baptist University in Plainview, on May 27-28, 1994. This program is the official preliminary to the 23rd Annual Texas National Teen-Ager Scholarship Program to be held at Texas Christian University in Fort Worth, Texas.

### Thunderbirds Entertain Crowd

The United States Air Force Thunderbirds streaked through the skies over Mathis Field in San Angelo Sunday, May 22, 1994. The demonstration team consisting of six F-16 fighter planes dazzled onlookers below with loops, rolls and near misses.

The celebration dubbed Air Fiesta '94 by organizers saw more than 40,000 fans pack the flight line to tour static aircraft displays and watch the thrilling fly-overs by various types of aircraft including the A-10 "Warthog" and

the F-117 "Stealth" fighter. The highlight of the day, however came late in the afternoon when the Thunderbirds roared into the sky.

Many Schleicher County citizens were in attendance to witness the hair-raising aerobatics. Earplugs were at a premium as the six planes shook the ground during the performance. At the conclusion of the show, the Thunderbird pilots took time to sign autographs for throngs of youngsters along the flight line.

## Over The Back Fence

Jacqueline Kennedy Onasis was buried this week and our nation, which has a fixation with anything Kennedy, spent the weekend delving into every facet of her life. Similar treatment, if with a somewhat reversed spin, was given to the life and times of Richard Milhous Nixon on the occasion of his death this past month. Can any two people have traveled more disparate paths into the national consciousness?

Jacqueline Bouvier was born to wealth and privilege and marrying John Fitzgerald Kennedy brought her even more. She was stylish. She became a darling of the media even before her husband became president. Their time in the White House has been called "Camelot" partly because of her grace and charm.

Then on November 22, 1963 shots were fired in Dallas and Jacqueline Kennedy became a widow as a stunned nation watched. Who can ever forget the image of her standing there in her bloodstained suit as Lyndon Johnson took the oath of office on Air Force One?

The intervening years saw her remarried to a Greek shipping tycoon. She fell from grace with most of the media, except, that is, for the tabloid press who hounded her relentlessly. No privacy was allowed her

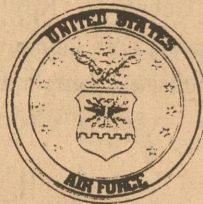
as photographers scaled walls and climbed trees hoping to catch a quick photo of "Jackie."

Richard Nixon took a much different course into the public eye, a course which at times was intertwined with that of the Kennedy family. He and the John Kennedy were political rivals. After serving eight years as Vice President under the immensely popular Dwight Eisenhower, Nixon ran for president himself in 1960. He was defeated by John Kennedy by the narrowest of margins.

Nixon came back, however, winning the presidency in 1968 and re-election by the biggest margin ever in 1972. Watergate brought him down in short order though and he was forced to resign the presidency as he also fell from grace.

Perhaps the most ironic twist in this story is the fact that Richard Nixon's plane had just touched down at Love Field in Dallas when the fatal shots were fired in Dealey Plaza; thirty years later, as Richard Nixon lay on his death bed in New York City, a very ill Jacqueline Kennedy Onasis checked herself into the same hospital.

No one will ever know the answers to all the questions that swirled around these two very public people. One can only hope that maybe now, at long last, they can each rest in peace.



## PAVE PAWS REPORT

Eldorado Air Station has been chosen as the test site for a joint Departments of Commerce and Defense project to determine the possible effects of a new National Weather Service radar, called the wind profiler, on the PAVE PAWS radar's ability to perform its missile warning mission.

Tests will continue through mid-June by Frank Burgess and his \$150,000 National Telecommunications and Information Administration van along U.S. Highway 277 north of Eldorado, Texas, and at a site along Interstate 10 west of Sonora, Texas. The van is equipped for this test with a wind profiler simulator along with his usual composite of radio signal analysis equipment. His findings will aid government

engineers in determining how close a real wind profiler can be located around the missile warning units throughout the United States.

As a result of negotiations between the two government departments, PAVE PAWS and the NWS radars will both operate on the same radio frequency, but with different beam paths. The testing will determine the level of compatibility between the two modes of operation.

When the fully-designed system of 300 wind profilers is in place across the U.S., the sensitive radar network will gather information on columns of wind at multiple atmospheric levels as they pass over the radar's location. This information will be fed

into huge weather pattern analysis computers to predict severe weather before the clouds form, giving local forecasters longer lead times on the storm's possible effects such as hail and tornadoes.

The weather service has a prototype system in the Midwest currently in operation. It however, operates on a frequency that may impact future operations of the global positioning system satellites.

## Texas and the Clinton Health Care Plan

For months the debate over the future of our health care system has dominated headlines and coffee-table discussions across America.

A dozen plans have been offered in Congress even as President Clinton's, introduced with great fanfare late last year, has steadily lost support.

Several "good government" groups have filed suit against Hillary Clinton's 500-member health care task force, which spent months in cloistered secrecy crafting the 1,342-page plan, for refusing to release its records or even its membership.

Even major supporters, such as Ways and Means Committee Chairman Rep. Dan Rostenkowski, have publicly argued with President Clinton's claim that his plan would not require tax increases.

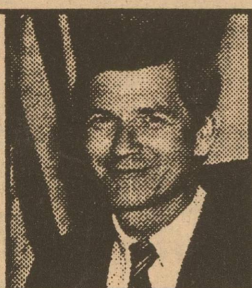
But the White House is far from giving up. Despite their sinking poll numbers and declining Congressional support, the president and his wife have been barnstorming across the U.S. in a frenzied campaign to drum up support.

Their logic has amounted to this: we support health care reform, therefore our plan is the right one. If you do not support our plan, you must be against health care reform.

Surely this kind of reasoning is a sign of desperation.

Why is the Clinton health care plan projected to cost so many jobs? Perhaps this chart holds a clue: these are the number of times the following words are found in the 1,342-page plan.

Those of us who support a less drastic approach to health care reform, one that preserves the strengths of our current system while improving its weaknesses, have had trouble getting ourselves heard over the din from the White House.

Until now, that is. Here, documented by three independent studies, are some of the effects President Clinton's health care plan would have on the state of Texas. These kind of frightening numbers ought to cut through the clutter coming from Washington.

One of the studies, by the American Legislative Exchange Council (ALEC), predicts that Texas would lose 70,000 jobs.

The second is even worse: CONSAD Research, a forecasting firm, estimates a job loss of 52,000 but adds that a whopping 1.4 million Texans would face reduced wages, hours or benefits.

The ALEC study also estimates that the cost of these lost wages and benefits would total more than \$6 billion.

The CONSAD study notes the obvious: "When business owners are faced with increased labor costs due to health care reform, they will attempt to pass the increase on to employees in the form of lower wages and fewer benefits."

Another study, by Lewin-VHI for the American Hospital Association, estimates that by the year 2000 the Clinton plan would result in Medicare reimbursing Texas hospitals only 70 cents for every dollar in services rendered.

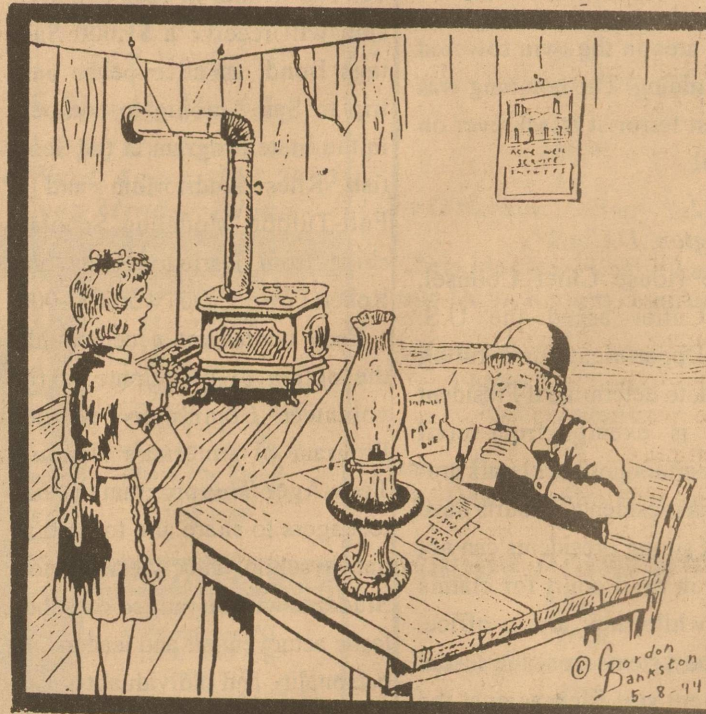
That study found: "Some communities may see their hospitals close for the wrong reasons—not because they are no longer needed, but because they are financially weak...These hospitals may be the very ones that need to remain open to assure access and coverage to underserved populations and achieve the broader goals of health care reform."

That doesn't sound much like "Health Care that's Always There" to me. It does sound like a direct hit on Texas' economy.

# Firefighters Meet With Commissioners

Schleicher County Commissioners met in regular session Monday, May 23, 1994. County Judge Johnny Griffin, Commissioners Jerry Jones and Ross Whitten were in attendance with Commissioners Johnny Mayo and Kerry Joy absent.

During the meeting the commissioner's court heard from members of the Eldorado Volunteer Fire Department who expressed concern regarding fire dispatch procedures. Robert Parker, Joey Jones and Carey Mayfield told the commissioners that recently, when 911 fire calls would be received by dispatchers at the Schleicher County Sheriff's Department, the dispatchers would send a Deputy to verify if a fire existed before paging the fire department.

Schleicher Chief Deputy Diego Gonzales, in attendance also, indicated that indeed dispatchers had been sending Deputies for confirmation before paging the

Fire Department. He stated that changes could be made easily and firefighters could be dispatched immediately upon receipt of any fire call.

Joey Jones stated, "Ten minutes is forever in any kind of a structure fire. We would rather be called out and not needed than to lose a home, or worse, a life because we weren't there."

The firefighters also asked to be called out with the ambulance crews to automobile accidents. Stating that early dispatch of the Jaws of Life and the foam unit could save lives.

In other business, commissioners discussed the possibility of locating a detention facility in the county. Funding possibilities were discussed with financial advisor Larry Skyles.

The court reviewed group health insurance plans, discussed swimming pool expenditures and accepted Constable George Arispe's resignation.

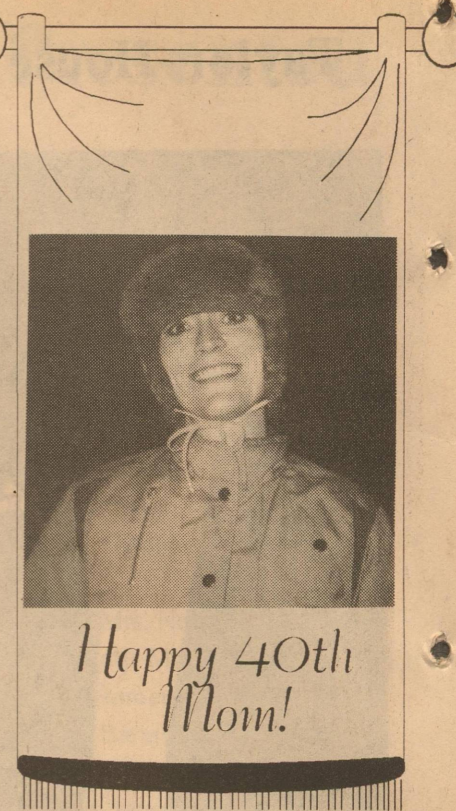

SPC Barajas, is the son of Mr. and Mrs. Ramiro Barajas, SR. of Eldorado.


**DOWNED POWER LINES — THE LOADED GUN**

When an overhead power line is downed by accident or weather, it's not necessarily dead — but you might be unless you stay away from it! An electrical power line is due the same respect as a firearm. Just as there is no such thing as an unloaded gun, there are no dead power lines.

A downed line that seems dead may be reenergized by a lightning strike on the line, contact with other power lines or interaction with another source of electricity somewhere back down the line. This may happen without warning or opportunity to break contact.

High voltages may be transmitted through materials other than metals. A wooden pole, a fiber rope or other normally non-conducting materials may carry an electrical current if they become wet or soiled. The loose ends of the conductor may also energize the wiring, plumbing or steel supports of structures, metal fences, telephone or cable television systems, and vehicles. Green tree limbs will conduct electricity.

Given the wrong set of circumstances, a current will go to ground in you. Don't give it the chance! Handle it safely by not handling it at all. Keep others away and give your electrical utility a call.



When I was a little girl I loved to slip off to a shady spot with a book and read. That was one of the joys of summer. But children's books have changed greatly since my children were small. Now many deal with real life problems and while I am not against this, I like a child's book that transports a child to a land full of fantasy and worlds unknown.

Therefore, when I began looking at the books available for summer reading, I especially enjoyed the following:

**The Very Hungry Caterpillar** - a little caterpillar eats and eats until he becomes a beautiful butterfly. This is filled with bright and vibrant illustrations.

**Sun Up** - a welcome rain storm breaks the heat of a summer day. The author must have experienced a West Texas summer, so feeling is his description of the sun's heat.

**Rainbow Crow** - a Lenape Indian tale filled with lovely illustrations. The crow receives an interesting reward for his bravery and sacrifice.

**Swinging And Swinging** - a little girl swings so high that a cloud falls on her head.

**Pamela Camel** - an unappreciated circus camel saves a train. The illustrations are filled with detail and Pamela's expressions are priceless.

**Barbar the Elephant** - an old favorite that never goes out of style.

There are shelves and bins of books for this age group and both parents and children will have a hard time picking out just a few to take home. I believe you will be just as entertained by these books as your child.

For the younger elementary grades there are floor to ceiling shelves filled with books of adventure, animal, cowboy and everyday living tales. Don't miss the shelf consisting only of the Bluebonnet Award books. Of course there is the ever popular **Bedknobs And Broomsticks** filled with magic and fantasy and **The Adventures Of Old Mr. Toad**. While this is an older story it has as much charm and entertains just as well as it did when first published. The **Wizard of Oz** books fit nicely in this age, too.

As a child gets older I notice a trend, books seem to be more or less divided along sex lines, there are girl's stories and boy's stories. This is too bad, I think, because both boys and girls can miss a lot of wonderful books simply because of preconceived ideas. Some books seem to straddle this line very nicely, the **Black Stallion** series, the **Lassie** books and the **Hank the Cowdog** series for example.

Then I found, and I felt basi-

cally for boys:

**Trader Woolly and the Terrorist** - an Army brat meets a countess is she a terrorist?

**Spike Of Swift River** - an outlaw dog teams up with an outlaw man.

**Higgins of the Railroad Museum** - a vandal causes a train derailment.

Girls will probably enjoy:

**The Mystery Of The Five Bright Keys** - who has the five front door keys and why do they not return them?

**Homeward the Seeking Heart** - three little girls seek new families via the "orphan train."

**The Overland Escape** - a girl, separated from her family during the Depression, struggles to find them.

Girls seem to fare better than boys in book series. For boys I found only the timeless **Hardy Boys** series, but for girls I found the **Little House** books, the **Judy Blume** books and, of course, the wonderful **Nancy Drew** series. There is even a **Nancy Drew Cookbook** filled with such recipes as Phantom Eggs, Red Gate Farm Tomatoes and Detective Burgers. These are all simple enough for a young cook to make on their own.

Past this age an adolescent is capable of reading anything an adult can read. Granted, many of the best sellers may not be suitable for their age. Of course,

sometimes I think they are not suitable for my age either. It seems to me that this the perfect time to become acquainted with some of the classics - **Treasure Island, Little Women, Wuthering Heights** and **Jane Eyre**. These may be slow going in some spots but the stories are still wonderful.

One last note - do not forget the **Summer Reading Program**.

This will be held at the library every Wednesday, 10:30-11:30, beginning June 15th and ending July 20th. I won't give away all of the surprises but I will say that the first program will be introduced by a real Cavalry Officer, so, don't miss it.

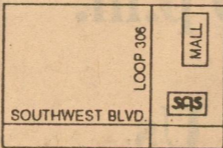

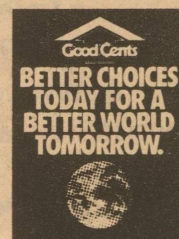

# Perry Addresses Landowner's Rights

AUSTIN -- Agriculture Commissioner Rick Perry said agribusiness must find ways to resolve government infringement on private property rights and overregulation to remain strong into the 21st century. "One of the biggest problems agriculture faces is that the average person is far removed from the farm," Perry said. "Less than 2 percent of the U.S. population lives on farms, and the U.S. Census is not even going to count us anymore. Urbanization, while it has led to much positive change, has created widespread ignorance about a way of life and an industry essential to this country's high standard of living."

Perry said that lack of knowledge has led to misunderstandings and unfounded claims that challenge not only farmers' stewardship but their skill, which produces the most abundant, affordable food supply in the world.

"Out of this climate, unfortunately, sometimes comes bad government policy," Perry said. "The Endangered Species Act is up for reauthorization and is an example of how a law with a noble purpose - protecting God's creatures from unnatural extinction - can be hijacked until it is now a threat to another noble end of government - private property rights."

"In Texas, rural landowners provide more than 95 percent of all wildlife habitat in the state. But today, under the Endangered Species Act, private solutions to wildlife preservation too often are overlooked, or, even worse, actively discouraged, and agriculture must bear the devastating economic impact of this piece of legislation."

"Excessively broad regulatory definitions make landowners adversaries by their mere presence on the land - despite the fact that farmers and ranchers co-existed compatibly with the species long before anyone even thought about these regulations," Perry said.

He said TDA has worked hard to bring together all affected parties to solve two endangered

species issues on a local level. The cases involve the Attwater's prairie chicken in the Gulf Coast area and the Comanche Springs pupfish and Pecos gambusia in the Trans-Pecos area in West Texas.

"We were able to come up with solutions that everyone - from the landowner to the endangered species itself - could live with," Perry said. "Getting local people involved and letting them figure out what's best for their community has a better chance of working than government sitting in an ivory tower dictating solutions based on bureaucratic reports and lobbyists' demands."

Government overregulation is becoming an increasing burden to the agricultural community, Perry said. "Some farmers are so overburdened with forms, they say they need to hire someone just to do their paperwork. We're working to reduce the confusion, frustration and expense of complying with our laws."

He praised the delay of enforcement of the new Environmental Protection Agency Worker Protection Standard. The new regulations were to go into effect on April 21 but Perry, along with other state departments of agriculture, worked to get them delayed until Jan. 25.

"We are not opposed to the regulations but EPA failed to provide us with the necessary information to comply with the regulations. They sent us a 132-page compliance manual last October that we were supposed to get in July. And they sent us 120 copies of this manual to distribute to 80,000 Texas farmers and ranchers. This delay will allow us to bring our producers up to speed on the new and complex regulations. We believe in compliance through education, not punishment" Perry said.

"We need to put common sense back into government," Perry said. "This is the only way government can help agriculture - and Texas - maintain its premier position into the 21st century."



