

Grandson of Locals Is Member Of **Wesleyan Singers**

Ben Bounds, son of Bob and Debbie Bounds, grandson of Charles and Jean Brazzel of Eldorado and great-grandson of Mrs. Selma Baxter of the Rio Concho Manor in San Angelo, is spending the first two weeks of the New Year touring and singing in Russia. He is part of the 40 member Wesleyan Singers at Texas Wesleyan University in Fort Worth.

The ensemble is made up mostly of students from the Fort Worth-Dallas area and the Southwest, including a number of students majoring in areas other than music.

The group's invitation to appear in Russia came through the International Fine Arts Institution, which particularly looking for a choral roup for engagements in Samara, Russia. Upon arrival in Moscow, the choir will mmediately depart for Samara, about 1,000 miles southeast of the capital. Site of a nuclear testing facility, Samara was closed to foreigners under the Soviet regime. The Wesleyan Singers will be the first American choir ever to appear

After a concert in the nearby city of Togliatti, the

choir will return to Moscow. They will be the first American choir to sing in the services of the Russian Orthodox Church in Moscow, As part of the highlights of the group's 17 day concert tour of Russia, they will perform the liturgy of the church in the Russian language on January 8th, the Russian Orthodox Christmas Day.

There is also a smaller, elite chamber choir, called the Trouveres (named for the traveling Medieval singers) within the Wesleyan Singers. This 16-member ensemble will perform separately during some concerts, combining dramatic presentations with the reading

The Wesleyan Singers were selected from many groups nationally that applied for the bookings in Russia. Tapes were submitted by such universities as Brigham Young and the University of Michigan.

Ben sings first tenor in the Wesleyan Singers, as well as in The Trouveres. He is 19 and a freshman at Texas Wesleyan this year. He was quoted as saying that he was very excited about the opportunity, and looking forward to quite a unique cultural experience.

Winds Of Change

F.A.A.F.P.

During my recent trip to southern Tennessee mountains I was able to share notes with some colleagues practicing in the Chattanooga area. The Tennessee medical world has recently seen major third party/insurance reform which has made front page news, and not necessarily good news for anybody. "TennCare" plan introduced there late last year and now enforce has doctors and patients alike outraged. Among its many mandates, one topic addressed is hospital emergency room coverage for recipients of the plan which includes Medicaid and indigent patients. Under the plan, patients presenting to emergency rooms for treatment are first screened by a nurse who then calls a primary doctor to which the patient is assigned to by the plan. This doctor must then decide if the problem requires management in the emergency room. In essence, this creates the so called 'gatekeeper" approach with the sole purpose of cutting costs of administering expensive emergency room care for problems that could be handled in the office or outpatient

Indeed, emergency room treatment costs are expensive

by Sergio A. Sobredo, Jr., MD. and add many millions to the national health care budget. Historically however, emergency rooms are often the site of abuse by patients seeking the convenience of a 24 hour facility which has catered to their every ailment, and more often than not at the taxpayers expense. In Tennessee however, this perceived abuse has now come to a halt as the insurance companies mandate that doctors do not approve emergency room care for "walk-in" or "clinic" problems. If they do, they will not be paid. Thus the task of denying emergency room care to the patient has been placed in the hands of the doctor, with all of its negative connotations. Needless to say, hundreds of doctors in Tennessee have opted out of the "TennCare" plan, creating significant shortages of physicians for this plan. There is no question that

healthcare reform is a heated topic of debate these days. With the example of emergency room coverage reforms which Tennessee residents are now experiencing, we must take a hard look at our own backyard. We may see similar changes here in the future. One can only wonder if voluntary and individual self-restraint will make a difference in our area.





Most homeowners are unaware that regardless of their income there are Federal, state and local programs that will help them repair and remodel their homes.

Government at all levels recognizes that neighborhoods are the basis of life in our country. When a neighborhood deteriorates, many things happen both physically and socially. low payments. Some of the other home improvements covered under these programs are: attic and wall insulation, new windows, outerwall siding, security doors and locks, window guards, sidewalks and masonry work, bathrooms and kitchens, electrical and plumbing work, roofs, gutters


