Soil Conservation District Supervisor to Be Elected Here

There will be an election for a District Supervisor for Zone 4 of the Eldorado-Divide Soil Conservation District Tuesday, October 2, 1945 at the courthouse at 3:00 p. m. This position has been occupied by Mr. J. E. Spencer, who has just recently resigned.

Zone 4 includes all landowners in the portion of the district located south of the Ozona road to the Schleicher County line and West of the Eldorado-Ft. McKavett road to the Schleicher county line. Every landowner in this zone should attend the meeting and help elect a qualified supervisor. Your presence and assistance in electing your board member will give him the assurance that you are not only interested in this kind of work but also back of him in representing the people from your part of the district. Only landowners and their wives are qualified to vote in the election.

The election will be of the convention type, with nominations being made from the floor and the nominee receiving the majority of votes being elected. The district supervisors run the business of the Soil Conservation District and can call upon and receive aid from any state or federal agency who has technical help or equipment to assist farmers and ranchers to work out conservation plans.

Present supervisors for the Schleicher County portion of the district include: B. E. Moore in Zone 3, and J. Forrest Runge, chairman, in Zone 5. The Supervisor to be elected must be a farmer or rancher owning land and residing in Zone 3.

Make your plans to attend the election meeting and cast your vote for your representative on the Board of Supervisors.

October Date Chosen For War Chest Drive

The last, and probably the most important United War Chest drive will open early next month, with W. M. Paterson in charge of raising Schleicher county's quota of \$1803. It will be remembered that this county oversubscribed last year by a percentage of 173—its quota then also being \$1803.

Officers include: W. M. Paterson, chairman; W. O. Alexander, treasurer; John Irvin King, special gifts chairman; Mrs. Fannie Pittman, rural; Mrs. Fred Gunstead, publicity.

Officers who are in close touch with relief work since the close of the war are unanimous in stressing its importance, as the world re-adjusts itself after devastating years of war. It is explained that until democratic governments can

be established to provide law and order and some degree of economic security, the helping hand of 13 European relief agencies will be needed. The program is temporary to provide a stop gap until each nation can take over on its own. For at least six months, and probably for a year, therefore, there can be no substitute for the service of the private agencies. As President Truman has said, their role is "indispensable and unique."

So to bring sympathy and support—when it is most needed—to brave peoples who are too stunned, exhausted, cold and hungry to stand on their feet unaided. European relief budgets (and likewise for the Philippines and China) have been stepped up in order to concentrate American help this fall and winter.

Prominent Rancher Dies Wednesday

Joe Tisdale, who homesteaded his large Schleicher County ranch at the turn of the century, died late Wednesday afternoon, Sept. 26, 1945, at the home place 10 miles northeast of Eldorado, his death following several years of illness.

He was born in 1881 in Fluvanna County, Va., and the next year came to Texas with his parents, who settled first in Abilene, then in 1885 moved to Kimble Co. and to Menard Co. in 1890. In 1905 he moved to Schleicher Co. to homestead a ranch, and two years later married Willie Prugal, the date being Feb. 14, 1907.

Funeral services were conducted Thursday afternoon (today) at 4:00 at the Methodist Church in Eldorado.

Surviving are his widow, and four children: Albert, Abilene; Mrs. Robert Baker, Ft. Sill, Ok.; Mrs. A. D. Harvey, Houston; Mrs. Clifford Jones, Corpus Christi; four grandchildren; and five brothers and sisters: D. J., Eldorado; Ralph, Eden; Lewis, Ft. McKavitt; Mrs. Lottie Bolt, Junction; and Mrs. Cora Millar, Corpus Christi.

Children Pack Boxes At Eldorado School for Children Abroad

Cooperating with the American Junior Red Cross, local school children are this week packing boxes containing both school supplies and toys for school children overseas who have had neither during the years of war.

Mrs. Sam D. Johnson, chairman of the Junior Red Cross of the Concho Valley Chapter, and Mrs. Maurine Prescott, executive secretary, distributed boxes here and to other schools in the Concho Chapter. The boxes are to be mailed by October 15 and will provide much cheer for the children who have known nothing but war for five years.

The small containers, one for a boy, and one for a girl, will contain such items as blotters, memo books, crayolas, pencils tooth paste, hand soap, art gum eraser, comb and mirror set, tooth brushes, barettes, three pairs of socks, two handkerchiefs, and hair ribbons.

The United States Office of Education recognizes that the American Junior Red Cross is able to serve as the agency through which boys and girls in school here can best assist in the educational rehabilitation of children abroad. All boxes packed in the United States this year shall go to children in Europe who have suffered from the war. The gift boxes will go mainly to the continent.

The small gifts may seem commonplace, but are anything but commonplace to European boys and girls who some times have not seen a toy in years, and whose schools are badly handicapped for lack of essential material.

Order of Road Bond Election

The State of Texas)
County of Schleicher)

On this the 10th day of September, 1945, the Commissioners' Court of Schleicher County, Texas, convened in regular session, at the regular meeting place thereof in the Court house at Eldorado, Texas, the following members of said Court, to-wit:

C. L. Meador Jr., County Judge, presiding; and,
C. A. Graves, Commissioner, Precinct No. 1;

John Irvin King, Commissioner, Precinct No. 2;

Pat Martin Commissioner, Precinct No. 3;

J. A. Enochs, Commissioner, Precinct No. 4;

being present and participating, came on to be considered the petition of Jno. F. Webster and 62 other persons, for an election to be held in Schleicher County, Texas, to determine whether or not bonds of said County shall be issued in the total principal sum of \$50,000, for the construction, maintenance and operation of macadamized, graveled or paved roads and turnpikes, or in aid thereof, in said County, and whether or not ad valorem taxes shall be levied upon all taxable property in said County for the purpose of paying the principal of and interest on said bonds at maturity; and,

It appearing to this Court that said petition is signed by more than fifty (50) qualified resident property taxpaying voters of Schleicher County, Texas; and,

It further appearing that the amount of bonds to be issued will not exceed one-fourth of the assessed valuation of the real property of said Schleicher County, Texas;

It is, therefore, considered and ordered by the commissioners' Court of Schleicher County, Texas:

1. That, pursuant to the aforesaid petition, an election shall be held in said County on the 13th day of October, 1945, which is not less than thirty (30) days from the date of this order, to determine whether or not bonds shall be issued on the faith and credit of said County, in the total principal sum of \$50,000, for the purpose of the construction, maintenance and operation of macadamized, graveled or paved roads and turnpikes, or in aid thereof, in said County, and whether or not ad valorem taxes shall be levied, annually, on all taxable property in said County for the purpose of paying the principal of and interest on said bonds at maturity, under authority of the Constitution and laws of the state of Texas, particularly Section 52, of Article 3, of the Constitution, and Chapter 16, Acts 1926, First Called Session, as amended; such bonds, if issued, will bear interest at a rate not to exceed 5 per cent per annum, and shall mature at such time as may be deemed most expedient by the Commissioners' Court of said County, not later than twenty-five (25) years from their date.

2. In the event said bonds are authorized by the necessary favorable vote of the qualified electors of said County, Voting at such election, the proceeds from the sale thereof shall be applied to the purchase of right-of-way, construction of fences, maintenance and operation, and to pay all necessary damages incident to the Construction of the following roads in said County as follows.

A road running east and west through the county, and also through the city of Eldorado, from county line to county line and designated by The State Highway Department of Texas, as Highway No. 151.

3. All persons who are legally qualified voters of said Schleicher County, Texas, who are resident property taxpayers of said County and who have duly rendered their property for taxation, shall be entitled to vote at said election.

4. All voters desiring to support the proposition to issue the bonds shall have written or printed upon their ballots, the words:

"FOR THE ISSUANCE OF BONDS AND THE LEVY OF AD VALOREM TAXES IN PAYMENT THEREOF."

And, those opposed to the proposition shall have written or printed upon their ballots, the words:

"AGAINST THE ISSUANCE OF BONDS AND THE LEVY OF AD VALOREM TAXES IN PAYMENT THEREOF."

5. The polling places and Presiding Officers of said election shall be, respectively, as follows:

Eldorado, Texas, Voting Precinct Number 1, at Court House, J. F. Isaacs, Presiding Judge.

Eldorado, Texas, Voting Precinct Number 1-A, High School Building, W. N. Ramsey, Presiding Judge.

Mayer Community, Texas, Voting Precinct Number 2, Mayer School House No. 1, Harry Freund Presiding Judge.

Rudd Community, Texas, Voting Precinct Number 3, Adams School House, Webb Montgomery Presiding Judge.

Vermont Community, Texas, Voting Precinct Number 4, Finnigan Ranch House, Ed Finnigan, Presiding Judge.

Mayer Community No. 2, Texas, Voting Precinct Number 5, Mayer School House No. 2, Joe Ruff, Presiding Judge.

Alexander Community, Texas, Voting Precinct Number 6, Alexander School House, E. F. Ramsel, Presiding Judge.

Cliff Community, Texas, Voting Precinct Number 8, Cliff School House, J. Forrest Runge, Presiding Judge.

6. The County Clerk of Schleicher County, Texas, is hereby authorized and directed to cause notice of said election to be published once each week for three consecutive weeks, in some newspaper of general circulation that has been continuously and regularly published for more than one year previous to the date of this order, in Schleicher County, Texas, and, in addition thereto, by posting notices of such election at four public places in Schleicher County, Texas, one of which shall be at the courthouse door of said County, for three consecutive weeks prior to said election.

7. A copy of this order, signed by the County Judge of Schleicher County, Texas, and certified to by the County Clerk of said County, shall serve as a proper notice of said election.

The above order having been read in full, it was moved by Commissioner Jno. Irvin King and seconded by Commissioner C. A. Graves that the same be passed and adopted. Thereupon, the question being called for, the following members of said Court voted "Aye": Commissioners Graves, King, Martin and Enochs; and the following voted "No": None.

Reconversion should not be a problem in Schleicher County. Ours is a ranching county, not an industrial one.

In a county such as ours there should be room for servicemen . . . not scores, but hundreds of them. Let's give them a place at home . . . for Schleicher County has just started to grow.

SPURGERS TWINS, ONE WITH BACK INJURY, BOTH 25 POUNDS LIGHTER, ARE CRAVING HOME-COOKED CHOW



Floyd and Lloyd Spurgers, twins, both sergeants and assigned to duty together by presidential request at the suggestion of their parents, Mr. and Mrs. R. C. Spurgers, are still in Guam, with the possibility that they may go to Japan. They have been in service two years and three months. Two other Spurgers boys, Pfc. L. M. Spurgers, of the quartermasters department in New Guinea, and W. C., seaman first class, now probably in Japan, are also still in service.

A letter received recently from the twins follows:

Sept. 6, 1945, Guam, CP Dearest Folks and all:

We haven't had any mail recently from anyone. No one is getting much mail now though.

Well finally and at last, censorship regulations have been lifted. They do spot censor every now and then, but we can tell you a little more than usual. I'll try to tell you why we were unable to write as regular as usual lately. We are very busy getting ready for occupation duty, studying Jap language, customs and such... very interesting, but we want to come home. All the officers who came over here with us were flown back to the states four months ago. We stay over here and get new officers. Enlisted men just don't have a chance over here. That's all right if we ever get to come home "we won't buy pencils from them." If we go to Japan we won't be home for another six months, and it looks as though we are going regardless of our 2 years and 3 months overseas. "Scuttle butt" has us going to the States, but we can't believe stuff like that. We don't think they care what happens to us now, but of all our time and combats we have 70 pts.

Maybe when we are here this much longer they'll think of us.

Maybe you all have worried about my back when I was hurt on Iwo Jima. I couldn't tell you before. A tank backed into mine up on the front lines. The Japs were hitting us extremely hard when the other tank hit me it caused my 75 mm gun to hit me in the back, knocked me out cold as a bat. I didn't suffer so much, so didn't report to the aid station. I could have had a purple heart and five more points, but Lloyd wouldn't have had, and I hate those purple hearts. So many get them who don't deserve them. When you see men with legs, arms, and half their faces blown off, you don't feel like getting in the Doctor's way with a hurt back. That's enough of that.

If you think our prisoners of the Japs suffered from malnutrition, you should see us. If we ever get back, we will eat like two horses. We've lost 25 pounds each over here.

It's been raining cats and dogs. We have been firing pistol for record again. It's a 45 automatic, just like yours, Dad. Lloyd fired sharpshooter and I fired marksman. That's pretty good with a pistol. We've had these same pistols ever since we have been over seas. I believe I killed some Japs with mine on Iwo. If I didn't I made them get down low. I was pretty low on deck myself.

We will quit for this time. Have some good old chow ready, mother, when we ever do get home. We could really use it.

Tell S. E. we haven't heard from him in a long time, and let us know if he will get out. Take care of yourselves for us, and write often. Love to all—Floyd and Lloyd.




