Loading Rack Built

Oil tankers, like Haley's and others, are often called upon to deliver a tank full of water—sometimes to oil wells, sometimes to road construction jobs, and sometimes to large ranch fires.

They usually buy the water from the City of Eldorado Water Department where connection is made from a fire hydrant. This usually results in a big spillage of water creating a job-lolly of water and mud. When things get too muddy they move to another location and start the process over again.

No wthe city has a job under way to set up a water loading rack on a vacant lot adjacent to Haley's (the old Chevrolet building). City recently acquired title to the lot.

According to Palmer West the city is running a 6-inch line to the site connecting it to the 8-inch main line coming from the new well south of town. Work was being held up last week awaiting arrival of a "reducer."

The work which is now under way is to provide a permanent water loading facility, controlled by a water meter and regulated to prevent water spillage.

After the facility has been completed and in operation, the county will cover the area with a substantial base of caliche to provide an allweather base for the heavy tank trucks that will use it.

Austerity Affects Season

The fuel and energy shortages have affected the current Christmas holiday season, both locally and nationwide.

The traditional lighting of local streets was not done this year, and the decorating contest was not held this year.

It's all a part of going along with requests from Gov. Briscoe and President Nixon to cut down on unnecessary uses of energy.

President Nixon asked for and got a reinstatement of Daylight Saving Time. It will go into effect January 6th at 2:00 a.m., four months ahead of its scheduled time and will be in effect year around for the first time since World War II.

Governor Dolph Briscoe was to call the Texas Legislature into special session this week to enact a 55 mile per hour speed limit.

And there is another phase of inflation coming up. On January 5th, the cost of mailing a First Class letter at the post office will go from 8c to 10c.

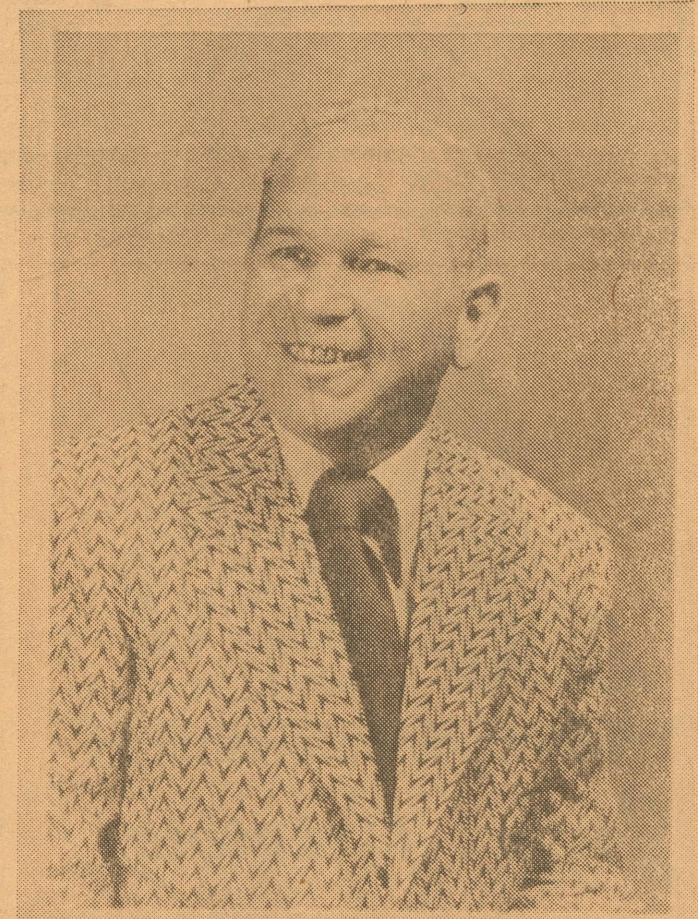
All the girls enjoyed pizza at Shakey's, then returned home for refreshments.

Political Year Coming Up

The Political Announcements column shown at the foot of this article will start running in the Jan. 3, 1974 issue of The Success, set for publication in two weeks.

The upcoming year 1974 is a political year and there is already interest being shown in both local and higher level races.

County Clerk, County Judge, County Treasurer and the Commissioners of Precincts 2 and 4 are offices which will be coming up for contest along with Justice of the Peace for Justice Precinct No. 1.

J. P. Enoch, County and District Clerk, has stated that he does not plan to be a candidate for re-election to office in the coming year. He ran for his first term in 1952, the year he defeated the late H. T. (Dogie) Finley.

The clerk's salary is presently \$7,623 per year, and in addition Enoch has drawn a salary as veterans service officer for Schleicher and Sutton counties.

Thus we have an "open" race coming up for County and District Clerk.

County Judge Bob McWhorter, and Commissioners Viola Henderson and Dee Love of Precincts 2 and 4 respectively are all completing their initial four-year terms in office and will, presumably, seek re-election to new terms.

The County Judge's salary is \$8,930 a year, and he also draws a salary as ex-officio school superintendent.

Commissioners are paid \$3,630

A. G. (Mack) McCormack is completing his fourth four-year term as County Treasurer. He was elected to his initial term in 1958 over Mrs. Mabel Parker, and he has not had an opponent since. Treasurer's job currently pays \$7,623 per year.

B. L. Blakeway's is completing his third four-year term as Justice of the Peace for Justice Precinct No. 1, which takes in the town of Eldorado. The job pays \$3,630 a year.

Congress Main Higher Race

Of the main races coming up on the higher level, that of Congress is the one in which main interest is expected. The long-time incumbent, O. C. Fisher, has announced that he will not seek re-election.

Fisher was elected to his initial term "way back in 1942 when he defeated the late Charles South of Coleman. The job paid \$10,000 a year then, and now pays \$42,500, or, as pointed out by some economists: equivalent to about \$51,000 a year when the "fringes" are counted in.

There are already several prospective candidates planning to run, all so far from the San Antonio area. The 21st district now stretches about 350 miles from San Antonio west to Big Lake.

Active races may develop for some of the top state jobs, Governor, Comptroller, etc., and the coming months will tell the story.

The Success will run initial announcements from candidates in our first issue in January; filing deadline is about a month later.

The prices for candidates' announcements are given in the Political Announcements Column, and must be paid for at the time they are ordered, either by incumbents or challengers.

Our commercial printing department is also equipped to print candidate cards in any quantity for those desiring them.

Be Sure You Are Registered

Voters formerly had to register to vote each year, but those who cast ballots regularly in elections are now registered automatically.

If you have any question about whether you are currently registered to vote, you should call Sheriff Orval Edmiston's office and inquire. If you need to re-register, all you have to do is fill out an application form.

There is apt to be quite a bit of interest develop in the Democratic and Republican primaries, and the General Election in 1974, so be sure that you are qualified to vote.

Be Careful About Christmas Appeals

(by John L. Hill, Attorney General)
Austin, Tex.—With the holiday season in full swing, many organizations take the opportunity to appeal to the public's good will and generosity of spirit to solicit contributions.

Many times this is done by sending goods through the mail and requesting that the recipient make a donation to the organization.

Most often, these direct mail solicitations come from well-known, respectable charitable organizations that perform a worthwhile service.

Sometimes, however, they come from businesses which specialize in preying on people's sympathy for a cause that may be of dubious value, or one that produces little income for the charity it purports to represent.

Many recipients of unordered merchandise wonder, "Do I have to pay for this item if I use it, or am I required to return it if I don't want it?"

The answer is no. There are both state and federal laws that now protect recipients of unordered merchandise.

According to a law passed in Texas in 1969, people who receive unsolicited merchandise have no obligation either to pay for it or to return it, unless the merchandise was sent accidentally. If that happens, the burden of proving a bona fide accidental error in delivery is upon the sender.

In addition, the Federal Postal Reorganization Act, which became effective in July, 1971, provides virtually the same protection.

Most of us are familiar with the traditional Christmas seals sent out by the American Tuberculosis and Respiratory Disease Association, and with other responsible charities that conduct direct mail programs. We are aware of the good work they do, the research and educational programs they sponsor.

Most of these reputable organizations are very careful to stress that the items they send are gifts and that the recipient is under no obligation whatever to send a donation.

But unfortunately, there are some organizations that trade upon the desire to help the needy or less fortunate.

These groups may imply that the merchandise they send has been produced by the handicapped, the aged, or by members of a certain minority group, or that sale of the item will benefit such people when in fact only a few such persons have been associated with the organization or will be helped by it.

These same groups may send merchandise along with a letter that implies the recipient should pay for the goods or return them. Or perhaps they simply fail to state that the recipient is under no obligation to pay for or return the item.

Either tactic may cause persons unsure of their legal obligations to pay for merchandise they don't want, don't need and haven't ordered.

Sometimes most of the money received by such organizations goes to the manufacturer of the item or is spent on operational expenses, leaving only a very small percentage for the charity supposedly being helped.

Items that are often mailed out at this time of year include greeting cards, neckties, pins, various type of buttons, key rings, handkerchieves, name and address labels, and other similar small items.

If you have any questions about the organizations sending these or other items to you, check with the Consumer Protection Division of the Attorney General's office, your county or district attorney, or local better business bureau.

Jo Ed Hill Heads Fund Drive For Arthritis

Mr. Jo Ed Hill is serving as Schleicher County Chairman for a Special Gifts Campaign for the West Texas Chapter of The Arthritis Foundation. Residents of the county will be receiving letters and information from Mr. Hill soon. Last year the response in Schleicher County was good, Mr. Hill said, and it is hoped for an even better response this year.

Ten per cent of the population suffers with the disease in some form, to the extent that medical care is needed. Many of these are completely disabled. The Arthritis Foundation reports. Arthritis is the Number One Crippler, and Mrs. Charles Linehan, Midland, Chapter Executive Director says the Foundation does not like being number one in this respect and is working to improve diagnosis and treatment techniques to reduce the pain and crippling, taking them out of that Number One spot, and to find a cause, cure or preventive, so in the future no one will have to suffer as so many do today.

Two hundred and fifty thousand of these afflicted are children. Dr. Charles Sisk, Foundation Medical Director, says, and over 250,000 ne weases are diagnosed annually. In many cases, early diagnosis and proper treatment can "manage" the disease, he states, so that the victims can live more normal lives longer.

One of the main problems is that there are not enough specialists in practice today, nor is there enough being done in research. Dr. Bruce Bartholomew, rheumatologist and head of the new department of rheumatology at the new medical school at Texas Tech and a medical director for the West Texas Chapter, says. He has expressed his appreciation to the Chapter for the support offered through research grants and fellowships for graduate students at the Medical School who choose this field as their specialty.

In the future this should help West Texas arthritics by providing more specialists to practice in the area, he said. With greater interest in this field of medicine, patients will be less likely to turn to the "quacks" and their so-called cures on which over four hundred million dollars is spent annually by arthritics who suffer such severe pain and disability, while only about eleven million dollars goes into research.

Of the contributions to The West Texas Chapter, one third goes for support of the national programs of research and education, another portion is committed to the research and fellowship program at Tech and the remainder is spent in the Chapter's 83-county area for patient services, public and professional education, such as forums and symposiums and distribution of thousands of pieces of literature, Mrs. Linehan says. The Chapter has provided programs with panels of doctors or other speakers throughout the area—and hopes to be asked to bring some of these to Schleicher County in the future. Many of these have been sponsored by the County Extension Agents, for which the Chapter is most grateful, Mrs. Linehan states.

By—Bill Boykin Texas Press Association Austin, Texas.—Texans will be offered a new option on health care insurance which proponents claim will lead to improved cost control and better health. The State Board of Insurance last week announced guidelines for so-called Health Maintenance Organizations (HMO's) which provide for prepaid care programs. Costs run from \$45 to \$70 per month in other states. Board Chairman Joe Christie said he feels proposed guidelines for HMO's answer objections raised by Texas Medical Association during the 1973 legislative session. "My legal staff assures me we are on sound legal grounds," said Christie. One of the major differences in HMO's and conventional hospitalization-medical insurance is that the new plan is designed to cover all bills, not just a standard portion of expenses. Employee groups and others, functioning under the plan, would, in effect, contract with insurance companies, doctors and hospitals. Lt. Gov. Bill Hobby predicted better cost control and better health for Texans as a result of the new plan. He said competing health care arrangements will strengthen the position of the individual consumer. Four insurance companies have submitted applications to provide coverage for pre-paid health care plans. At least one HMO is in beginning operation—at San Antonio, under Bexar County Medical Foundation direction.

County Ag. Agent's Column

Protect Landscape Plants From Cold Damage

The winter season is at hand, and many plants in your home landscape may need protection from severe cold weather.

Sudden drops in temperature after prolonged warm periods can be especially damaging to landscape plants. Since the weather this fall has been unseasonably warm, many plants have not been "conditioned" to winter temperatures.

Therefore, a little extra care of these plants will help them get through the winter.

Cold susceptible plants and shrubs such as citrus and avocados must be covered and heat must be provided to keep the temperature above the freezing point. Plastic has been a popular covering material but must be removed as soon as the severe cold has passed. Structural wood frames may be built and covered with plastic.

Heavy mulching with hay, pine straw or cane pulp can prevent cold damage to normally winter hardy plants such as pansies, stock, calendulas, ranunculas and anemones in the southern part of the state. After the extreme cold has passed, the mulch can be removed from the top of the plants to expose them to more light.

Nature has provided most plants with the ability to adjust to temperature extremes, but many landscape plants are from other regions of the world and may not be readily able to adapt to extreme temperature changes. Thus, a little extra care during the winter months will give them the cold protection that they need.

Ice damage to trees and shrubs is always a possibility during the winter months, especially for evergreens such as pines that have more surface area and accumulate more ice. Little can be done to prevent ice accumulation, but proper pruning of broken limbs after ice damage is essential.

Do Some Arm Chair Gardening

Plan your spring and summer flower garden from the comfort of your favorite arm chair, using gar-

den catalogs as references. Armed with information from such catalogs, it's easy to plan a well arranged, attractive garden.

Most reputable seed companies provide accurate information on flowers on such details as color, height, planting tips and season of bloom because they want to keep you as a satisfied customer year after year.

At times, be adventuresome and select one or two of the new or different varieties as a conversation piece for your garden. Another interesting variation is to plan an all-white or all-pink flowerbed. Or try to select only flowers with fragrance.

Whether you start annuals from seed or purchase started plants, develop a well organized planting plan. It will enable you to make your purchases early and obtain quality plants rather than have to take what is left at the end of the season.

When purchasing seeds or plants, price should not be a major factor. Quality plants, although they may be slightly more expensive, will usually provide much more beauty and satisfaction in the long run.

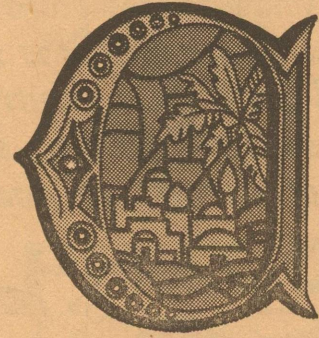

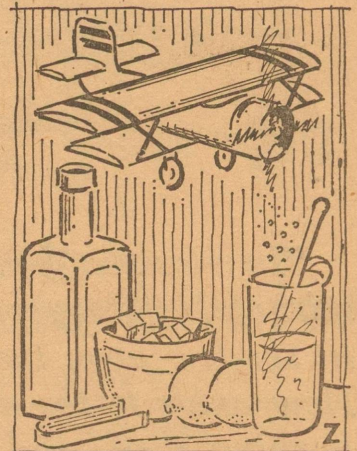

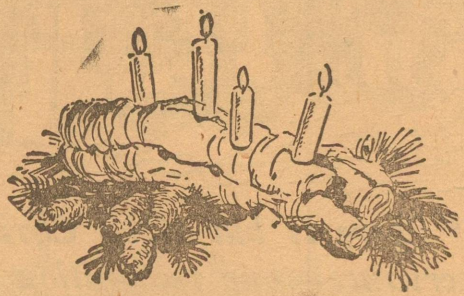

'For Unto You This Day Is Born a Saviour . . .'

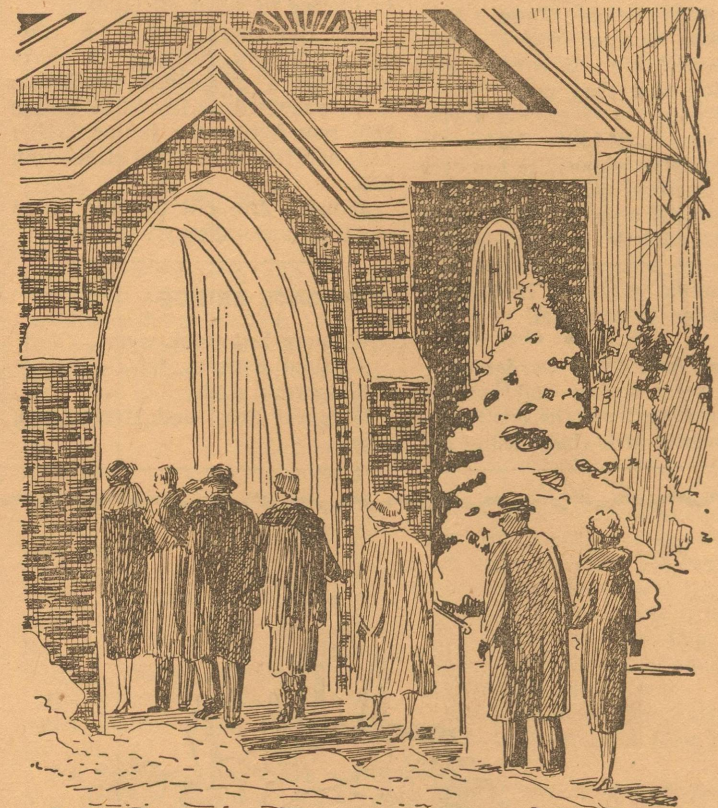

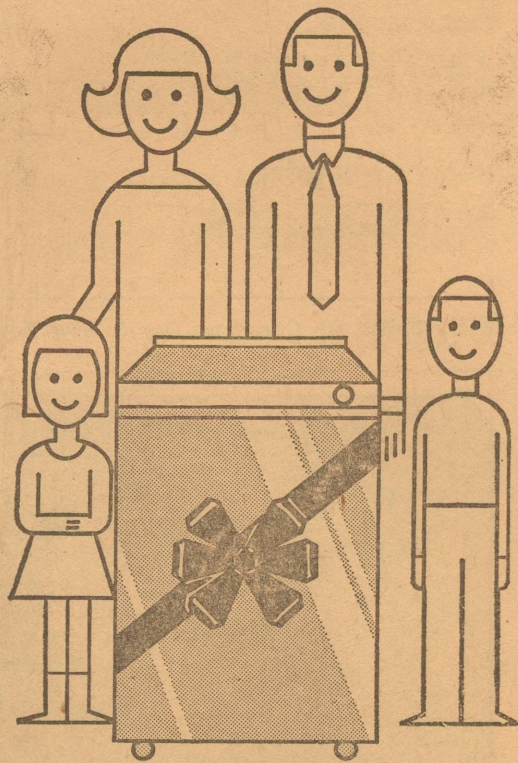

The Sunday School Christmas program will be Sunday Evening, December 23rd, at 7:00 p.m.

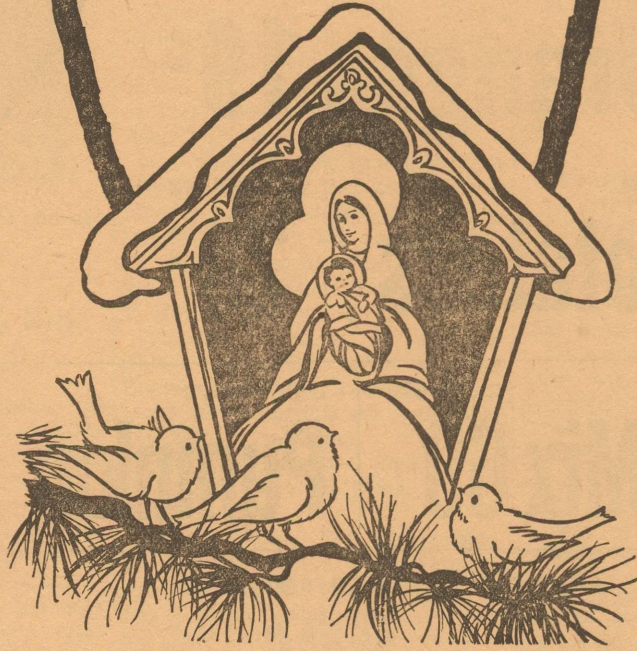
Holy Communion Service will be at 6:30 on December 24th.
