# Freighters were important

Vermont Ranch began the population of the West Texas area that included Schleicher County. Settlers and cowboys moved into this area and began to build permanent homes. The small town of Verand was established about a quarter of a mile from the main house of Vermont Ranch.

Verand consisted of a stage station, a store, a hotel, a school and several family homes. The town began to progress and the need for better transportation became evident.

In the late 1800s and early 1900s freighting outfits were established to supply the needs of the people in this area.

Several freighting outfits operated the route from San Angelo to Sonora. Most freighters had three wagons and a team of eight horses. Two horses were wheel horses, four were places in the swing, and two were in the lead of the team.

The lead horses were the only ones with reins, and were especially trained to lead the rest of the team in the direction the driver indicated. The wheel horses were trained to hold back if the wagon's brake failed to hold. The untrained horses were placed in the swing. This team

pulled three wagons trailed together. The driver rode the left wheel horse, instead of the lead

The freighter's day was from sun-up to sun-down. They traveled through rough country and followed dangerous roads. Travel continued through bad weather and freighters would be gone weeks at a time. Three and one-half days were usually re-

quired for a run from San Angelo to Sonora, but storms would often hold the wagons up for

The wagons consisted of oak wheels, axels, and tongues. The wagon bed was made from pine. Wheels had to be greased to avoid coming off. If a tire came off, the wagon had to be jacked up and the tire slipped back on. The wooden wheel had to soak in

water until it was swollen enough for the tire to fit snugly.

The cargo of the freight wagons consisted of groceries, salt, stock feed, and barbed wire. In the spring, around shearing time the freight wagons returned to San Angelo loaded with wool.

Stage coaches provided passenger transportation. The stage coach was pulled by four horse See FREIGHTERS Page 4.

#### ONE ELDORADO MAN ARRESTED

Schleicher County Sheriff Ronnie Detective Kevin Holloway, and Norris and Deputy Richard Har- Detective Mickey Jones. The ris, along with members of the Task Force officers assisted the Rio Concho Multi-Agency Drug Enforcement Task Force raided a local residence early last Tuesday morning.

Recovered from the Herman Street residence were approximately 12 ounces of marijuana, other narcotic paraphernalia and approximately \$660 in cash.

Arrested at the scene and charged with felony possession of marijuana was Felix Chavez, Jr., 21, who occupied the house with his wife.

The Schleicher County Sheriff's Department is a member of the Rio Concho Multi-Agency Drug Enforcement Task Force, which is designed to help local law enforcement agencies in the Concho Valley area combat drug problems in their communities.

The Meritorious Service Medal is awarded specifically for outstanding non-combat meritprious achievement or service to the United States.


