In what was the most exciting high school basketball game that this reporter has ever seen, the Eldorado Eagles toppled the Ozona Lions 51-43. Anyone who traveled the 50 miles to Ozona on Tuesday night, February 7, would have to agree that the ball game was definitely worth the trip.

At the end of regulation play the score was 43-43, but in the three minutes overtime playoff, the Eagles controlled the ball well and were able to keep the Lions from scoring.

Jeff Patton led the scoring for the Eagles with 13 points, followed by Stan

Meador with 12 points, and Carter Edmiston with 11 points. Meador led the overtime scoring with four points, followed by Steve Whitten and Jeff Patton with two points each.

The lead bounded between the two teams throughout the night with only a few points separating them during the entire game.

With less than a minute remaining in regulation play the Eagles were behind by three points. With the determination of champions, the Eagles were able to bring the ball game to a tie at the end of regulation play and go on to win in overtime play.

This was the 20th win for the Eagles this season. According to Coach Greg Cleveland, this is the first time in 24 or 25 years that the Eagles have won 20 games in one season.

"Ozona is a quality team and we have been able to defeat them twice," said Coach Cleveland. "Tonight our boys showed more character and quality than I have seen in a long time."

The Eagles play in Stanton this coming Friday night. If that game is anything like this last one, it is surely one you don't want to miss.

AT&T ANNOUNCES PRICE CHANGES FOR LONG DISTANCE CALLS WITHIN TEXAS

AT&T announces April 1, 1989, price changes for Long Distance Service (MTS) within Texas. AT&T's prices for long distance calling within Texas will be increased by two cents per minute for calls under 82 miles in distance and one cent per minute for calls that are 82 miles or greater in distance. AT&T's current discounts of 25% for evening calls and 40% for night and weekend calls will remain in effect. The price increases are expected to produce approximately \$22.8 million, which is nearly 2.9% of AT&T's annual revenues for Texas Long Distance Service.

This represents the first AT&T price increase for long distance calls within Texas. AT&T's long distance prices for calls within Texas have been reduced overall by about 12% since 1986.

The Long Distance Service price changes will also impact AT&T's PROSM WATS Texas offering, which offers subscribers a 10% discount on all long distance calls within Texas. These price changes are expected to produce approximately \$661,000, or about 3.5% of the annual revenues for AT&T's PROSM WATS Texas offering.

Prices for AT&T's REACH OUT[®] Texas offering will also change. The price for initial hour usage will increase from \$12.55 to \$12.95; the additional hour price will increase from \$11.40 to \$12.00. These price increases are expected to produce approximately \$364,000, or about 2.1% of the annual revenues for AT&T's REACH OUT[®] Texas offering.

AT&T's tariffs implementing these changes will be filed with the Public Utility Commission of Texas on March 1, 1989, with an effective date of April 1, 1989. The combined price increases are expected to produce approximately \$23.9 million, which is approximately 2.4% of AT&T's annual revenues for all Texas intrastate services.

Inequity Threatens Rural Hospitals

Senator Lloyd Bentsen, Chairman of the Senate Finance Committee, introduced legislation recently designed to correct an inequity in Medicare reimbursement that threatens the survival of rural hospitals.

Bentsen was joined by Senate Republican Leader Robert Dole in offering the Equity For Rural Hospitals Act of 1989.

"This bill provides urgently needed short-term relief for the escalating problems faced by rural hospitals and long-term structural reforms as well," Bentsen said in remarks accompanying his legislation.

"In 1988, 43 rural hospitals closed across the United States, 19 of those in my home State of Texas. Hospital administrators surveyed recently by Touche Ross suggest that as many as 600 hospitals could close their doors in the next five years."

Bentsen said inequities in Medicare's

prospective payment system (PPS), which was inaugurated in 1984, are a big part of the problem. Under PPS, reimbursements to hospitals are no longer based on individual costs but on a system of average costs. In 1987, half the rural hospitals in the U.S. lost money on their Medicare patients.

Because rural hospitals have historically incurred lower average costs than city hospitals, their Medicare payment rates are currently 12-13 percent lower than the payments received by their urban counterparts.

Under the Bentsen bill a new uniform reimbursement will be phased in, beginning in 1991, to insure equity for rural hospitals. During the interim, Medicare will guarantee that rural hospitals with large numbers of elderly patients and 100 beds or less receive reimbursement for their full costs.

The Bentsen bill also creates a special review board to look into complaints by "border" hospitals -- located near cities -- that they are unfairly treated by Medicare; increases funding for the new "transition

grant" program which helps rural hospital administrators improve services; expands a demonstration program under which teaching hospitals are encouraged to send resident physicians to rural areas for training; and adds new demonstration programs which encourage students to enter the nursing profession.

"Rural hospitals are the cornerstones of health care delivery systems in their communities. Without them, people residing in small, often isolated areas can be denied vital health care services. This is particularly true for older Americans enrolled in Medicare. The elderly comprise 12 percent of the nation's population as a whole, but 25 percent of the population of rural areas," Bentsen said.

"I encourage my colleagues to join in supporting this effort to give rural hospitals a new lease on life by assuring them of equity under Medicare," Senator Bentsen said.

A Touch Of History

Schleicher County has witnessed many changes through her years of existence. Progress and time have changed this county greatly the past one hundred years; however, one thing remains the same, the quality people in her boundaries.

These are the people that make progress happen. They see a bright future and labor toward it. One of these men is William Rye "Dick" Bearce.

Bearce came to Schleicher County in 1906 with his parents, Mr. and Mrs. W.M. Bearce and four sisters. His parents had earned immigrant cars from the railroad to make the move from Childress County where he was born in 1904.

This allowed them to bring wagons, surrey, household goods, and livestock. The rail line ended in San Angelo, and from there the Bearce family hitched the horses to the wagon and surrey traveling on to Eldorado.

Dick Bearce leased the land his father had bought in Schleicher County after he was grown and married to his wife, Winnie. Two children were born to this family a daughter, JoAnn and a son, William Rye, Jr.

Bearce continued to ranch and farm. He was interested in soil conservation and has controlled prickly pear and mesquite on the ranch over the years, receiving several awards from the Eldorado Soil Conservation District.

He also served nine years as School Trustee. During this time election was called to consolidate the common school districts of the county. School buses were bought to transport children from rural areas.

Bearce, with six other men, helped create and organize the Southwest Texas Electric Cooperative. He is the only living charter member.

In 1954, William "Dick" Bearce was elected judge of Schleicher County. He served this position until 1966 when he retired. During his 12 years as judge he served in many civic groups as a leader for our community.

He also helped organize the Schleicher County Historical Society. He called the first meeting in 1962. He is a charter member.

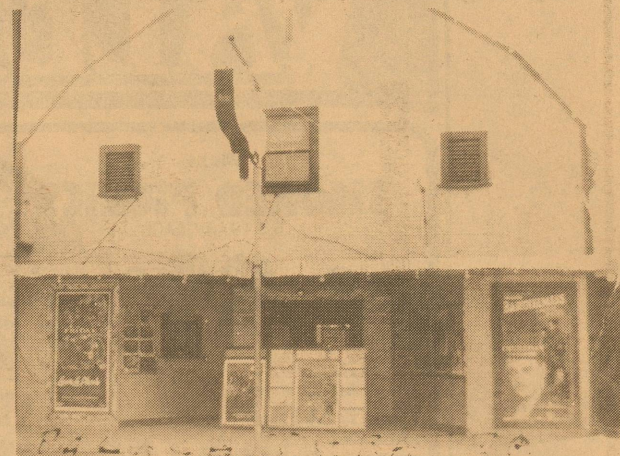
Bearce and his wife, Winnie, have been active workers in the Methodist Church over the years.

When the old timers become reminiscent of their early days with Dick, they talk of his school days and many tell

about the "Owl Theatre". In June, 1920, Dick Bearce and Palmer West, teenagers at the time, opened the theatre. Movie goers watched intently on hard wooden benches to see a Charlie Chaplin thriller. There was no electricity so Dick or Palmer turned the reels by hand.

The 1922-23 school annual, called "The Divide", wrote this about senior Dick Bearce: "His enthusiasm varies in direct proportion to this distance from work. Athletic and witty. He is admired by all."

This seems to be the attitude of Schleicher County citizens, "He is admired by all."



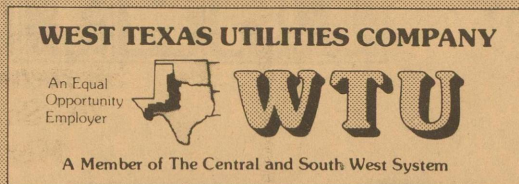
Pictured is the old movie theatre, located on Main Street in Eldorado in the early days.

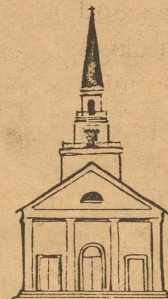

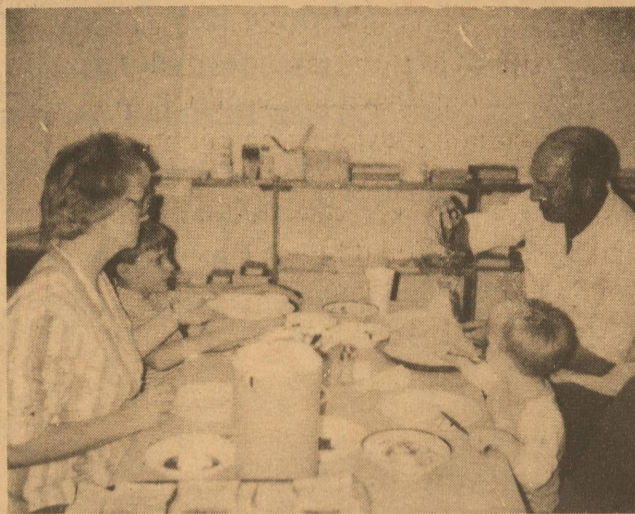

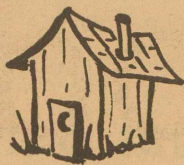

COTTON REFERENDUM AND PRODUCER BOARD ELECTION

Being certified by the Commissioner of Agriculture of the State of Texas for this purpose, the Schleicher County Cotton Association, Box 695, Eldorado, Texas 76936, proposes a referendum election on April 15, 1989 under provision of the Texas Commodity Referendum Law Chapter 41, Texas Agricultural Code, on the proposition of whether or not cotton producers in Schleicher County of the State of Texas shall assess themselves a maximum amount of twenty dollars per acre to be collected at the point of first processing, handling or sale and to elect members for a six (6) man Cotton Producers Board to administer proceeds of such assessment to be used for Boll Weevil Diapause Spraying. There will be no exemptions allowed.

The referendum and election will be held in the Memorial Building Auditorium by personal balloting. Polls will be open from 7:00 a.m. until 7:00 p.m. on April 15, 1989.

Any person within the area described above engaged in the business of producing

or causing to be produced, cotton for commercial purposes is eligible to vote, including owners of farms and their tenants and sharecroppers, if such person would be required to pay the assessment proposed.

Any person qualified to vote at the referendum may place his name in nomination for election to the proposed Commodity Producers Board by written application to the above organization signed by himself and at least ten (10) other persons eligible to vote in the referendum. Such applications must be filed at least thirty (30) days prior to the election date.

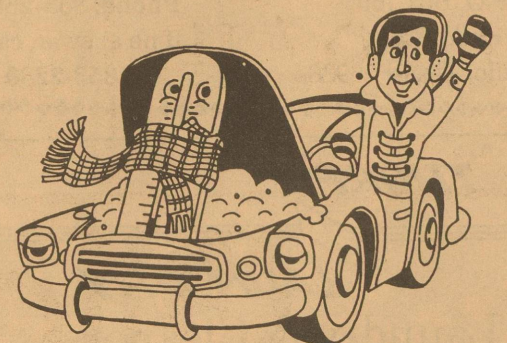

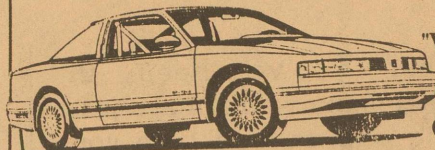

Public Notice

On November 9, Southwestern Bell Telephone Company filed a tariff which proposes to prevent local exchange calling over interstate, unrestricted, multi-jurisdictional, WATS Access Lines (UWALS) and intrastate WATS Access Lines (WALS).

UWALS are provided to interexchange carriers for their use in the provision of interexchange interstate and intrastate long-distance and WATS-type services. Similarly, WALS are designed for use in the provision of interLATA and intraLATA WATS services. The UWALS and WALS were not intended to allow local exchange calling.

If these proposed tariff changes are approved, the blocking of local exchange calls over intrastate WATS access lines and UWALS will take place within 30 days. This proposed tariff change will not result in the blocking of local calls placed to an 800 Service number.

The Public Utility Commission (PUC) of Texas has assigned this matter to Docket 8421. A hearing on the merits of these proposed tariff changes is scheduled for March 13, 1989.

Persons who wish to intervene or otherwise participate in these proceedings should mail a request to the Public Utility Commission of Texas, 7800 Shoal Creek Boulevard, Suite 400N, Austin, Texas 78757 by February 27, 1989. Commodity Foods

Commodity Foods will be distributed Wednesday, February 15, at 1 p.m. on the courthouse lawn. If the weather is bad it will be at the Memorial Building.

Eligible persons are asked to take two paper sacks for the commodities as there will be more distributed this time, including canned beans, raisins, butter, powdered eggs, cornmeal or flour.

Cost-Share Program

USDA provides cost-share assistance to farmers and ranchers through the Agricultural Stabilization and Conservation Service and Soil Conservation Service. Some of the approved practices for cost-share are terraces, water wells, water storage tanks, crossfences, pipelines for livestock water, and brush and pear control.

There are three programs administered jointly by ASCS and SCS to provide USDA assistance. Mini long term agreements are three to five year contracts.

The current signup for this program is February 1 through March 3. The producer may sign up four times yearly under the ASCS's annual program, ACP. Signup for this period is February 1 to 17. The SCS offers the Great Plains Program in three to 10 year contracts.

USDA would like landusers to take advantage of these programs designed to help the farmer and rancher make improvements to his land. It is an excellent opportunity to build the terraces or the crossfences you've been putting off.

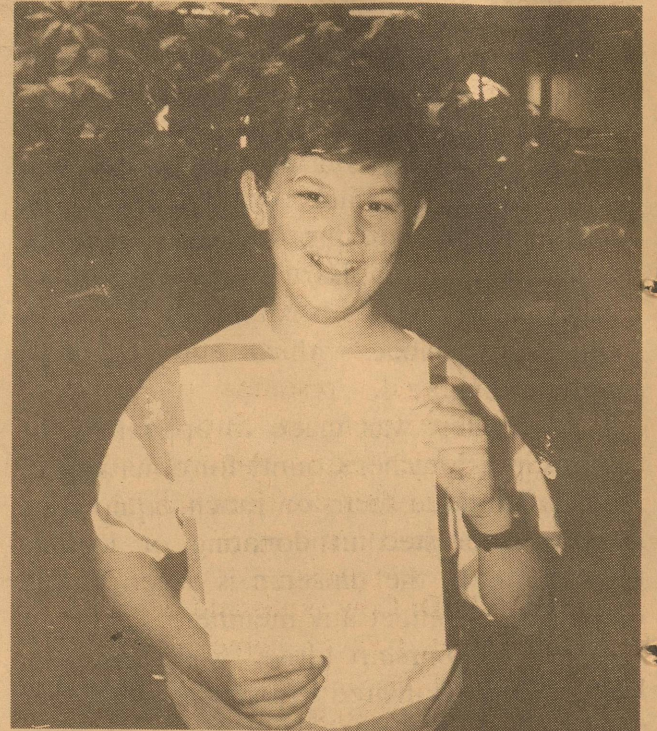
Edmiston Wins Geography Bee

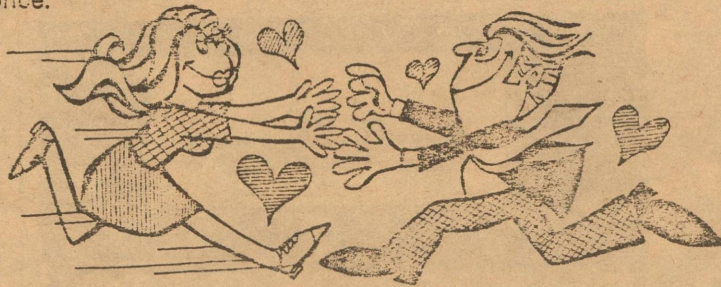
