TIGER BAND PRACTICES TO START MONDAY

Band Director Herb Germer announced this week that the McLean Tiger Band will start rehearsals for the 1965-66 school year on August 16. Fifth graders will not start band until after school starts. Rehearsals will be in the gymnasium until that time to purchase instruments.

The Tiger Band, composed of 150 members, who took band last year, will not rehearse during the summer.

The Junior High Band, composed of seventh and eighth grade students who took band last year, will rehearse from 10-11 a.m., Monday through Friday.

The Senior High Band will have daily rehearsals from 7-9 p.m. each evening.

Everyone interested in participating in any of these bands and was scheduled last year in the program, is urged to attend these rehearsals. All Monday rehearsals will be in the gymnasium. Marching activities will start Tuesday.

Anyone interested in grades 6-12, who was not enrolled in the band program last year but is interested in participating this year, is asked to be at the band hall at 2 o'clock Monday afternoon for interview. It is necessary that these students start on an instrument before school starts so they will be more capable in performing the music in their respective bands.

Tips Reports

Child's Development

At what age should children learn and be able to do certain things?

Any such listing must always keep in mind the fact that no two children are alike and that development periods can and do vary widely in perfectly normal children, says Today's Health Guide, the American Medical Association's annual of health information for the family.

There are certain things that most babies learn at approximately the same age in the early development period. Here are some of them:

- One month—Can raise chin off bed.
- Two months—Can raise chest off bed.
- Three months—Reaches for objects, but without success.
- Four months—Can sit with support.
- Five months—Can sit on lap and can grasp small objects.
- Six months—Can sit in high chair and grasp a dangling object.
- Seven months—Can sit alone.
- Eight months—Can stand with help.
- Nine months—Can stand by holding to pieces of furniture.
- Ten months—Can creep.
- Eleven months—Can walk if held by one hand.
- Twelve months—Can pull up and stand with the help of furniture.
- Thirteen months—Can climb up a few stairs.
- Fourteen months—Can stand alone.
- Fifteen months—Can walk alone.

But, cautions Today's Health Guide, the parent has no real basis for either an unwarranted pride in the precociousness of the child or an unwarranted pessimism over his slowness if the child's development pattern should vary widely from the above table.

No two children are alike.

More than 120 commercial exhibits will show grocers latest innovations in all phases of the food industry.

The convention will close Tuesday, Aug. 17, with election and installation of officers and directors.

CROP SEEKING BEEF FOR HOPE

The Texas CROP Livestock Advisory Committee met this week in Austin to launch a "BEEF FOR HOPE" project as an effort to assist hungry people abroad, thru the churches, with canned beef from the United States.

As an advisory group of the Texas CROP-CWS board the committee gives guidance to the livestock appeals of the state program. The committee consists of church, ranch and CROP leaders of the central Texas area.

Hugh O. Schulze of Mason, a dedicated CROP worker since the program's origin in 1947, led the meeting in the absence of the committee's chairman, Dolph Briscoe, Jr., of Uvalde.

Three million pounds of canned meat have been requested by the overseas programs of the churches through Church World Service for 1965, reported Texas CROP-CWS Director Norman A. Sundwall of Austin. The requests have come, the director said, from the areas of the world where two-thirds of the world's population suffer from hunger and malnutrition. The meat is needed for disaster relief in areas like East Pakistan where seven million people lost their homes through their most devastating cyclone in history; and for self-help programs in other areas where CROP food is provided as wages for those workers in local development projects.

CROP is a community resources program for Church World Service and has been authorized to handle designations for other overseas church relief agencies such as Catholic Relief Services and Lutheran World Relief.

By way of the "BEEF FOR HOPE" project ranchers of Texas will be asked to contribute a beef, or its equivalent, to help CROP meet the needs for meat through Church World Service. In addition to receiving tax deductible receipts for their contributions, the ranchers will be given "BEEF FOR HOPE" stickers for their truck windows.

GRAY COUNTY TO ESTABLISH S. S. OFFICE

A full-time Social Security office will be opened in Pampa in the near future, it was announced by Rep. Walter Rogers.

The congressman said the Social Security Administration within the next few days will have an official announcement on the time and place of the office opening.

Rogers said the decision to open an office in Pampa was made in order to better serve residents of the immediate area.

Necessity for the additional office in the Panhandle, he said, has arisen because of increased information needed by Social Security beneficiaries under Medicare and new regulations.

Rep. Rogers said the administration will announce details of the office operation in Pampa. The number of persons to be employed in the office will be announced at the same time.

Under the present system, a Social Security representative from the Amarillo office is available in Gray County towns on the average of one day a week.

Pioneer-day cattle stampedes on the celebrated Panhandle ranges never caused a greater melee than the weekend jamboree when hundreds launch their boats on the new Lake Meredith, according to Texas Parks and Wildlife Department observers.

Two boat ramps are marked by langes of boat trailers and automobiles. National Park officials said 1,500 boats and 30,000 people were counted on the lake on the July 4th weekend. Popularity of the lake, created by a dam on the Canadian River, has already exceeded expectations of planners.

Mrs. Riley Resigns To Accept College Position

At a meeting August 5 the McLean school board accepted the resignation of Mrs. Mary Tom Riley, business education teacher. Mrs. Riley has been in the McLean school system for the past nine years.

Mrs. Riley has been teaching for the Western Republic College in Amarillo this summer and will become a full-time staff member this fall. Mrs. Riley will be teaching accounting and charm and modeling and continue to work in the personnel department. She will represent the college through the mediums of TV, radio and public speaking.

Mrs. Riley's new position will take her to Amarillo during the

school week, though she will still be a part of this community on weekends as in the past. Mrs. Riley comments that she will always feel McLean is "home."

Mrs. Riley in her letter of resignation to the board of education stated: "It has been my belief that no higher monetary achievement surpassed the appeal that was found in working with our high school. Now due to a very decisive opportunity, it seems that my time can best be utilized in a new position. Due to the facts that you have generously allowed me to teach in your school, live and be a part of your community, and work and love the high school students for the past nine years—it is with deep feeling that I

submit my resignation subject to your approval."

Mrs. Riley has represented McLean High School throughout the state in various teacher organizations. She is a past president of Gray-Roberts Teachers Unit, TSTA. She served on the executive board and represented District IX at several state conventions and workshops. She has recently completed serving a two-year term on the Professional Standards and Advancement Committee for the Texas Business Education Agency.

Mrs. Riley represented the high school teachers of Texas while serving on this five-position board. Mrs. Riley is currently serving as District IX Educational Advance-

ment Committee chairman and area director for FBLA. She is a past chairman of District IX Business Teachers.

Mrs. Riley initiated the Future Business Leaders of America chapter in McLean High School. The chapter has won the honor of having the Best Chapter in the State Award for two years out of the five of its existence. Each year she has taken a delegation of local students to the state and national conventions, each time showing an exhibit that has won first place in state competition and placed in the top five in national competition. Mrs. Riley has served on area, state and national boards for FBLA. She is an active member in

Delta Kappa Gamma (an honorary teachers' fraternity), Beta Delta chapter, Pampa.

Locally, Mrs. Riley has been a member of the Pioneer Study Club, past president, Golf Club board of directors, served as the Red Cross secretary for several years and has worked on March of Dimes committees.

Mrs. Riley also expressed her deep sentiment and gratitude to the students and ex-students of MHS, to their parents, to the school administration, school board, faculty, and to the community. STATE CAPITAL Highlights AND Sidelights by Vern Sanford

State offices are playing a game of musical chairs.

Better make note of these departmental moves that have just taken place, are now being made or will be completed this month:

Teacher Retirement System of Texas has moved from the fourth floor of the Sam Houston State Office Building, formerly State Office Building No. 1, to the third floor of the Lowich Building.

Texas' new Coordinating Board of Higher Education soon will occupy the entire sixth floor of the Sam Houston State Office Building.

Parks Division of the Texas Parks & Wildlife Department moves out of the Sam Houston Building—into the newly acquired American Legion Building—to make room for the Board of Higher Education.

State Building Commission will move from the Reagan State Office Building (State Office Building No. 2) into the west wing of the Sam Houston Building.

Texas Tourist Development Agency, now in the Sam Houston Building, will move into offices in the Reagan Building vacated by the Building Commission.

State Water Commission will move from the American Legion Building into the east wing of the Sam Houston Building.

AG OPINIONS—Atty. Gen. Waggoner Carr reached these conclusions in official rulings:

City employees installing restroom facilities in municipal parks must be paid the prevailing wage rate.

Board of Pardons and Paroles has no authority to recommend, and the governor no power to grant, a posthumous full pardon to a deceased convicted felon on application of a relative or other interested party.

An act authorizing Grayson County Commissioners Court to appoint a juvenile officer and assistant is unconstitutional as a "local and special" law.

State employees can collect \$12 a day travel allowance if staying at regular public lodgings but only \$7 if they stay on military installations or at educational or eleemosynary institutions.

Judge Harry Loftis of Tyler, Charles P. McGaha of Wichita Falls, Runnels County Judge W. H. Rumpy and former Atty. Gen. John Ben Shepperd of Odessa.

Barnes named Reps. G. F. Mutscher of Brenham and Maurice S. Pipkin of Brownsville to the legislative Budget Board. Reps. W. S. Healy of Paducah and Ben Atwell of Dallas are automatically budget board members since they are chairmen of appropriations and revenue and taxation committees of the House.

Earlier Barnes picked a committee composed of Reps. Roger Thurmond Jr. of Del Rio, Bill Rapp of Raymondville, John E. Blaine of El Paso, Dick McKissack of Dallas and Jack McLaughlin of Fort Worth to study the Texas liquor control act.

ANTI-POVERTY PROJECTS OKAYED—Three more Community Action programs and four additional Neighborhood Youth Corps applications have been approved by Governor Connally.

Community Action projects in Houston, San Antonio and Mercedes carry federal grants totaling more than \$2,000,000.

NYC grants of \$155,040 will permit employment of 393 students in Luling, Anderson County, San Jacinto County and Trinity County.

CHEMICAL PLANT AT DIBOLL—Borden Chemical Company has purchased a 100-acre site at Diboll on which to construct a synthetic resins plant. Governor Connally announces.

An initial \$1,000,000 expenditure is contemplated. Company reportedly will make resins in East Texas for such applications as plywood and particle board adhesives and foundry core binders.

Selection of Diboll for the new plant site attests to the growth of and prospects for the southern pine plywood industry in Texas, said Connally.

INTERCOASTAL CANAL DILEMMA—Joe Moore has a \$400,000 problem and, so far, no solution. Moore, a member of Gov. John Connally's staff, is trying to find a way to allow Texas to live up to its commitment made by Gov.

Allen Shivers exactly 10 years ago. In August of 1955, Governor Shivers gave the state's endorsement for the widening and deepening of the Intracoastal Waterway from the mouth of the Sabine River to just south of the Brazoria County line across West Bay.

He assured the U.S. Army Corps of Engineers that local sponsors would meet the cost of the right-of-way so that the canal could be widened to 140 feet from 125 feet.

"All that was needed to keep the project going in 1955 was the state's commitment," Moore said. "There was no need to produce the right-of-way money then. But there is now, if we're not going to lose the project. The state has at least a moral commitment to aid in getting local sponsors."

Although no firm figures are available, Moore believes acquisition of right-of-way for the project through Jefferson, Chambers and Galveston Counties would cost about \$400,000. The federal government's cost of widening and deepening the waterway is expected to be in excess of \$6,000,000.

Completion of the project would open the channel to Mississippi River barges.

TRAIN LAKES—Changing times were reflected in three recent actions of the Texas Water Commission.

Actions amend West Texas water permits at the request of the Gulf, Colorado and Santa Fe Railway Company.

Company built three lakes years ago—in Nolan, Lampasas and Mills Counties—so that their steam-boiler engines would have water supplies.

Permission to use the lakes for recreational purposes now has been granted, since today nearly all engines are diesel and don't need water.

Nolan County's lake also will provide irrigation water for the Sweetwater Country Club.

THE FAMILY LAWYER

"PAYMENT IN FULL"
Suppose a borrowing friend of yours has run up a debt of substantial size. According to your calculations, he owes you \$1800. But according to him, he owes you only \$1200.

One day he sends you a check for \$1500 with the following notation: "PAYMENT IN FULL."

Should you go ahead and cash it, saving the arguments for later? There is a problem. For if you do, you may be giving up your claim to the extra \$300.

The law sees it this way: When your friend sent you a check with that condition attached, he was making an offer to settle a bona fide dispute at a compromise figure. If you cash the check, you automatically accept his offer and make a binding contract of settlement.

Would you prefer to preserve your claim to the full \$1800? Then the safest way is to return the check. Halfway measures are risky. Thus:

One man receiving such a check tried crossing out the notation. Another man erased the word "FULL" and wrote in "PART." But in each case, the act of cashing the check was held to have cancelled any further claim. The court ruled that the creditor had no right, on his own initiative, to change the terms of the offer.

But while the creditor should be wary, so should the debtor. His intention of making a settlement offer doesn't count unless he makes that intention clear to the creditor.

For example, suppose your friend in the above case had sent you the check without any notation at all. With no reason to think otherwise, you could probably assume this was merely a payment on account—leaving a \$300 balance still due. Cashing the check in those circumstances would not hurt

your claim for more money. In short, the law won't let a debtor "off the hook" unless he gave you fair warning that cashing his check would have that effect.

And on the other hand, the law will hold you to a settlement fairly arrived at. After all, a compromise is often the best solution to an argument of this kind. Fifteen hundred dollars in the hand may well be worth \$1800 in the sweet by-and-by.

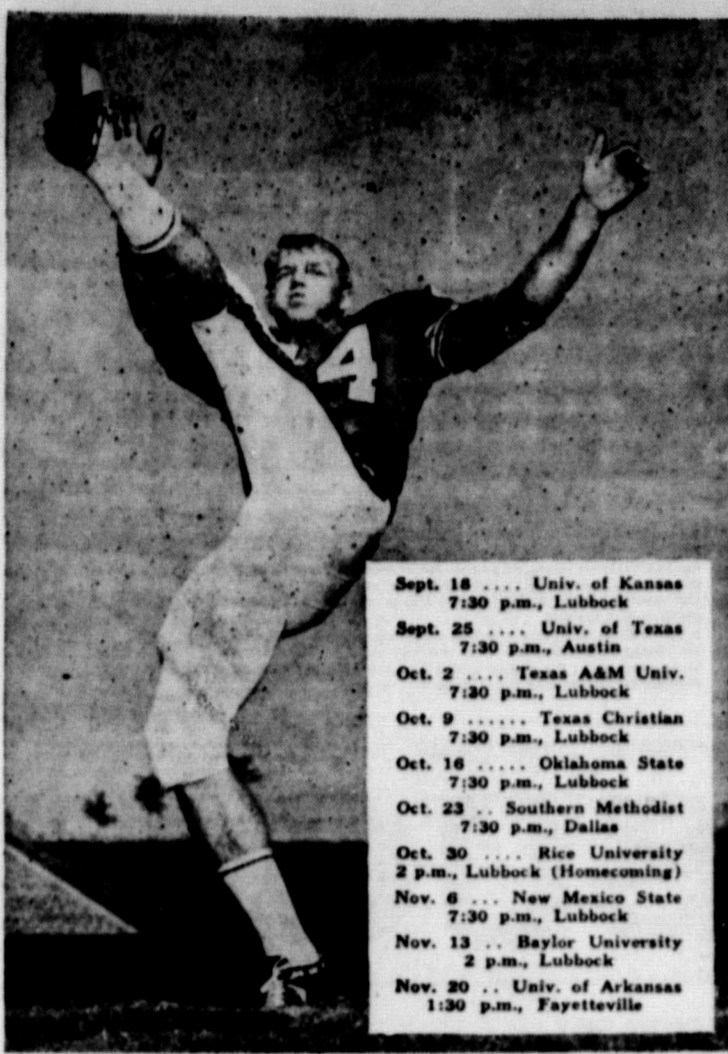

SPOTTED ALFALFA APHIDS

Alfalfa aphids have been doing damage in Truitt Johnson and Jenks Shaw alfalfa northeast of McLean. Malathion is most commonly used when spraying for aphids. Malathion should be applied at the rate of 2/3 pint per acre. Do not apply malathion during full bloom. Other recommended sprays are for Parathion, Demeton and Endrin.

FUTURES MARKET
The Futures Market is being used by cattlemen, particularly feeders, and even by some cow-calf operators. Some feeders sustained losses by hedging early this year because the market moved up. However, they plan to continue to hedge.

Bankers and financiers have been more willing to loan substantially more on hedged cattle operation than those not hedged.

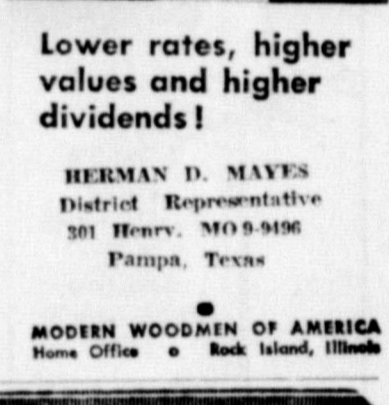
The effects of the future trading may be substantial on reducing risk, increasing profits, and eventually reducing the marketing margin on beef.

Many have been concerned about delivery of cattle sold on the futures market. This over-concern about delivery is uncalled for since very few cattle will ever be delivered under future trading.

Live cattle closing prices on the futures market as of August 2 were: August—26.67; October—25.60; December—24.85; February—24.50; April—24.50.

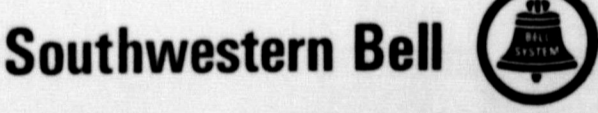

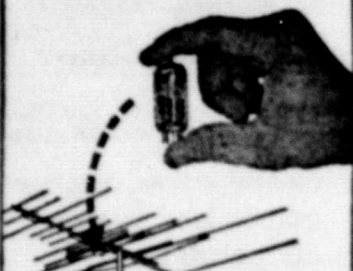

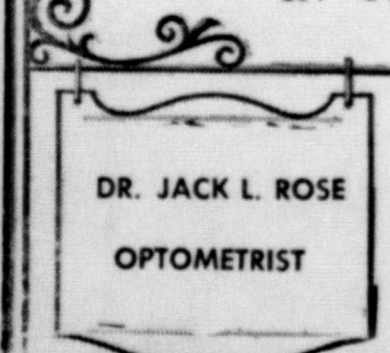

DECLARATION OF INDEPENDENCE EXPRESSES BASIC BELIEF

What do we mean when we say that in the United States we have a "government of law" and not a government of men? Basically we mean that we have certain individual rights, guaranteed by our federal and state constitutions and laws, which may not be denied by any governing body.

The early American colonists had their fill of government by men, and the Declaration of Independence, signed 188 years ago, set out their complaints against that type of government and revealed their belief in a principle which we now accept as basic to our American way of life.

The indictments set out in the document against King George III of Great Britain charged him with numerous violations of that principle. Among the complaints enumerated are the following:

"He has dissolved Representative Houses repeatedly, for opposing with manly firmness his invasions on the rights of the people."

"He has obstructed the administration of justice, by refusing his assent for laws for establishing judiciary powers."

"He has made judges dependent upon his will alone, for the tenure of their offices, and the amount and payment of their salaries."

"He has refused his assent to laws, the most wholesome and necessary for the public good."

"He has combined with others to subject us to a jurisdiction foreign to our constitution, and unacknowledged by our laws; giving his assent to their acts of pretended legislation..."

"For depriving us, in many cases, of the benefits of trial by jury; for transporting us beyond seas to be tried for pretended offences..."

"For taking away our charters, abolishing our most valuable laws, and altering fundamentally the forms of our governments..."

"For suspending our own legislatures, and declaring themselves invested with power to legislate for us in all cases whatsoever."

Our forefathers who subscribed to the principles of the Declaration of Independence were willing to fight for their beliefs. The Revolutionary War followed, dragging through weary years of suffering and suspense. Each of us takes pride in their eventual triumph over gigantic obstacles.

In 1787, when the framers of our Constitution met at Independence Hall in Philadelphia, where the Declaration of Independence had been signed 11 years previously, they set to work to create a system of checks and balances in government which was to perpetuate the fundamental theory mentioned in the preamble of the earlier document:

"We hold these truths to be self-evident: That all men are created equal; that they are endowed by their Creator with certain unalienable rights; that among these are life, liberty, and the pursuit of happiness."

"That to secure these rights, governments are instituted among men, deriving their just powers from the consent of the governed..."

Some five years later, the first 10 amendments to our Constitution were adopted at one time, specifically detailing various basic civil rights stemming from the underlying theory of the Declaration of Independence.

Our courts day by day guard these rights for us.

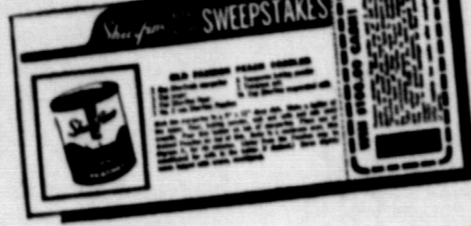

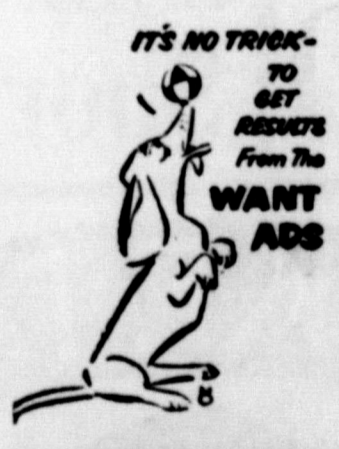
