Permanent Endowment Fund announced

The Golden Spread Senior Citizens Association held several meetings on Tuesday, October 30, 1984 to announce the beginning of a long term permanent endowment fund for the benefit of the Assoc. here in Spearman. Mrs. Marsha Murphy, President of the Center, and Mr. John B. Bingham, Director of Finance with the Amarillo Area Foundation, hosted a lunch at the Center to explain the workings of this new endowment fund. Local leaders and those interested in the Center attended. Then Mr. Bingham spoke to the general membership of the Center at the stew supper.

The permanent endowment fund is available to accept gifts of all kinds that will benefit the Center. Memorials, Birthdays, and Anniversaries are special occasions where gifts to the endowment can be made. Deferred giving, and bequests from Wills and Estates can also be made to the endowment. The gifts to the Center will be kept in

Spearman in the form of C.D.'s for investment purposes.

The Amarillo Area Foundation is related to the Endowment only through special services that the AAF can provide. The Foundation only provides the mechanism for and endowment to function -- such as accounting, legal, and estate counseling. The Board of Directors for the Center are in day-to-day command of the fund, and will make all decisions as to the investment and distribution of the funds.

The endowment concept has been used in many other places of the Panhandle. For example, in Perryton, Texas, several organizations have taken advantage of this concept:

The Museum of the Plains, The Ochiltree Co. Senior Citizens Association, The Ochiltree Memorial Hospital, The Perryton Sattelite Center.

In Dumas such organization as: The Moore County Libraries. The endowment can accept any

kind of asset, points out Mr. Bingham. The fund can take land, royalty, insurance, even cattle, if someone wanted to give them as a gift. Money or assets placed in the endowment remain in Spearman and accrue interest for the future. All gifts to the endowment enjoy the maximum tax advantages.

Mr. Bingham further explained that with a change in political climate, the Foundation has received an increasing number of requests from Panhandle non-profit institutions for grants from the general Endowment Fund. However, those institutions for which endowment funds were established years ago are now finding themselves in a more secure economic position. Obviously the need exists to provide permanent and long-range financing for the Senior Citizens Center. It can also take advantage of a pool of philanthropic dollars available in the local area.

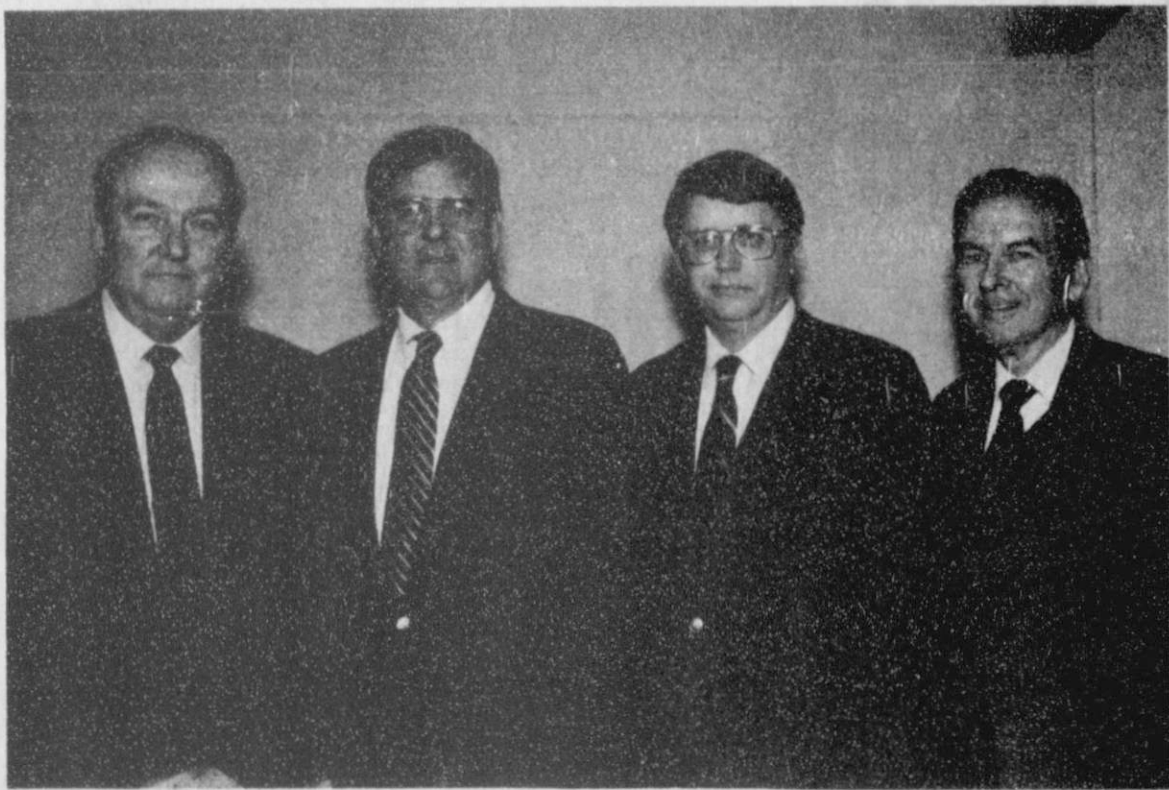

A Big Year For TCFA

A year full of issues--some resolved and others still brewing--and a big shift of feedyard numbers to the High Plains highlighted Dick Waterfield's year as president of Texas Cattle Feeders Association.

Waterfield noted during his address at TCFA's 17th annual convention Oct. 21-23 in Amarillo that a record 5.2 million head of fed cattle will be marketed in Texas in 1984, and 6.2 million from the Association's total membership area including Texas, Oklahoma and New Mexico.

Waterfield's address came in the middle of a packed convention schedule enjoyed by a record 917 registrants at the TCFA gathering. Other speakers included Secretary of Agriculture John Block and former ABC newsmen Howard K. Smith.

Waterfield said the shift to cattle feeding in Texas is a result of economic factors favoring the High Plains' commercial feedyards over other areas.

"About three years ago," said Waterfield, "some folks--espe-

cially in the Midwest--predicted that feeding would shift back to the Midwest because of the abundance of grain there.

"The reverse has occurred... I'm convinced it's still because of our economic advantages."

Waterfield said the Association had a full year in 1984, starting with the dairy PIC program that threatened to severely depress cattle prices.

"TCFA and National Cattlemen's Association fought hard on this issue," he said, "but we were too late with too little." The dairy industry, with their \$3 million in political contributions, already had the votes lined up in Congress.

"As it turned out, the dairy bite was not as bad as the bark. Only 12% of the nation's dairy farmers signed up, instead of the 50% expected; and only about 300,000 dairy cows were slaughtered, instead of the 1,000,000 expected.

"But it was a sober reminder to cattlemen that we must get more involved in the political area to protect our own interests. We are

doing that and will continue to be more and more involved."

Waterfield said TCFA had more luck in working for truck deregulation--obtaining legislation allowing "negotiated rates" and in getting clear title legislation introduced at the national level.

Waterfield also noted TCFA, along with NCA, had worked hard on getting IRS to trim its "tax shelter" regulations to a more workable level.

IRS announced shortly after the convention that it had indeed refined the regulations by exempting family business from registration as tax shelters and requiring only feedyards soliciting tax feeders to register.

In the convention business session, TCFA officers elected included Robert D. Josserand of Amarillo, replacing Waterfield as president; Mike Bowles of Summerfield, president-elect; and Zay Gilbreath of Gruver, vice-president.

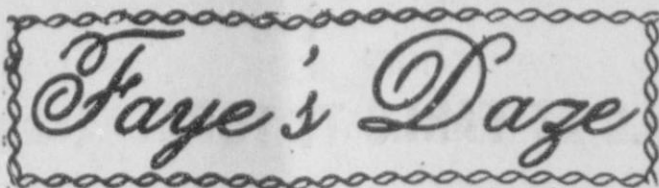

Tax Practitioner Workshops

The Texas Agricultural Extension Service is cooperating with the Internal Revenue Service in offering 38 Tax Practitioner Workshops across the state, reports Karen Harruff, County Extension Agent. The nearest workshop to our area is Amarillo and Lubbock.

These two-day workshops are specifically designed for tax practitioners who work extensively with farmers and ranchers.

Topics to be covered in the general workshops are: What's New; Alternative Minimum Tax; Capital Gains; Net Operating Losses; Self-Employment Tax and Social Security Planning; Subchapter S Corporation; Financial Distress--Tax Considerations; Retirement Plan Problems--IRAs.

HR 10s.

This year 13 advanced programs will be offered in major cities. The closest one to us is Lubbock. Topics to be discussed in the Advanced Workshops are: What's New; The Tax Reform Act of 1984; A Special Look at Corporations; and Introduction to Oil and Gas Taxation. The Tax Practitioner educational program has been highly successful. Last year about 3,300 people participated in this state-wide series. These practitioners reported filing more than 680,000 tax returns. 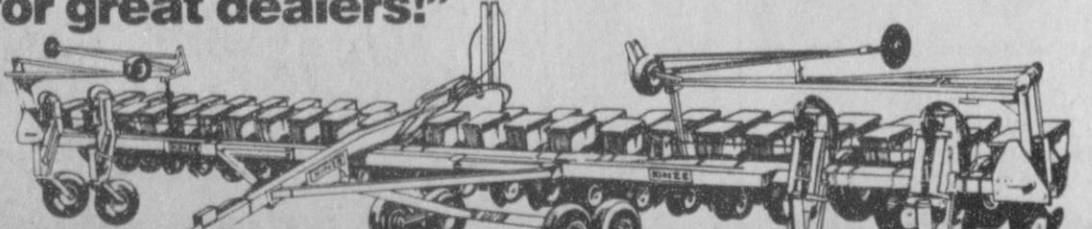

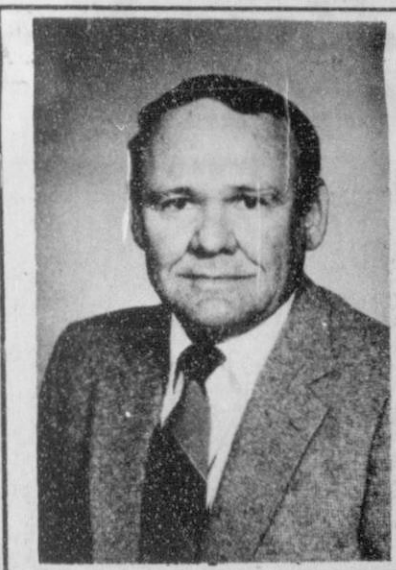

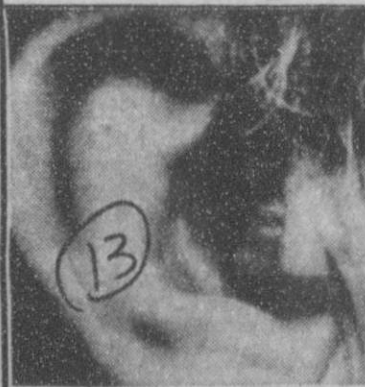

Hansford County mixed drink tax

AUSTIN--State Comptroller Bob Bullock Monday sent checks totaling \$11.6 million to 221 counties and 425 cities as their third quarter share of the state's 10 percent mixed drink tax collected through October 1, 1984.

The Texas Legislature raised the rate to 12 percent, effective October 2.

Bullock said the state collected \$40.4 million in taxes on the sale of mixed drinks during the quarter, up 8.5 percent over the same period in 1983.

Texas cities and counties each now receive a 15 percent rebate of the tax collected on mixed drinks sold within their boundaries under the law that legalized the sale of mixed drinks in the state. The state's general revenue fund receives the balance--\$28.7 million--of the tax money collected.

Cities and counties will get a 15

percent share of the increased mixed drinks gross receipts tax from fourth quarter collections. Beginning with the first quarter of 1985, cities and counties will each receive a 12.5 percent share of the increased tax and the state will get the entire gain from the tax increase.

The mixed drink tax is collected by the Alcoholic Beverage Commission and city-county rebates are sent out quarterly by the Comptroller's Office.

Bullock said the mixed drink tax has brought in \$120.5 million so far during 1984.

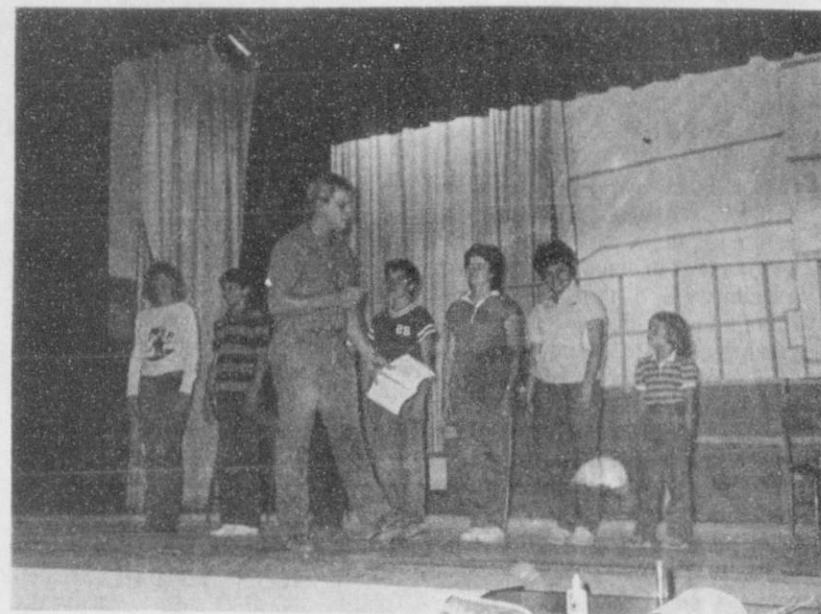

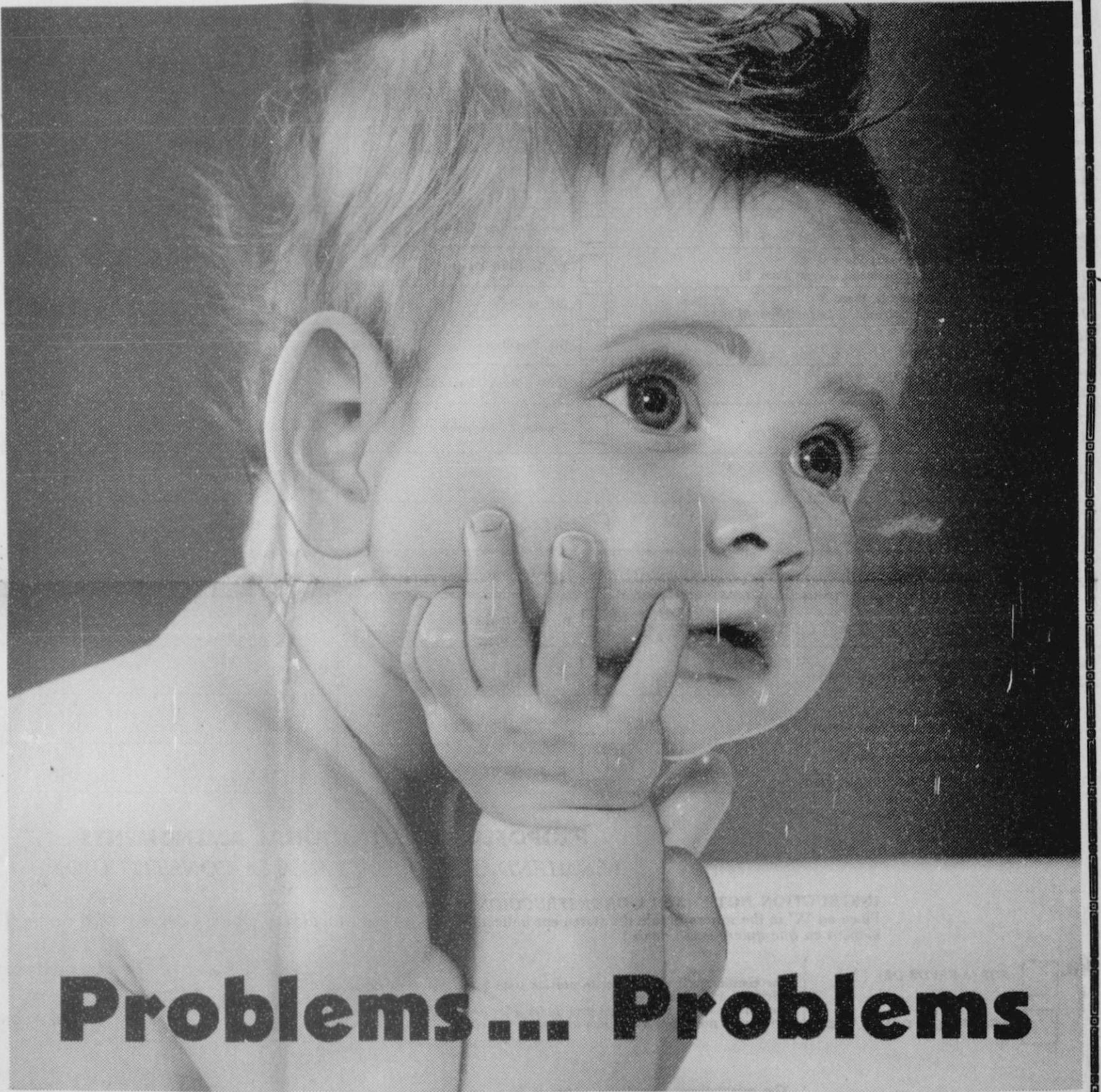
