School Board Meets

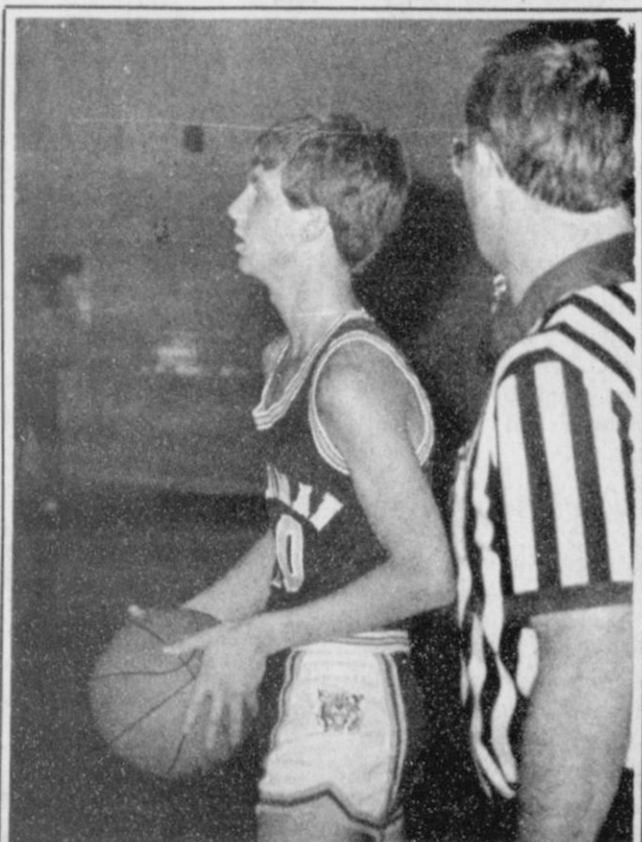

The minutes read as follows: Motion was made by Kent Guthrie and seconded by Phillip Renner that the minutes of previous meetings be approved as presented. Motion carried.

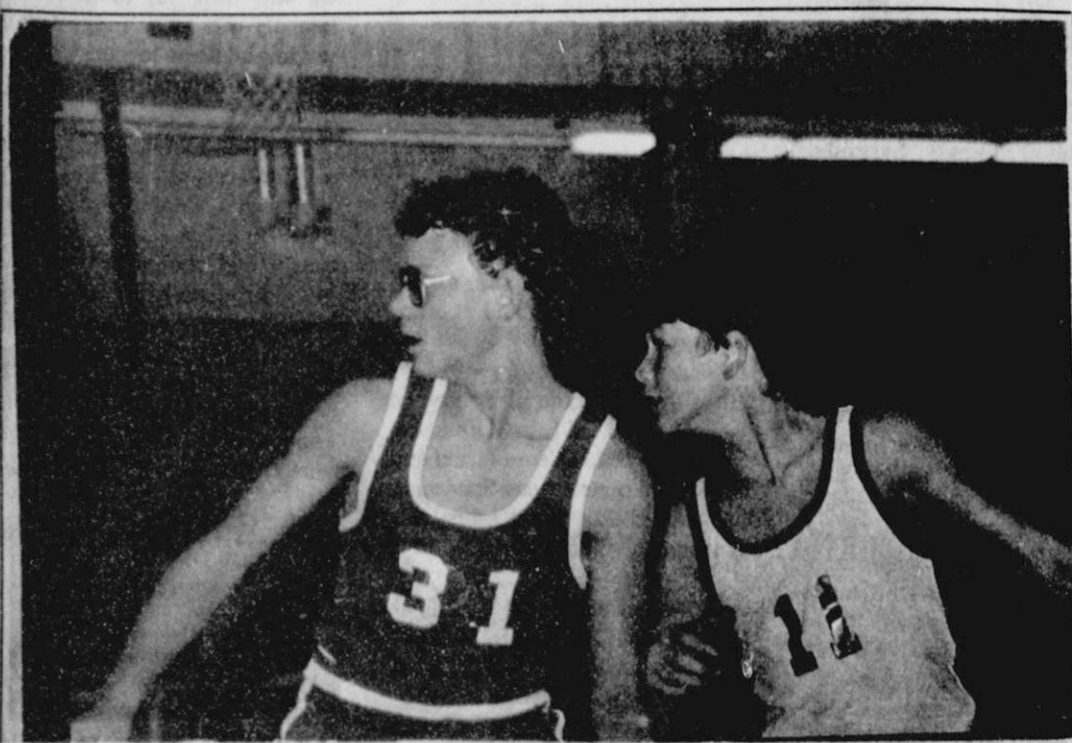

Hansford Hospital Bake Sale

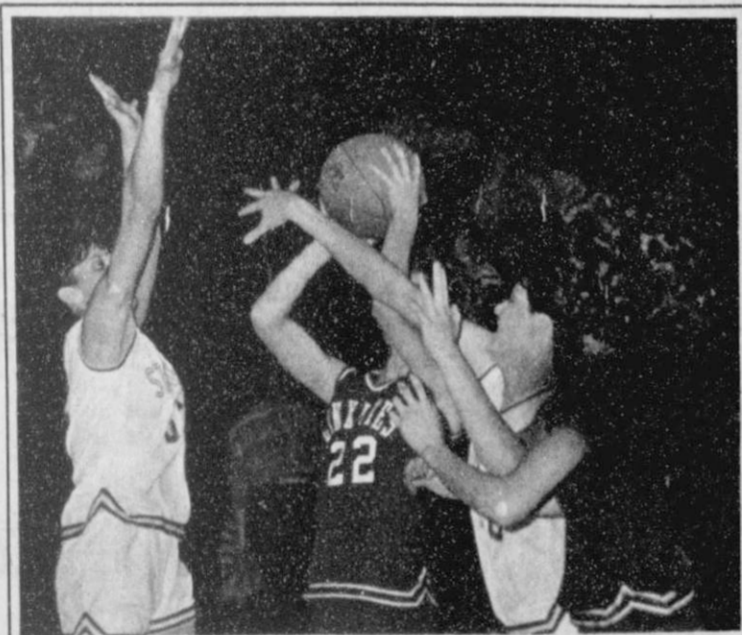

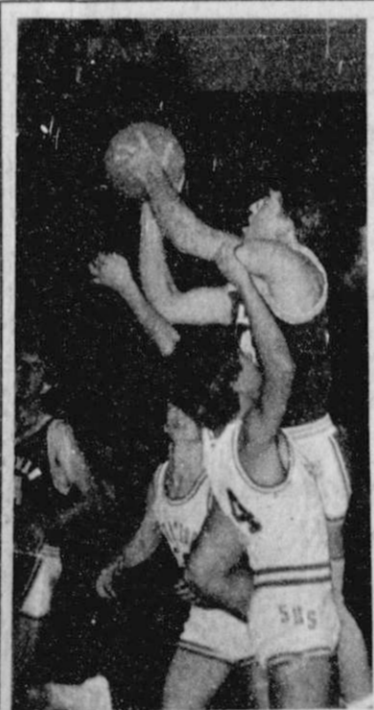
Thad Reid prepares to shoot free throws during last week's Stratford game.



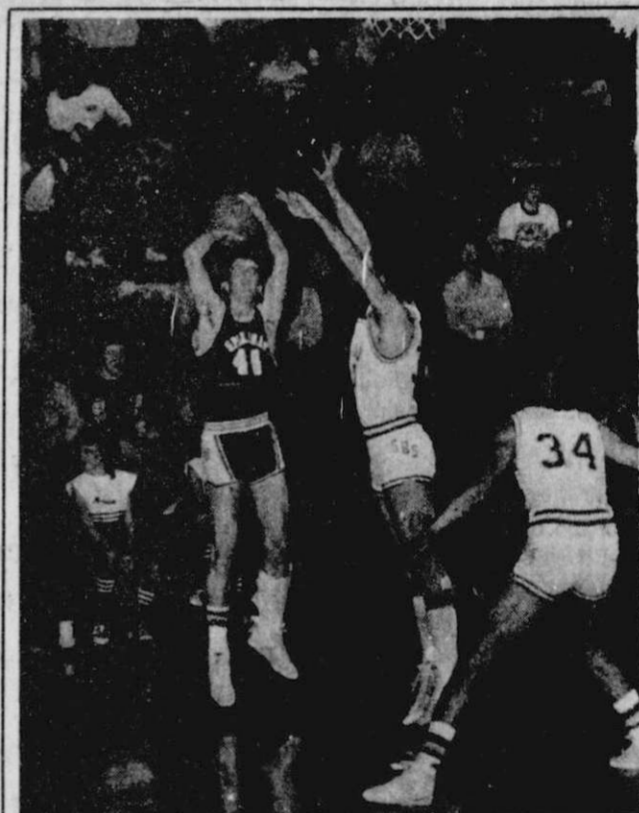
Edward Mayfield, 11, watches for his chance during Monday's game here against Stratford.

Two Bit Sermons

TWO BIT SERMONS

ATONEMENT

Of the great chapters in the Bible, Romans Chapter Five must be included. I would believe it to be included because of one word. That would be atonement. In the New Testament you find the word atonement only once, Romans 5:11 tells us that because of atonement we who are reconciled to God by the Death of His Son. Atonement is an act performed by one party on behalf of another.

Our salvation is made possible thru the work of Jesus on the cross of Calvary. It would be impossible for man to gain or even help in the area of His Salvation. For salvation to be offered to man there had to be a man as perfect as the first man, Adam, was. Romans 5:17 tells us that because the first man sinned all would then be born

in sin. It would take the work of another perfect man to redeem us from this sin in our life. Romans 3:10 says that all men are unrighteous. Therefore the only one left that was worthy was Jesus Christ, the Virgin Born Son of God. We find then that only a working of God could ever redeem a soul.

As to whether any kind of work will save, keep, or help you attain unto salvation I can find none in the scriptures. I find that scriptures such as Romans 3:20, Rom. 3:25, Eph. 2:8-9, Gal. 3:11, and Col. 1:20 that all of the work of salvation was accomplished by Christ in the work that he carried out in His death, burial, and resurrection from the grave. If the

work of atonement and reconciliation was not completed by Christ then Paul was mistaken. I believe that I will place my hope in the word of God and its promises rather than the teachings of men.

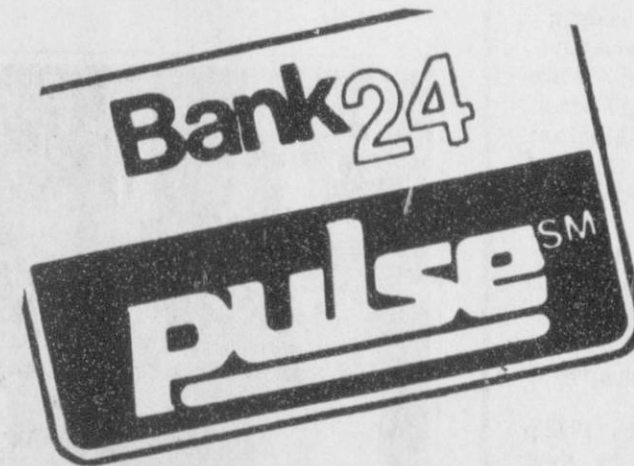

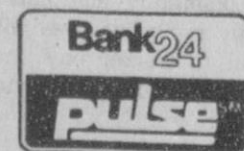

Rotate Grazing Pasture

Rotating livestock through two or more pastures in a planned sequence can be very beneficial to the production of a ranch. Moving the cattle in a planned order and resting the pastures from grazing will allow the plants which were grazed to grow back before being grazed off again. Allowing the grass to grow back will help make a vigorous stand of forage. Continuously grazing the grass without giving it a chance to grow and produce food for itself will make it less hardy in drought years and freeze out easier during cold winters. Therefore, a planned grazing system will allow livestock to graze the grasses properly without damaging them.

Grazing in one pasture, then moving to another pasture is very similar to how the buffalo grazed this country years ago. Moving onto fresh ungrazed grass is very beneficial to the cattle as well as the grass being rested. Also, with a planned grazing system and good management it is possible that a ranch will feed more cattle, provided the initial stocking rate is within reason. The cattle usually will graze the less desirable grasses as well as the more desirable

ones, therefore, using the forage more uniformly.

A planned system should be designed so that each pasture is rested, but not during the same season each time it is rested. For example, if a pasture is rested during the spring one year, then it should be rested during the summer, fall, or winter the next rest period. This allows for a more complete balance of forage. Also, if a pasture was grazed during the growing season every year continuously, then it is possible that the most desirable grasses would be grazed out.

Major benefits for a planned grazing system are: maintaining plant cover to prevent soil erosion while properly using the forage in all pastures; improve efficiency of grazing by uniformly using all parts of each pasture; increased number of livestock, provided initial stocking rate is reasonable; and to insure a supply of forage throughout the year.

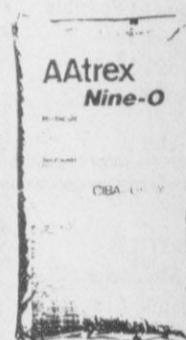
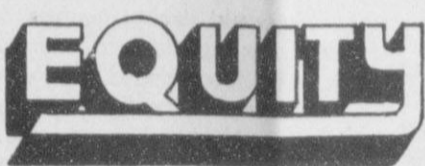

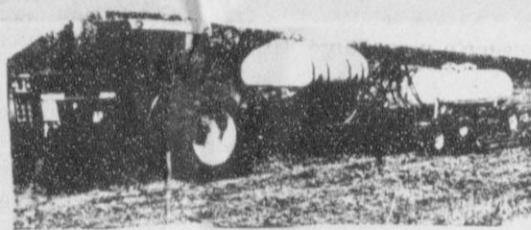

Water, frost or ice on the inside of windows is a chore to clean up and can produce conditions for the growth of mildew in your home.

Homeowners may not realize that it takes only four to six pints of water to raise the relative humidity of a 1,000 square foot house from 15 to 60 percent.

For example, a person breathing produces 1/8 pint of moisture per hour and mopping a 150 square foot floor will release 4 1/2 pints of moisture into the air.

In addition to normally generated moisture, certain heating methods can contribute to moisture in the home. In very tightly sealed homes with good insulation and storm windows, the use of an unvented kerosene space heater can double the amount of moisture vapor generated in the house each day.

The presence of continuous condensation on windows is a good sign of excess moisture. If frost or ice forms on a glass or metal frame and sash and if paint peels and wood rots, there is certainly excess moisture.

If a single pane of glass gets so cold that moisture condenses and runs down it in the winter, then double glass and/or a heating vent located beneath the window can eliminate the problem.

But sometimes condensation will occur on windows even when the relative humidity in the house

is low. In this case, condensation on windows results more from the cold window surface than from excessively high moisture in the room. Adding storm windows or polyurethane film to the windows, or placing heated air vents can solve the problem.

If moisture condenses between the permanent window and storm window, or polyurethane film and the window, the warm, moist air from inside the house is leaking to the airspace between the two. To correct this problem, seal the leaking spaces or ventilate the two windows. Ventilate the windows by drilling two three-eighths inch holes at the top and bottom of the storm windows or loosening them slightly.

When mildew or dampness is present on the ceiling or on the outside walls near the ceiling, there is a possibility that the insulation is not properly installed.

In this case reposition the insulation in order to prevent cold wind from chilling the area where vapor will condense in your house.

COLLEGE STATION — Texas A&M University is known for some of the most generous alumni in the country, who are always looking for ways to "give something back" to their alma mater.

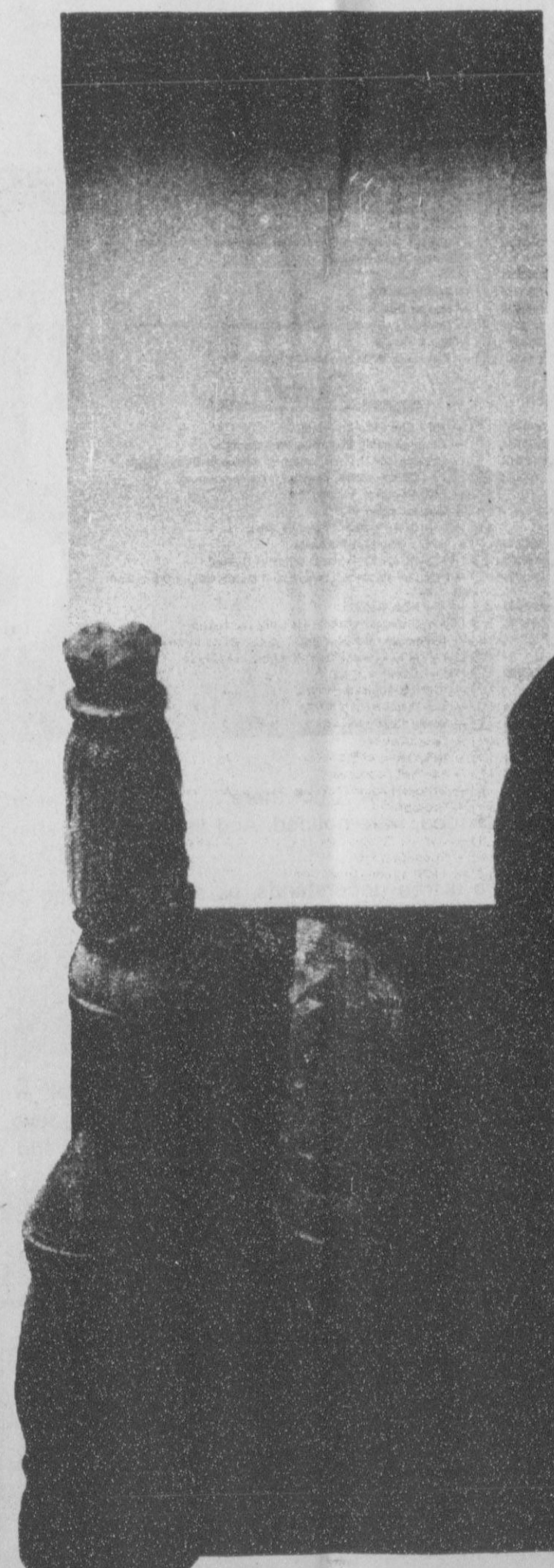
Under a program developed by the university's Association of Former Students, Aggies are now able to keep that tradition going while at the same time providing a unique link to current Texas A&M students.
