Juveniles make \$5,000 restitution for damage to home

Sheriff R.L. McFarlin reported this week that the three juveniles who vandalized the Butch Lasater ranch home north of Spearman were found guilty in their recent trial. The three were placed on probation until they are 18 years old. They must make complete restitution to the Lasater estate for the \$5,000 damage done to the home.

Sheriff McFarlin also reports that last week Ricky McDowell, 26 years old, allegedly stole a trophy saddle, trophies, etc., from the E.E. Greene building in Spearman. McDowell is now being held in jail. All stolen equipment has been returned.

The Sheriff returned Calvin Batiste to Spearman for alleged probation violation. He was arrested in Ada, Oklahoma. He was originally sentenced to 4 years probation for allegedly stealing a saddle.

Augustine Salazar, 49 years old, was arrested for pulling a knife on a subject. It was learned that he was an illegal alien and he was turned over to the Border Patrol and returned to Mexico.

The Sheriff's Office is holding Stephen Crisp who allegedly forged checks to local merchants in Spearman and the surrounding area. He is being held on a \$10,000 bond.

North Plains line project in process

Twelve miles of all new distribution lines are being installed in the North Plains Electric Cooperative in addition to revamping of 17 miles of line during the last segment of a two-year upgrading program.

Jerry Pshigoda, administrative assistant at North Plains, said the revamping is to replace lines built in the early 1940s when the cooperative was first opened. The new line and replacement lines are being installed to accommodate larger loads.

The revamping project includes reconfiguring, which is replacement of old wire with larger new wire; and going from single phase (two wires) to three-phase (four wires), or retiring, which means replacing old poles and wires.

The project has been contracted to Buck Construction of Lubbock and should be completed by the end of January if weather permits. Customers who will be affected by temporary power outages will be notified.

County breakdowns of the work areas follows.

Hansford — Four miles of brand new line is being put in. One mile is just west of the Hansford feeder and the remainder is northeast of Spearman near Palo Duro Creek. One mile of reconfiguring is also being done in that county.

Hemphill — Four miles of line will be retired.

Lipscomb — New line is being put in on a 5 1/2 mile stretch south of Booker. Also in Lipscomb county will be 5 1/2 miles of reconfiguring, and three miles of retired line.

Ochiltree — South of Waka 2 1/2 miles of new line is going in plus one mile of reconfiguring and three miles of retiring line.

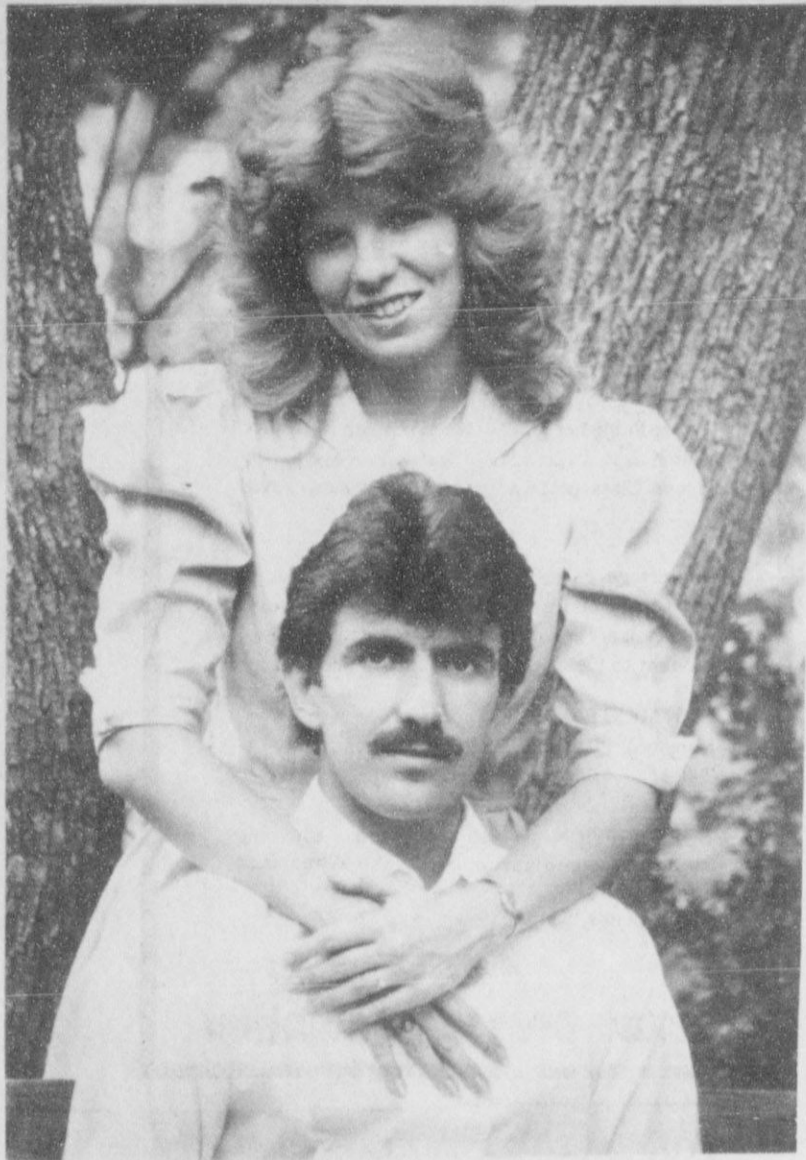

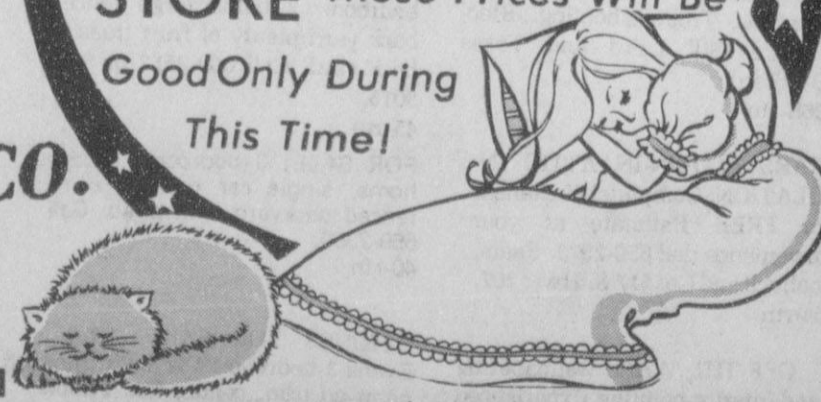

PSAT/NMSQT to be offered Oct. 23

More than 1.4 million students are expected to take the Preliminary Scholastic Aptitude Test National Merit Scholarship Qualifying Test (PSAT/NMSQT) this fall in over 19,000 high schools across the nation. Among them will be 17 students scheduled to take the test October 23 at Spearman High School, according to Margie Alford of the school's guidance staff.

The PSAT/NMSQT will be offered nationally this year on Saturday, October 20 and Tuesday, October 23. Since 1959, nearly 30 million students have taken the test, which measures verbal and mathematical abilities. "Students take the PSAT/NMSQT for several reasons," said the local guidance official. "The PSAT/NMSQT is the qualifying exam for students wishing to participate in competitions of the National Merit Scholarship Corporation. Students also want to find out how they rank among their peers taking the test in other parts of the country."

The test also provides an opportunity to become familiar with types of questions similar to those on the Scholastic Aptitude Test, which many college-bound students take. In addition, the test is the first step in qualifying for the National Hispanic Scholar Awards Program, conducted by the College Board under a \$2.1 million grant from the Andrew W. Mellon Foundation.

Particularly helpful for students is the Report of Student Answers, which includes the correct answers and their own responses and scores. They also receive their own test booklets so they can review the actual questions, see the ones they got wrong, and try to figure out the correct answer and why they may have missed it.

The College Board also provides other services that enable counselors and other school personnel to better understand and interpret the test results to students and parents. These services include school summaries of students' answers, profiles of the academic characteristics and career interests of students taking the test, and a special publication for use with students as part of a general guidance program.

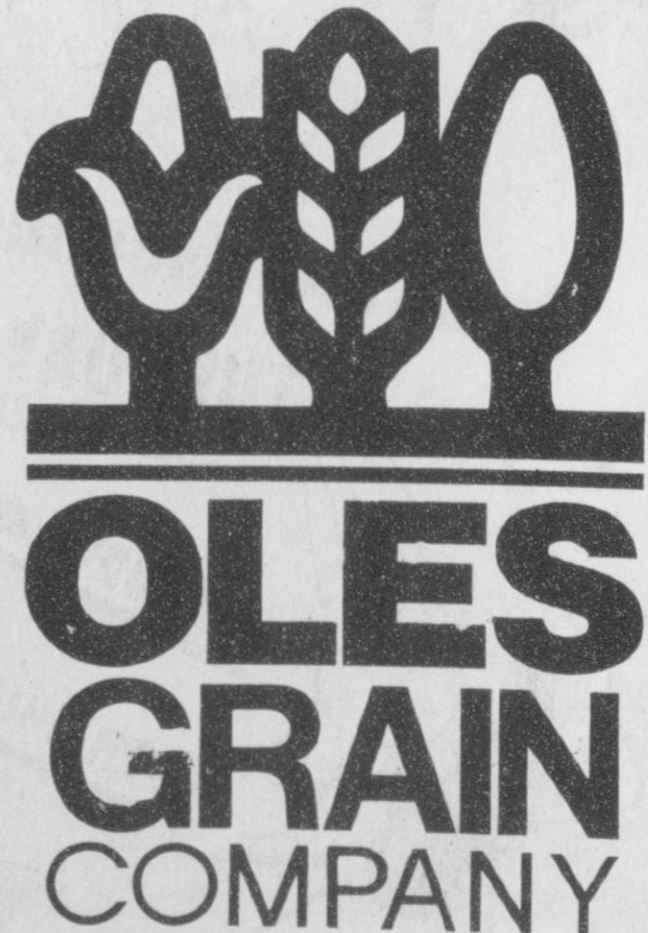

Keith Lamb re-elected to SWCD board

Keith Lamb of Gruver was recently re-elected to the Hansford SWCD board of directors.

The purpose of the Hansford SWCD, with headquarters in Spearman is to promote sound soil and water conservation programs on farm and ranch lands within the district and to serve as a voice for farmers and ranchers on conservation matters and other issues affecting private property rights of landowners.

The board of directors coordinates the conservation efforts of various local, state and federal agencies and other organizations and has authority to enter into working agreements with these governmental agencies and private concerns to carry out its purposes.

As one of five individuals

serving on the district board of directors, Lamb will be responsible for district policies and procedures for carrying out the district program within the framework of the Texas soil conservation district law.

In Texas there are 201 soil and water conservation districts. Each is a legal subdivision of state government organized by local agricultural landowners with the assistance of the Texas State Soil and Water Conservation Board. Unlike most other legal subdivisions of state government, SWCDs do not have the powers of taxation or eminent domain. All conservation programs managed by the districts are of a voluntary nature to the landowner or operator.

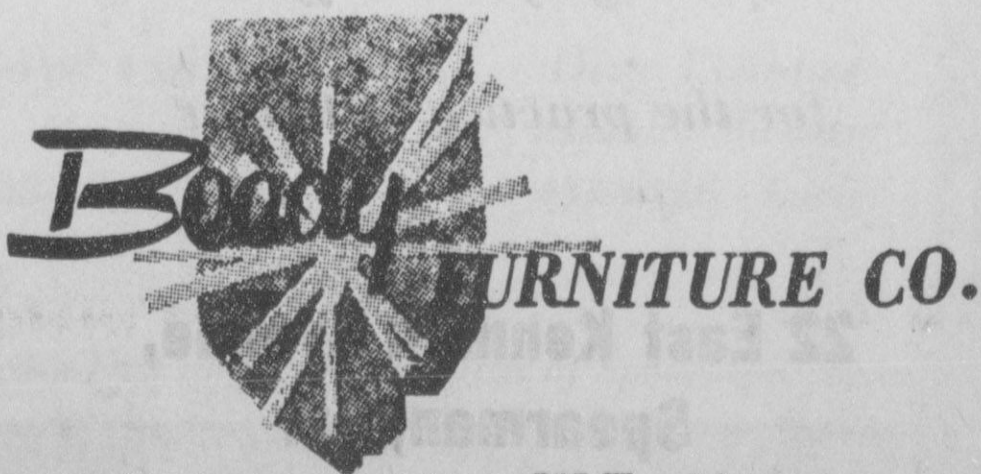

FmHA Assistance to Farmers in debt restructuring

FmHA ASSISTANCE TO FARMERS IN DEBT RESTRUCTURING
FOUR TYPES OF ACTION: The President announced on September 18, 1984, that he has authorized the following actions by the Farmers Home Administration (FmHA) to help farmers who have demonstrated good production skills but cannot repay existing loans due to cash flow problems:

- A. FmHA may set aside a part of an existing farmer borrower's debt without interest, thereby reducing payments so that the remaining payments will be within the borrower's positive cash flow necessary for repayment ability.
- B. FmHA may give loan guarantees not to exceed 90 percent to other lending institutions that reduce a debt enough to allow a borrower to have the positive cash flow necessary for repayment ability.
- C. FmHA will provide more credit counseling and farm management guidance to farmers.
- D. FmHA will conduct a pilot project to evaluate contracting for services of other lenders experienced in servicing farm loans to augment regular FmHA county office personnel.

(A) LOANS HELD BY FmHA
 What borrowers will be eligible for assistance?

All FmHA borrowers who are good managers and are in financial distress because their loan payment obligations exceed what they can pay from existing cash flow of their farm operations.

What action will be taken to restructure the debt?

FmHA may set aside collection of up to 25 percent, not to exceed \$100,000, of the borrower's total debt to FmHA. If it is possible to work out a repayment schedule the borrower can meet based on the balance not set aside, payment will be rescheduled on this basis. It must be determined that a new, reduced schedule of payments can be met from the borrower's anticipated cash flow and that full payment can be resumed at the end of the set aside period.

For how long will the debt be set aside?

Five years.
 Will the portion of debt set-aside draw interest?

No, it will not accrue interest during the set aside period.

How will the set-aside portion eventually be paid off?
 Payments on portions set aside will resume at the end of the 5-year period.

How much loan funding does FmHA require to implement this part of the program?

None. It can be accomplished under the Secretary's present statutory authority to set aside or reschedule a borrower's existing obligation to FmHA. Restructuring loan payments to bring them within the means of the borrower's cash flow involves no disbursement of additional loan money.

(B) LOANS HELD BY OTHER LENDERS

What borrowers will be eligible for assistance?

Farmers who are good managers and whose loans are in a state of nonperformance or other classification of difficulty, and who meet the statutory restriction of FmHA services to owners or operators of "not larger than family farms."

What form will FmHA assistance

take?

Issuance to the bank, Farm Credit System lender or other eligible private-sector lender of a loan guarantee.

How can a lender qualify for the guarantee?

The lender must write off enough of what the borrower owes, and take any other necessary action to assure that the borrower's repayment obligation can be met from the borrower's anticipated cash flow. At least 10% of a borrower's total debt must be written off. In adjusting the rate of payment to the farmer's cash flow, it may be necessary to reduce the balance due by more than 10 percent and/or liberalize the borrower's repayment schedule.

How would this restructuring benefit borrower and lender?

It would restructure the borrower's debt on a basis within the borrower's ability to pay, and it would avert loan failure.

Where and by whom is a guarantee application made?

A lender must initiate an application, and should consult with the local FmHA office for guidance

on assembling its first request. All applications are received and processed at FmHA county offices.

What interest rate will the loan bear?

The rate agreed to by lender and borrower not to exceed the rate given to the lender's best farm borrower.

What are the limits on FmHA-guaranteed loan amounts?

\$400,000 for operating purposes, \$300,000 for real estate purposes.

How will this part (B) of the debt restructuring program be funded?

Under FmHA's appropriated authority to guarantee other lenders' loans for farm operating and real estate purposes.

What happens when loans are paid in full?

When borrowers pay the guaranteed loans in full, the guarantee is automatically terminated.

(C) ADDITIONAL CREDIT AND MANAGEMENT GUIDANCE

How will this additional assistance be provided?

by contracted experts who are competent to advise farmers on developing and carrying out

financial and operational plans that are tailored to their needs and will enhance prospects for success of their farming operations. This service is extended from county offices and continues the professional expertise of FmHA along with the addition of contracted staff.

Who may obtain this assistance?

Any farmer or lender who requests it. The service will not be limited to those who are direct borrowers or loan guarantee beneficiaries of FmHA.

(D) PILOT PROJECT FOR CONTRACTING LOAN SERVICE

What services will be obtained?

Services of other lender organizations experienced in serving agricultural loans, to give FmHA's full-time professional staff reinforcement in peak seasons of farm loan servicing.

When will contraction occur?

Contracting at the county office level for an initial pilot program in several critical states will be completed by January 1, 1985.

At what level will contracting be conducted?

County office level.

National Rifle Association's Sighting -In Days Program

As the 1984 fall hunting season opens, gun clubs nationwide will conduct the National Rifle Association's Sighting-In Days Program. The program provides sportsmen with an opportunity to accurately sight-in their firearms and bows at life-size game targets.

Riflemen and bow hunters will test the accuracy of their sporting arms by shooting at life-size paper targets of various wild game. Shot-gunners will fire at clay targets which simulate flying game birds. If a hunter's firearm or bow doesn't aim properly, a

program volunteer will assist the hunter in making accurate sight adjustments, while gunsmiths will be available to perform equipment and safety checks. Once the hunter's sporting arm is shooting precisely and operating safely, the sportsman is prepared for the field.

NRA's Hunter Services Division has prepared packages of life-size white-tailed deer, mallard duck, rabbit, wild turkey and squirrel targets, ideal for sighting-in days programs. The targets provide realistic shooting condi-

tions, assist hunters' firing accuracy and improve depth perception. Target packages are available at greatly reduced prices ranging from \$1.00 - \$4.00.

Sighting-in days programs stress the necessity of hunter marksmanship preparation and safety in the field.
