## Light turnout indicated by absentee ballots . . . Hansford voters to polls Tuesday

Absentee balloting for Tuesday's presidential preference primary closed Friday afternoon with indications at noon Friday that this could be a light turnout for Texas' move to the second Tuesday primary balloting.

By noon Friday only 47 absentee ballots had been cast at the Hansford county clerk's office -- 27 on the Republican side and 20 on the Democratic side.

Early indications are that Tuesday's election could be the first time in Hansford county's history that the county has gone Republican in a primary election if that trend holds true through balloting this Tuesday.

Polls Tuesday will open at voting precincts throughout Texas and Hansford county at 7 a.m. with balloting to continue through 7 o'clock that evening.

But Tuesday's balloting could also be light if absetee voting is any indication. "This is the lightest turnout we've ever had for a presidential primary," notes Hansford county clerk Amelia Johnson. "Of course, we may get a lot more to come in before 5 o'clock this afternoon.

The balloting through noon Friday showed that 20 people had cast their ballots in person in the Republican primary with seven more through the mail.

On the Democratic side, 13 have voted in person and another seven has come through the mail. Local interest is centered on an

active campaign for 84th district attorney on both the Republican and Democratic ballots. Three Republicans and two Democrats are vying for the right to represent their party in November's general election.

John LaGrone and Vance Jones, both Borger attornies, are on the Democratic ballot while incumbent Gene Compton is being challenged by former district attorney Stephen F. "Steve" Cross and political newcomer Phil Black. They are all from Borger as well.

Both Jones on the Democratic ticket and Cross on the Republican ticket maintain offices in Hansford county as well.

The only other local election is a low key campaign for precinct three county commission with incumbent B.J. Renner being challenged by Don Evans of Gruver for that position on the Democratic ticket. There are no Republican candidates.

Other races of local interest include that for U.S. Representative and for Texas state senator where a large slate of candidates exists in both party primaries.

There are six Republican and three Democratic candidates for the district 13 U.S. representative ballot.

Repbulicans include Chip Staniswalis, Alan Pickering, Bob Price, Ron Buffum, Larry S. Milner and Jim Brandon.

Democratics are current state senator Bill Sarpaulius, Randy Hollums and Ed Lehman.

Running for state senator from district 31 on the Democratic ballot are Nancy Garms, H. Bryan Poff, Jr., and Mel Phillips.

Republican candidates -- both from Amarillo -- are rancher/oilman Teel Bivins and businessman Ron Slover.

This is the first year for Texas voters to cast primary ballots in March. Since the early 1960's, voters in the Lone Star state have had primary elections the first Saturday in May.

Texas legislators moved the primary vote to the second Tuesday in March to coincide with 15 other Southern states who also hold primary elections in what has become known as Super Tuesday during presidential campaign years.



## Survey shows Gephardt, Dukakis, Bush, Dole are strong in Hansford

A sampling of Spearman residents Friday showed an active interest in Tuesday's presidential preference primary as residents were asked which candidate in each party they preferred.

The respondents were picked at random and asked to choose between the active candidates in each party without revealing which party primary they will vote in this Tuesday.

Snow cancels rodeo event A 2-day Tri-State High School Rodeo Association rodeo to be held in Spearman this weekend was forced to cancel due to wet weather which left the rodeo arena area too wet for performances, announces a spokesman for the Gruver-Spearman group which was to host the event.

A total of 50 residents were interviewed and, in the survey, Dick Gephardt ran narrowly ahead of undecided. Gephardt had 14 votes while 13 people listed themselves as either undecided or "Don't know".

Mike Dukakis received 11 votes while Al Gore had eight. Paul Simon and Gary Hart each received two votes apiece while Jesse Jackson failed to register at all in the survey.

On the Republican side of the ticket, George Bush and Bob Dole finished in almost a dead heat with Bush receiving 18 votes and Dole,

Undecided received seven votes, Pat Robertson, six and Jack Kemp only two votes.

The actual outcome of the election could be quite different from the survey results because of that. The high number of undecided on the Democratic side of the survey, however, could suggest one of two things. It could be a barometer of some confusion within the Democratic ranks as to whom can lead the party most effectively, or it could be an indicator that some of those questioned will be voting Republican and had not considered a strong Democratic contender.

While results were not complete as of Friday morning, early indications from absentee balloting at the Hansford county courthouse showed Republican voters leading Democratic voters by a 27-19 count. Jesse Jackson Gary Hart Al Gore Undecided REPUBLICAN

Hansford hospital is currently served by Drs. Romeo Sangalang and Juan Viola with the latter splitting his time between Gruver and Spearman.

## Storm dumps rain, snow -breaking 6-week dry spell

A 6-week dry spell came to an abrupt end this week when winterlike weather returned to Hansford county, turning a general rain first into ice and sleet, then into a 4-inch snow which was whipped by winds which were in excess of 40 mph.

The last moisture recorded in Hansford county was in mid-January when a pair of backto-back days of snow left .72 inch of moisture.

Wednesday's rain-ice-snow fall saw 1.25 inches of moisture recorded, breaking that 6-week dry spell which had extended through the entire month of February.

February was the first month since January, 1986, that Hansford county had gone for a full month without recording any moisture at all, according to records kept at KRDF-FM, the official weather reporting station in the county.

Icy road conditions led to treacherous driving which saw a group of Hansford county residents near the

A 6-week dry spell came to an Pringle vicinity in Hutchinson or upt end this week when winter- county.

The Hansford county sheriff's office aided motorists all through Wednesday evening in getting their vehicles out of bar ditches along state and county roads in Hansford.

Stranded in Hutchinson county were Hansford residents Toby Kuehl, Dr. and Mrs. Romeo Sangalang, Ed Pearson, Lenny Pool, Melissa Vesquez, Tammy Burch, John Roland and Richard Espinosa according to information from the sheriff's office.

These individuals were picked up by members of the Hutchinson county sheriff's office and transported to Stinnett where they wound up spending the night.

Traffic for a time from Stinnett to Spearman was completely cut off as icy road conditions forced the closing of the highway.

In the early hours of Wednesday morning, a general rain began with an office rainfall of .52 inch before and advancing cold front turned the moisture first into ice and sleet, then into snow.

A total of 4-inches of snow was recorded in addition to another .58 inches of rain. The snow melt provided another .15 of an inch for total precipitation of 1.25 inches.

The most recent blast of winter weather saw white out conditions in some portions of the county as the 40 mph winds whipped the snow into typical Texas Panhandle drifts.

Reports of cattle loose were frequent in and around both Spearman and Gruver during that period which also increased driving hazards.

No accidents, however, were reported by either the Spearman police department or by the Hansford county sheriff's office during the storm.

### Names listed on unclaimed money

Texans who have unclaimed money in the state treasury are listed in an annual publication from the Texas Treasury Department a publication entitled 'Texas Treasury Unclaimed Money Fund.

The 20-page newspaper size publication lists the names of people or organizations which have at least \$50 -- in many cases, more than that amount -- due back to them from banks or other businesses.

Most of these funds have been reported to the state treasury from banks who hold accounts. Accounts turned into the state for this special publication are those which have been inactive for three years or more.

The 1988 publication has some 75,000 people or organizations with some \$60-million being held in these inactive accounts. Claim forms for the funds should

be ordered from the State Treasurer, Box 12608, Capitol Station, Austin, Tx. or by calling a toll free number, (800)321-2274.

A total of 32 Hansford County names appear in the publication from Morse, Gruver and Spearman.

Names in the publication are listed by addresses on the accounts. People who have lived in other Texas cities may have their name listed there if the account has been inactive for three or more years.

Funds now in the state treasury's unclaimed money fund from Morse include Richard Hedgecoke, Richards Hedgecoke and Delbert McCloy.
