Sante Fe Surveyors.

A. P. Kittrell, Chief engineer and a party of sixteen assistants were in Snyder last week. Mr. Kittrell is working for the Sante Fe railroad and will begin surveying north of Snyder where Mr. Duvall left off on the Snyder, Roscoe & Pacific road and complete the survey on northwest to Texico complete the survey for the main line of the Sante Fe cut off between the Gulf and the Pacific.

Mr. Kittrell and party started from Talpa on the San Angelo branch of the Sante Fe and crossed the Orient about sixteen miles south of Sweetwater and the Texas & Pacific road at Roscoe. Mr. Kittrell further stated to a representative of the Coming West that the survey would also embrace Lubbock — Snyder Coming West.
