Conscience is an unseen part of the "inner man. Conscience plays a very definite part in salvation. But conscience cannot be trusted, unless it is first taught by the gospel of Christ. Let us take note of Paul's conscience before and after he surrendered to Christ.

"I am a Jew, born in Tarsus of Cilicia, but brought up in this city, educated under Gamaliel, strictly according to the law of our fathers, being zealous for God, just as you all are today. And I persecuted this Way to the death, binding and putting both men and women into prisons, as also the high priest and all the Council of the elders can testify. From them I also received letters to the brethren, and started off for Damascus, in order to bring even those who were there to Jerusalem as prisoners to be punished." Acts 22:3--5

Besides these verses. Paul's heart was with those who killed God's faithful man, Stephen. Acts 22:20. Paul further states that he imprisoned and beat those who believed in Christ. Acts 22:19.

In Spite of these vicious crimes against Christians, Paul states that he lived a life of "perfectly Good conscience . . . to this day." Acts 23:1. How could Paul make such a claim?


