

The Upper Leon River Municipal Water District has installed fire plugs in various areas that it serves. The primary use for the fire plug is to flush the lines of the Water District. The fire plugs may be used for the purposes of fighting fires; however, the Water District hereby advises you that the Water District in no way warrants the capabilities of the fire plugs or the capacities of the water supply furnished in connection therewith for fire fighting purposes. The Water District takes no responsibility whatever for the furnishing of water, either for volume, pressure or collapsed lines for fighting

The fire plugs are located at PAR Country Club, in the Foley area, Buffalo Springs area, and there are three in Proctor, and one is located on Highway 377-67 about 1 mile east of Comanche on a 4" line. The fire plug located in Comyn is on a 6" line which is connected to a 14" main. The fire plug at Rucker is on a 8" main, but is pressurized only when the pumpis running. There are 7 fire plugs on 6" pvc mains in PAR Village.

This information is furnished to you so that you will be aware of the limitations and/or capacities of the lines; however, they are to be used in the event of fire solely at the risk of your fire department, and any person unfortunate enough to have a fire.

As stated, the purpose for which these fire plugs were installed is for use in flushing lines, and any future fire plugs installed by the Water District will be for the same purpose. Therefore, the above mentioned plugs, as well as any plugs that are erected in the future, may be used for fire purposes strictly at the risk of the fire department.





Let me talk about a program that I would like to see instituted in this state, that program most often being referred to as "workfare."

Workfare is a program whereby any adult welfare recipient able to work is required to perform a reasonable amount of community service work as a prerequisite to receipt of public funds. The work may well take the form of collecting trash along roadways, working in public hospitals or an almost endless list of tasks that gives the public at least some benefit.

The objection to workfare has

primarily been that it is degrading to the person receiving the welfare funds and is unhealthy to the society forcing the individual to work. This objection, of course, flies directly in the face of what most of us have always been taught, that being that any honest work is not degrading.

It makes no difference which side of the argument you choose, the fact is the social welfare system, state and federal, cannot continue to function as it currently exists.

Even if we do not attempt something like workfare, the end is in sight because our country is quite simply going to drown in red ink.

I do not think my constituents have any problems with the theory that you need to work for what you get, so I do not think you will be angered with me when I support workfare in the next session of the Texas Legislature.

At any rate, if you feel differently, now is the time to let me know.

Some controversy appears to be in the making concerning the proposed use of generic substitute prescription drugs to welfare recipients. As I am sure each of you knows, the market in pharmaceuticals has name brands much like Chevrolet, Chrysler or Cadillac in the auto industry. Of course, we do not have a generic substitute for Cadillac but for many of the better known prescription drugs, I am told there is a generic substitute.

The definition of generic is "relating to or characteristic of a whole group or class" or "not protected by trademark registration." In the case of pharmaceuticals the Legislature would hope funds could be saved by providing the substitute drugs to welfare recipients at a reduced cost to the State. This is, of course, predicated upon the presumption that the substitute is as good as the name brand and considerably cheaper.

I have recently been advised by people who should know that the generics are often inferior in quality to the name brands. As is always the case with science and scientific applications, it becomes the role of the social scientist to determine the application.

The question becomes as follows: Are welfare recipients shortehanged and discriminated against by the use of generics?

Not everyone can afford to drive Cadillacs and, while a Chevrolet is almost as good, I think everyone will admit it is not the same. Those who have money can afford a Cadillac, those who do not, cannot. The problem I am having difficulty with is whether or not the State of Texas has any obligation to furnish Cadillac prescription drugs to welfare recipients. I have come to the conclusion the State of Texas has no such obligation. I have concluded, in my mind at least, that the State's obligation is to furnish prescription drugs that meet a minimal standard and if that minimal standard can be met by generic substitutes, then the State has fulfilled its obligation.

This is not a small or simple problem because the same reasoning as must be used with generic drugs and welfare recipients applies to virtually every social service provided by government to needy people. It is a thought provoking problem and one that merits serious consideration as a forerunner of our attitudes toward social progress and social welfare in the 1990's and beyond.

I hope we have learned we cannot use public monies to create equal social conditions for unequal individuals. The issue of generic substitutes to welfare recipients is a good place to commence formulating our future ideas. If you are one of the rare individuals who are at all concerned about this, I would like to hear from you.



### **EASTLAND COUNTY PECAN SHOW SET** DECEMBER 6 and 7

The Eastland County Pecan Show is scheduled for December 6 and 7 in the Eastland County courthouse lobby. This will be the 33rd consecutive pecan show in the county reports Charles Walker, President of the Eastland County Pecan Growers Association. The show is sponsored by the grower's association and the Eastland Chamber of Commerce.

A large pecan crop is being harvested this year. The quality of the pecans in the show should also be good according to the County Extension Agent DeMarquis Gord-

Anyone producing pecans in 1985 may enter the pecan show. An entry consists of 43 pecans of one variety and natives or seedlings from any single tree. All entries should be sacked and labeled with the grower's name, address and variety of pecans.

All entries of nuts must be entered by 4 p.m. on Thursday, December 5. They may be sent or left at the County Agent's office in Eastland prior to December 5. Growers are limited to one entry of each improved or papershell variety and as many natives or seedling entries as they

The first place entries will be sent to the Regional Pecan Show. Entries not winning first place will be sold to pay expenses of the show.

Any alteration of pecan shells by marking, filing, or polishing will disqualify the entry so treated. However, exhibitors are encouraged to remove all traces of husks and foreign matter from the shells.

Walker said there will be a class for every variety provided there are at least two entries in that class. There will be a class for the smallest pecans, native pecans, seedlings, as well as all varieties. Plaques will be given to exhibitors of champion in-shell, shelling and native entries. Rosettes will be awarded for reserve champions and the first three place ribbons will be given in each class.

Pecans will be judged by Extension Service and Experiment Station Horticulturists. They will judge pecans based on size, color, appearance, shell thickness, cracking quality, kernel quality, and other fac-

After the pecan show on Saturday, December 7, the growers organization will sell shelled pecans and in-shell pecans that do not win first place to help pay expenses of the pecan show reports Walker.

#### **PECAN BAKE SHOW**

Pecan baked goodies will be on display at the 1985 Eastland County Pecan Bake Show on Friday, December 6 in the Eastland County Courthouse lobby.

The Pecan Bake Show is traditionally held in conjunction with the annual pecan show. The show is being sponsored by the Eastland Chamber of Commerce and the Eastland County Extension Homemakers Council.

The public is invited to participate and enter the bake show. There will be a youth and adult division. You can have only one entry per class.

The 6 class divisions are: Ples - must enter whole pie Cake - must enter whole cake Candy - must enter at least 12 pieces Nut Bread - enter one whole loaf Cookle - enter at least 12 cookies Snacks - enter ample portion for

All entries must contain pecans. Recipe should accompany all bake show entries.

All entries are to entered between the hours of 8 a.m. until 11 a.m. on Friday, December 6 when the judging will begin in the courthouse lobby.

Cash awards and ribbons will be awarded as follows:

1st - \$2.50, 2nd - \$1.50, 3rd - \$1.00 There will be a Grand Champion and a Reserve Champion for both the adult and youth divisions. Cash awards will be Champion - \$5.00 and Reserve Champion - \$4.00. Engraved silver trays will be awarded the Grand Champion winners.

Entries in the adult Pecan Bake Show division will be returned to their owners between 4 and 5 p.m. on Friday, December 6. Adult Pecan Bake Show entries not claimed by 5 p.m. on Friday, December 6 will be sold to the public and money will go to the Extension Homemaker Council treasury fund.

Persons wishing additional information on the Pecan Bake Show are invited to contact Mrs. Janet Thomas, County Extension Agent at 629-2222. Mrs. Thomas states that all pecan bake show entries should be entered on disposable material or plates. All baked items need to be covered with clear plastic wrap.




