When the pager goes off...

You never know when your pager goes off what it will mean if you're a volunteer fireman, says Lazbuddie's Donnie McDonald.

Last weekend, Lazbuddie firefighters and EMS personnel learned the truth in that statement firsthand.

It started Saturday when a trash fire was reported behind the Baptist Church at 11:15 a.m. Since the church is adjacent to the fire house, it was quickly controlled.

About 2:15 p.m., a call came in about a grass fire 3 miles east of Lazbuddie. Not more than two minutes later came a call of a grass fire at Clay's Corner. Units from Lazbuddie handled the first call, while Clay's Corner personnel took the second.

While this was still going on came a third call of a sileage fire about two miles north of Clay's Corner. Firemen responded again.

If the firemen felt they had already put in a day's hard work, little did they know what was to come that dark night. It started at 2 a.m. - the middle of the night.

Lazbuddie personnel were dispatched to a report of an accident about four miles east of Lazbuddie on Highway 145. They were told there were two victims, with one person trapped in the car. Lazbuddie responded with an ambulance and Jaws of Life unit.

When they arrived, they found an overturned Mustang - but no people. They searched the area and still couldn't find anyone. A Castro County sheriff's department officer (the accident was near the county line with Parmer) and Texas Highway Patrol officer Craig Hunt assisted.

A wrecker arrived to remove the vehicle. The ambufance was sent back since no victims were found. Then a vehicle drives up through the grass with its headlights off, said McDonald. A couple of firemen thought they recognized the vehicle but didn't know the driver. Hunt was alerted.

Then a fireman drove up to the scene and told Hunt that he had gotten a phone call saying that a vehicle had been stolen - and it matched the description of the vehicle that had arrived with its lights off. Hunt arrested the driver, Joseph Tackett, 36, of Tacoma, Wash., on charges of DWI and unauthorized use of a motor vehicle.

Meanwhile, the Lazbuddie personnel, plus some other local men, continued searching for a second person. A report was received of a man who went to a nearby home and asked for a ride to Hereford. When the homeowner said he couldn't do that but would call the sheriff's office to seek a ride for the man, the man left. The homeowner reported his vehicle had been vandalized.

Also, one of Lazbuddie's EMS personnel, who was returning home, spotted a man walking near the highway. She notified the other personnel through the dispatcher and an extensive search started up again.

One of the firemen spotted some tracks behind a house. The tracks were several feet apart so it was felt the person had been running. The firemen followed the tracks,

which went into a weed row. They saw some weeds moving unnaturally.

The firemen came across an old truck bed and a fireman saw a man's leg sticking out from underneath it. The man was surrounded, his legs tied and he was instructed to stay put until a Castro County deputy sheriff

could arrive. The Castro County officers who had been there earlier had left before it had been ascertained there was a second man.

The Castro County sheriff's department arrested the man, Stanley Tackett, 33, of Tacoma, Wash., on a charge of burglary of a vehicle. Hunt said the two Tacketts are brothers who are farm laborers.

Most of the Lazbuddie personnel finally got home about 5:30 a.m. On behalf of the Lazbuddie personnel, Fire Chief Nicky Nickels thanked the Texas Highway Patrol and Castro County sheriff's office for their assistance. A total of 13 Lazbuddie firemen and EMS personnel participated in the incident, plus three other local men.

It was a frightening experience for some Lazbuddie residents, since it involved one vehicle being taken and another burglarized, and strangers knocking on their doors in the middle of the night.

But the Lazbuddie Volunteer Fire Department showed the rural community it was there when needed.



As I pen this column, the baseball strike is still on. It doesn't bother me at all.

As a kid, I was a baseball fanatic, following my beloved Chicago Cubs every day of the season.

All us Cub fans ever wanted was to see was Ernie Banks in the World Series. If the Cubs ever make that step again (the last time was in 1945), Ernie - Mr. Cub - will be signed on as a coach so he can be with them on that historic day.

There was a time when I actually thought the Cubs had a decent chance to achieve this. Silly.

I was 1 year old when the Cubs were last in the World Series, but I remember reading newspaper clippings about that season. Passeau, Borowy, Leonard, Cavaretta ... ah, what a team.

Unfortunately, World War II had now ended and the other teams got their players back. End of the one-year dynasty.

Then came the dark days for the perennial seconddivision Cubs, with Ernie Banks as the only highlight. There was a chance for the team, though, in the early 1960s when they signed a kid named Lou Brock.

I used to read the "Sporting News" in those days, and it was a time when they carried stats from all the baseball minor leagues. I followed Brock when he played for St. Cloud, Minn., in the Northern League. He was batting .403 when the Cubs called him up to the majors.

But it was a time when the Cubs' owner, Phil Wrigley, tired of firing managers every year, had gone to a manager of the month program. At the first of each month, a different Cubs' coach was "in

A 90th birthday reception is planned for Beulah Wilma Stone Williams at the First Baptist Church of Farwell from 2 to 3:30 p.m. Sunday.

Mrs. Williams was born March 18, 1905, on a farm near Joshua, Texas. She was the oldest of five children. A sister, Zelpha Fowler, lives in Carnegie, Okla.; a brother, Harrison, lives in Twin Falls, Ida., and a brother, Hal Stone, lives in Clovis. Another brother, Judge, is deceased but his widow, Mae Stone, lives in Texico.

Her parents, Harley and Margaret Stone, lived in Farwell at the time of their deaths.

While she was very young, her parents moved to Oklahoma. They returned to Joshua when she was 5 and she still can remember riding in the covered wagon and stopping at night to rest and let the horses eat out of the trough at the back of the wagon.

As most children of that era did, she worked alongside her parents tending the cotton fields and gathering the cotton as well as doing household chores.

After she graduated from high school at Cleburne, Texas, the family moved to a small community near Hollis, Okla. While there, she enrolled in Oklahoma College for Women at Chickasha, and received a teaching certificate.

She married John S. Williams on July 12, 1923, at Hollis. He was a farmer living in that area. They were married for 69 1/2 years when he died on Jan. 28, 1992. He was 93 years old.

While living in Oklahoma, they had two children, Flora Lee and Bert. The family moved to the West Camp area south of Farwell in 1930. Johnny's brother, Willie, and his family, and his sister, Grace Snider, and her family, all moved about the same time to three sections of adjoining land in West Camp.

A daughter, Jo Ann, was born while they lived here.

Mrs. Williams was busy during those years raising her family. She had a garden and canned food. She was very involved in the home demonstration club work under the Bailey County Agriculture Extension Office. The women's agent directed them in new methods of preserving food, sewing, and other things of interest to homemakers.

She once entered a dress in a sewing contest for women in the home demonstration clubs. She was a countywide and district winner and advanced to the state competition, where she won a new Singer sewing machine.

She sewed for her daughters and herself. After her girls enrolled at Texas Tech, she sewed for them hours every day to get them ready for school in the fall. They were the envy of their friends. She can still be seen wearing suits she has made when she attends services at the First Baptist Church of Farwell. She is a charter member of the church and was a teacher for a women's class for many years.

Mrs. Williams was a substitute teacher at West Camp. After the children left home, she and her husband moved to Farwell. During that time, Farwell Schools were segregated and some African-Americans moved into the area. Mrs. Williams was allowed to teach them in a separate building from the school. She found this a very fulfilling experience.

City Marshal Gil Holguin announced after Tuesday's City Council meeting that he will begin issuing removal notices for vehicles that violate the city ordinance.

Other cleanup problems discussed were:

- Junked vehicles in the 500 block of North Garwood.

- Junk on the Moore property at the north end of KKR Park. Councilman Oran Jay Autrey said he was told this property was outside the city limits. City Attorney Marion Ty Rutter will check on it.

- Heard Holguin report on some property owners, who have already been cited for violations in court, are working on cleanup.

In other business, the council:

- Will have the vents in the community building checked to see if the heaters need replacing.

- Said a rabies clinic will be held from 3 to 5 p.m. in the community building on April 5. Dr. Glen Keim will be here. Animal owners also can get city tags, costing \$3, at this time for their pets.

 Approved the annual participation in the regional drug task force. The fee is up about \$100.

- Gave Holguin the go-ahead to buy some equipment for the third city police officer who will be hired under the federal grant program. Holguin explained that it will take some time to get some of the equipment, such as gun, pager, badge, etc.

The Chief's Corner

by Farwell Police Chief Roy McGaa

Too often, parents have informed me that they can't discipline their children by spanking because they would go to jail.

There is a difference between spanking and child abuse and the State of Texas recognizes that difference. Children lack the knowledge and experience of adults; one of the ways they find out about life is to test the limits. If a parent is unable to set the limits and enforce the limits, there is likely to be grief ahead.

Texas Family Code: Chapter 12 - the parent-child relationship. Sec. 12.04 Except as otherwise provided by judicial order or by an affidavit of relinquishment of parental rights executed under Section 15.03 of this code, the parent of a child has the following rights, privileges, duties and powers:

(1) the right to have physical possession, to direct the moral and religious training, and to establish the legal domicile of the child; (2) the duty to care, control, protection, and reasonable discipline of the child; (5) the right to services and earnings of the child; (10) any other right, privilege, duty or power existing between a parent and child by virtue of law.

Texas Penal Code: Subchapter F. Special Relationships Sec. 9.61 parent-child: (a) the use of force, but not deadly force, against a child younger than 18 years is justified; (1) if the actor is the child's parent or step-parent or is acting in loco parentis to the child; and (2) when and to the degree the actor reasonably believes the force is necessary to discipline the child or to safeguard or promote his welfare. (b) for purposes of this section, "in loco parentis" includes grandparent and guardian, any person acting by, though or under the direction of a court with jurisdiction over the child, and anyone who has express or implied consent of the parent or parents.

The Farwell Police Department will do everything possible to arrest a child abuser. It is also realized that children do threaten parents, attempting to impose discipline, by saying they will call a Child Protective Agency. As this can cause untold problems for parents, the police department, upon request by the parents, will witness punishment.

WTRT Cooperative plans annual meeting

Election of directors for the Tharp, Milo Center and Westway exchanges and voting on a major revision of the by-laws will highlight the 41st annual meeting of the West Texas Rural Telephone Cooperative March 21 at the Hereford Bull Barn.

Registration and serving of a barbeque beef and sausage dinner starts at 6 p.m. The business session starts at 7 p.m. "The Texas Country" will provide music for the third straight year. Door prizes valued at over \$1,000 will be drawn.

According to co-op officials, amending the by-laws will update and clarify them, simplify accounting, eliminate membership fees and retain unclaimed patronage capital credit funds for local benefit.

In the past, when the cooperative was unable to forward capital credit checks to their rightful owners within three years due to lack of a current address, those funds reverted to the state. The proposed amendment would allow these unclaimed funds to be considered a gift to the co-op and put into a scholarship fund to assist students within the WTRT service area.

Amending the by-laws also would clarify procedures for dealing with certain taxable patronage funds.

Another proposal would eliminate the required \$10 membership fee and issuing of membership certificates. All membership fees currently being held by the co-op would be refunded. Officials said the co-op's financial position is strong enough to eliminate the need for the membership fees and the change would substantially reduce paperwork.

The requirement that two candidates be named by the nominating committee for board posts would be eliminated under a proposed amendment. The nominating committee

Wolverines post state quarter-final win

It was a real nail-biter Wednesday as the Texico Wolverines broke a jinx and won their quarter-final Class AA basketball game in Albuquerque over the Navajo Pine Warriors, 63-59.

The past three times Texico had gotten to state, they had lost in the first round. Not this time.

Texico, 21-6, was scheduled to play Tularosa, 23-4, Thursday morning. Navajo Pine finished with 22-4.

It was a classic case of a team effort overcoming one great player. Navajo Pine had a 6'4 center who scored 34 of his team's 59 points before fouling out with 3 minutes left.

Scoring for Texico were: Pat Chumley, 12; Tyrone Gooden, 17; Nathan Ketterling, 8; Bobby Russell, 6; Ruben Escamilla, 5; Johnny Salinas, 11; Clyde Jenkins, 4.

The game opened with the teams trading baskets. But Navajo Pine jumped from an 11-11 tie to a 19-13 lead at the end of the first quarter.

Texico earns tourney spot

The Texico Wolverines earned a spot in the state tournament by defeating the Santa Rosa Lions, 93-87, last Friday in the regional semi-finals at Texico.

Santa Rosa was ranked No. 2 in the state and the loss was a shock for the Lions' fans.

It was a game of ebb and flo as both teams went on scoring runs. But a key to the victory was the hot shooting of Tyrone Gooden in the second quarter when it appeared that Santa Rosa would blow the game wide open.

The Lions were led by an outstanding guard, Larry Chavez, who scored 32 points, including 5 3-point tries. He had 21 of those points in the first half.

But Gooden came through with 16 points in the second quarter alone, including a trio of 3-pointers to keep pace.

Scoring for the Wolverines were Gooden, 28; Pat Chumley, 9; Ruben Escamilla, 16; Nathan Ketterling, 19; Clyde Jenkins, 4; Bobby Russell, 5; Johnny Salinas, 12. Chumley and Salinas both scored all their points in the second half.

The Texico gym was packed and rocking at tip-off. Ketterling scored 3 of Texico's first four baskets on baseline drives. A pair of Escamilla free throws put Texico into the lead for the first time at 10-9.

But Santa Rose battled back, taking an 18-15 lead on a Chavez 3 pointer. The Lions were winning the rebound battle as they led 25-19 at the end of the first quarter.

The Lions increased their lead to 28-19 when Gooden began sparking the Wolverines. Gooden scored six of Texico's next 7 baskets to keep his team in the game. At the end of his run, Santa Rosa only led 41-35.

Then the rest of Texico's team began sinking buckets and the gap closed. A 3 pointer by Russell put Texico back in front, 43-42. And Texico went into halftime, ahead 50-47.

Santa Rosa was exhibiting excellent shooting, especially from long range. And both teams played tenacious defense.

At the start of the third quarter, both teams traded baskets and it was tied 55-all halfway through it. Santa Rosa crept ahead again, leading 65-60 Then Texico took over, going on an 10-2 run to move ahead 70-67 at the start of the final stanza.

Baskets by Ketterling and Escamilla boosted the Wolverine lead to 76-67. Now it was time for the Lions to go on a run, as they closed the gap to 79-76. But a pair of baskets by Ketterling kept Texico ahead.

Navajo Pine increased its lead to 9 points, 27-18, midway through the second quarter before Texico fought back. Baskets by Gooden, Salinas and Escamilla helped narrow the

The third quarter was a different story, as Texico won this period, 17-10, to close the gap. But Mora went into an effective stall with 2 1/2 minutes left in the quarter and led 44-32 going into the final period.

Texico continued to come on strong in the final period. Fast-break layups by Gooden and Ketterling reduced the deficit to 8. Then with just over three minutes left a shot by Russell cut it to 6 points. But Mora went into its stall again. Mora scored 6 of its last 8 points on free throws when Texico was forced to foul. gap and Texico went into halftime trailing, 30-27.



Santa Rosa continued fouling but Texico began hitting its free throws, as the lead was upped to 89-81. Finally, with only 29 seconds left, Santa Rosa made a basket, making it 89-83.

Texico hit four more free throws to move up by 10 points. In the final 7 seconds, Santa Rosa scored 4 points to close the final margin to 6.
