Two weeks ago, I had asked concerned folks to contact government officials about the worsening drug problem. But Williams said no one had called him.


Thus, I assume folks are not concerned about the topic and prefer the status quo; so this will be the last I write about drugs for awhile.


Any merchant who hasn't been contacted but wishes to participate should call BTD Chairman Mike Pomper at 481-3681 immediately.

Also on July 4, Shannon Hallmark, 25, of Albuquerque, was charged with aggravated DWI, speeding, and evading a police officer.



Bryan Goldsmith was hired to coach junior high girls basketball and varsity assistant and football assistant.


Jacob Thompson was hired to coach junior high boys football, basketball, and track and varsity football assistant.

--Accepted a bid from Security State Bank for depository contracts for the next two years.





Ray Autrey protests new ordinance; will be discussed again

After hearing a protest from Ray Autrey about newly passed Ordinance 284, the Texico City Council voted Tuesday to rediscuss it and possibly make changes.

Autrey asked that the ordinance be rescinded. He pointed out three rules that he felt should be eliminated that dealt with fences: that permits not be needed, thus saving the resident money; that new material not be mandated, again due to higher costs and also the fact that some used material would suffice when a fence needs repair; and that the 1 1/2-ft. setbacks not be required.

Autrey talked of having residents sign a petition opposing the new ordinance.

Responding to Autrey's criticisms, Mayor Nathan Tharp said the ordinance allows residents to seek variances from the council. And the indication was that if the requests made sense, the council would approve them.

Tharp said the council has had problems with fencing in Texico that has caused it to make the changes. Again, he stressed the appeal process.

Discussing zoning problems, he noted that there are still eight mobile homes that were moved into the community that haven't been brought up to asthetic review standards despite the fact that the homeowners promised to do so.

Tharp urged the council not to return to the old ordinances due to many problems and the lack of their.enforcement ability. But some of the councilmen were unaware of some of the language in the new ordinance and decided to bring it back for discussion at its next meeting.

In other business, the council:

-- Discussed plans for the new city hall complex to be built adjacent to the new community center. Councilman Oran Jay Autrey is working on this with engineer Bob Lydick.

-- Heard city marshal Gil Holguin report that 56 calls were received in June. Accident reports were up (5) and there were 8 arrests.

-- Changed the date for its next meeting to July 17. The meeting will begin 30 minutes early with a public hearing on the Infrastructure Capital Improvement Plan.

-- Approved the annual joint powers agreement with Clovis on housing prisoners there.

-- Named new councilman Dean Henninger as the EPCOG

representative.

-- Heard city attorney Marion Ty Rutter report that West Hereford Street was never dedicated to the city and isn't the city's responsibility although it's inside the city limits. Property owners along the street will be talked with about dedicating it to the city so the city can repair it.

-- Is seeking an animal control officer.

-- Received no bids for the city's used pickup. It was advertised in the Clovis paper, but not the Tribune.

-- Received two bids from Clovis firms (one was accepted) for the janitorial work at the community center. It was advertised in the Clovis paper, but not the Tribune. Oran Jay Autrey said he doubted anyone locally was licensed to do this work.

-- Accepted a bid from Valley Mower for \$6,200 for a mower.

ALTER YOUR LIFE

Amendment must be made by every responsible being. Some alteration must take place. "Except ye turn (be converted)...ye shall in no wise enter into the kingdom of heaven" (Matt 18:3). The Pentecostians. Acts 2. Peter and the eleven preached. The audience was made up of people from 17 nations. The gospel message was communicated. Faith caused the outcry, "What shall we do?" They were advised to repent and be baptized. 3000 obeyed. (vv14-41).

Simon. Acts 8. Philip preached. Simon and others came under the influence of the gospel. They believed and obeyed (vv 12,13).

The Eunuch. Acts 8. Philip preached Jesus. The eunuch heard the story of Christ. He believed and obeyed (vv 35-40).

Saul. Acts 9. The teacher was Ananias; the good news of Christ was presented. Saul believed and was baptized (vv 10-19).

Cornelius. Acts 10. Peter was the preacher. Cornelius, his kinsmen and friends heard; faith and obedience followed (vv 34-48). Lydia. Acts 16. Paul preached. Lydia heard the gospel.

She believed and was baptized, she and her household (vv14,15).

The Jailor. Acts 16. Paul and Silas preached. Jailor was told to "believe on the Lord." He and family obeyed (vv30-34).

The Corinthians. Acts 13. Paul preached. "Many of the Corinthians hearing, believed and were baptized" (v8).
