## **Farwell Schools** want your view on laying a new track

The Farwell School Board wants the public's views on whether to put in a new track at the football stadium.

Board members ask that folks give them their feelings before the next meeting. Or they are invited to an open forum at 6:45 p.m. on April 12 at the school administration office, just before the regular meeting commences.

There are several pluses to having a better track, with one negative.

The negative is the cost.

School Supt. Larry Gregory estimates that if the board hires a contractor to do the whole job, from start to finish, it would be more than \$200,000.

But he said that if school personnel do the prep work and some of the subcontracting themselves, the cost could be lowered to about \$125,000.

Gregory will be advertising for project bids to get a closer idea as to the cost before the board makes a decision.

As for the pluses:

Students would have a better facility for track and field events.

Currently, the track is mostly dirt with some cinders. Originally, it was built as a cinder track. A new 7-lane track would feature an all-weather surface (acrylic latex) which would enhance the track program.

The old track, which doesn't have lanes marked, would be converted from 440 yards to the 400 meters that are in use throughout Texas now. Track meet races, for example, are in meters -- 100, 400, 800, 1600 and 3200.

Also, areas would be built for high jump and triple jump events. The school already has a pole vault pit. The runway for pole vaulting would convert from concrete to the all-weather surface.

Another plus, Gregory said, for a new track is that the community also uses it, and it would be an imp for them, too.

Farwell approves band trip to San Antonio

The Farwell School Board on March 15 approved the band trip to San Antonio.

Several Band Booster members and band director Bill Shelly attended the meeting to support the trip.

In other business, the board:

-- Accepted a bid from BAC, of Roswell, N.M., for high school gym roof repairs.

-- Accepted a bid from Richard Bermea Construction for repairs to the high school - junior high parking lots.

-- Approved the annual resolution to tax vehicles.

-- Tabled a request from Jay Bowers Construction to pay \$100 to the school for 50 feet of lots 29-32 (100 block of Avenue A) where he is building a tire store.

Value on the property on the tax roll is \$1,920. This request also has been tabled by the Farwell City Council after the Parmer County Commissioners tabled it because they felt Bowers was not offering enough money.

-- Heard School Supt. Larry Gregory report on preliminary results for the reading part of the TAAKS test for 3rd and 5th graders.

These results are given to schools early because it is necessary for these pupils to pass this test before they can advance to the next grade.

100 percent of the 3rd graders passed the test, with 21 of the 31 pupils receiving "commended" honors, which show they did excellently on the tests.

87 percent of the 5th graders passed the test. Those who didn't (four pupils) get two more opportunities to pass it, and Gregory, who doubles as Farwell Elementary School principal, said he believed all four will.

State averages for the reading part of TAAKS are: 3rd grade, passing, 89 percent; and 5th grade, passing, 75 percent.

-- Discussed whether to put in a new track. Gregory will seek bids to get an idea of what the cost might be. No decision was made on whether to build a track (see story elsewhere in today's paper) until the board gets more input from citizens.



## JESUS IS RISEN FROM THE DEAD

## **Grave in the Garden Reported Empty**

### Man of Galilee **Influenced Many**

Last Friday Jesus of Nazareth was put to death by crucifixion. Today the population of this capitol city was rocked by the startling news that he is alive! Who is this man who has made such an impact on the whole city and country?

Born in the city of Bethlehem about 33 years ago, Jesus spent most of his childhood and youth in Nazareth. He lived with his parents, Joseph and Mary, attending the regular Jewish schools and assisting his father in the carpenter shop.

It is reported that the popular preacher had an intense interest in people. On one of his trips to Jerusalem ten men afflicted with leprosy came to him for help. He directed them to report to the priests for inspection. It was on their way to the temple that they were healed.

Certainly a person who can heal a disease such as leprosy would be considered a desirable member of society.

Early yesterday morning several women set out dead, and He will meet you in Gaillee." for Joseph's garden to complete the task of annointing Christ's body. They kept asking each other, "Who shall roll away the stone from the door of the sepulchre?"

When they came to the grave they saw that the stone was rolled away. They could harly believe their eyes, for on the stone was a most unusual person. He was dressed in a pure white garment and his face was as brilliant as lightning

It is reported that this was an angel and that he told the women, "Fear not, for I know that you seek Jesus who was crucified. He is not here; for He is risen as He said. Come see the place where you and the others put His body. Now go quickly and tell His disciples that He is risen from the

The women left the grave and as they returned to the city they were met by the risen Jesus whom they immediately recognized. Another follower of Jesus, Mary Magdalene

also came to the grave early yesterday. Mary remained at the grave and was very dejected over the absence of Christ's body. To her utter surprise, this man was none other than the risen Christ who identified Himself by calling her by her name. Last evening, Jesus appeared to ten of his

Last Words Of **Jesus Unusual** 

> The death of Jesus of Nazareth was unlike any other death. Even the words of this dying man were extraordinary.

After Jesus was nailed to the cross and the cross was placed in an upright position, He prayed for pardon and forgiveness for His enemies. A Roman soldier remarked, "Usually we are cursed to death in hell."

A conversation took place between Jesus on the center cross and the thief who was crucified on His right. The thief apparently recognized in Jesus more than criminal traits as he asked to be remembered by Him in His kingdom. The thief received the answer, ''Today you shall be with Me in paradise."

### Centurion **Testifies**

The centurion, who was in charge of the crucifixion of Jesus of Nazareth and responsible for preserving law and order, gave what may be considered the most eloquent testimony of all in regard to the person who was crucified on Calvary's hill.

He had been a silent witness to all that happened. When questioned soon after the events of Friday, he spoke with conviction. He stated that there had been a great miscarriage of justice, since the words and actions of the man crucified were not those of a man guilty of crime.

When asked who he thought the crucified man was, he replied, "To the best of my knowledge, He was, as He Himself said, the Son of God." That this sort of testimony should come from a man trained in the rigors and discipline of the Roman army is indeed surprising. It is proof that the death of Jesus of Nazareth has had an impact on all with whom He came in contact. crazed rebel and murderer back in circulation. To his distress the leaders persuaded the crowd to ask for Barabbas' freedom and Jesus' death.

Sensing that the crowd would be satisfied with nothing less than blood, the judge compromised justice and ordered the innocent prisoner scourged. Dripping with blood, disheveled and thorn-crowned, Jesus was presented to the crowd as Pilate announced: "Behold, I bring him forth unto you that you may know that I find no fault in him. Behold the Man." Again the crowd would not be pacified. The Governor finally reconciled himself to the fact that neither compromise nor reason would satisfy the mob.

It was then that the opposition took command calling out: "If you release this man, you are not the emperor's friend." Was this a veiled threat? Would Pilate's past misdeeds be reported to Caesar? Reluctantly but deliberately, he washed his hands before the mob, saying: "I am innocen of the blood of this just Person; see to it yourselves." Reluctantly he signed the death warrant for Jesus of Nazareth. Justice finally had been trampled into the dust. Pilate had sold out to the opposition.

This raises some interesting questions: Will Rome condone such action in its courts? Can Pilate continue as Governor? What, in fact, does the future hold for Pilate? Time alone will tell.

A few minutes before His death he shouted, 'It is finished!" That appeared to be a shout of victory. Was it a victory just to die? Or was there some other victory or accomplishment He gained through this suffering and death?

At this time analysts are trying to piece together these words of Jesus of Nazareth to determine what meaning they carry. The question being asked is, "Was Jesus giving His life in place of others rather than dying for any crimes He had committed?'







### *Rev. Randy Gregory remembered*

This information came from the Gurnee, III., newspaper involving the recent death of Farwell High grad Randy Gregory:

He wasn't a pulpitpounding preacher. He was gentle, thoughtful. A family man who left the corporate world in his native Texas and answered a calling to teach the laws of God for the church to which he and his wife devoted much of their adult lives.

So those who knew Randy Gregory can't understand why anyone would want to kill the Gurnee man and his family as he spoke in characteristic quiet tones during his weekly sermonette in front of his congregation in a Milwaukee suburb.

But police said that's exactly what Terry Ratzmann did: target Gregory and his son.

It's possible no one will ever know precisely why Ratzmann, a 44-year-old computer technician who lived with his mother and sister two miles away, for answers.

"Obviously, we're asking God, 'How on earth can this happen?' " said J.D. Crockett, director of business for the Charlotte, N.C.-based church of some 7,000 members, and a friend of the Gregory's. "He certainly didn't cause this, but He allowed it to happen. We're trying to wrap our minds around that."

Police said they think Ratzmann targeted Gregory and his son specifically but chose other targets at random.

Randy and Marjean Gregory both attended Ambassador University in Big Sandy, Texas, in the 1970s. The liberal arts college was affiliated with parent-church Worldwide Church of God until 1993, when it closed.

Years later, after Randy Gregory had settled into a successful career with IBM, the church invited him to minister fulltime.

Gregory took a pay cut and moved the family to Gurnee. He chose Lake County so he could run the "circuit" of services between southern Wisconsin and Peoria sometimes on the same day, church officials said.

And when it came to disagreement and conflict, Randy Gregory was a peacemaker, Crockett said.

Gregory ran a church summer camp in Missouri, teaching pre-teen boys the fine arts of canoeing and archery as well as biblical lessons. smile could handle it. "And that's why all this is so tragic."





By now, you should have received a picture with a short note from my sister, Valarie Henneman, to be included in the 100th Anniversary Edition of the Tribune.

Squeezing six lives into 15 inches of news space took quite a struggle, but many of the "old-timers" will remember us, as the Dial Family was a fixture of Farwell for 25 years. All four of the children graduated from FHS, and all four played on the high school basketball teams. The two boys also played football and were involved in the track program. Ronny and Benjy both graduated from ENMU, and I attended there one year.

My mother, Clytie Dial, was the Candy-Lady for several years. Our house was right across the street from the school, and we inherited a "candy store" when we bought the house. All the kids could come across the street to buy school supplies, snacks, candy and sodas. She opened the store before school, during lunch hour and after school. Later, the "store" was actually moved into the basement of the old high school and she ran it there.

Murray died in 1955 at age 45. Six months later, the house burned to the ground. There was an outpouring of generosity in the community, and the townspeople collected \$1,500 to help Clytie get back on her feet.

She built the Dial Dairy Drive-In (3-D) and ran that for awhile. She was an office nurse for Dr. Green and maybe others before she bought Ruby's dry goods store in Texico and renamed it Dial's Variety. She worked at nights and by correspondence on a nursing degree, and had to move to Amarillo for the last year of schooling. She became a Registered Nurse at age 59. Quite an accomplishment, I think.

In 1977, when my older brother Ronny passed away suddenly at age 43, he was brought back from North Carolina to Farwell for the funeral, which was held at the First Baptist Church. The Dial's were charter members of that church when it was first established. The church women provided a wonderful meal for the family, even though the last "Dial" had moved away in 1971. You just can't beat the good folks that live in Farwell.

My younger brother, Benjy, won all sorts of awards for sports at Farwell and at ENMU. He was drafted by Pittsburgh for the pros when he graduated from ENMU in 1966. He played in the NFL for four years, then in Canadian professional football for two more years. He later became a very successful high school football coach, and was the coach and athletic director at DeSoto, Texas, when he passed away at age 58.

Valarie married a Farwell graduate, A.C. Henneman, in 1950. After four years in the Air Force, they moved to Amarillo and have lived there ever since. At present, they have a bookkeeping service that they operate out of their home.

I am the nomad of the family, having married a football coach myself. I met Tommy Hightower in college. He



coached in Farmington, N.M., Los Alamos, N.M., and was the head football coach at Western New Mexico University in Silver City when he decided to change professions.

When he entered the insurance business, he ran up the corporate ladder quite quickly, and we moved from Silver City to Wichita Falls to Norman, Okla., to Albuquerque within three years. In 1979, we opened a retail floor covering business which was very successful. We sold the business in 1996 and retired, splitting our time between Albuquerque and Sun City West, Ariz.

With all this time on my hands, I decided to become a writer, and have self-published my first one, a murder mystery. I have almost sold out the first printing of 533 books, and am now looking for an agent or publisher.




Their evening ended with a "Fantasmic" fireworks and laser show around the lake at MGM.

### Anne Corn recalls her family's experiences in World War II

On March 8, students in Mrs. Burch's English III classes were treated to an interesting presentation from former Bovina and Farwell teacher Anne Corn.

The students viewed slides of modern-day Germany while Mrs. Corn described the country, past and present. She told the students about her childhood in Germany and of her family's experiences during World War II under Adolf Hitler.

She told the students that they must appreciate their freedom of speech in the U.S. and explained that because the German people did not have such freedom, they were afraid to speak against the Nazi government.

When the students questioned Mrs. Corn about the concentration camps, she said most German people were not aware of them during that time. She added that many non-Jewish people were also sent to the camps.

Mrs. Corn's family owned a store in Germany and had enough food to eat, but she said that most of the people were on a starvation diet, especially as the war progressed. She also said that her small town was bombed, and members of a family next door were killed.

Mrs. Corn met her husband after the end of the war. He was one of the soldiers stationed in Germany during the American occupation there. Because she had learned English in school, she became a translator for the Americans.

The students were surprised by some of Mrs. Corn's descriptions of Germany and of the German people. They were excited when she graciously spoke a few German phrases for them.

Her presentation showed the students a different side of her native Germany and a very interesting aspect of history, of government, and of people who are so much the same in all countries.

2. child's up-to-date immunization.


3. child's Social Security number.
