# Wind energy: The future?

Over my lifetime I can't tell you how many times I have complained, and heard others complain, about the wind in West Texas. Not anymore!

Who would have ever thought there would be such a stir from companies wanting to be the first in line to develop and turn our wind into a major resource for energy?

Well it's coming, and we need to understand what it is all about. The first step is the building of new transmission lines into the Panhandle so that electricity can be transported to

where demand.

The Feb. 16, 2007, issue of the Lubbock Avalanche Journal carried an important article that is very meaningful.

The article said that "companies nationwide filed proposals Thursday with the Public Utilities Commission of Texas (PUCT) proposing the best spots to harness windbased electricity for Texans and to develop new transmission capabili-

"Every major construction company in the nation will be bidding on this," said one company officer. The newspaper went on

supply is in to say that the plans. including one proposing \$10 billion in regional investment, await the selection of Competitive Renewable Energy Zones numbered blobs on a map of Texas that represent areas rich with wind or other renewable energy potential.

"The most lucrative of those zones cover areas far from lines that can carry their energy to the rest of Texas. The process could clear two Panhandle hurdles with one strong gust: allowing wind energy to be exported and importing the state's electricity infrastructure ... linking zones over Amarillo and Bailey County ... could add 4,200 megawatts of


Our young musicians will compete May 28 at San Marcos for the state solo and ensemble contest.

new wind energy, enough for roughly 1 million homes, as well as two new gas-powered plants in Hockley and Yoakum counties and improvements to a coal plant in

Along these lines, Sharyland Utilities announced last week it has filed a proposal with the PUCT to build an 800-mile electric transmission loop throughout the Texas Panhandle.

If this is followed through on, it means the ERCOT grid system would be brought into the Texas Panhandle and the entire state could enjoy the wind resources located here, plus substantial gas and coal resources, said a Sharyland official. If approved by the PUCT, Sharyland has a project completion goal of 2010.

Once the Panhandle loop is in place, wind farm developers and other energy industries will likely follow to develop areas where the wind can support commercial grade turbines.

Here is why wind power is so sought-after: This combination of wind, coal, and gas generation ensures that a greater amount of electric power is constantly flowing along the power lines, thus resulting in a more efficient and cost-effective transmission system.

I became interested in the wind farm industry several years ago while visiting down in central Texas where I met a gentleman from California who was working on several wind farm projects with General Electric. He was blown away, no pun intended, by the lack of pursuit in developing the wind in Texas.

After several phone calls and e-mail exchanges, he encouraged me to develop a company that would support and promote wind farming in the Texas Panhandle. A year later, I formed Premium Wind Coalition (PWC), a subsidiary of XIT Options, Inc.

PWC is made up of area landowners who have made available their land to be considered for potential wind farm development. It provides the service to promote and contact potential wind farm developers to our area. Right now, PWC offers land in Texas, New Mexico and Colorado. There is no fee to landowners to join PWC. We prefer to have landowners who have 1,500 to 3,000 acres; however everyone is welcome to join our coali-

The potential for the long-stranded wind power of the Panhandle is big. The potential for individual landowner, cities and counties to share in future revenues generated by renewable clean energy wind farms is good for future economic growth in our region.





• Must have exactly two letters of recommendation



LIVE CATTLE: Cash trade was another disappointment this week with cash prices trading between \$90.00-91.50 which was a couple of dollars less than expected. Futures prices have held steady for the week in anticipation of higher cash prices. Technically, the market has been top heavy for the last couple of weeks and is still expected to see some type of decline into late April.

FEEDER CATTLE: Prices softened late this week after corn prices moved sharply higher on Friday. The market is trading at levels which have made it almost impossible for cattle feeders to project anything other than losses. Higher corn prices are probably going to keep some pressure on the market, but at this time, feeder prices are trading between \$5-10 higher than can be projected to break-even taking into consideration the price of feed.

CORN: The market closes at the highest levels in over to years last Friday. Although the nearby contracts were only able to make it back to contract highs, the December o7 into the o8 contracts all made new closing contract highs on Friday. The market is still expected to continue to trend higher into the March 31st Planting Intention's

SOYBEANS: Over the last couple of weeks, soybeans prices continue to trade into new contract highs almost on a daily basis. The continued strength in soybeans is a direct result of holding acres. Corn and beans are likely to continue their fight up into the very last day before planting? South American harvest pressure has had absolutely no impact on bean prices this year.

WHEAT: The July KC Wheat contract close at \$5.08 on Friday which was the strongest close seen in over a month. Higher prices across the grain complex has helped to support higher wheat prices as well. There remains strong resistance between \$5.10-5.20 which may hold the market down, but a break above these levels would then project up towards the \$5.65 area? We'll see?

COTTON: Long term trends turned down a couple of weeks ago and the market has continued to drift lower. With the absence of any positive news to support prices, traders have reluctant to hold long positions. Cotton will not fight for acres as we move into planting which may be supportive out into next year. Supplies remain large and demand remains weak.



## Overpass project appears dead

The Farwell City Council met on Tuesday with top officials of the Texas Department of Highways and Transportation (TxDot), plus the mayor and city councilmen from Texico, to discuss the status of the overpass project.

Due to increased railroad traffic at the state line, more folks have been asking about what can be done.

After the discussion, what came across is "nothing." It appears the status quo will stay in effect. Here's why:

## Coach Parr resigns

The Farwell School Board on Tuesday received the resignation of girls' varsity basketball coach Brent Parr.

This was Parr's first year teaching and coaching at Farwell.

He may move back to the Lubbock area, where he has an ill father.

In other business, the board:

- -- Re-hired the three campus principals (Gary Cates, elementary; Jimmie Mace, junior high, and Mike Read, high school), counselor Hayley Christian an athletic director Mark Anglin.
- -- Approved the school calendar for 2007-2008. It includes major changes from previous years due to state legislation mandating a later starting date. Here are some of the changes forced on Farwell:
- 1. School for students starts Aug. 28, and ends on May 30.
- 2. Labor Day Monday will no longer be a day off.
- 3. The Thanksgiving holiday was reduced from three to two days (the Wednesday preceding Thanksgiving will now be a school day).
- 4. The "ski break" in February has been eliminated.
- 5. Easter will be combined with the spring break.
- 6. The first semester will only have 85 days while the second semester will have 102 days. This allows the first semester to end at

the Christmas break.
School officials are

Why did the state want a later starting school date? Due to pressure from amusement firms and other businesses employing youths over the summer, among other reasons.

- -- Approved a band trip to Denver June 4-7. This is a reward trip that Band Director Bill Shelly wanted his students to have in recognition of their successes and long hours of preparation during the school year.
- -- Called for the school board election to be May 12. Two posts are on the ballot. Incumbents are Sam Billingsley and Kendall Devault.
- -- Named Linda Moss as election judge.
- -- Extended the depository contract with Security State Bank to 2009.
- -- Heard Supt. Larry Gregory report that the locks at the high school and junior high were changed over Christmas break.

1. If the overpass were to be put in over the highway, it would take up about one-quarter mile in both Texico and Farwell. Plus a frontage road would have

to be put in.

This means that some businesses, such as Tire Country and Gallery Fifteen in Farwell, and Town & Country food store in Texico, would be severely affected. And officials of both Farwell and Texico don't want to see that.

- 2. It would be difficult to build an overpass south of the highway because of railroad inter-changes, said TxDot officials.
- 3. Building an overpass north of the highway is a problem because to put in access to the Amarillo highway is difficult because the railroad tracks are so closely parallel to that highway.

4. Building an overpass outside of Farwell would have a disastrous impact on some Texico and Farwell businesses. And such a project would have a very high cost, going as far north as halfway to Bovina for re-routing. Farwell officials would fight such a project.

Speaking for TxDot was Steve Warren, transportation planning and development director for TxDot.

He noted that New Mexico has not been receptive to joining with Texas on an overpass project. If such a project were to start, the first step would be for both governors to sign an inter-state pact. Texas will not move ahead with a project unless New Mexico sends

positive words.

Warren noted that an overpass would have "a serious impact on both towns."

The Burlington Northern Santa Fe Railroad is talking of "triple tracking", thus adding more traffic to the route that goes through the Twin Cities.

One other suggestion was made:

-- Could the railroad build a tunnel and go under the highway? Warren said it's highly doubtful the BNSF would pay for it, and TxDot is not allowed to help pay for this cost.

Other comments included:

-- Texico councilman Oran Jay Autrey said an overpass through Texico-Farwell would have a devastating effect on Texico. Autrey also pointed out the traffic jams on Texico and Farwell north-south streets going into the highway. Highway officials would need 200-feet of right-of-way.


- -- Texico councilwoman Monnie Cunningham said Town & Country officials have said that if T&C ended up on a frontage road, it would close down.
- -- Texico Fire Chief Lewis Cooper said New Mexico has a 20-year construction plan, set up two years ago. It has no funds for an overpass.
- -- Warren said that if an overpass project went ahead, by law, Farwell would be responsible to pay 10 percent of the right-of-way purchase. And if the project were to be in the county, then Parmer County would assume that

cost

- -- Warren ended the meeting by saying that highway officials would develop sketches of proposed plans and send them to Farwell, but he stressed it was very preliminary.
- In other business, the Farwell Council:
- -- Heard Burton report on a man who was bit by a pit bull on Feb. 17. The man was visiting someone when the dog attacked him in the doorway.
- -- Heard Burton say he had issued 49 citations so far this month. Burton also said he was planning to move to Farwell from Lazbuddie.
- -- Approved buying a backhoe.
- -- Agreed to share the cost (with the Farwell Chamber of Commerce) of a full page ad in the State Line Tribune's 100th anniversary issue for Parmer County.
- -- Approved building permits for J.T. Stanton, 101 Ave. B, storage building; and Ricky Coleman, 606 4th St., shop building.
- -- Agreed to allow the First Baptist Church have three gravel pads for RV parking on its property. The religious mission is aimed at retirees who travel.

Stipulations are that there will be a 3-night maximum (a month), and not allowed using a generator at night. There will be no utility hookups.

-- Will interview four applicants on March 6 for the city clerk's post. Cynthia Trower will retire this summer.

-- Named Larry Hodnett as the new city judge (this was reported in last week's Tribune). Hodnett needs to attend a certifying class within 12 months. But he is allowed to start his new duties immediately after being sworn in by Mayor Stan Miller.

This also means that Hodnett is ineligible to run for council while serving as city judge.

-- Was briefed by City Manager Ernest Terry on the water and sewer project. The city may receive its permit to start construction by June. The contract with OJD Engineering for this project was accepted by the coun-

-- Heard a presentation by Fire Chief Cesar Marquez. He said he is seeking a grant for \$12,000 worth of

bunker gear (the heavy suits firemen wear). Such suits cost about \$1,000 apiece. If approved, the city would have to pay 30 percent of this cost.

Also, Marquez said the department needs a truck to haul the grass fire-fighting rig it has received.

Terry will look at the city's budget to determine if funds are available for these requests in the current fiscal year or the next.

-- Approved fighting the Atmos Energy cost hike by joining a group of area cities. There are two such groups that have been formed. Terry will check into them before picking one -- or getting the two to join forces.

-- Named Lisa Villarreal to the Bovina Housing Authority board. She is a tenant there. Authority rules stipulate that a tenant needs to serve on the board.

-- Approved the Xcel Energy franchise fee.

-- Reimbursed the city of Midland \$453 as Bovina's share in fighting the past Atmos Energy GRIP hike. Midland served as the collection point for the cities involved in this fight.

-- Okayed the interlocal agreement with Texas Municipal League intergovernmental employee benefits pool. This is for city employees.

-- Set the next council meeting for March 13.






