Live and learn

I had a really unusual experience occur last week that I wanted to share with you.

This column will only be of interest to you if you hold a major credit card, since it involves a problem I had with a major company.

As you know, I attended my daughter Patty's wedding a couple of weeks back. So I used my credit card for some of the expenses - hotel, church, restaurants, etc. I kept a mental count and knew I was only at about 60 percent of my credit line so I wasn't worried.

Thus, it came as a surprise when a company called me about a \$60 tab - saying the credit card company had declined to approve the expense.

So I called the credit card company and found out something most interesting.

When you pay with your credit card, the merchant normally runs it through a machine to ascertain its acceptance. Sometimes the merchant isn't sure it "took" so he runs it through a second time.

Well, if it did "take" the first time, that means the total went into the computer twice. One of those totals is dropped after 10 days, so there's no problem with the payment.

BUT it means both totals are applied to your credit line, for that 10-day period.

Let me give you an example.

You have a credit line of \$1,000. You go to a restaurant and use your card to pay a total of \$75. Well, if the merchant puts the card through twice, the card company computer picks up a total of \$150 toward your credit line.

The example I gave would cause you no problem. But what happened to me was a real mess because the double total put me over the credit limit.

Here's another example:

You have a credit line of \$1,000. You want to buy a ring for your spouse for \$600. Well, if the merchant makes an error using the credit card, it goes into the computer as \$1,200 - disallowing the purchase.

There's another type of problem that also occurred for me with the card. When you go into a hotel, they usually ask for your card, put it into the computer, and give the card company an estimate of what you will be spending. Then, when you leave, you make the actual payment with your card. BOTH totals go into the computer - and are applied toward your credit line.

For example:

You go into the hotel and say you'll be there 3 days. They put the card in and estimate \$300. Your actual bill is \$280 but the computer lists \$580 toward your credit line. After 10 days, the \$300 estimate is dropped. But for that period, your estimation of where your credit is can be off a bunch.

When I talked with the credit card company customer service person last week, he acknowledged that the system wasn't perfect. I agree.

The lesson I learned is never to use more than half the credit line you are given.

Farwell folks return from Brazil mission

Three Farwell residents - Ralph Franse, Otis McMillan, and the Rev. Rick Sullivan have returned from a mission trip, "Church Planting in Brazil." They spent, Oct. 24 - Nov. 5 in Brazil.

"Most of the time we were in a 'little' suburb of 2 million people near Rio De Janeiro," said Rev. Sullivan.

This mission trip was the second one that the Texas Baptist partnership has made with Brazil. The first was done in the 1980's. The Texas Baptist partnership hopes to start 45 new churches in Brazil by the year 2000. "We go and minister in a church and work with the people there," he said.

According to Rev. Sullivan, the churches they are starting are small; often the congregation meets in the home of one of their members. The team of Texas Baptists was there to spread the word of Christ, not to build buildings at this point in the program. The team was there primarily to teach the Brazilians to share their faith and to follow up on the work that had been done.

The trip was very satisfying for those who went. "We had 100 decisions for Jesus in over a week," said Rev. Sullivan. But he also noted that "They needed five groups to come, and we were the only ones to go."

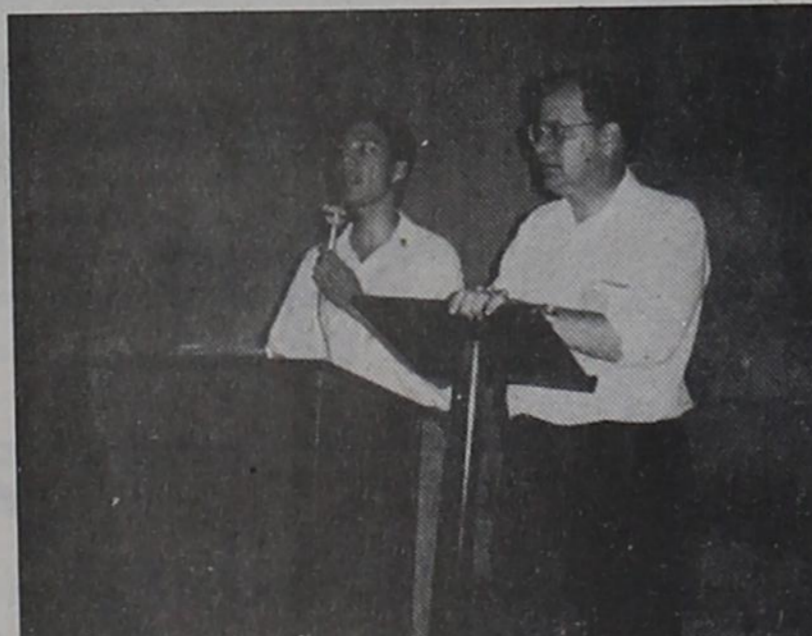
While in Brazil, the group participated in mission work at two different churches.

Sullivan calls the Brazilians very religious, inquiring people who are looking for answers. Most are Catholic by inheritance, but "I wouldn't say most people are Catholic by commitment. Spiritism is stronger there." Sullivan believes that satanism and the occult are major influences in Brazil due to the African influences. "A lot of influential people are of that persuasion," said Rev. Sullivan.

Rev. Sullivan believes that Brazilians have not been made aware of the teachings of Christ. "In one town of 40,000 the (Catholic) priest comes only two times per year. Most of them are not connected to any church. They don't know the story of Jesus Christ. We want to communicate to them the gospel story as simply as we can."

Brazil, like the United States, is a large country with a diverse population. "Brazilians come in every shade and color and every description; there is no stereotype; they are

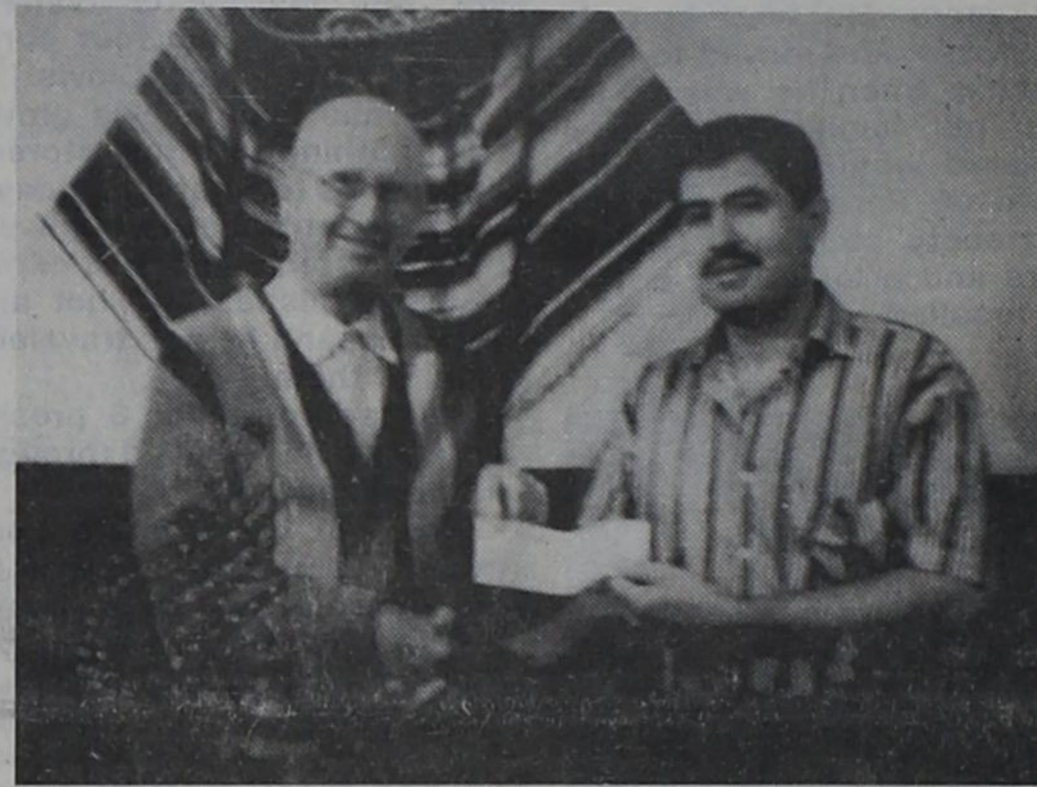

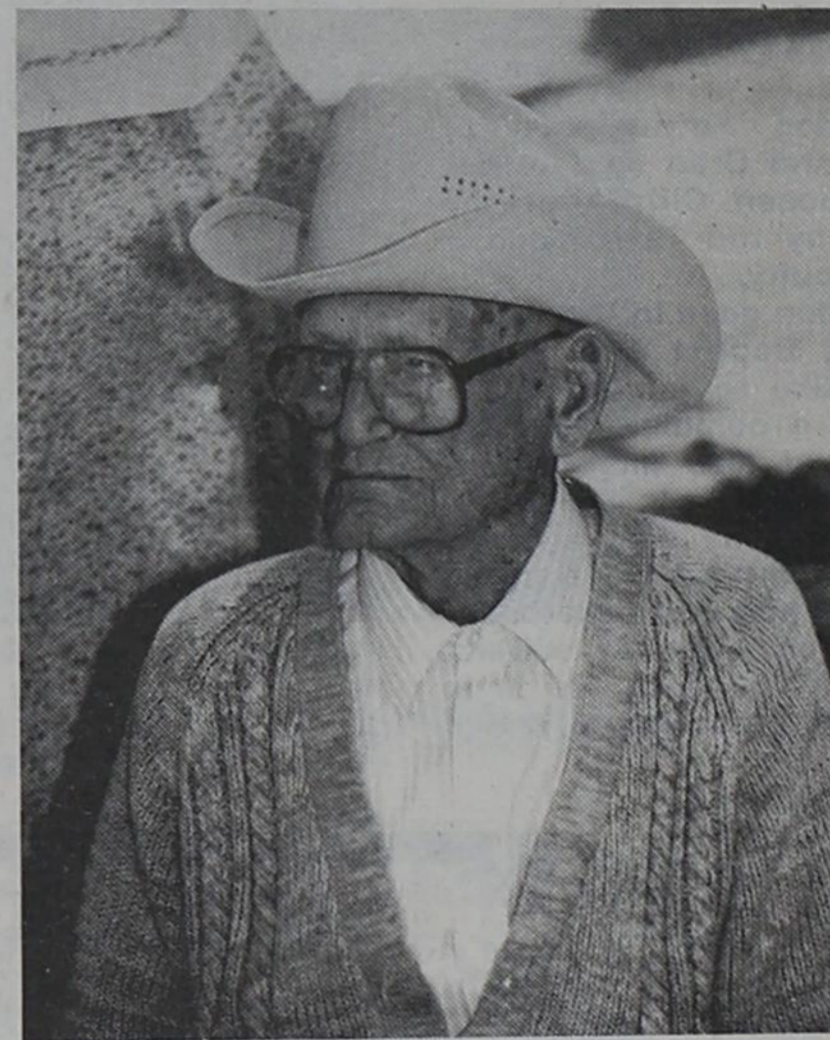

On Nov. 14, they were called at 6:57 to 910 7th Street where a motorcycle accident had occurred. A person was transported to Cannon AFB hospital.

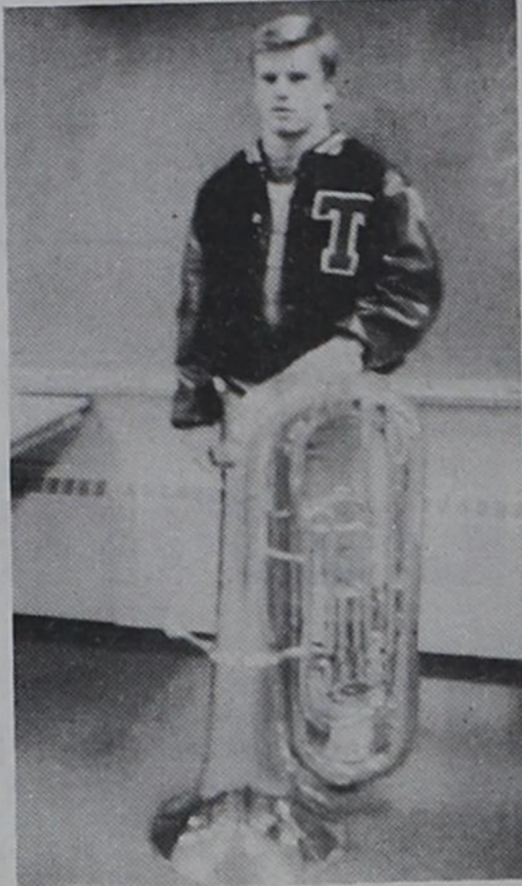
On Nov. 18, the ambulance was called to 303 Ave. G at 3:29. A person was trans-

Each year at this service, contributions are made to help support the transient fund.

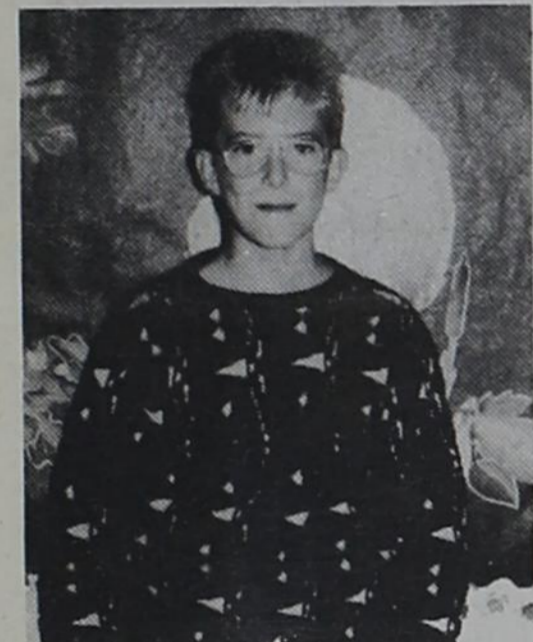

all Brazilian," says Rev. Sullivan. "They are accommodating people; willing to get along with each other."

Most are very poor. He said the average income there is only \$15 per week. The missionaries noted that a new Bible costs about \$14 - nearly a week's salary.

"They don't know they are poor. The people eat well there, and the poor people barter a lot for food, and services," he explained. "They are happy people, quick to sing or play a musical instrument by ear."

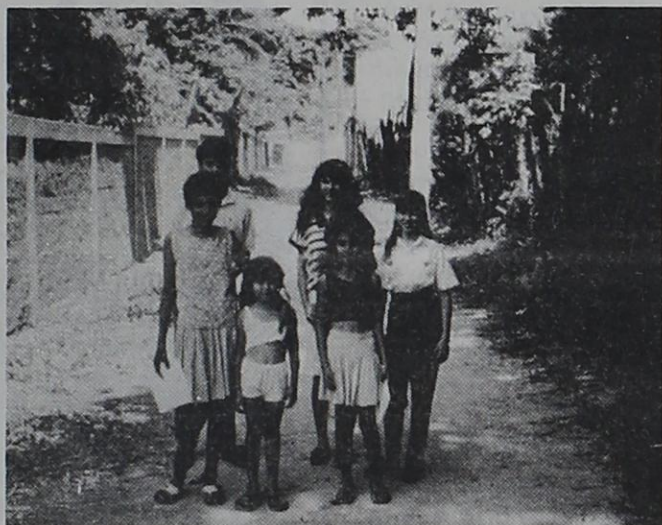
Rev. Sullivan described the country as one where most people lived in small houses. Everybody had TV's, electricity and running water, but because of the tropical temperature, there was no need for heat. They did not have any type of cooling systems.

Brazil is one of the most wealthy nations in the world as far as natural resources go. It has a lush tropical climate that encourages the growth of vegetation.

Rev. Sullivan said Brazil raises enough food to feed itself. The country does not import much of anything - it is one of the policies of their country. "They import a few high tech items, but they try to be self sufficient."

While the Farwell residents were there, Brazil was experiencing some major inflation problems - the unit of currency went from 700 per U.S. dollar to 800 per U.S. dollar in 1 week's time.

Brazil has experienced a tremendous population explosion in the past several years. Rio de Janeiro is a city of 9 million people, and its suburbs have another 2 million. Families are large there; most households include 3 generations.



A group of Brazilians stand in a tree lined street.

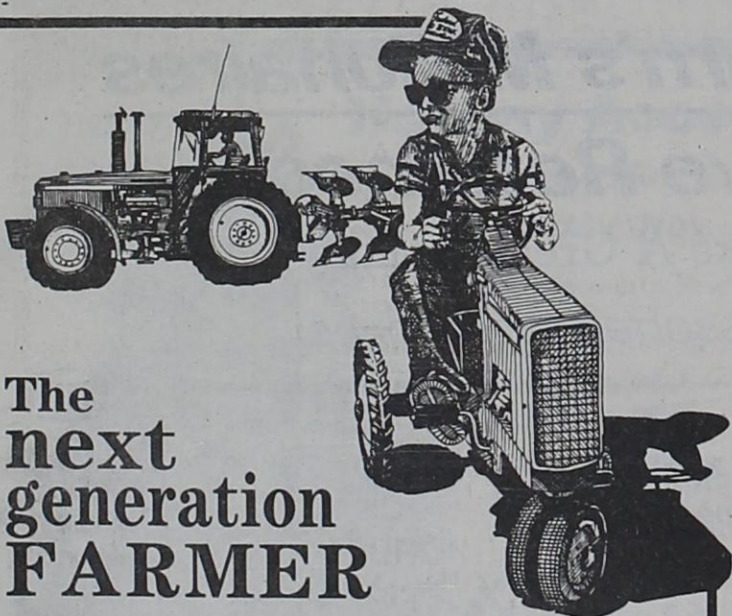
Recipe of Week

Swiss Steak

- 3 lbs. round steak (1 1/2" thick)

Mix flour and seasonings together. Cut meat into 3" squares. Pound flour into the meat.

Melt fat in a heavy pan. Brown meat well in the fat. Add vegetables. Cover and cook over low heat for 1 1/2 hours.

Size of cotton crop here estimated

Steve Verett, Board Chairman of Lubbock-based Plains Cotton Growers (PCG), presented comments on the proposed North American Free Trade Agreement (NAFTA) with Mexico at a hearing on Tuesday, November 12. The hearing was presided over by Texas Agriculture Commissioner Rick Perry.

The hearing was conducted at the Texas Agricultural Experiment Station north of Lubbock. Verett's comments were heard by members of the Select Committee on North American Free Trade. Committee members present at the hearing were Perry, Billy Bob Brown of Seminole, Gary Williams an economist with Texas A&M University, and Richard Pena with the Texas Department of Agriculture.

Verett pointed out many of the concerns High Plains cotton producers have about the proposed agreement. Some of the issues he addressed were rules of origin; Mexico's status as a net exporter of cotton; environmental issues associated with an increase in Mexican cotton production; and the need to be consistent with current and future GATT rules and procedures.

Verett noted that one of the most important issues facing the cotton industry is the need for strong, enforceable, rules of origin. The rules are necessary to regulate the movement of raw cotton and finished textile products between the U.S. and Mexico.

He noted that PCG has joined with other members of the cotton industry to insure cotton has a "Fiber-Forward" rule included in a final agreement.

PCG Executive Vice President Donald Johnson echoes that sentiment. He explained that PCG's

Board of Directors feels any agreement, be it the NAFTA or the GATT, should follow basic common sense rules to insure each side receives the maximum possible benefit.

Verett concluded his remarks by saying, "The goal of the U.S. in this agreement should be to help American agriculture stay competitive in the world market by providing a level playing field for our producers. As producers, from an area of cotton production that benefits from a strong export market, we on the High Plains believe in fair trade. When put on equal footing American agriculture can hold it's own."

* * * * *

USDA raised the production estimate for the High Plains by 20,000 bales to 3.05 million bales in their November 12 estimate. General opinion is that the estimate fails to reflect accurately the severity of the October 28 freeze. Instead of receiving a light frost or two before the hard freeze, area temperatures plummeted below the freezing mark and stayed there for several days.

The freeze apparently damaged many bolls before they were fully mature. Boll numbers had promised a good size crop, however the full extent of the damage will not be known until producers can get back in the fields. The majority of the bolls in question were in cotton fields planted late and already pushing the limits of available time before harvest.

"From what we understand from discussions with people from across the area the majority of this

year's crop was ready for the freeze unfortunately the southern portion of the High Plains had a good bit of late planted cotton that really needed another week to ten days of warm weather in order to put the final touches on the bolls they were carrying.

"Indications at this time seem to be that many of these bolls were permanently harmed by the freeze and simply will not open up and produce any lint at all," notes Donald Johnson, PCG Executive Vice President. "Taking this into account many of the people venturing a guess about the eventual size of this year's crop are staying in the 2.6-2.8 million bale range. Most estimates are on the low end of that range."

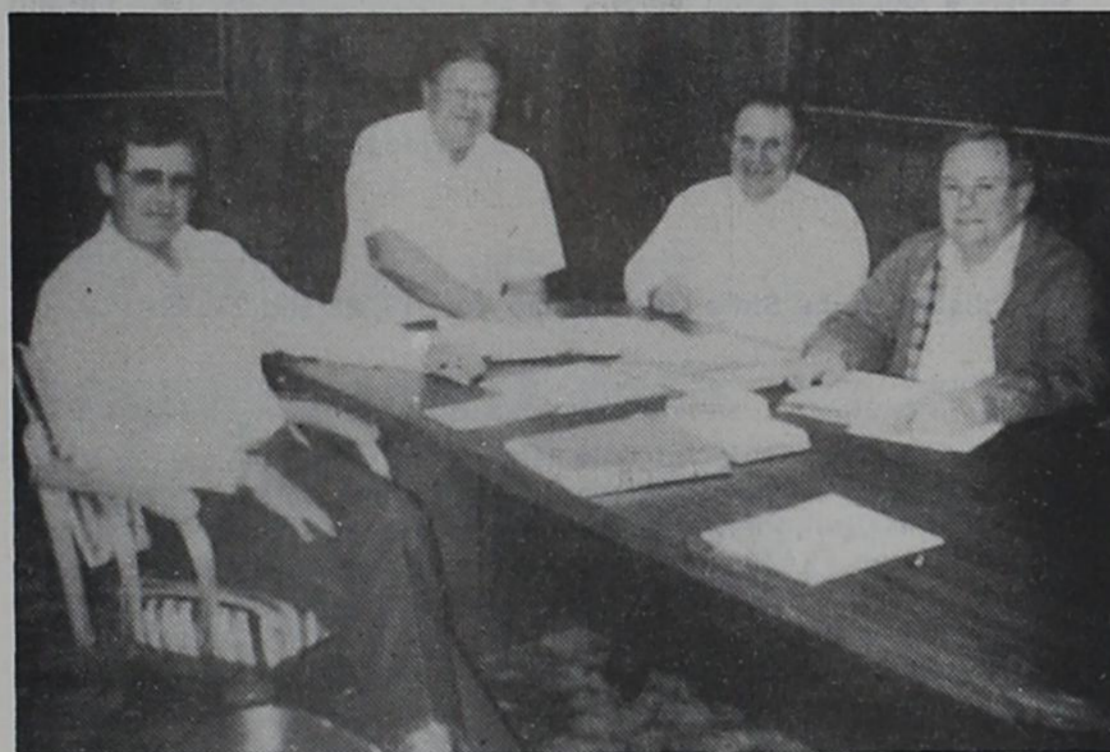
ASCS change cited



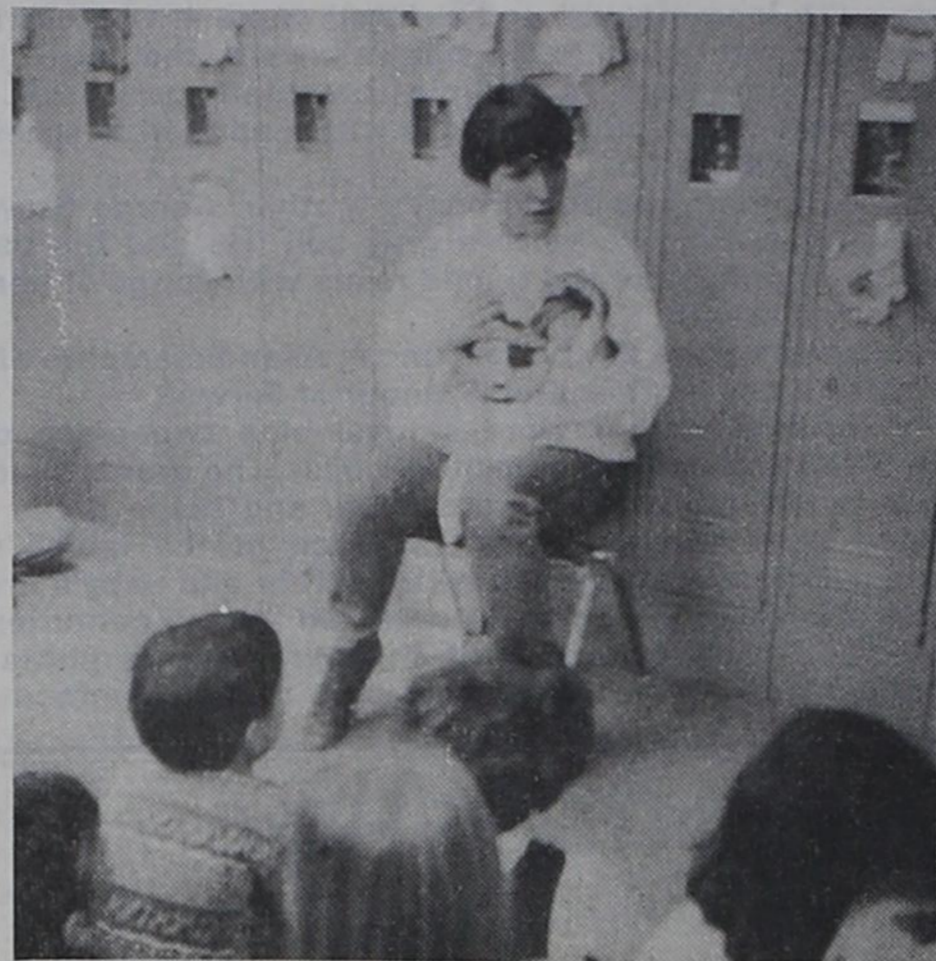

Fall rains will help next year's crop

The ghosts and goblins of Halloween are long gone, but the hard freeze which swept across the Texas South Plains Oct. 30-31 continues to haunt area cotton producers. The sudden, sharp and prolonged drop in temperature appears to have cut the crop by as much as a third in some fields.

Cotton specialists in the Texas Agricultural Extension Service agree with many area growers that yields from the 25-county "cotton patch" of more than three million acres won't measure up to U.S. Department of Agriculture estimates from the November federal crop survey.

"That estimate said (the 25-county area) could make as much as three million bales," said Dr. James Supak, Extension Service cotton agronomist at Lubbock. Supak estimates the yield will be closer to 2.7 million bales, for at least a 10 percent loss.

Supak said the discrepancy in figures may partly be due to the timing of the field survey on which the USDA based its November estimate. That crop count had to be completed before the end of October, at which time the effect of the hard freeze wasn't apparent, he explained.

"The effect of that freeze was very severe," agreed Dr. Carl Anderson, Extension Service cotton marketing specialist at College Station. After such a freeze, Anderson said, "you can't assess how many bolls won't open until two weeks or so."

One reason the freeze did so much damage, Supak said, was because it occurred before the plants had been subjected to a frost and was accompanied by moisture. A frost or light freeze stops plant growth and begins drying of the plant and bolls. As it was this season, many bolls were green and sappy and froze instead of drying down and opening.

"The freeze ruined some bolls that probably would have opened and made some contribution to the yield" under more normal conditions, Supak said.

"Anderson said the USDA estimate was based on a boll count that was probably very accurate, but the surveyors had no way to accurately assess what damage the freeze had done.

He said they do include a loss factor based on the experience of the past three crops. "We've had some good carry - through on bolls the past three years," Anderson said.

To add to the growers' problem, clouds, high humidity, some snow and rain have remained across the South Plains almost continuously since the freeze. Most producers have been unable to harvest their crop and the moist conditions have caused problems with barkiness— an excessive amount of twigs, bark, strands and leaves—in much of what has been stripped, Supak said.

He said weather conditions also are causing loss of poundage and quality. It contributes to discoloring and staining of lint, which combine to lower the grades of the yield.

On a brighter note, Supak said the rains of September did contribute to the subsoil moisture of the area. "That could be a significant factor for the next year's crop," he said.

The November USDA estimate projects a U.S. crop of 18.2 billion bales. Anderson said this compares to 15.5 bales last season and the record 1937 crop of 18.9 million bales. The latest estimate for Texas projects 5.8 million bales, the same as the month before.

Meanwhile, the estimate of cotton use by the U.S. mills rose slightly, from 9.0 to 9.1 million bales. The crop and mill projections were accompanied by a new low in the cotton market in early November.

Anderson said weather problems may cost Texas 200,000 to 400,000 bales, "a 5.4 - to 5.6 million bale harvest that will likely be reflected in the December crop report."

At the same time, Anderson reported, world production was set slightly higher at 91.6 million bales while use edged down to 87.7, for ending stocks of 31.4 million bales. As a result, the world price for cotton has been falling faster than the U.S. market. This has dropped the adjusted world price below the USDA loan level, triggering the loan deficiency payment.

"Eligible producers now have several alternatives to sell cotton not priced earlier," Anderson said. "None of these alternatives are exciting."

He said the choices are to place cotton under loan and

hope to work out some agreement to sell cotton with an "equity" payment; sell cotton and apply for a "Producer Optional Payment" when average world price is under loan level; or, sell on the cash market and accept what the market offers.

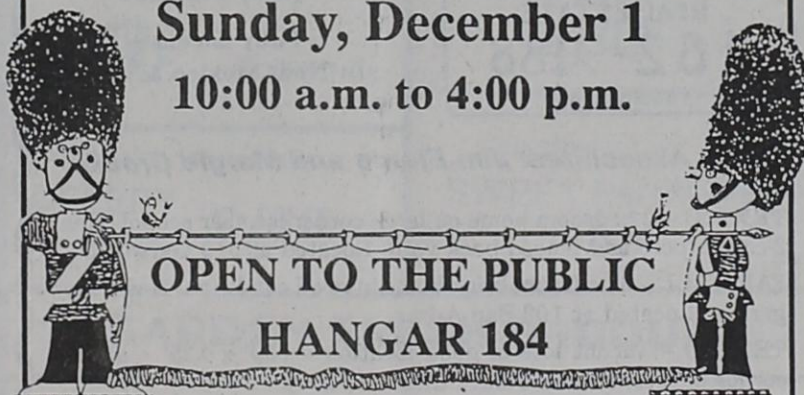


