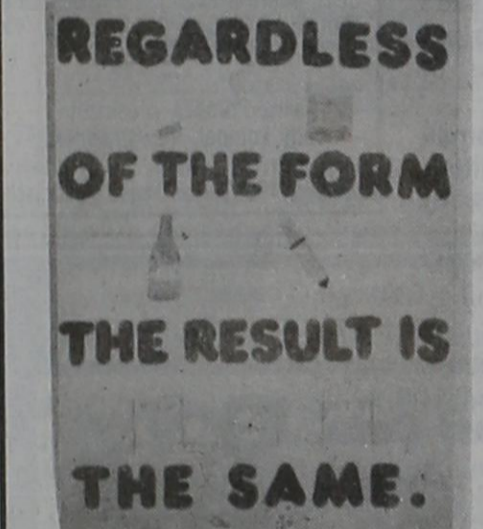

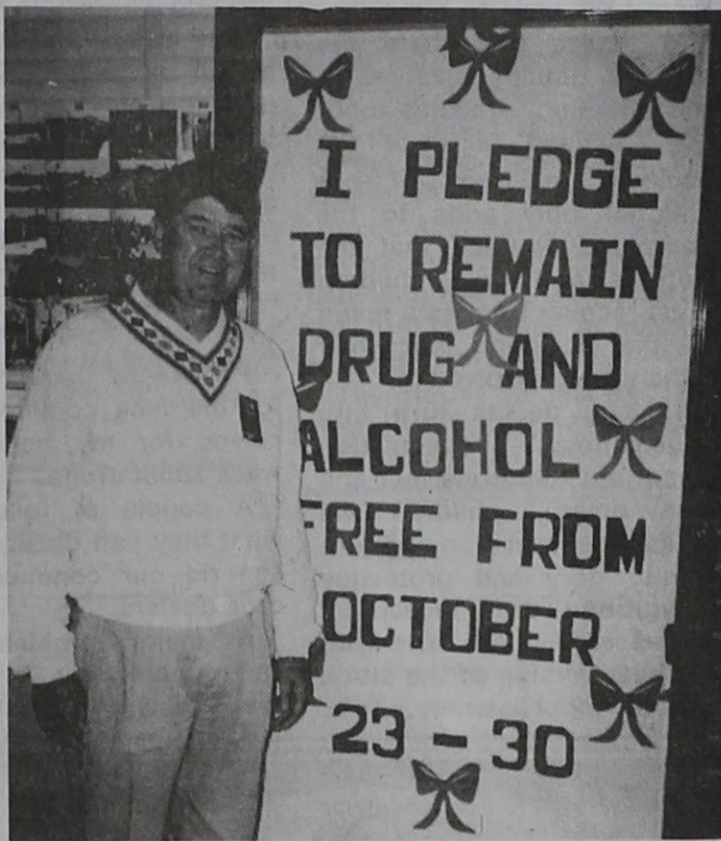

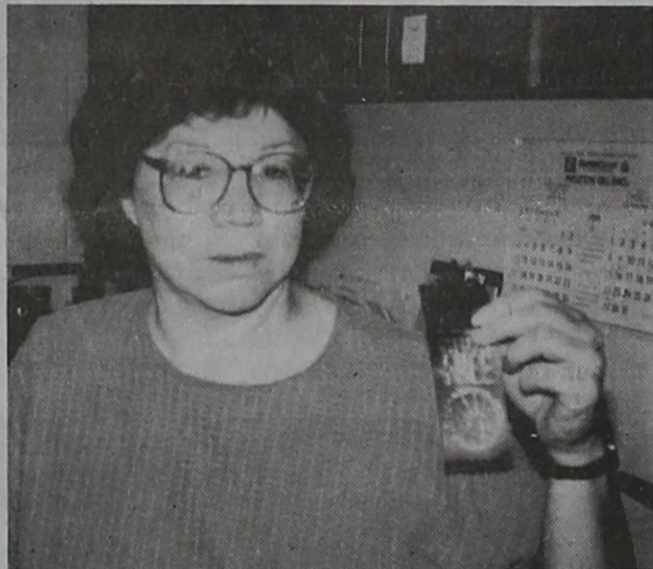

I'm sitting here at my computer having a really hard time thinking of a way to begin this column.
I want to express some thoughts, views and experiences that I have concerning the etiquette of dealing with death.
It is not a subject that many care to discuss, but it is one of the inevitable facts of our lives on earth. The worst aspect of death, however is how those of us left behind have to deal with it.
The sudden loss of Billy Roberts has touched many of us. Billy and his family are much cared for and about; a fact proven by the turnout at the memorial service held for

County DARE program future in question

It was announced at Monday's Parmer County Commission meeting that DARE (drug education) officer Roy Smith has left the Parmer County Sheriff's Department to join the Friona Police Department.
This has created a question as to the future of the DARE program since the agreement to fund the DARE program states that it is to be channeled through the county sheriff's department.
Funds are provided for DARE by Bovina, Friona and Farwell, Parmer County, plus the Lazbuddie, Friona, Farwell and Bovina schools.
Smith would like to continue being the DARE officer. This would necessitate new agreements with the funding entities so that the money would be channeled through the Friona police department.
Sheriff Rex Williams said he had no comment on whether this should be done.
Last week, the county sent letters to the cities and school districts noting that the county will hold on to the funds from these entities until a decision is reached on DARE's future in Parmer County.

Results of last week's games were:

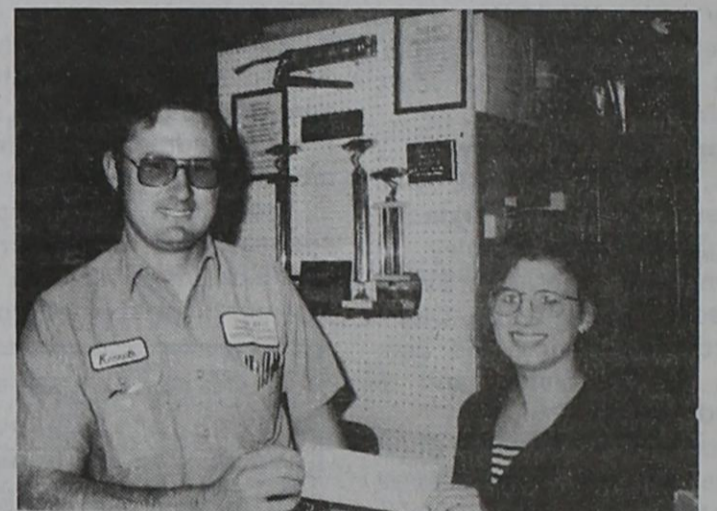

Funeral services for Eugene Lonsdale, 68, Farwell, were Monday at First Baptist Church of Farwell with the Rev. Bob Burris officiating.

He died Oct. 20 at Clovis hospital after suffering a stroke last week.

He was born Aug. 30, 1927, in Los Angeles. He married Patsy Shannon on May 20, 1949, in Van Buren, Ark.

He had been a Farwell resident since 1975, moving here from Belen. He was in the U.S. Navy during World War II and retired from the Santa Fe Railroad in 1990 after 33 years service.

Gaye has expressed to me that she is so very grateful for the compassion shown to her, her children and to the other family members during the last weeks. In fact, I think that many in Farwell would be hard pressed to find a woman more grateful for the friends she has than Gaye Roberts. And I mean this in the best way possible.

I have a title for my article that keeps running through my mind, and I think that I just proved it to myself that it is appropriate. I'm calling it Careless Compassion.

We all mean well, and are simply acting as human beings. We're naturally curious. We are concerned and we also have an uncanny

way of sticking our feet in our mouths.

The facts of the accident are still not exactly known, but that really doesn't matter. It happened. It's over.

Except it's really not. The talking, the questions and the carelessly made comments that get spread so quickly and taken for gospel truth won't let it lie.

Three families have been devastatingly and eternally effected by this accident. The Roberts, the Cain's and the Pool's.

They will replay the incident over and over in their heads enough to last a lifetime. They will always have questions. They will always have regrets; memories and images will always be there

for them.

And as the bystanders to these families, we should let that be enough. But we talk, we speculate on what happened and all the other details of the event. Somewhere in the midst of our talking, these family members hear what we say or ask.

So is it proper to directly ask the people involved? Most often the answer is yes...but only if it is vital that you really have to know the answer. If you don't need to know, don't ask.

There is a saying that goes, "Little Pitchers have Big Ears." It is referring to the fact that children hear everything that is said around them. We have to remember and realize that there are children directly involved in this situation. Talking about the so-called facts of the accident in front of our children only adds to the enormous wounds that the Roberts and Cain children must recover from as a result of the accident that their fathers were involved in.

Sketchy details turn into speculation, speculation turns into rumorous fact and many times children will take this information and turn it into gory and grotesque playground and lockerroom discussions. The one with the best version of the story, gets the most listeners.

In the meantime, the children of the actual victims, get bad information and that leads to problems dealing with the real facts and in getting on with their lives.

But, Teresa, you may be thinking, we're only concerned for the families. We want to help. Talking about it makes us feel better.

A very good friend of my family came to me during the meal following the funeral for my first husband. This man was usually very talkative and had something to say about every topic.

Except this time, all he could do was hold me for little while in a great big hug and whisper over and over again: "I have no words. I have no words."

This phrase has stuck with me for the past 8 years. At a time like this, for all of the families involved the best thing we could say is nothing at all.

In fact, the title that I should really adopt for this is "Silence is Golden."

I'd like to thank everyone for the nice comments I received for my column last week about drugs.

A couple of folks asked what they can do to help police rid our communities of drug dealers.

A major problem small communities has in fighting drug dealers is the lack of

funds to get undercover police that are necessary to convict these criminals.

I suggested to a couple of folks who called that they contact the Texico marshal and Farwell police chief about how to start a fund to get the money necessary to hire undercover police.

And I said to put me down as a contributor to any such funds that are begun locally.

Parmer County Crime Stoppers held a meeting Oct. 18 at the B&W Cafe in Lazbuddie.

The group welcomed five new members.

County Sheriff Rex Williams reported on how crime statistics in Parmer County have decreased since Crime Stoppers began -- and he credited the agency as a major asset in that change.

Crime Stoppers will have their annual meeting Nov. 15 at 8 p.m. at the Headquarters Cafe in Friona.

The letter, signed by county judge Bonnie Clayton and Williams, said, "After seeking legal counsel, I am advised that no monies may be transferred unless all parties are in complete agreement. In the event that any or all parties not agree, monies would then be returned, pro-rated, to each respective entity according to services rendered."

The letter invited everyone to Monday's meeting for a full discussion.

Attending were Smith; Gene Hutto, Bovina mayor; Leon Sadler, Bovina police chief; Paula Wilson, Friona city manager; Hal Ratcliff, Friona school superintendent, and Phil Warren, Lazbuddie school superintendent, plus the commissioners court.

The county commissioners now will await official responses from the governmental entities before a decision is reached. Judge Clayton said the commissioner want to implement the wishes of those entities.

The Texico Lady Spikers won both their matches on the road last week to claim the district championship. Texico will host the district tournament finals on Oct. 28. On Oct. 19, Texico nipped Eunice in a barnburner -- 8-15, 15-6, 15-9, 9-15, 16-14. "This was a big win for us, especially on the road," said coach Michael Littlejohn. "This kept us in the district race. There were about 300 screaming fans standing the whole two hours during the match. We came back from 13-14 in the final game to win 16-14. The girls showed a lot of character." Against Eunice, Misty Barnes had 12 kills and 6 blocks; Jessica Russell, 6 blocks; Kelley Cooper, 14 kills; Brandi Norvell, 18 kills, and Whitney Johns, 10 blocks. Two nights later, Texico had an easier time, beating Jal, 15-12, 9-15, 15-7, 15-7. Barnes had 10 kills, 4 blocks; Russell, 21 assists; Cooper, 15 kills; Norvell, 10 kills and 4 blocks; Johns, 4 blocks and 5 kills; Stacy Stewart, 16 assists.

Tobie Askew among area grid leaders

Here is a look at how our area teams fare according to statistics kept by the Lubbock newspaper: Among area New Mexico teams, Texico ranks 8th on team offense, with 264 points a game, and 8th on team defense, allowing 264 yards a game. Tobie Askew rates 4th among the rushers with 858 yards and 3rd among the scorers with 66 points. Among area 6-Man teams, Lazbuddie is 2nd on team offense, with 375 yards a game. Justin St. Clair rates 2nd at quarterback with 73 completions in 140 attempts for 1,345 yards. Three receivers are listed in the top 10 -- Brice Foster, 7th, with 250 yards; Josh Warren, 9th, with 327 yards, and Juan Reyes, with 284 yards. Among the Class 1A teams, Farwell quarterback Brock Anderson is 5th with 31 completions in 77 throws for 630 yards. Chase Hardage is 10th among the receivers with 15 catches for 493 yards.

When the police get enough calls, they will have to make it a priority to put these drug users/dealers behind bars. I would like to encourage all concerned citizens to attend the next city council meeting. Let's show our city officials that we do want them to take a more forceful role in the right against drugs. Let's work to make our community drug free. And to the drug users/dealers, know this -- you are not welcome in our community. You are being watched and you will get caught.

Texico animal control officer resigns

Mayor Nathan Tharp told the Texico City Council Tuesday that animal control officer Will Byrd has resigned. Applications are being taken for a new officer, with a deadline of 3 p.m. mst Nov. 7, at which time Tharp will appoint a new officer. Becky Stocio, a previous animal control officer, said she will apply for the post.

Center work to be re-bid

The Texico City Council held a special meeting Oct. 19 to discuss the bids it had received for the new community center. Six bids were received, with the lowest from J.M. Brooks, of Clovis, for \$319,832. This presented a problem since the state grant was for \$300,000. And the construction bid didn't include funds for the gross receipts tax, for example. According to state law, a government entity can negotiate with the lowest bidder if the bid is within a certain amount. The Brooks bid met this criteria and the council wanted

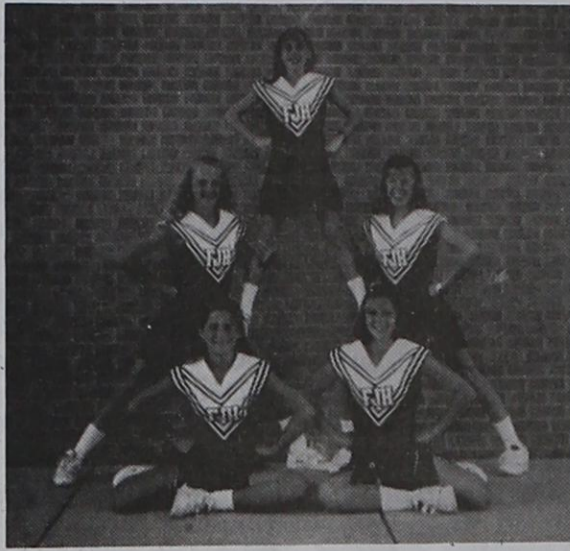

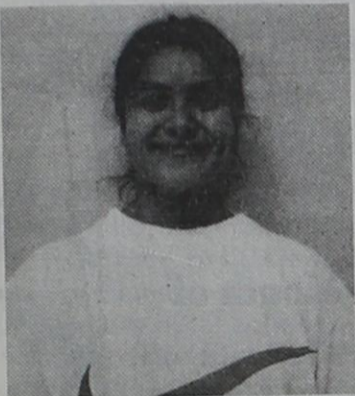
