Prevent Blindness Month

The Texas Society to Prevent Blindness will put the state on a two-pronged "Lazy Eye Alert" during September, Prevent Blindness Month, in an effort to reach the more than 600,000 youngsters who have an eye problem that can be best treated in the preschool years.

This major effort to "save the young eyes of Texas", as announced by Society president Clymer Wright, Jr., of Houston, is in commemoration of TSPB's 25th birthday as well as being a Society contribution toward the International Year of the Child.

"The first prong will consist of specieal vision screenings held from Houston to El Paso by volunteers trained by Prevent Blindness," said.

"While the program is an ongoing one during which more than 36,000 children are screened each year, special emphasis will be given this year to expand general awareness of children's vision needs as well as to increase the total number screened."



The Advisory Committee, headed by P. R. "Bobby" Smith, Assistant Secretary for Marketing and Transportation Services, serves to bring the experience and knowledge of the livestock and poultry industries to bear on the problems related to prevention, control, and eradication of foreign animal and poultry diseases that gain entry into this country.

The new appointee and her husband, James L. Snyder, Texas Tech graduates, have been involved in farming and ranching for 28 years. Their home is located in Baird. The Snyders are members of the Callahan and Shackelford County Farm Bureaus, The Texas and Southwestern Cattle Raisers, and the National Cattlemens Association.

Mrs. Snyder gained State prominence in agriculture when she became the first woman in Texas to be appointed to the State Agricultural Stabilization and Conservation (ASC) Committee in November of 1977, filling the position left vacant by Charles Stemholm who is presently

serving in the U.S. House of Representatives. Snyder gained national attention when she was elected to the Board of Directors of the National Rural Center (NRC),in June of 1978. The NRC, headquartered in Washington, D. C., is an independent,

I ain't never gonna apologize or feel guilty again for emitting "hunnhh?". That's a part of my language, see, and I have just as much raht to express myself freely as the rest of youse keeds. I be tellin yall that should Black-ese be accepted as a language, then so should Jere-ese, West-Tex-ese, Gail-ese, Bronx-ese, or even Plains-ese (Gawga, that be(...

There is a movement to include what is now termed Black-ese in the English textbooks across the polyglot of this nation. The fact that we are an English speaking nation seems irrevelant in our zeal to accomodate teh Blacks. We are told that the dialect of the Black should be an acceptable language-that it is something the Black race holds as a cultural heritage-and that the black childrens shouldn't be made to keep set apart by their word usuage and diction. "Black English is a distinct dialect and not just slovenly talk", we are told. Hogwash. I have heard Black citizens of the British Empire speak with such precise diction and with such erudite phrasing that it puts US po' whites this side of the Union Jack to shame. Black-ese is not a universal dialect of the

Black race. It is not a learned language as is proper English and should best be untaught in the process of learning good English

Now when I speak or write in a colloquial way, I am the first to admit it is slovenly expression. I know better-I am either lazy or am trying to be funny. But I am not asking that my misuse of the English language be made a part of an English manual for teaching exloquialisms and slovenliness and the Blacks' dialects are not good English. If they are to be accepted as separate languages, then teach them as such just as Latin, Spanish and French are taught---amo, amas, amat---I be, you be, he be---. Hunnhh? - I beg your pardon? -Say what?--Que dice usted? "I be qwine to d Black-ese class fo to learn pikaninny talk." If I were a Black, that would be a source of embarassment to me. In my quest for betterment advancement,

improvement in my means of communication would be my top priority. Now should the Black wish to lapse back or emulate the uneducated, that's ok by me-I do it all the time. But I really do know better-sho'

nuff.

Second prong of the "Lazy Eye Alert" will be the distribution of 200,000 of the Society's "Home Eye Test for Preschoolers". 100,000 of the tests have been printed as a public service project of Soroptimist International of Houston and will be sent to industrial and professional sites for distribution among employees. The second 100,000 have been printed by the Zale Corporation for distribution during September in the pharmacy departments of their 123 Skillern's Drug Stores.

"The Home Eye Test" is a simple-do-it yourself way for parents to check the vision of their preschoolers at home. It has proven a reliable indicator of vision problems," said Wright. "If the child fails the test, we advise the parents to then take the child for a professional eye examination."

"Similarly, the trained screeners also notify parents whose children fail their vision tests that these children need a professional examination. The screeners, moreover, follow up for at least six months to make sure the child gets that examination."

The program has been named the "Lazy-Eye Alert" because on of its primary purposes is the detection of a eye weakness known as ambloypia or "lazy eye". The Society warns that a lazy eye usually has no outward signs and that unless treatment for it is started by the age of six, a child can suffer permanent vision loss or even blindness in that eye.

"However, even with all the screenings and test distribution, some children will still be missed in the alert," said Wright and urged parents of these children to write for one of the Home Eye Tests to Prevent Blindness, P.O. Box 2020, Austin, Texas, 79768.

The Texas Society to Prevent Blindness was established in 1954 as an affiliate of the National Society to Prevent Blindness.



Ezzell Named Commission

State Rep. Mike Ezzell of Snyder has been named to the Sunset Advisory Commission by Speaker of the House Bill Clayton.

Rep. Ezzell becomes one of four House members serving on the commission. The other four members are members of the Texas Senate and appointed by the Lt. Governor.

The commission is charged to review those agencies due to be abolished by the Texas Sunset Act. The review process includes public hearings and a final report of findings to the Legislature with the commission's recommendations for each agency.

"Sunset is proving to be an important addition to our legislative system," Clayton said, adding, "Rep. Ezzell with be a strong member of the commission and will help provide the leadership necessary to determine the need for agencies to continue their role in state government."





Rev Up For Brown-Bag Lunches

"Rev" up your ingenuity for brown-bag lunches – with nutrition, safety and enjoyment in mind.

Enjoyment depends on nutirition, safety and taste - so basic guidelines and imagination are all you need.

Basic Guidelines NUTRITION

nutritious lunch includes foods from the basic-four food groups.

They are milk, meat, fruity-vegetable and bread-cereal.

Milk-group foods can be milk or milk products

Meat-group foods can be meat, fish, poultry, eggs, beans or nuts.

SAFETY - First, be sure to wash your hands before preparing the foods, and used clean tabletops, chopboards, utensils and other equipment.

Then, make sure to keep hot foods hot and cold foods cold to insure safety.

Foods to keep cold include milk, meat, fish, poultry and eggs.

Also, to retain "appetite appeal," some fruits and vegetables and other foods should stay cold - such as crunchy-cold carrot or celery sticks, along with cheese cubes.

To keep foods cold, use a freeze-gel packet or margarine tub filled with frozen water. These items will keep foods cold even in an ordinary brown bag.

Also, you can freeze some foods - such as sandwiches - and pack them frozen. By lunchtime, they'll be thawed and ready to eat.

Brown-Bag Ideas

Try this idea for a tasty brown-bag lunch: a ham-and-cheese sandwich with lettuce, carrot strips, an apple and an oatmeal cookie.

Keep the ham-and-cheese sandwich cold for safety, and keep the lettuce and carrots cold for crispness.

Here's another idea - this one needs no refrigeration: a peanut butter-and-jelly sandwich, cheese straws, an orange or a banana and a slice of carrot cake.

1980 Wheat Program

All wheat procucers will be eligible for loans, deficiency, or disaster payments without being required to set-aside or divert acreage in 1980. The loan rate has been increased from \$2.35 to \$2.50 per bushel.

Disaster
Should cotton or grain sorghum fail due to natural disaster such as hail, insects, flood, drought or other reason, it must be reported to the ASCS Office before grazing, plowing, or other wise destroying evicence of the crop condition.

1979Loan Rates

The loan rate for grain sorghum is 3.37 per cwt. The loan rate for cotton is 50.35 cents per pound based on strict low middling 1 16 inch staple.

The interest rate will be 9 percent. Loans will be available in the County Office.



SPECIAL ELECTION NOVEMBER 6, 1979

PROPOSITION NO. 1 ON THE BALLOT

(H.J.R. 108)

House Joint Resolution 108 proposes an amendment to the Texas Constitution relating to the appointment and terms of notaries public. The proposed amendment would:

Require the Secretary of State to appoint a convenient number of Notaries Public for the state; and

—Authorize terms of office of Notaries Public of not less than two years nor more than four years.

A temporary provision of the proposed constitutional amendment provides that the amendment would take effect January 1, 1980; that each person who was appointed a notary public before January 1, 1980, would continue to serve as a notary public for the term for which the person was appointed; and that this temporary provision would expire January 1, 1982.

PROPOSITION NO. 2 ON THE BALLOT

(H.J.R. 133)

House Joint Resolution 133 proposes an amendment to the Texas Constitution to provide for legislative review of the process of rulemaking by agencies in the executive department. The proposed amendment would allow the Legislature to enact

- To provide for legislative review of the process of rulemaking by agencies in the executive department;
- —To prescribe conditions for rules to take effect;
- —To provide for suspension, repeal, or expiration of rules;
- -To prescribe procedures: and
- —To delegate powers to either or both houses or to committees of either or both houses.

"The constitutional amendment to provide for legislative review of

the process of rulemaking by agencies in the executive department."

PROPOSITION NO. 3 ON THE BALLOT

(S.J.R. 13)

Senate Joint Resolution 13 proposes an amendment the Texas Constitution authorizing the Legislature to provide for the guarantee of loans used to purchase farm and ranch real estate for qualified borrowers. The proposed amendment would allow the Legislature to provide for, issue, and sell general obligation bonds called "Farm and Ranch Loan Security Bonds" of the State of Texas not to exceed 10 million dollars. All money received from the sale of such bonds would he deposited in a separate fund with the State Treasurer and administered by the commissioner of agriculture without further appropriations. funds would be used to guarantee loans for the purchase of farm and ranch real estate. The commissioner of agriculture would use these funds, under provisions to be pre-scribed by the Legislature for the purpose of guaranteeing loans used for the purchase of farm and ranch real estate, to acquire real estate mortgages or deeds of trust on purchased with guaranteed loans. These funds would also be used to advance to the borrower a percentage of the principal and interest due. The Legislature may also authorize the commissioner of agriculture to sell at foreclosure any land acquired in the manner authorized by this amendment. The commissioner of agriculture would be required to charge at least 6 percent interest on such The proposed loans. amendment appropriates an amount that is sufficient to pay the principal and interest on the bonds that mature or become due during the fiscal year less the amount in the interest and sinking fund at the close of the prior fiscal

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment authorizing the legislature to provide for the guarantee of loans for purchase of farm and ranch real estate for qualified borrowers by the sale of general obligation bonds of the State of Texas."


