## **County approves balanced budget**

The Parmer County Commissioners Court met in regular session on Monday, August 24.

Parmer County Auditor Larry Johnston reported that for the first time since 2010 they have a balanced budget with a 24 percent net increase of \$855,000. The cash reserves peaked in 2009 but have been down for the last seven years before the latest increase.

The commissioners extended the burn ban. They stressed the importance of abiding the ban. The one exception to the ban is that if someone wants to burn they must abide the following: if the wind is less than 10 miles per hour; and they must call the Sheriff's Office (806) 481-3303 and the local fire department.

The fire departments in Parmer County are as follows: Friona Volunteer Fire Department (806) 250-2711; Bovina Volunteer Fire Department-day (806) 251-1116 or night (806) 251-1212; Rhea Community Volunteer Fire Department-Chief Monty Schueler (806) 265-5337; Lazbuddie Volunteer Fire Department-Chief Kasey Whatley (806) 647-8320; or Farwell Volunteer Fire Department-Chief Daniel Kaltwasser (575) 799-3439.

If someone does not follow these mandates, they are in violation of the burn ban and will be issued a citation. If they are given permission to burn, they may still be liable for damages if the fire gets away from them.

In other business the commissioners authorized County Judge Trey Ellis to sign on behalf of the county for the purchase of the property in Bovina. The land being purchased is at 301 Gardner and houses the Justice of the Peace, AgriLife Extension and DPS.

The next commissioners meeting will be May 8 at 10 a.m. in the County Courtroom in Farwell.







## Texas Medicaid mosquito repellent to protect Texans

Starting May 1, Texas will begin providing this year's statewide Medicaid benefit for mosquito repellent to prevent Zika virus transmission. The Texas Health and Human Services Commission is offering the repellent to more Medicaid clients to ensure additional Texans are protected from the virus that can be devastating to unborn babies.

For the first time in Texas, some boys and men will be eligible Health Insurance Program and to receive the benefit, as well as

of an infected mosquito, but it can also spread by sexual contact. While symptoms are often minor, Zika can cause severe birth defects in the babies of some women infected with the virus during pregnancy.

The benefit is for pregnant women, women ages 10-55, and males age 14 and up who are enrolled in Medicaid managed care, fee-for-service, the Children's CHIP-Perinatal programs. Recipients can pick up mosquito repellent without needing a prescription. In addition, individuals who meet the eligibility criteria for Healthy Texas Women, Children with Special Health Care Needs, or the Family Planning Program can receive the benefit. Eligible clients in the CSHCN program require a prescription.

tion. Last year, the HHSC and Department of State Health Services received approval to use state funds for mosquito repellents and announced the availability of this new benefit. The 2017 benefit will build on ongoing efforts to prevent transmission.

State health officials urge people to protect themselves at home and while traveling to areas where Zika is spreading. Precautions include consistently using mosquito repellent when outside, wearing long sleeves and pants, and using air conditioning or making sure window screens will keep mosquitoes out of the home. Texas is also calling on people to dump out containers that could hold standing water in and around their homes and businesses to deny mosquitoes a place to lay their eggs, decrease the overall number of mosquitoes, and help protect family members and neighbors from Zika.

"We want to support the health and safety of Texans," said HHSC Executive Commissioner Charles Smith. "The best way to protect yourself from the Zika virus is by using mosquito repellent."

Zika virus is transmitted to people primarily through the bite





## The Redeemer Center

The Redeemer Literacy Center as the Friends refer to the building, officially known as the "Redeemer Evangelical Lutheran Church" when it was first organized as a mission church of the Immanuel Lutheran Church at Rhea. The Church, organized in 1962, had 14 original families as members. In January 1963, the church purchased Block 4 of the Drake Addition in Friona and by November 1964, construction had begun. Matlock Builders served as contractors for the construction of the church. The unusual design is unique among churches in Friona. The first service was March 4, 1965 and their pastor Reverend Ervin Binger, of the Immanuel Lutheran Church at Rhea served this church. A Ladies Aid Society began in 1963 as well as a Walther League and then later the men's organization Laymen's League in 1967.

Other pastors included Reverend Ervin Binger 62-63, Reverend Fred Beversdorf 63-66 (during the construction); Reverend Otto Kretzmann 66-71; Reverend Duane Kirchner 72-75; Reverend William Rumpel 76-79; finally, Reverend Reuben Haase 80-?

mer County had an interesting beginning going as far back as 1909 when Herman F. Reinking from Indiana decided to purchase land in Texas. At 60, he had already seen the development of land in Nebraska and Iowa. He However, they were not used saw the potential, bought land directly from the Wright Brothers, and bargained for land reserved exclusively for German Lutheran settlers. 'Lots of land in one spot'--10 sections with 40 acres of it reserved for a church Brothers allocated more land to and a colony house deeded to



German Lutheran Congregation Missouri Synod. Reinking specifically asked them to donate \$1,000 for the construction of a chapel. The Wright Bros readily agreed and promised Rev. Reinking a bell for the chapel as well although this is the only part of the requests agreed to but not delivered.

Reinking eventually brought his son and his daughter (his wife stayed in Indiana and refused to come to Texas) to the Panhandle and to the 280 he had purchased. The Lutheran Church in Par- Like many early settlers, Reinking brought his livestock and farm equipment with him by rail. The biggest obstacle for the settlers other than infrastructure (house, barn, pens, etc.) was that there was no rain, none at all! to that. Nevertheless, they persevered and soon, by 1910, had established a 4 inch well and a colony house and church to try to attract more settlers and soon all the land sold and the Wright be reserved for these 'German

Lutheran' setters. [story by his son Herman J. as written in 'A History of Parmer County' c. 1976]

The Redeemer Lutheran members graciously donated the building to the City of Friona in 1999 because its members had passed away or moved from Friona and no longer met for services. In 2009, the Friends added new flooring in the kitchen and bathrooms and carpeting elsewhere. We received gifts of new appliances, a stove and a refrigerator, from Linda White and Bi-Wize Drug. Hugh Moseley kindly donated a painting by Bobby Wied, a member of the church. Since 2012, the Friends of the Library have used the Redeemer Center for ESL Classes and annual meetings. In 2016, the City of Friona added landscaping, a flagpole and a new sidewalk in addition to inside painting and new countertop in the kitchen. We hope we have honored the tradition of the members of the Redeemer Lutheran congregation by keeping the facility nice.

Needless to say for most caregivers the responsibilities generally increase before they get less.

Topics covered include providing care related to the recipient's disease process, addressing physical and emotional changes that may be associated with the disease process, and incorporating self-care.





## **Conserve water this** spring & summer

Outdoor water use can account for 50 to 80 percent of a home's total water use in the spring and summer. Much of this water is often wasted by inefficient landscape watering practices, including runoff.

High Plains Underground Water Conservation District (HPWD) encourages people to incorporate water-efficient practices into their landscapes to avoid water waste.

Add water efficient plant varieties into your landscape. These plants are native or well-adapted to climate conditions in your area. Additional information is available at texastreeplanting.tamu.edu and texassuperstar.com

Reduce water evaporation by irrigating at proper times. Evaporation losses can be 60 percent or higher during the day. You can reduce this by irrigating in early morning or late evening. Be sure to follow your town or city landscape watering ordinances, if applicable.

Do not water landscapes on windy days. Wind drift and evaporation increase water losses.

Consider use of drip irrigation to water narrow parkway areas or reduce turf in those areas with water-wise plant varieties that can thrive on less water.

Position sprinklers so that driveways and sidewalks are not irrigated. Check spray patterns for variations caused by changes in water pressure.

Consider rainwater harvesting to collect/store water for future use in your landscape rainwaterharvesting.tamu.edu

Use mulch to retain soil moisture, reduce runoff, moderate soil temperature, and to slow weed growth.



They should be enrolled in at least one high school agricultural class each semester, participate in extra-curricular activities such as FFA and have a supervised agricultural experience project.





# Cotton varieties eyed in AgriLife trials across Texas High Plains

## **By Kay Ledbetter**

With a growing number of producers interested in cotton due to good markets and prices, the Texas A&M AgriLife Extension Service variety trials are sure to get more attention in the coming weeks and years, an agency agronomist said.

Although producers in the southern part of the Texas High Plains have more experience with cotton, it is still fairly new in the northern part and more farmers with little to no experience are looking at the crop, said Dr. Jourdan Bell, AgriLife Extension agronomist in Amarillo.

"We will be planting our annual cotton variety trials in the next few weeks, where we will be evaluating early and early to mid-maturing varieties," Bell said. "But also important, we will be looking at some new herbicide chemistries that are gaining a lot of attention."

Bell said they will have eight locations; six irrigated trials in Deaf Smith, Hartley, Hansford, Parmer, Sherman and Swisher counties, and two dryland trials in Gray and Randall counties.

"Variety selection is one of the most important decisions a producer can make," she said. "When we talk about cotton in the Panhandle, we are in a growing-degree day limited region, so our AgriLife Extension variety trials provide the opportunity to look at multiple varieties across multiple environments and management scenarios.

"In evaluating the different varieties being offered by various companies, we are able to provide an unbiased data set on stability and yield potential."

The new component of the said. "We have 12 varieties that 2017 trials is many of the varieties have a triple-stacked herbicide trait, meaning they are glyphosate-tolerant, glufosinatetolerant and either dicamba or 2,4-D tolerant, Bell said. She said they will be evaluating the yield potential of these varieties and not the herbicide performance.

"Producers are really excited to see how varieties with these new herbicide traits perform," she



are positioned for the High Plains production that will be included in this year's trial."

Bell provided a brief description of each variety based on company descriptions and/or previous varietal performance:

– DeltaPine 1518 B2XF – An irrigated early variety widely planted with good yield potential and resistance to bacterial blight with the XtendFlex herbicide trait.

– DeltaPine 1522 B2XF – A stable variety for the Panhandle with good yield and quality with the XtendFlex herbicide trait in the XtendFlex herbicide trait perboth irrigated and dryland. It is susceptible to bacterial blight.

– DeltaPine 1549 B2XF – A dryland variety with the Xtend- riety known for its high turnout Flex herbicide trait that performed well in 2016.

– DeltaPine 1612 B2XF – This variety is positioned as a high

yielding variety on dryland and limited irrigation with the Xtend-Flex herbicide trait in both irrigated and dryland.

– FiberMax 1320 GLB2 – This early variety had good yield and proven quality in both irrigated and dryland.

- FiberMax 1888 GLB2 - Another early maturing variety with good early vigor and high yield potential in the northern Panhandle on both irrigated and dryland. - Stoneville 4747 GLB2 - This

large seeded variety is favored for its early season vigor on both irrigated and dryland. It is a short stature variety with good yield potential.

- NexGen 3406 B2XF - This early mid-maturing variety with forms well on both dryland and irrigated acres.

- NexGen 3640 B2XF - Vaand strength in both irrigated and dryland with the XtendFlex herbicide trait.

- NexGen 3699 B2XF - An http://bit.ly/2l5oloq.

aggressive, early maturing variety that is ideal for high input systems in both irrigated and dryland with the XtendFlex herbicide trait.

- Phytogen 243WRF - An early maturing variety with good verticillium tolerance and adapted to both irrigated and dryland.

- Phytogen 300W3FE - An early to mid-maturing Enlist variety that performs well on dryland and irrigated acres with good verticillium tolerance.

- Phytogen 330W3FE - An early to mid-maturing Enlist variety that performs well on dryland and irrigated acres.

– Phytogen 490W3FE – A mid-maturing variety with a high yield potential and quality. Under dryland conditions, Phytogen 490W3FE is reportedly determinant with a strong yield potential in early environments.

economic value to Xcel Energy customers with a total of nearly \$8 billion in fuel cost savings over the life of the projects. Federal production tax credits, combined with today's low wind costs, allow the company to secure low energy prices for wind.

Xcel Energy's wind portfolio will contribute to an estimated 45 percent reduction companywide in carbon emissions from 2005 levels by 2021, if the company is able to fully imple-

ment approved and proposed renewable energy plans.

States and communities served by Xcel Energy are already seeing economic benefits from existing wind farms. New wind farms will benefit many more local communities by generating nearly \$400 million in property taxes over the life of the projects. Landowner payments are another economic benefit. Most of the new wind farms are large projects of 200 megawatts or more. Wind developers generally estimate about 200 temporary construction jobs and a dozen full-time jobs for a large wind farm. In total, the new wind farms will create 2,000 construction jobs and full-time jobs.
