If the writer of these notes answered every call to raise money for objects of charity, that is, for people who are passing through our town he would be on the streets half of his time trying to get money. We have always been very careful about asking folks to contribute to charity and have done very little of it since coming to this town. We don't expect to do very much of that kind of work, but when ever we feel that duty calls we do it. Last week we asked the citizens of our town to respond to the call of our fellowmen who were victims of the storm that passed over our state last week. These people were not an object of charity, but because of unfortunate circumstances they were in distress, and needed help. It was the duty of every citizen of this country to hear their cry for help, and if possible respond, and on approaching our citizens most of them responded in a beautiful way, giving to the amount of \$72. Of course there are some people who never respond to such calls and get angry when asked to do so. These people generally think that they are immune from such disasters and that it is impossible for them to ever be in distressed circumstances, and to help the cry of the suffering would be an unpardonable sin.

We noticed in last week's Eagle where there would be no fishing at the lake on Sunday I do not know who is responsible for such action; but those that are needs to be highly commended. Gentlemen you could have done nothing else that would have pleased our Heavenly Father more. It's true that God made the Sabbath day for man, but not for him to fish, hunt, and desecrate the day in other ways but that he might rest from his daily labors, and feed his soul the altars of God's house, giving up his spiritual life, preparing him for a new week with new obligations.

A NEW FIRE RECORD

Recently the National Board of Fire Underwriters issued a summary giving the causes for the greatest fire losses in each state in 1928. In 19 states cigarettes, cigars and matches were responsible for a majority of the waste; in 11 states, defective chimneys and flues; in five states, boilers, furnaces and the like; in two states, sparks on roofs, and in three states, misuse of electricity, oil products and spontaneous combustion.

Recent inspections of chimneys, flues and electric wiring, and careful storing and handling of gasoline on the part of American citizens would greatly reduce our fire loss almost overnight.

During March, the total estimated loss was \$42,964,392, representing an increase of \$1,686,578 over the same month last year. And the loss during both January and February was appreciably in excess of the loss in 1929. If the present trend continues, 1930 will probably see the establishment of a new high record for fire waste.

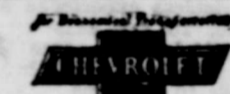

SUCCESSFUL MARRIAGE

Successful marriage is built on the successful continuance of domestic contentment. Homes are broken up when the husband browbeats the wife into submission on a question of controversy or when the wife brings the supposed lord of the hearth around to her way of thinking. When they quit scraping they quit housekeeping. A good stubborn Methodist wife can not be converted to the estimable Presbyterian theory of predestination. A good stubborn blue light husband can not be convinced there is efficacy in immersion. And the good stubborn Baptist can not be convinced of anything that isn't Baptist. So it goes. Domestic debate on religion keeps the subject alive. This doesn't go for the in-laws. All of the objection to interdenominational marriage comes from the outside. Nearly all of the trouble in married life comes from the outside, too. There seems to be a deep-rooted objection to two folks living happily together in their own family arguments, their own domestic troubles, and their communal domestic bliss. But it is as nothing to the deep-rooted objection of one's Catholic daughter marrying a Campbellite lad or a husky son of one of the two surviving tribes taking to his bosom a daughter of a high church Episcopalian. Of course there is unhappiness in mixed religion in marriage—it is in the conversation of the outsiders. The young folks get along pretty well. But when it is the latter it is usually the quality of the domestic cooking or the uxorial bridge game that disturbs not the infelicity of differential creed.—State Press in Dallas News.

MRS. R. Q. LEE

Candidate for Congress,
Unexpired Term
Election May 20, 1930.

In a statement sent out by Mrs. R. Q. Lee, who is a candidate for her husband's term in congress, she makes it clear that she is not endeavoring to make the people believe that all of the members of congress are thieves and hoodlums. She says: "My association with the members of the congress of the United States during my husband's tenure of office as representative from the seventeenth district of Texas has convinced me that men of this great legislative body are gentlemen and not slingers of 'slush' who are unfit for the association of honorable women, declared Mrs. R. Q. Lee in commenting upon her campaign for election to congress in the special election, May 20, to fill out the unexpired term of her husband. "It is difficult to believe that the highest legislative body in the greatest nation in the world is composed of moral reprobates and political sinners. From personal experience, I know this is not the truth. I would not reflect upon the electorate throughout the United States and condemn them as unfit to choose honorable and capable representatives, nor will I proclaim myself as the only honest member when I am selected by my constituency to fill out this unexpired term for which I am now offering.

"I said that I wished to complete the work that Mr. Lee was engaged upon. During the past year he handled more than one hundred veteran and pension cases for the seventeenth district. Of these many were completed but many others are still in an unfinished state. However, the telephone reaches out after them with a long arm, and the radio's instantaneous broadcast beats the swiftest automobile. And we need scientific education also. The young folks must be shown that they ruin their lives when they enter the yellow path.

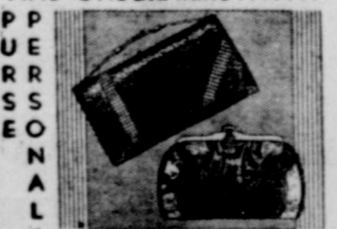

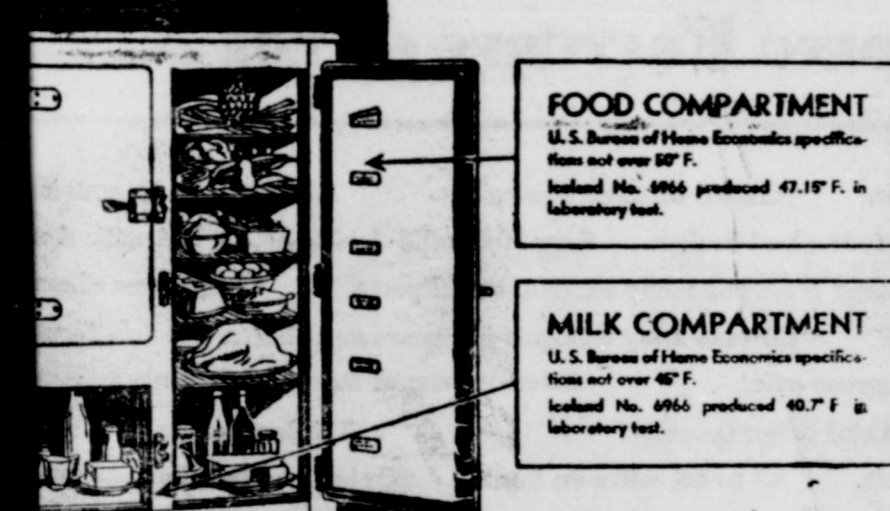

TALK TAXES THIS YEAR

The biggest problem facing Texas and some of her neighbors today is what most of the candidates are not talking about—taxes. When they do speak, too often it is the time-worn generalities that mean nothing. Most of them, frankly, have not studied the principles of taxation sufficiently to declare for a concrete policy.

One thing is certain. Present systems of taxation are not adapted to modern conditions. "Equal taxation" is, of course, an impossible ideal, but the discrepancies between the respective burdens on different vocations have become so wide that they mock the ancient principle.

Candidates for legislative and executive positions who have nothing better to offer than the vague and discredited pronouncement for lower taxes, owe their constituents an apology for speaking on the subject at all. Everybody is for lower taxes for himself. But anything of a permanent value must come by a reconstruction of taxing systems to meet the conditions of modern times.

We have had plenty of legislation to meet an emergency. We have had plenty of tinkering up the outworn machinery. It is time that men who have studied taxation scientifically be put on the job to build a new machine for extracting the costs of Government from its people on a more equitable basis than the old machine can ever again do. — Farm and Ranch.

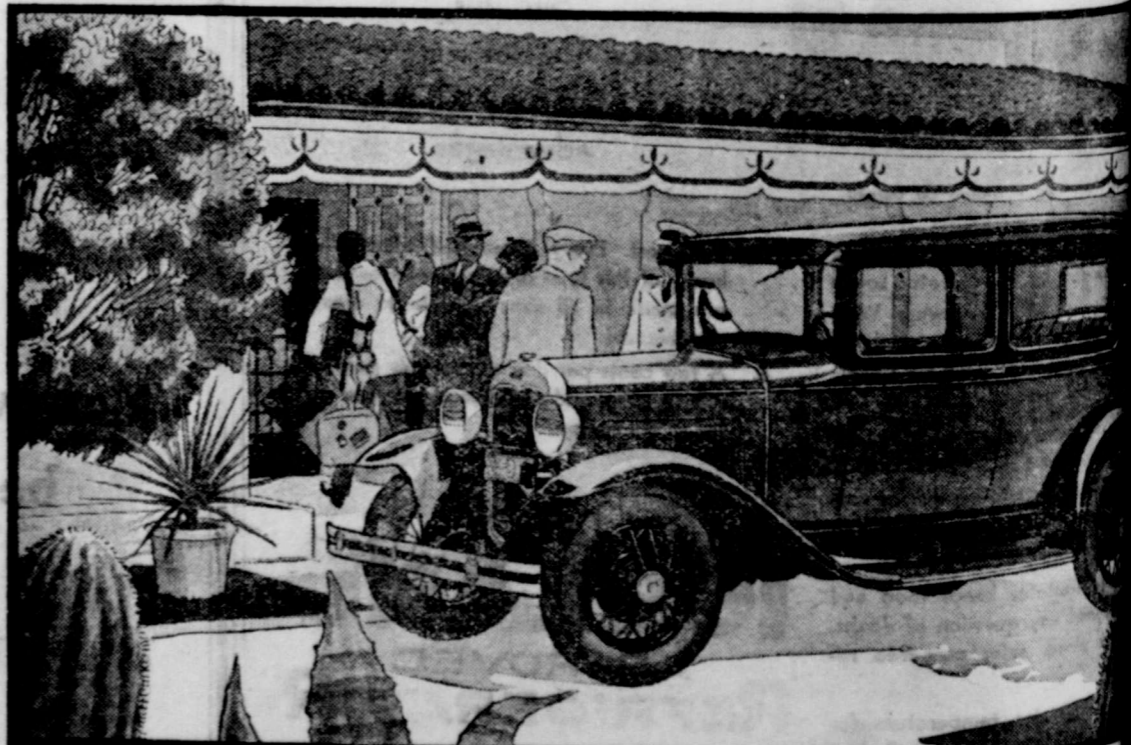

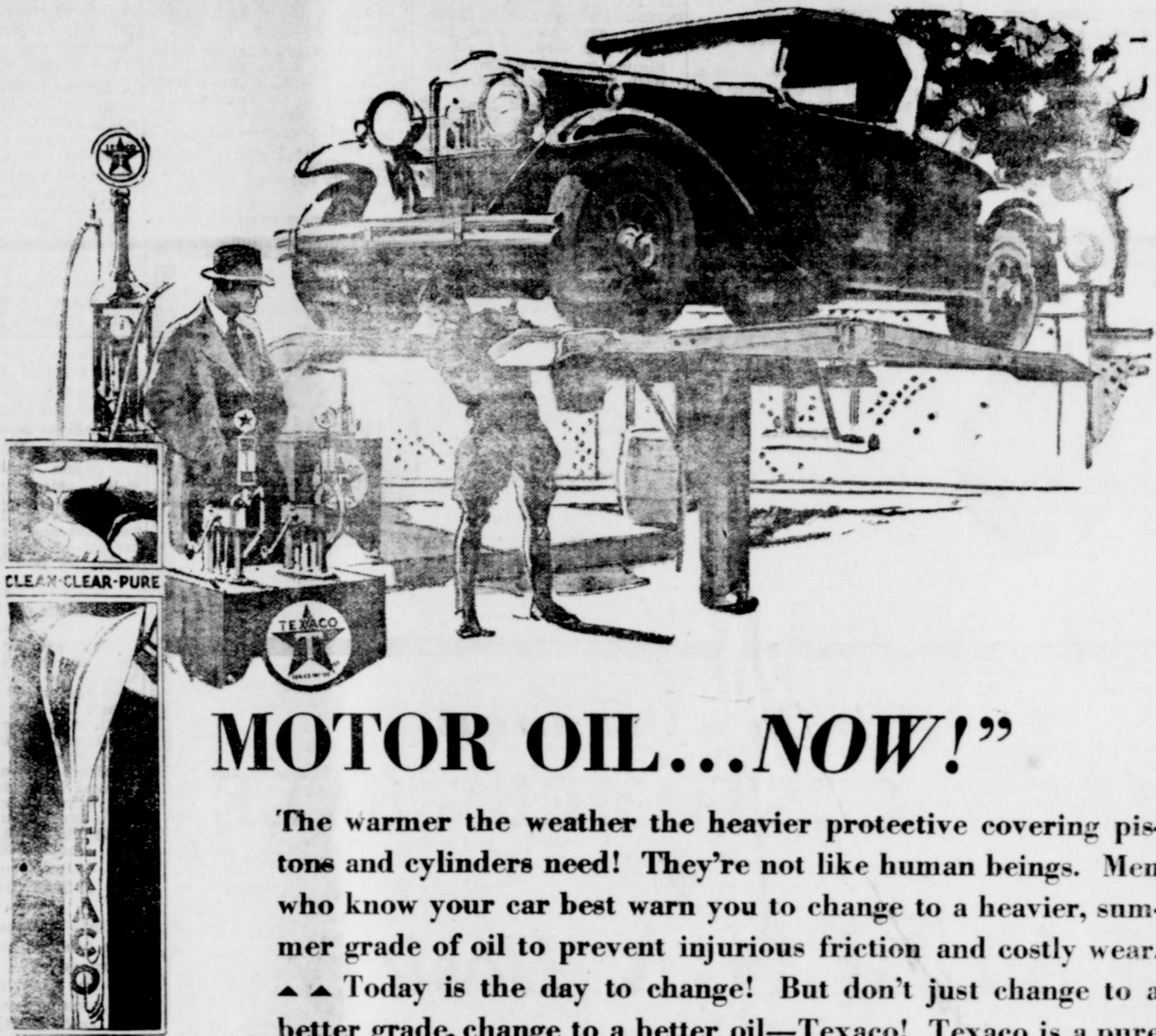
