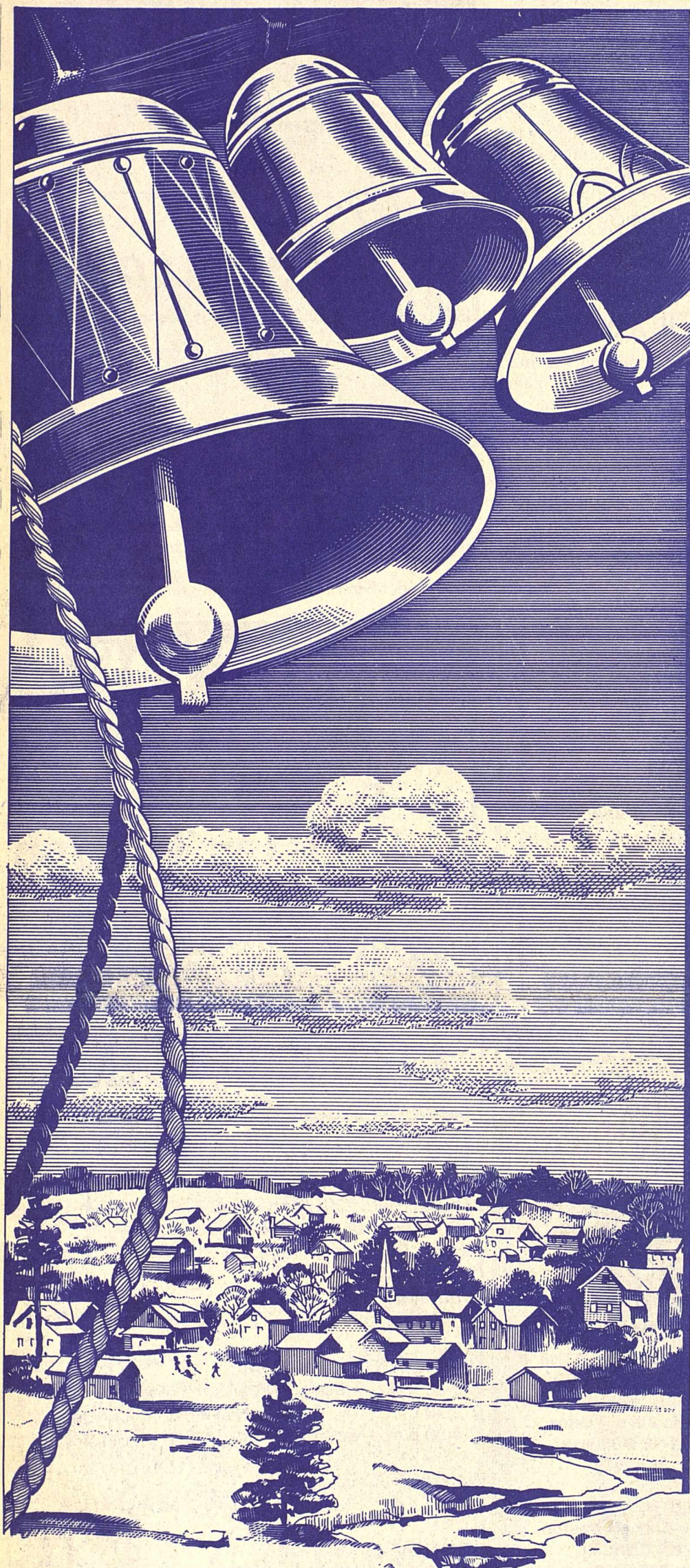

Ask The Historical Society

Q. I am researching my family tree and was wondering how your county got its name? Was it named for a person? If so who was that person? Charlie Sutton, McPherson, KS

A. Sutton County was created in 1887 from Crockett County. Sutton County was organized in 1890. Sutton County was named after Lt. Col. John S. Sutton, of the 7th Texas Cavalry of the Confederate States of America. He had been a member of the Texas Santa Fe Expedition and of the Mier expedition.

A memorial marker erected in his honor states the following: County named for Texas Confederate Colonel John S. Sutton, 1812 to 1862. At outbreak of Civil War, this veteran soldier, ranger, Indian fighter, joined 7th Regiment, Texas, Texas Mounted Volunteers. Elected Lt. Colonel, led five companies Arizona-New Mexico Campaign, designed to make Confederacy an ocean to ocean nation. Mortally wounded in battle of Vas Verde while leading a rifle assault against enemy cannons. He refused immediate aid and motioned on his battalion, which

captured the battery.

Q. Who are the officers of the Sutton County Historical Society?

A. Eddie Sawyer, President; Virginia Epps, Vice-President; Al Elliott, Treasurer; Jo-Ann Palmer, Secretary.

Q. How can I join the Sutton County Historical Society?

A. By sending a check for 10 dollars made out to the Sutton County Historical Society, to Al Elliott, Treasurer, Sutton County Historical Society, P.O. Box 885, Sonora, TX 76950-0885. All members, in good standing, are sent notices when meetings are to be held.

Q. Does the Sutton County Historical Society accept donations?

A. Yes. Donations and memorials should be sent attention Al Elliott, Treasurer.

Q. How does the Sutton County Historical Society raise money?

A. We are dependent on dues, donations, memorials and for building restoration grants. We do occasionally hold a raffle or some other type of fund raiser. Dues and donations are a very important part of our budget as we must pay insurance and upkeep on our buildings plus every day

operation expenses.

Q. What are you doing to the Miers Home Museum? I rode by it the other day and it is all torn up?

A. The Miers Home Museum is being restored to what it looked like when it was first built in 1890. When finished it will represent a true 1890's home in Sutton County. If you ride by you will note that the building at first was not painted. The finish in exposed areas is untouched. We have also uncovered the window and door frames that have been changed through the years. The outside stairs did not exist in 1890 nor the upstairs door and this will be eliminated.

The foundation has been covered by eroding dirt over the years and is being dug out

and a retention wall built to keep this from happening again. The dirt had built up so badly that the living room addition floor was totally rotted out as were parts of the walls and window frames. Luckily the main part of the house had a higher foundation and was not damaged as badly.

I think when it is finished people will really be pleased with the restoration and that students touring the museum will get a true representation of an 1890's home.

AIR QUALITY REGULATIONS MEAN CHANGES

Residents of Sutton County must now go through some extra steps before the Texas Department of Transportation is allowed to issue motor vehicle registration to them. This action is required by a new federal law that regulates air quality in Texas.

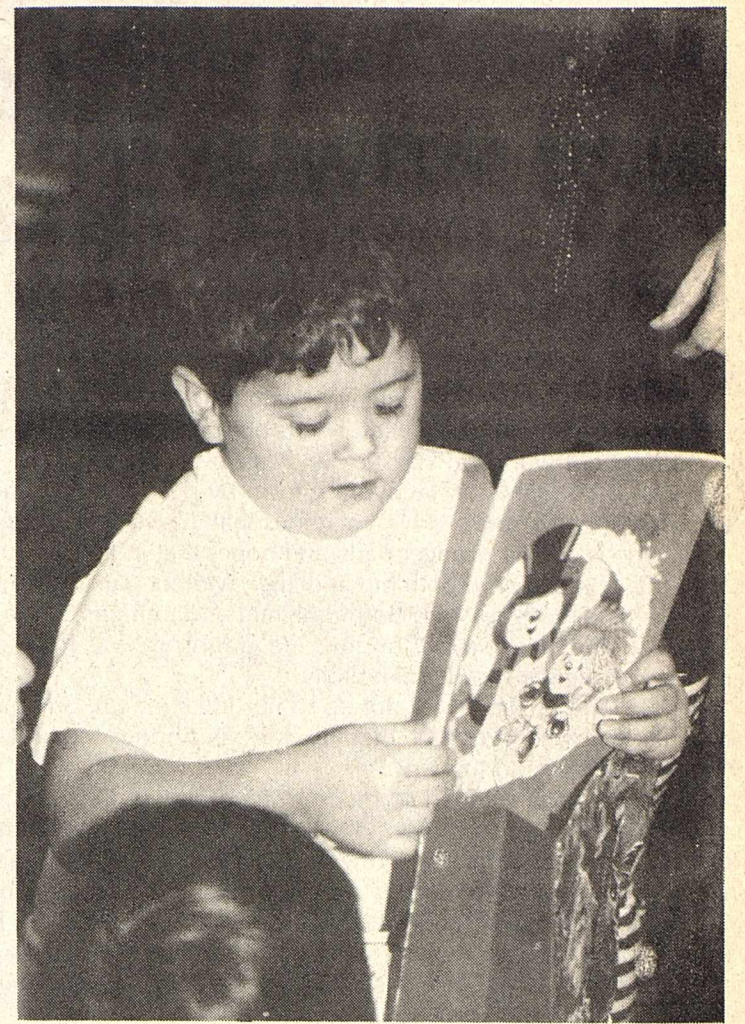
The federal government has identified several metropolitan areas where the level of air pollution is serious: Dallas/Fort Worth, Houston, Beaumont/Port Arthur and El Paso. Vehicle emissions testing will be required in counties that fall within those four areas.

Even though an emissions test will not be required in Sutton County, motorists will still have to prove that is where they actually live and are not trying to dodge the law.

The Sutton County Tax Assessor-Collector's Office is a statutory agent of the Texas Department of Transportation and has the responsibility of verifying a motor vehicle owner's address. The following documents or copies will be accepted as proof of residency: voter registration card, driver license, utility or phone bill, property tax statement or receipt, school tuition receipt or valid proof of liability insurance. One of these items must be presented whether the motorist is obtaining registration by mail or in person.

House Bill 1969, enacted by the Texas Legislature in 1993, authorizes the collection of a 25¢ fee by tax assessor-collectors in counties where motorists must show proof of residency. This fee is compensation for the mandatory need to confirm the required residency documentation.

TAEX DISCLOSES REPORTS

ECONOMICAL CONTROL OF CEDAR

Ashe and redberry juniper, commonly referred to as cedar in polite circles and other things in the pasture, is becoming the major brush problem in West Texas. Approximately 10 million acres is infested with blueberry (ashe) juniper and 12 million acres with redberry juniper; most of this infestation occurs on the Edwards Plateau and Rolling Plains resource areas of Texas. This pest is severely reducing stocking rates on the area in general and making it difficult to impossible to work stock in heavily infested pastures.

Many methods of control have been used to curb cedar densities including axing, chaining, grubbing, and burning. Grubbing with crawler type tractors has been popular with many ranchers but a cost of forty dollars per acre or more makes this a prohibitive practice. During the past several years, the most cost effective method of juniper control has been one-way chaining followed by burning one to three years following the chaining.

The cost of one-way chaining is about 10 dollars per acre; the cost associated with building fire guards will generally be less than two dollars per acre. On a ranch in Schleicher County, a pasture of 679 acres was chained one way at a cost of 10 dollars per acre. Fire guards were dozed around the entire perimeter of the pasture and a second fire guard, 500 feet inside of the outer fireguard was dozed on the north and east side of the pasture. The total cost of the fireguards was \$1.67 per acre.

Blacklines, the area between the outer and inner fireguards on the north and east side of the pasture, were burned in late January under "cool" conditions. The conditions for the blackline burn were 80% relative humidity, air temperature of 67 degrees and a wind speed of 6-8 mph. Ideal conditions for burning these blacklines would be a relative humidity of greater than 50%, air temperature of less than 35 degrees and a wind speed of 6-10 mph.

The main fire on this pasture was burned the first week in March. Conditions for the head fire were a relative humidity of 20-25%, air temperature of 75-80 degrees and a wind speed of 8 mph out of the southwest. The main fire was very hot and successfully controlled most of the cedar in the pasture.

Final counts of dead cedar showed a 36% mortality on the blackline area and a 92% mortality on the rest of the pasture. The total cost of doing the chaining and burning was \$11.67 per acre. The cost of resting the pasture before the fire to grow grass for the burn or after the fire to allow grass to recover was not included in the total cost of the brush work. Deferment cost associated with chaining and burning are real costs and should be figured in when planning what total costs actually were.

For those ranchers considering chaining and burning, it is essential that double fire guards be used to insure adequate conditions for both the blackline and the head fire. With double fire guards, blacklines can be burned with "cool" and safe conditions. optimum conditions can then be chosen for burning the head fire to get maximum control of the cedar.

Ranchers must also consider the costs associated with resting pastures prior to and after the fire. To be effective, fires must have an adequate fuel load of 1500-2000 pounds per acre. In some instances, it will require a full growing season rest to grow this much fuel and on a very shallow, poor country, two grazing season rests may be required.

All in all, chaining and burning for cedar control are not cheap but may prove to be far less expensive than other control measures.

Beginning in 1986, the Texas Agricultural Extension Service (TAEX) took a comprehensive look at the issues that were of greatest concern to Texas citizens. The resulting effort, the Long-Range Extension Program, provided a valuable blueprint for the TAEX as it moved into issue-based programming.

Issues related to the economy, the environment, health and the development of life skills and leadership qualities continue to evolve, altering the climate in which the TAEX will provide educational programming. Some issues are identified which require interagency support or legislative action. The TAEX supports these concerns and welcomes the opportunity to network with others in developing solutions to the critical concerns of our citizens.

The planning process involves 40-50 local citizens in an in depth planning effort led by group discussion volunteers and an overall moderator. The first planning meeting was held in 1986 with 53 volunteers, and the second LREP meeting was held with 48 volunteers present on April 30, 1990. The process was repeated on April 25, 1994, with 43 volunteer planners.

Examples of issues identified in the past and successful action taken include: 1) Medical facilities and Health & Wellness Education-formation of the Hospital District, organization of an annual County Health Fair, monthly programming for the Senior Center and W.I.C. program, and 4-H Foods and Nutrition training. 2) Predator Management-formation of Sutton County Predator Management Association, the formation of the Sutton County Collar Pool, and county finding for 2 predator management specialists, and 3) Revitalization of Main Street, Recycling and Economic Development-Texas Community Assessment Plan, Texas Main Street Community Program, and economic development seminars and schools such as the Total Ranch Management School attended by over 25 local ranchers.

The six issues identified most recently which will be addressed from 1995-1999 are: 1) Agricultural Profitability and Sustainability, 2) Parenting, 3) Life Skills and Leadership Development, 4) Political and Legislative Awareness, Education, and Involvement, 5) Economic Diversification and Industrial Development, and 6) Adult Nutrition and Proper Exercise.

Printed reports explaining these issues of concern, the volunteers who identified them, state issues and methods for addressing them are available at the County Extension office. In addition, a printed report of actions taken to address issues identified in the 1987 and 1991 LREP's is also available.

STOCK SHOW TIME IS NEAR

SUWCD TO MONITOR WELLS

submitted by *Sutton Underground Water Conservation District*

The Sutton Underground Water Conservation District will be conducting the annual monitor well program starting the last two weeks of January. Over 30 constituents in approximately 20 wells will be tested. These results will then be compared back to the results of three years ago. This will enable the district to look for any significant changes in water quality.

The district is continuing to register all wells within Sutton County. This is mandated by state law. Landowners will continue to be contacted as time allows to coordinate the registration. If you have not been contacted, please notify the district office as soon as possible.

The new legislative session gets underway in January. Legislation concerning water issues is expected to come out of this session. The district will keep informed of any legislation which may affect this county by attending several hearings throughout the session.

Studies are underway in the High Plains to provide an Ogallala Aquifer Management Plan. They feel by implementing water conservation (irrigation practices with efficiency rates of 70-90%) and augmentation (cloud setting) agriculture products could be increased by \$500 million. The Ogallala comes as far south as Ector, Midland, and Glasscock counties.

FYI: In the U.S. lawns occupy more land than any single crop, including wheat, corn, or tobacco. Homeowners use 10 times more chemical pesticide per acre than farmers. As much as 60% of water in Western cities is used for lawns; as much as 30% in Eastern cities. Of the 34 major pesticides commonly used on lawns, 32 have not been tested for their long term effects on humans or the environment. - *Newsweek*

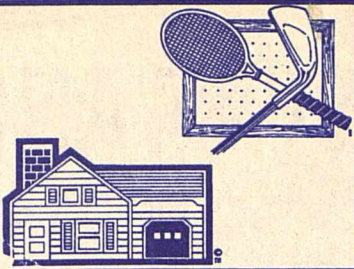

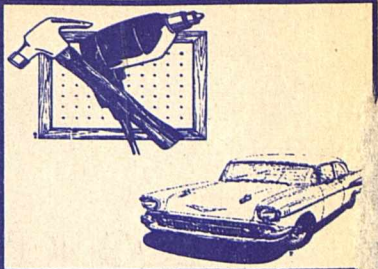
