Runnels County Precinct 2 Justice of the Peace Joyce Weems resigns after ten years of service

A fixture in Runnels County government for nearly ten years, Precinct 2 Justice of the Peace Joyce Weems has resigned her position effective the end of this month.

Weems began her JP duties on January 1, 1991. Since that time she has handled all the precinct's traffic citations from the Texas Department of Public Safety and Runnels County Sheriff's office.

In addition she had processed all Class C misdemeanors and felony complaints; pronounced all unattended deaths; served as a magistrate to juveniles; and set bonds at the Runnels County Jail. Weems says the biggest reason

she became Justice of the Peace is because she always found law enforcement interesting. Joyce and her late husband Johnny worked closely with local government officials for 28 years as owners of Winters Wrecking Service. With that experience, Weems said, "I thought I would enjoy it."



And enjoy it she has. "I've met a lot of good

people, worked with good people—met interesting people," said Weems. "I've enjoyed everybody I've worked with. Everybody's been so nice and so good."

"Other than the deaths (she's

had to pronounce) I've enjoyed everything I've done. Everyday, every case, every person was different. It's always been real interesting," she adds.

In her ten years, Weems admits she's heard it all. "I've heard everything—all kinds of tales. It's always somebody else's fault. Nobody ever did anything," she laughs.

"You deal with all kinds of people. I've tried awfully hard to be fair to all these people. They all deserve the same fairness and treatment."

"I have taken the time for each of these people. They may have

Grandmother charged in child's death

Indictment issued for 1999 fire incident

Margaret Brockington, 43, of Winters, was arrested Friday, Nov. 17, in connection with the death of her grandson, Dalvin Huffman. The 5-year-old died of smoke inhalation on March 27, 1999, when the house in which he and his grandmother were sleeping caught fire.

The fire was investigated as an arson and a homicide, and authorities indicated the State Fire Marshal's office had proved the fire was the work of an arsonist, but was initially unable to gather enough evidence to identify that person.

Brockington, who escaped uninjured from the burning house, told members of the Winters Police Department that she was sleeping in the front room of the wood frame house at 311 Wood Street. The child was apparently sleeping in a middle bedroom near

the rear of the house, close to where the fire began.

According to Fire Chief Jack Davis, Jr., members of the Winters Volunteer Fire Department responded in three minutes after receiving two 911 calls from neighbors who reported the 12:30 a.m. blaze.

"The fire originated in the rear of the structure and no accidental cause could be determined," said Alfredo Sanchez, a sergeant with the Winters Police Department at the time of the incident.

The incident has been investigated by members of the Winters Police Department, along with the Runnels County Sheriff's Department and the State Fire Marshal's Office. Winters Officers Terry Johnson and Jeff Whitaker arrested the suspect at her residence around 4:30 Friday afternoon.

She was indicted by a 119th

District Grand Jury Thursday on charges of injury to a child. She was taken to Runnels County Jail where she was held until released after posting bond of \$50,000 that same day. She is scheduled to appear in District Court for arraignment on December 4.

The indictment, filed in the Runnels County District Clerk's Office, alleged Brockington failed to provide proper care for her grandson by leaving him alone with no supervision.

Because he was left alone without supervision, he died from smoke inhalation, according to the indictment.

The child was taken by ambulance to North Runnels Hospital where medical personnel worked for about an hour in an unsuccessful effort to revive him. The body was sent to the State Medical Examiner's Office in San Antonio for autopsy.

Blizzards named to All-District teams

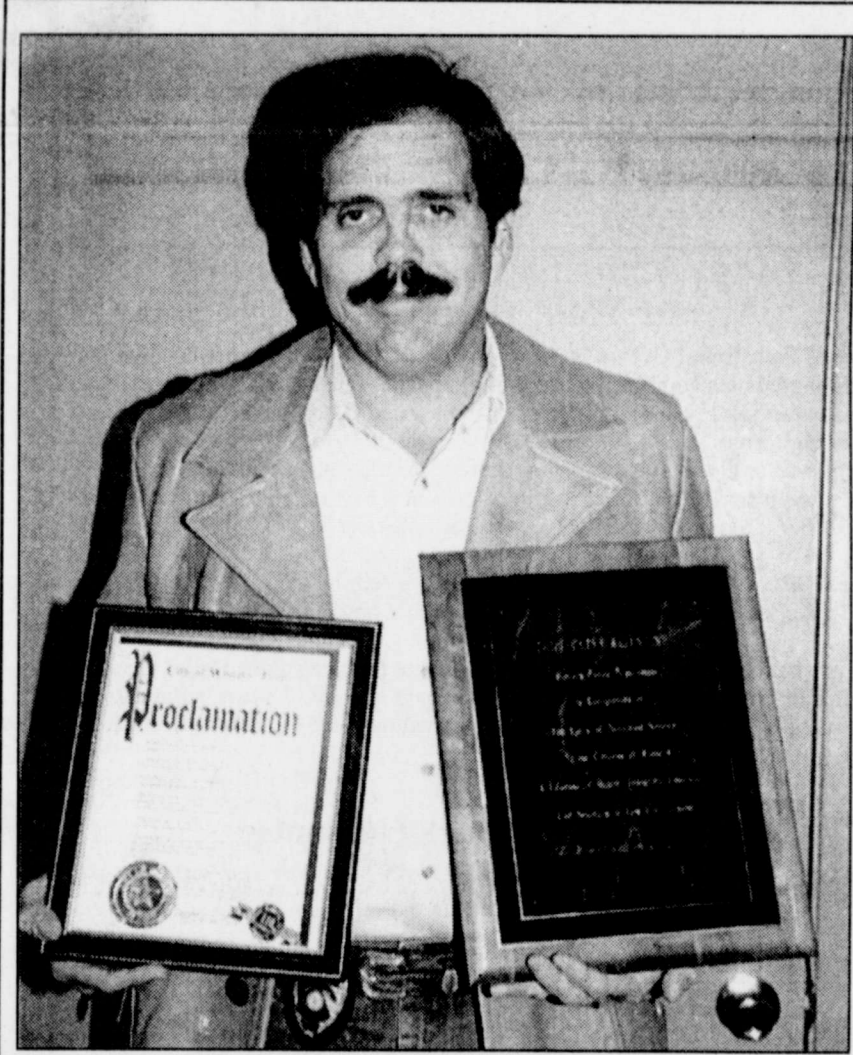
Eight members of the varsity Blizzard football team have received All-District recognition.

Two die in automobile accident near Miles

A Ballinger woman and a Talpa man were killed as the result of injuries suffered in an automobile accident on Highway 67 last Friday morning, November 17, 2000. The accident occurred just inside the Tom Green County Line, near San Angelo Feed Yard.

Monroe Werner, 85, of Talpa, was pronounced dead at the scene by Tom Green County Justice of the Peace Jerry Jennison.

Mildred Lee, 78, of Ballinger, was airlifted to Shannon Medical Center in San Angelo where she was pronounced dead, according to Texas Highway Patrol Trooper Roger Looka, who investigated the accident.

The accident happened around 11 a.m. when Rex Allen, 49, of Hugo, Oklahoma, drove his tractor-trailer out of the feed yard onto Highway 67, crossing the southbound lane of the highway. As he stopped to allow a car to pass, his trailer remained in the

southbound lanes of the highway.

Werner, driving a 1985 Ford Crown Victoria, was traveling south and as he came over a hill was unable to stop, colliding with the trailer, according to Looka. The impact pushed the cattle trailer some 10 feet sideways.

San Angelo firefighters used the Jaw of Life to remove the driver's side door and Werner's body from the vehicle. Looka said a witness to the accident said another car was able to go around the trailer before Werner's vehicle hit it. Werner's vehicle left a 140-foot skid mark before hitting the trailer.

Lee was a passenger in the vehicle and was Werner's caretaker.

The Quail Valley Volunteer Fire Department, Miles Volunteer Fire Department, Tom Green Sheriff's Department, and the Texas Department of Transportation assisted in the accident.

Oil Bidness

We saw it happen recently in internet stocks, and now it is happening right here in the oil and gas business.

You may recall that, before the latest reversal of fortunes in internet companies began, there were hundreds of Initial Public Offerings (IPO's) hitting the exchanges for any company with a ".com" in its name. Companies were eager to tap the higher market price for these offerings while the gettin' was good.

Companies could raise billions by starting a company or spinning off a company with an IPO. The cash could be used to buy other companies or expand in other ways.

Now, oil and gas companies are starting to see some improvement in their own share prices. There is also a strong optimism beginning to dominate the financial view of the industry.

The result is that companies are looking at ways to benefit from the rising tide.

Some companies are using their improved share price to buy companies whose shares have yet to improve in price. Others are creating newly traded entities through IPO's.

Just as internet companies were doing several months ago, some oil and gas companies are spinning off companies, while others are entering the public arena for the first time. While the enthusiasm for petroleum companies will never reach the euphoric levels of internet stocks, these old

economy stocks are being looked at in a more positive way these days.

And, it's not just higher stock prices and optimism. A company producing oil and gas is now producing large amounts of cash. It is there, financial analysts know it, and it needs to be invested. By issuing new stock or going public for the first time, a company can leverage its new cash piles into bigger piles and make new acquisitions or kick off more ambitious projects.

New companies going public stand to benefit the most. A company with big cashflow, an optimistic investing public, and increasing valuations in comparable companies is set to reap rewards that will not be there at the bottom of the cycle. Now is an opportune time to sell a piece of a company.

Just think about the fundamentals. Oil prices have tripled from two years ago. Gas prices are higher than they have ever been and winter isn't even here, yet.

As a simple analogy: if you owned a 55-gallon drum of gasoline, would you rather sell it now or wait until gas prices go below a \$1 a gallon again?

Simple, isn't it?

Medicare supplement program to be offered to Runnels County retirees

In a short, five-minute open session on Tuesday, Runnels County Commissioners approved the Blue Cross-Blue Shield County Choice Silver program to be offered to county retirees.

The program costs the county nothing, and the county will pass along names of those retired or who will retire to the company, along with birth date, to allow them to offer the program, which is a Medicare supplement.

Following approval of minutes of the previous meeting, current accounts, and the health program, Commissioners moved into closed

session to consider applicants for the Precinct 2 position of Justice of the Peace. That position is being vacated by Joyce Weems at the end of this month.

Following the executive session, Commissioners voted to authorize County Judge Marilyn Egan to contact five applicants for an oral interview on Monday, November 27.

All commissioners, County Judge Marilyn Egan, County Auditor Darlene Smith, and County Treasurer Margaret Smith were present for the meeting.

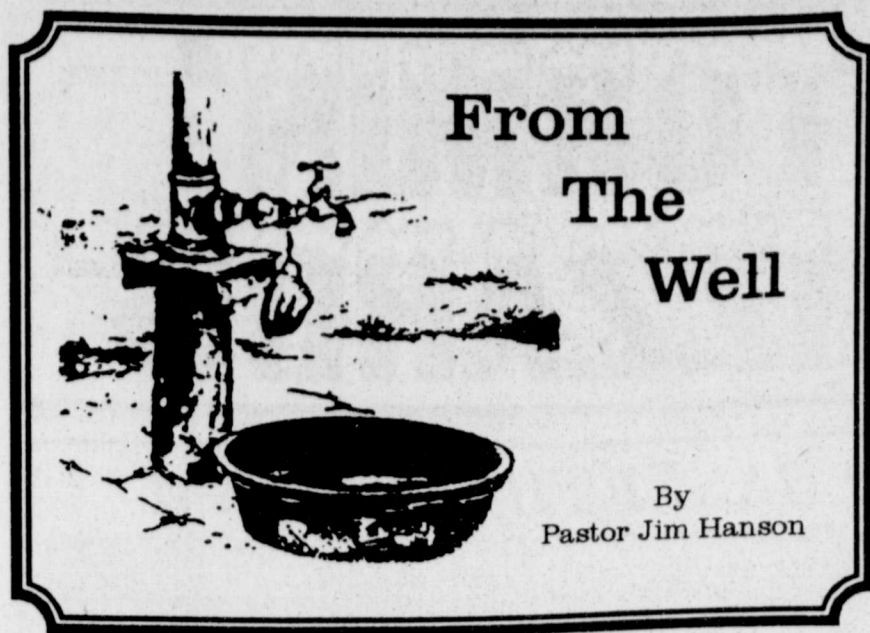

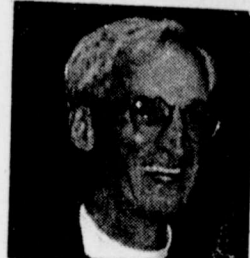

From The Well

How can I say thanks? Every Thanksgiving she sang it. Up in Northern Minnesota. When she did, I was always on the verge of tears. Because of my failure...to give thanks. And when she sang it, I thought of all the opportunities I had had in which

to give thanks. It's really quite a song. It is called "My Tribute." The opening lines are:

"How can I say thanks for all the things You have done for me? Things so undeserved, Yet You gave to prove Your love for me; The voices of a million angels could not express my gratitude. All that I am, and ever hope to be; I owe it all to Thee."

And then the praise:

"To God be the glory, To God be the glory, To God be the glory for the things He has done."

Wow! Such a thanksgiving...to God! And then these lines:

"With His blood He has saved me; With His power He has raised me; To God be the glory for the things He has done. Just let me live my life...Let it be pleasing, Lord, to Thee; And if I gain any praise, Let it go to Calvary. With His blood He has saved me; With His power He has raised me; To God be the glory for the things He has done."

Even when there has not been enough rain to make a crop. And prices aren't what they should be. When times are tough...God's people give thanks. People like Martin Rinkart, who wrote the hymn "Now Thank We All Our God." He lived in the worst of times. The 30 Years War. 1618-48. A war that has been described as the most devastating in all history.

Called at the age of 31 to pastor the state Lutheran church in his native city of Eilenberg, Germany, he arrived just as the dreadful bloodshed began. And spent the remaining 32 years of his life faithfully ministering to those needy people.

It was a "religious war," not unlike the one in northern Ireland. Catholic and Protestant. Not a war of words, but of military might. Forces from both sides came to Germany and fought their battle there. In those years the population of Germany dwindled from 16 million to 6 million. Because Eilenberg was a walled city, it became a refuge for political and military fugitives from all over. During these years of war, waves of deadly diseases and famine swept the city. The various armies marched through town, leaving death and destruction behind them. The plague of 1637 was particularly severe. When it was worst, Rinkart was the only minister left in town to care for the sick and the dying. It is said that 10 thousand died during that plague, and that Rinkart buried all of them...many times in mass burials...30 at a time.

It was after this plague that he wrote:

"Now thank we all our God with hearts and hands and voices, who wondrous things hath done, in Whom His world rejoices; who from our mothers' arms hath blessed us on our way with countless gifts of love, and still is ours today.

"O may this bounteous God through all our life be near us, with ever joyful hearts and blesses peace to cheer us; and keep us in His grace, and guide us when perplexed, and free us from all ills in this world and the next.

"All praise and thanks to God the father now be given, the Son and Him who reigns with Them in highest heaven...the one eternal God whom earth and heaven adore...for thus it was, is, now, and shall be evermore."

"How can I say thanks?" Like Andrae Crouch. "Give God the Glory." Like Martin Rinkart. "Now thank we all our God..." "Just do it." "Say it." "Sing it." "Shout it!" And discover the joy of receiving God...in "giving thanks..." to Him. And may He bless your Thanksgiving.

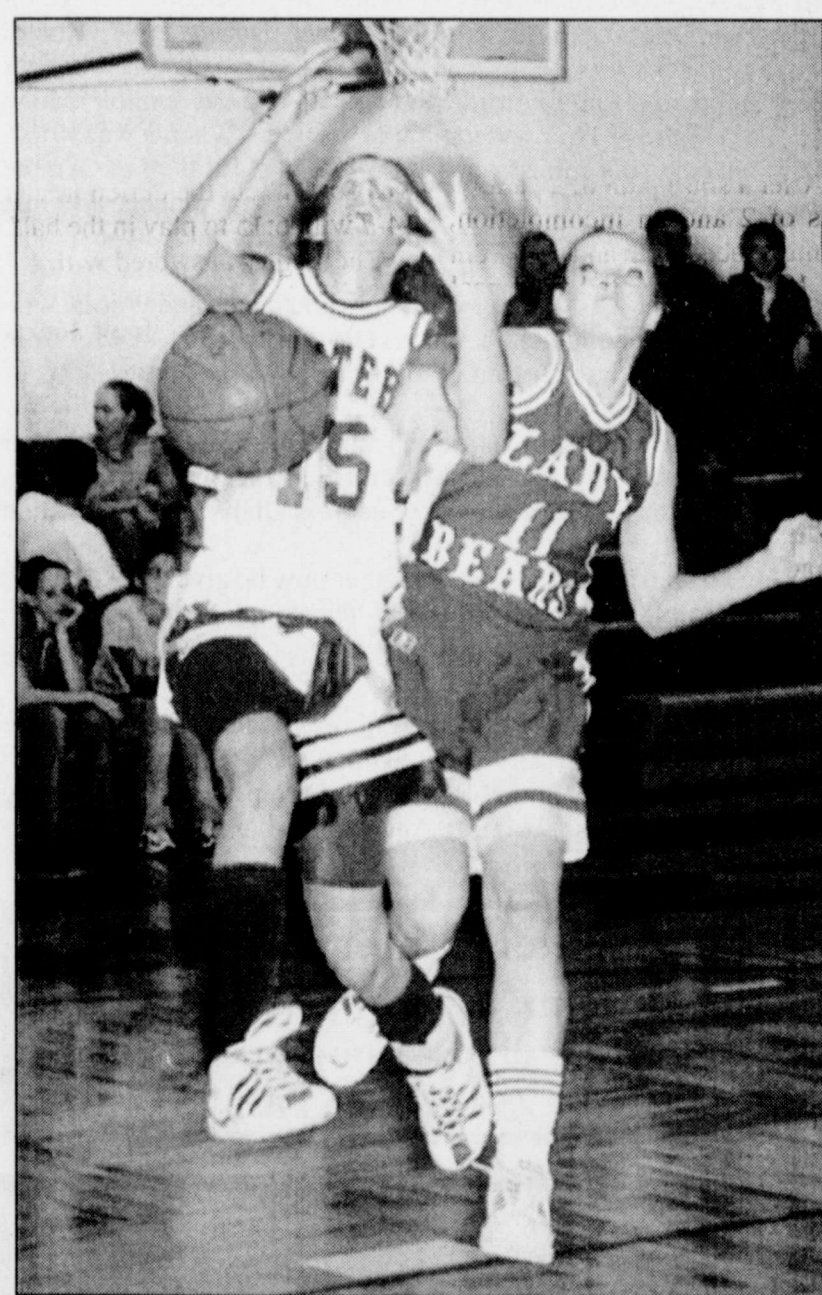

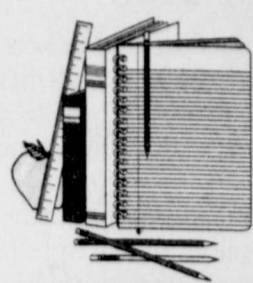
LACI WALKER of the varsity Lady Blizzards receives the back foul as she goes for the lay up against the Lady Bear from Baird.

Blizzards drop bi-district contest

Season ends with 21-7 loss to Goldthwaite Eagles

It was a strong, consistent Goldthwaite ground game that eventually spelled doom for the Blizzards in bi-district playoff action Friday night.

The Eagles rushed for 243 yards on 54 attempts while throwing the ball only four times for 61 yards.

Winters won the toss and elected to receive. Zeke Martinez set the Blizzards up on their own 39 yard line after a short return. The first series was to be a 3 and out for the Blizzards after a short gain by Chris Yanez, and an intentional grounding penalty brought up 4th and 25 on their own 24 yard line.

After the Josh Minzenmayer punt, the Eagles began at the mid-field stripe. They proceeded to go three and out also after a blitz by Aaron Pritchard on third down to bring up 4th and 12.

The Blizzards took over at their own 27 after the Goldthwaite punt. Winters then put together a 10-play drive that looked very impressive as they gained four consecutive first downs.

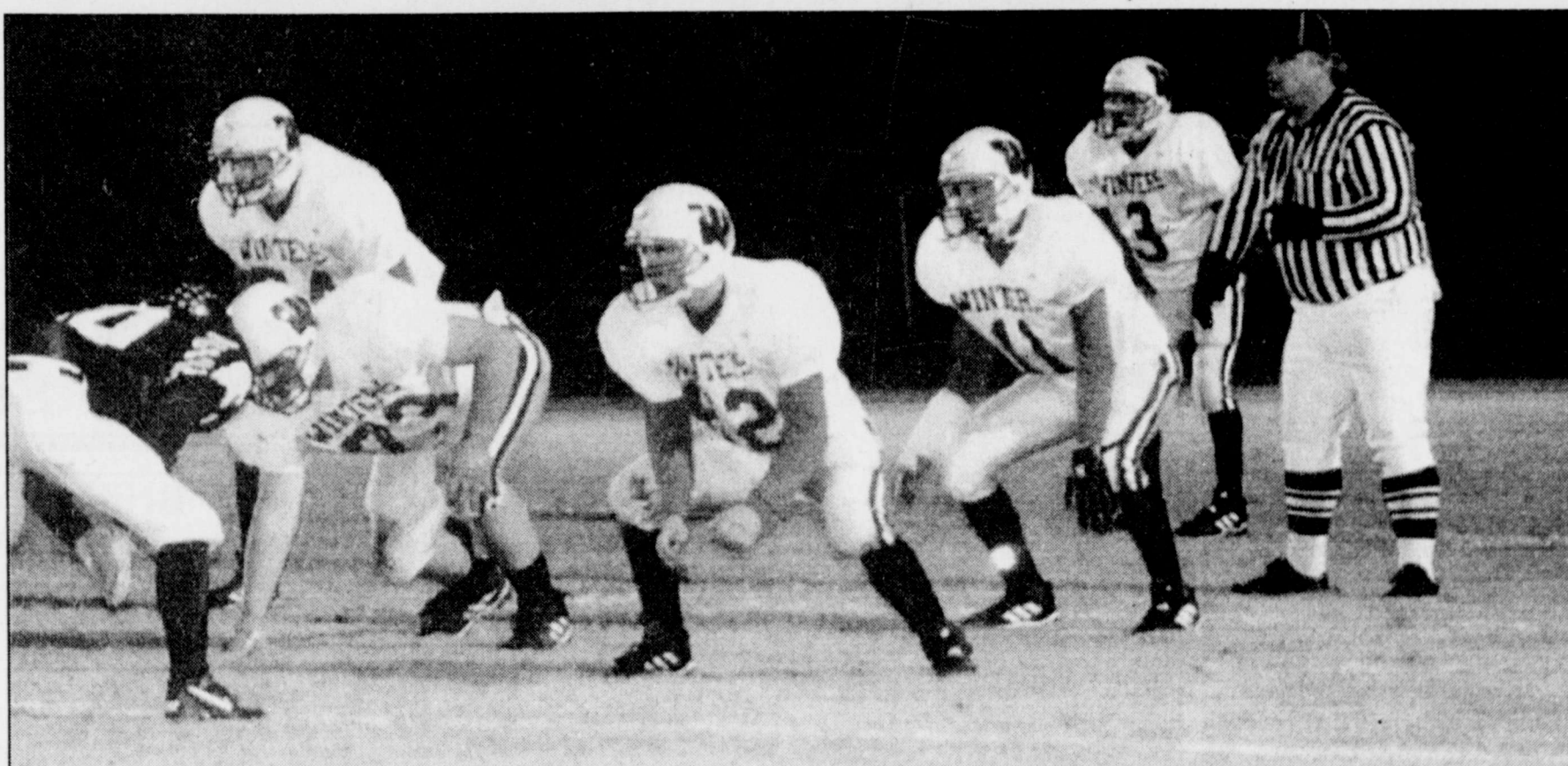
During this drive, Minzenmayer found Aaron Pritchard for 32 yards to the Goldthwaite 41 yard line. On the next play, Mark Moreno ripped off 13 yards to the 27, then Yanez carried for five more. Moreno added 12 more yards to put the Blizzards at the 10 yard line with a first and goal. However, this is where the drive stopped.

After a short gain of 2 yards, a loss of 2 and an incompletion, Winters faced a 4th and goal from the 10. The attempted field goal was missed.

After the failed field goal, the Eagles took over on their own 20 yard line. The first play was a strange one; a quarterback sneak for 45 yards to the Blizzards 35 yard line. The Big Blue then appeared to shut the door on the Eagles, bringing up 4th and 18 from the Blizzards 33 yard line.

The Eagles chose to try and convert — and convert they did, with a 33 yard completion and 6 points with 1:49 to go in the first quarter. The extra point was blocked by Andrew Medina.

The next series brought a 3 and out, and the punt set the Eagles up at the Blue 40 yard line. Six plays into the second quarter, the Eagles struck paydirt again with a one yard run. The try for two was good, pushing the Eagle lead to 14 with 7:52 to go in the half.

The next Winters possession appeared to right the ship as the Blizzards resorted to some trickery to find success. On first down from the Winters 37 yard line, Pritchard gained eight yards on an end around. After two short gains by Moreno, Pritchard would shine again on an end around pass completion to Wade Parramore who broke two tackles to cover the 54 yards for the touchdown.

Jeffery Oats' extra point kick was good to cut the deficit to 7 at 14-7 with 6:15 to play in the half.

The Eagles answered with a 7 play drive to the Blizzards 11 yard line when an alert Joey Joeris pounced on the Eagle fumble to shut the door on the Goldthwaite threat.

The Winters bunch then began a 10 play drive highlighted by a Minzenmayer quarterback draw for 11 on 3rd and 6. A 44 yard completion to Parramore brought up 1st and 10 at the Goldthwaite 19 yard line with 1:03 left in the half.

After a Minzenmayer run for five, the drive stalled and a failed 29 yard field goal attempt left the Blizzards empty-handed. The half ended with the Eagles on top 14-7.

The Blizzards kicked off to begin the second half. The Eagles kept the ball for 6 minutes and 15 seconds while putting together a 12 play drive that culminated in a 2 yard run for the touchdown with

5:45 left in the third quarter. The extra point was good and the Eagles led 21-7.

The next series for the Blizzards was short. On second and 16 Minzenmayer's pass was tipped and intercepted by the Eagle defensive back near midfield. After six plays, the Eagles punted on 4th and 19 as the Big Blue Wrecking Crew rose to the occasion. This series brought the end of the third quarter and a 21-7 Goldthwaite lead.

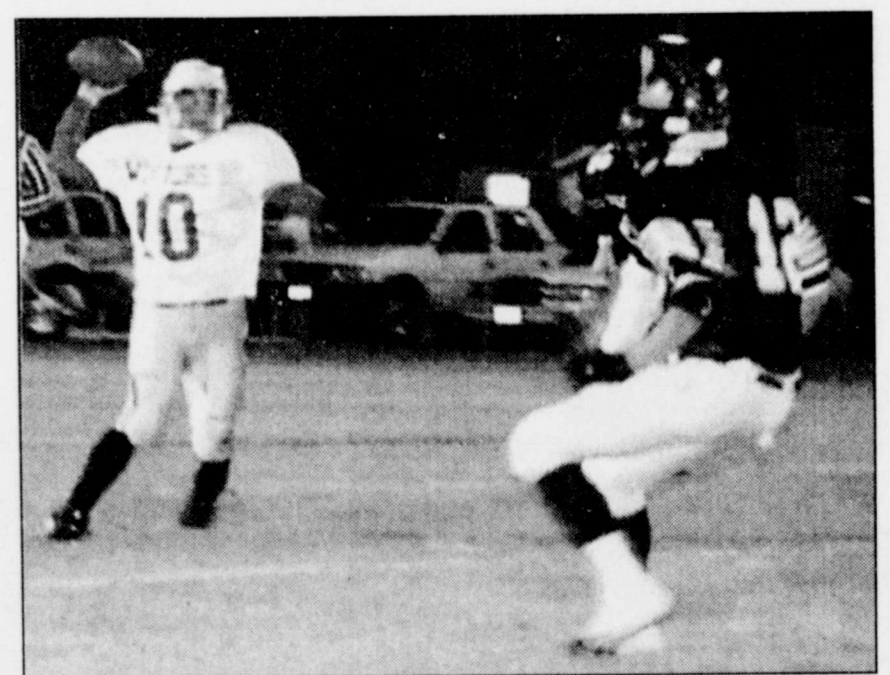
The fourth quarter was spent in futility as the Blizzards pulled out all the stops and tried to create miracles on each possession.

The Eagles, on the other hand, were content with their 14 point lead and stuck with the basics of the ground game.

The game and the season ended for the Blizzards with a 21-7 loss to the Eagles.

Police Beat

Some of the information is provided to police by citizens, and in some cases, police have not finished investigating the reports. These reports make up a small percentage of the total calls the Department receives and responds to each week.

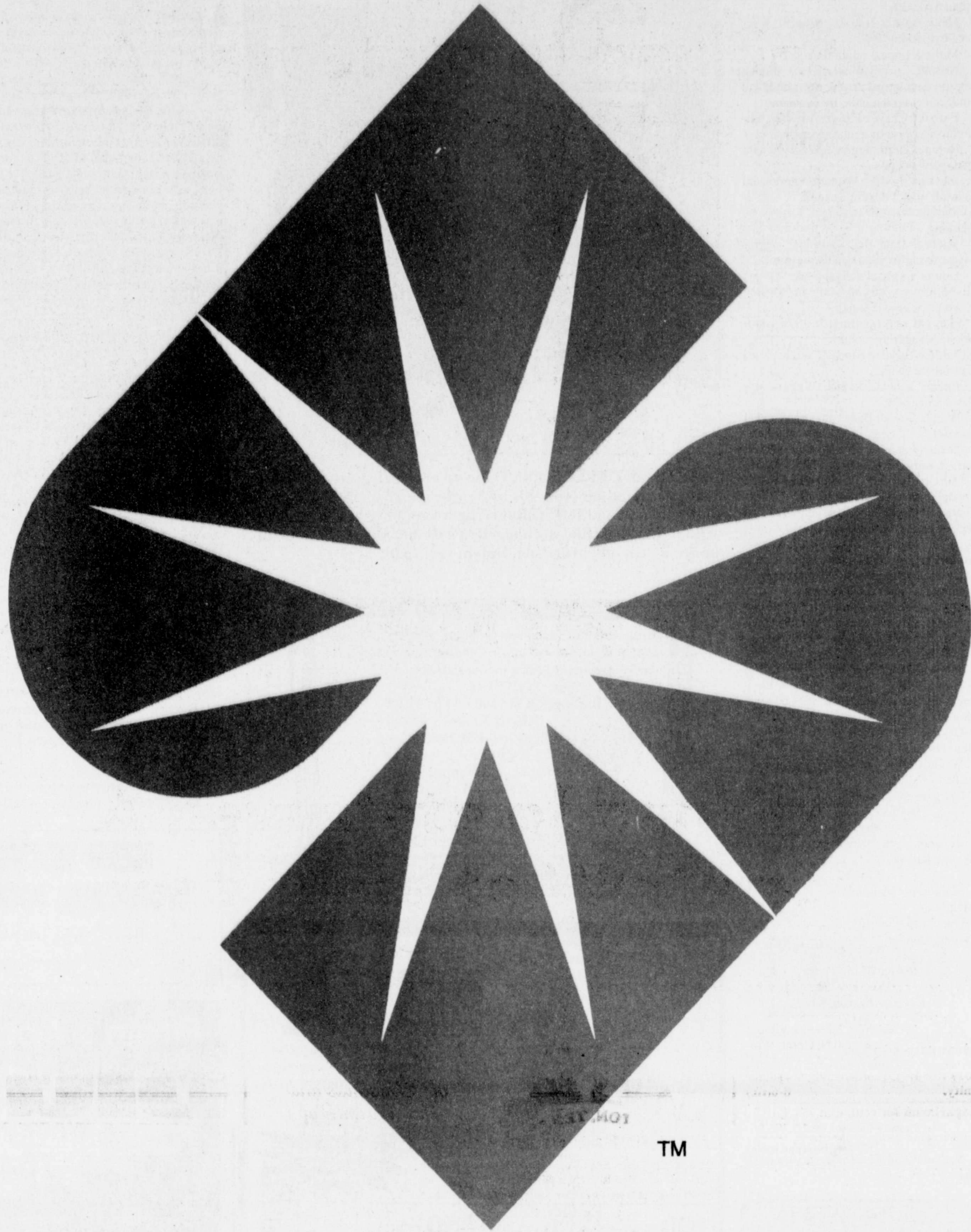



A committee has been formed through the West Central Texas Council of Governments to organize a West Central Weather Modification Association, primarily around Abilene. Counties have until December 1 to make a commitment to participate in the program.

The cost to Runnels County to participate in the cloud seeding program is \$58,154 per year for four years. The cost formula is based on total acreage, total population, and county retail sales. The state will pay \$30,447 of this amount and the county commissioners have pledged \$17,000. This leaves \$10,707 income from other sources.

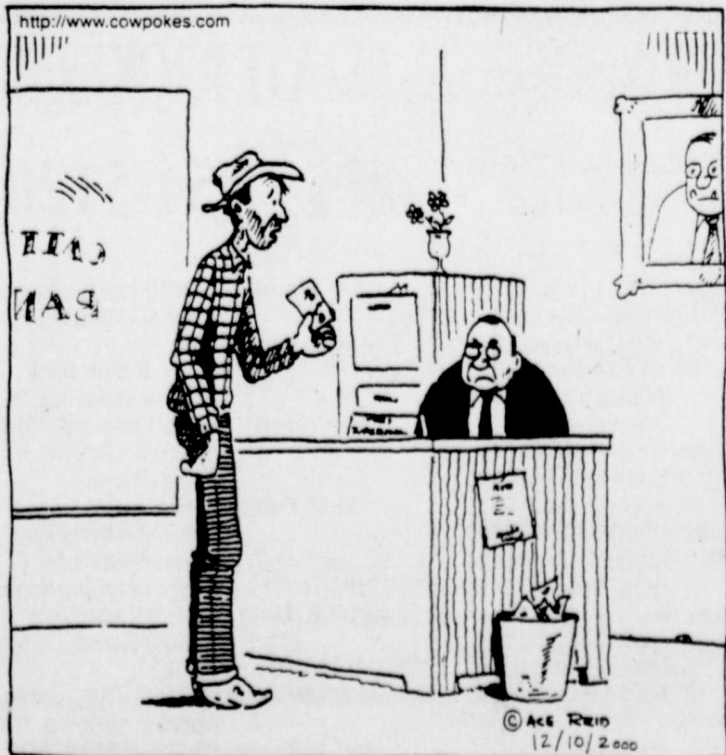

Helpful tips for holiday leftovers

The holiday season typically includes a special time spent dining with family and friends. If asked what we planned to make for that holiday meal, many of us might answer: food and plenty of it.

Because households typically prepare an abundance of food for the Thanksgiving feast, there are always leftovers. Of course, leftovers are great for following meals but there are precautions to follow. Here are tips on how to handle the leftovers. Here are five ACTION STEPS to take with leftovers:

1. Leftovers must be refrigerated or frozen within two hours from time of service.

TWO hours is the maximum time perishable foods should be at room temperature. This INCLUDES the time they're on the table during your meal. Just ONE bacterium, doubling every 20 minutes, can grow to over 32,768 bacteria in five hours!

Perishable foods include:
•meat, poultry, and seafood
•dairy products
•cooked pasta, rice and vegetables; and
•fresh, peeled and/or cut fruits and vegetables.

Also, if food is left out too long, some bacteria, such as *staphylococcus aureus* (staph), can form a heat-resistant toxin that cooking can't destroy.

One of the most common sources of staph bacteria is the human body. Even healthy people carry staph in the nasal passages, throats, and on the hair and skin.

Most likely, the only way you'll know if a food contained staph bacteria is when someone gets sick. Say farewell to your leftovers if you can't refrigerate or freeze them within TWO

hours. Or prepare defensively to eliminate large amounts of leftovers.

2. Cool leftovers quickly in shallow containers in your refrigerator.

Key points in cooling hot leftovers include:

1. Refrigerate and cool leftovers in shallow containers; limit food depth to about 2 inches.

2. Let the refrigerator cool leftovers. Protect hot leftovers from cross-contamination from other foods by storing them on the top shelf of the refrigerator. Cover them LOOSELY so the food cools faster; then, cover them tightly when they're cool.

3. Cold leftovers such as salads, pies, etc., should be covered and refrigerated immediately.

4. Store packages of raw meat, poultry, or seafood, on the BOTTOM shelf of your refrigerator so their juices don't drip onto your leftovers and other foods.

5. Food keeps best if your refrigerator temperature is 40°F or less. Buy appliance thermometers for your refrigerator and your freezer as a present to yourself for the holidays.

3. Eat leftovers in one to two days or freeze them for longer storage.

For best safety and quality, eat leftovers in a day or two. Or, freeze them at 0°F if you'd like to keep them longer.

Thaw frozen leftovers in the refrigerator, as part of the cooking process, or in your microwave.

If food is thawed in the microwave, cook it right away. Unlike food thawed in a refrigerator, microwave-thawed foods reach temperatures that encourage bacterial growth.

At 0°F, frozen leftovers are safe indefinitely; however the U.S. Department of Agriculture Food Safety and Inspection Service (USDA/FSIS) recommends most foods will have best quality if used within two to four months.

4. Reheat leftovers at 165°F.

Reheat leftovers to 165°F until they're steaming hot THROUGHOUT. At this temperature, harmful bacteria should be destroyed. Stir to promote even heating. However, remember as described in action step 1, certain toxins formed by bacteria can be heat resistant. It's still important to follow the "two hour rule" regardless of how high and how long you heat a food.

Beware of microwaving leftovers in the disposable foam containers like those used in restaurants for take-outs. At high temperatures, certain foam containers, may not be stable. It's possible that melting or warping may cause harmful chemicals to migrate into the food. USDA/FSIS gives these recommendations for safe containers and wraps:

1. Only use cookware that is especially manufactured for use in the microwave. Glass, ceramic containers, and all plastics should be labeled for microwave use.

2. One-time use containers should not be used in microwave ovens. These containers can warp or melt, possibly causing harmful chemicals to migrate into the food.

3. Microwave plastic wraps, was paper, cooking bags, parchment paper, and white microwave-safe paper towels should be safe to use. Do not let plastic wrap touch foods during microwaving.

4. Never use thin plastic storage bags, brown paper or plastic grocery bags, newspapers or aluminum foil in the microwave.

5. When in doubt, toss leftovers out.

Suppose you:
1. Left your take-home package of leftovers on the car seat overnight;

2. Let your leftovers sit over a week in the refrigerator; or

3. Forgot your frozen leftovers on the kitchen counter all day.

Is there any way to know if they're still safe to eat? You cannot SEE or SMELL most bacteria that might make you sick.

TASTING is risky and also won't tell if food is unsafe. For some bacteria, such as E. coli, even a tiny taste may be enough to make you sick. Plus, depending on the foodborne illness, it may take from about 1 hour to 6 or more weeks to get sick from contaminated food. By the time you know for sure a food was probably safe, it would be too old to eat!

That's why the advise most frequently given is: WHEN IN DOUBT, THROW IT OUT!

If you get sick soon after a meal, remember it isn't always the food that is the culprit. Overindulging during the holidays can cause some of the same symptoms as a foodborne illness, such as an upset stomach or nauseous feeling.
