Deputy Sheriff Rex Cowart went to investigate the fight. When he left Dimmitt, Deputy Sheriff Granville Martin drove in from Hart to back him up here. Sheriff Jack Cartwright was just driving into the city and was monitoring the activity on his police radio.

The fight was over when Cowart arrived at Tam Anne. The sister of Mrs. Zoila Luna Olivarez, 13, said three men who were intoxicated had come there to pick up Mrs. Olivarez to take her to Palo Duro Canyon with them, and that the women's father, George Luna, had tried to stop them. She said the youths had struck Mr. Luna in the head, then had taken Mrs. Olivarez and her 14month-old son, Johnny Joe.



"For God's sake, stop them before they get into town or they're going to kill somebody."

POLICE Chief W. W. Jones said this was the plea which Sheriff Jack Cartwright radioed to him at 9 p.m. Saturday, just before the 1963 Chevrolet came hurdling out of the darkness into the western city limits.

Officers weren't trying to pursue the car. They were trying to get it off the road. Jones and Patrolman Fred Moulton set up a road block in the city, "but they didn't even slow down," the police chief said. "They were running it wide open and were weaving all over the road."

The driver, Tony Guia, evidently had been "running it wide open" long before he knew he was being tailed by law officers. Mr. and Mrs. Juan Martinez reported the speeding car had run them off the highway five miles west of Dimmitt-two miles before Guia encountered the first patrol car.

would you have said? (2) If our officers had shot out a tire on the speeding vehicle and caused a wreck that undoubtedly would have killed all five passengers, what would your reaction have been?


LAWMEN don't have the luxury of second guessing, or canvassing for popular opinion before making a decision that could affect the lives of others.

In this case, officers knew what they needed to do: they needed to stop the speeding car and get it off the highway. This they tried to do. They had it stopped once, but the car roared off again before officers could get the driver out of it.

The chase had little to do with any nebulous "pursuit policy." No such policy can be applied to each individual case. In this case, for instance, the driver of the speeding car was on probation for burglary, was reported to officers to have been intoxicated, faced possible kidnap and assault charges, knew he had probably been reported to the law, and knew he would go to prison if he were caught.

As one local official summed it up: "He knew he was in for it if he got caught, and he was determined not to get stopped."

OUR CITY has witnessed the worst twocar accident in the Texas Panhandle's history. It has been an irreparable loss for the families of all 10 persons killed in the accident, and has cast a pall over our neigh-We will be a long time getting over the consequences of this terrible accident. But we should not create ugly consequences of our own by pointing fingers irresponsibly. Our law officers laid their lives on the line trying to stop the speeding car. They deserve better than they've been

"Sharp was trying personally to sell National Bankers Life stock to Martin, although the attorney general said that Sharp never mentioned the possibility of Sharpstown Bank loans to buy the stock. "Martin said that he turned the

stock offer down because it would have cost too much, because NBL was in 'shaky' condition, and because he did not buy 'speculative' stocks.

"He did not comment on the ethical aspects of a state official's accepting a stock tip of that sort perhaps, because Martin, as attorney general, had ruled in favor of Sharp on a key legal issue about Sharpstown State Bank only two and one half years before Sharp made the stock offer to Martin.

"Martin's ruling had the effect of increasing the bank's capitalization dramatically and thus its ability to make large loans, ultimately giving Sharp the financial resources he used in the manipulations charged by the SEC.

As you know, hundreds of Texans lost their life savings because of Sharp's stock manipulations and it probably wouldn't have happened but for Atty. Gen Martin's legal opinion. Don't you agree, it's time for a
