company operates under a state franchise for the construction and maintenance of equipment, but negotiates separate agreements with individual cities for the 'maintenance' of the equipment." Present basic rates were established in Eastland in 1960, he said, at the time dial telephones were placed in service.

These rates were the result of a request filed in June, 1956, based on a study of operating results and econor conditions during 1955, the manager said.

"Since that time, the continuing high cost of furnishing telephone service in Eastland has resulted in unsatisfactory earnings in our operations here," Boothe declared.

"The company has done all it can to keep expenses here as low as possible. The only solution is a reasonable increase in rates, in keeping with today's higher costs. We hope our request will receive prom-pt and favorable action Boothe said.
