## Maize Queen's Pageant Slated This Saturday

Fourteen girls are seeking the Friona Maize Queen title, in the pageant which will be held today (September 11) at the Junior High Auditorium.

Those planning to attend the pageant are reminded of the change in the dates, as the pageant has usually been held on Thursday night, as well as the change in auditoriums from the high school to the junior high.

The pageant begins for the public with the preliminaries at 3:30 p.m. Saturday. All fourteen contestants will be judged in their talent acts, as well as their formal competition in the afternoon session.

The contestants' day will begin with interviews with the judges at 10 a.m., followed by a luncheon at 12 noon sponsored by the Friona Young Homemakers, at the Union Congregational Church.

Finals in the pageant begin at 7 p.m. at the Junior High Auditorium. The field will be trimmed to the top eight, who will present their talent acts a second time in the evening finals.

Admission price will be \$2.00 in the afternoon and \$3.00 for the finals.

Dana Rogers of Hurst, who was second runnerup in the 1982 Miss Texas Pageant, will serve as mistress of ceremonies for the pageant. Miss Rogers, the reigning Miss Haltom-Richland Area, will entertain the crowd with her singing during the course of the pageant.

Decorations will carry out the "Wild, Wild, West" theme of the 1982 Maize Days celebration, and pageant director Helen Lewis will present the contestants in an opening number in which they will all be wearing prairie skirts.

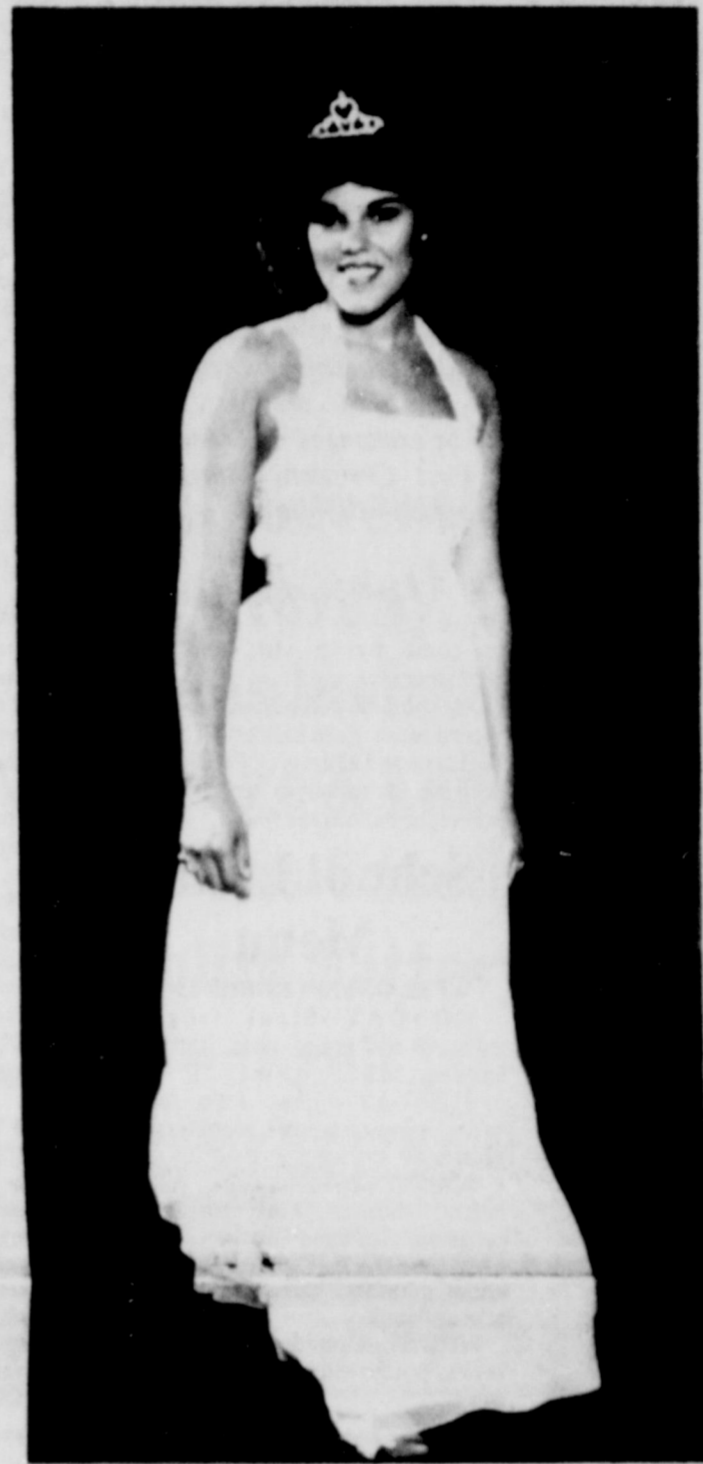

## Wild, Wild West Is Maize Days

Friona's 1982 Maize Days celebration kicks off Saturday, September 11 with the annual Queen's Pageant, and as usual, the schedule is packed with events all the way through.

The Queen's pageant gets a jump on the rest of the schedule, being held earlier than usual this year (see separate story, this page).

On Tuesday, the Great Southwest Shows, the Maize Days carnival, will open in the City Park, and will continue each evening the rest of the week. Jim Hoggard, owner, promises a good selection of the newest in carnival rides and attractions.

The Little Miss pageant, sponsored by the Progressive Study Club, will be held at the Friona High School Auditorium, at 7:30 p.m. Tuesday. Eighteen young ladies are entered in this event. Their pictures are featured inside this issue.

On Thursday evening, seventh and eighth grade football will be played locally, with the Seventh Grade Braves meeting Shallowater at 5 p.m., followed by the eighth grade game at 6:30 p.m.

Thursday is also the deadline to enter the photography show. Photographs should be brought to the old Rushing Insurance Office on Main street.

Friday's feature event is the football game between Friona and Shallowater, which will be the first-ever meeting of the two schools on the gridiron, at 8 p.m. at Chieftain Field.

Saturday, September 18, will be the big day on the Maize Days schedule. Things start early with a Pancake Breakfast at the high school cafeteria, beginning at 5:30 a.m. American Legion is the sponsor.

For the athletically-inclined, the annual Dixon-Six Mile Race is slated to begin at 8 a.m. at the Anthony Corner six miles north of Friona.

The Maize Days Parade pulls out at 10 a.m. down Main Street. (See separate story).

At 12 noon, the barbecue will be dished up at the southwest corner of City Park, featuring all you can eat for \$4 (advance) or \$4.50 at the gate for adults, and \$2.50 for children six and

under. Savage's Hickory Pit Barbecue of Hereford is catering.

The Six-Gun Shootout will be held periodically in the park. Watch for the booth and the time schedule. An antique car show is scheduled at the parking lot of Sis-Sons, following the parade.

The children's pet show will be held at 2 p.m. on the lawn of the American Legion building. A Team Roping will be held at 8 p.m. at the Riding Club Arena, and at 8:30 p.m. a football game will be held featuring the law enforcement officers versus the local coaches, proceeds to benefit Girlstown.

Many other activities and booths are on tap. John Blackwell and Bob Beville are serving as co-chairmen of the 1982 celebration.

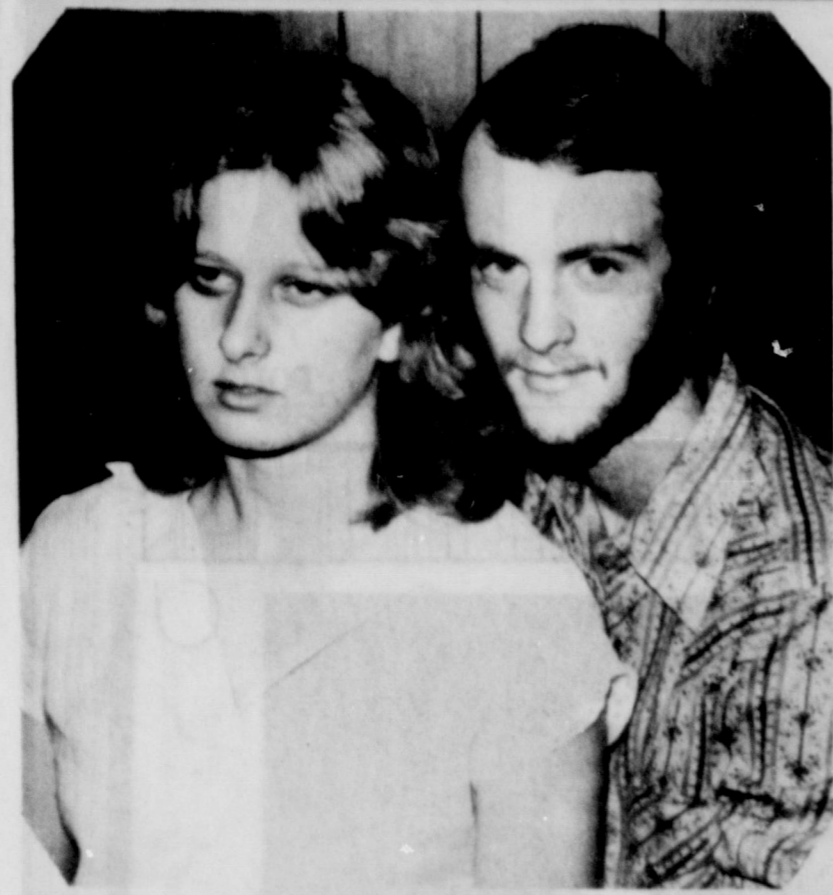
## Business People Asked To "Dress Western"

# Friona Flashbacks ...from the files of The Friona Star

## 50 YEARS AGO--SEPT. 16, 1932

Five new teachers have been secured in place of some of last year's instructors. Three of these are in the grade school department of the school and two are in high school. The complete faculty list is as follows: Glenn F. Davis, grade school principal, piano, voice and public school music; O.M. Stewart, geography and history; G.C. Applegate, geography and history; Miss Arvie Lewis, writing and art; Miss Vivian Boston, fourth grade; Miss Louise Jacobsen, third grade and public school music; Miss Herta Meyer, third and first grades; Mrs. H.B. Whitley, first grade and primary superintendent.

## 40 YEARS AGO--SEPT. 11, 1942

Enrollment in the Friona schools reached a total of 446 this week as the new term got off to a good start. Largest class in the grade school was the fifth grade, with 65 students. A total of 331 were enrolled in the first eight grades. High school had 115 enrolled, with 49 freshmen, 32 sophomores, 19 juniors and 15 seniors.

## 30 YEARS AGO--SEPT. 11, 1952

Ground was broken Monday at the Parmer County Community Hospital in Friona, for a \$5,000 addition, providing five more rooms and emergency capacity of nine more beds. Henry White and Bill Hannold are doing the construction and work schedule calls for completion in 45-60 days.

The annual Parmer County Fair is scheduled this weekend in Friona. A big free barbecue will be served beginning at the park at 6:30 p.m. Presentation of community candidates for Fair Queen will immediately follow.

## 25 YEARS AGO--SEPT. 12, 1957

Bill Sheehan, 29-year-old lawyer who began his practice in Parmer County seven years ago, is the district attorney for the newly created 154th Judicial District, which was formed September 1 under an act of the Texas Legislature. Sheehan rose to the position through appointment by Governor Price Daniel, and his appointment named him the D.A. for

16 months. The office will then be filled by an elected official.

**CONSTITUTIONAL AMENDMENTS**  
GENERAL ELECTION  
NOVEMBER 2, 1982

### PROPOSITION NO. 1 ON THE BALLOT

House Joint Resolution 1 proposes a constitutional amendment that prohibits any state ad valorem tax. Receipts from previously authorized state ad valorem taxes that are collected after the effective date of the proposed amendment shall be deposited to the credit of the general fund of the county collecting the taxes and may be expended for county purposes. Taxes collected before that date shall be distributed by the legislature among educational institutions eligible to receive those funds under prior law. The proposed amendment also repeals a section of the Constitution levying an ad valorem tax for a construction fund for 17 state colleges and universities.

The proposed amendment will appear on the ballot as follows:  
"The constitutional amendment repealing the state property tax."

### PROPOSITION NO. 2 ON THE BALLOT

House Joint Resolution 62 as amended by Senate Joint Resolution 10 proposes a constitutional amendment that would eliminate the \$80,000,000 ceiling on state welfare aid during any fiscal year. The amendment would set the state welfare spending limit at \$160,000,000 for the 1982-1983 biennium. The amendment further provides that, for each subsequent biennium, the maximum amount spent for state welfare shall not exceed one percent of the state budget.

The proposed amendment will appear on the ballot as follows:  
"The constitutional amendment to authorize the legislature to provide assistance through the appropriations process to needy persons and to place a ceiling on payments for needy dependent children at one percent of the state budget."

### PROPOSITION NO. 3 ON THE BALLOT

Senate Joint Resolution 8 proposes a constitutional amendment that would exempt machinery and equipment used in the production of farm and ranch products from taxation. No dollar limits would be imposed and the exemption would apply to corporations and partnerships as well as to families and individuals. The proposed amendment will appear on the ballot as follows:  
"The constitutional amendment exempting implements of husbandry (agricultural machinery and equipment) from ad valorem taxation."

### PROPOSITION NO. 4 ON THE BALLOT

House Joint Resolution 77 proposes a constitutional amendment that would authorize the Legislature to set a four year maximum term of office for board members of certain water districts and conservation and reclamation districts.

The proposed amendment will appear on the ballot as follows:  
"The constitutional amendment authorizing the Legislature to provide terms not to exceed four years for members of governing boards of certain water districts and conservation and reclamation districts."

### PROPOSITION NO. 5 ON THE BALLOT

House Joint Resolution 119 proposes a constitutional amendment that would authorize Tarrant and Bee counties to hold county-wide elections to abolish the county treasurer's office by majority vote.

Should the county treasurer's office be abolished, the duties, powers, and functions of that office would be transferred to the county auditor or the successor to the auditor's functions. The proposed amendment will appear on the ballot as follows:  
"The constitutional amendment to abolish the office of county treasurer in Tarrant and Bee counties."

### PROPOSITION NO. 6 ON THE BALLOT

Senate Joint Resolution 6 proposes a constitutional amendment that would raise the constitutional interest rate limit on state general obligation bonds from 6% to 12%. The new 12% ceiling does not, however, apply to bonds issued by the Veterans' Land Board.

The proposed amendment will appear on the ballot as follows:  
"The constitutional amendment increasing the maximum interest rate allowed on state general obligation bonds to a weighted average annual interest rate of 12%."

### PROPOSICION NUMERO 1 EN LA BOLETA

Resolución Conjunta de la Cámara de Representantes 1 propone una enmienda constitucional que prohíba cualquier impuesto estatal por avalúo. Los recibos de impuestos estatales por avalúo anteriormente autorizados que son cobrados después de la fecha efectiva de la propuesta enmienda a esta sección serán depositados al crédito del fondo general del condado que cobra los impuestos y pueden ser gastados para los fines del condado. Los impuestos que son cobrados antes de esa fecha serán distribuidos por la Legislatura entre las instituciones educativas que son elegibles para recibir esos fondos bajo ley previa. La propuesta enmienda también revoca una sección de la Constitución que impone un impuesto por avalúo para un fondo para la construcción de 17 colegios y universidades estatales.

La propuesta enmienda aparecerá en la boleta como sigue:  
"La enmienda constitucional que revoca el impuesto estatal sobre la propiedad."

### PROPOSICION NUMERO 2 EN LA BOLETA

Resolución Conjunta de la Cámara de Representantes 62 tal como fue enmendada por Resolución Conjunta del Senado 10 propone una enmienda constitucional que elimine el límite de \$80,000,000 de asistencia pública estatal durante cualquier año fiscal.

La enmienda establecería el límite de gastos de asistencia pública estatal a \$160,000,000 para el bienio 1982-1983.

Además la enmienda provee que para cada bienio subsecuente la cantidad máxima que se pueda gastar en asistencia pública no será en exceso de 1% del presupuesto estatal.

La propuesta enmienda aparecerá en la boleta como sigue:  
"La enmienda constitucional que autoriza a la Legislatura proveer asistencia por el proceso de asignación a necesitados y establecer un límite sobre los pagos para niños dependientes necesitados de un por ciento del presupuesto estatal."

### PROPOSICION NUMERO 3 EN LA BOLETA

Resolución Conjunta del Senado 8 propone una enmienda constitucional que exencione de la imposición de impuestos la maquinaria y el equipo que se usan en la producción de productos agrícolas y ganaderos. No se impondría límites de dólares y la exención se aplicaría a las sociedades anónimas y colectivas tanto como a las familias y los individuos.

La propuesta enmienda aparecerá en la boleta como sigue:

"La enmienda constitucional que exenciona los implementos de producción agrícola (maquinaria y equipo agrícola) de la imposición de impuestos por avalúo."

### PROPOSICION NUMERO 4 EN LA BOLETA

Resolución Conjunta de la Cámara de Representantes 77 propone una enmienda constitucional que autorice a la Legislatura establecer un límite de cuatro años para los plazos de ciertos distritos de agua y distritos de conservación y reclamación.

La enmienda propuesta aparecerá en la boleta como sigue:

"La enmienda constitucional que autoriza a la Legislatura proveer plazos de no más de cuatro años para los miembros de las juntas gubernamentales de ciertos distritos de agua y distritos de conservación y reclamación."

### PROPOSICION NUMERO 5 EN LA BOLETA

Resolución Conjunta No. 119 de la Cámara de Representantes propone una enmienda constitucional que autorice a los condados de Tarrant y Bee celebrar elecciones en los dos condados para anular por mayoría el oficio de tesoro del condado.

Si se anula el oficio de tesoro del condado, se cederán los deberes, poderes y funciones de dicho oficio al auditor del condado o al sucesor de las funciones del auditor.

La enmienda propuesta aparecerá en la boleta como sigue:

"La enmienda constitucional que anula el oficio de tesoro del condado en los condados de Tarrant y Bee."

### PROPOSICION NUMERO 6 EN LA BOLETA

Resolución Conjunta del Senado 6 propone una enmienda constitucional que aumente el límite de la tarifa constitucional de interés en los bonos generales estatales de obligación de 6% a 12%. Sin embargo, el nuevo límite de 12% no se aplica a bonos emitidos de la Junta de Terrenos para Veteranos.

La propuesta enmienda aparecerá en la boleta como sigue:

"La enmienda constitucional que aumenta la tarifa máxima de interés que se permite en los bonos generales estatales de obligación a un promedio ponderado de 12% de interés anual."

I want to talk this week about taxes and good intentions.

As I travel around Texas, I notice that what's known as the Peveto Bill is the subject of much talk and controversy. This bill, named after state representative Wayne Peveto, is a tax reform law, legislation of the best intention.

The law was designed to end confusion and unfairness in the way property taxes were assessed. Property was often on different tax rolls at different values. Older properties went years, sometimes decades, without being revalued or updated. New construction and newly sold property was on the rolls at more correct values and so people who owned it paid a higher share of taxes. Some property was simply left off the rolls entirely. The system was confusing and inequitable.

In an attempt to correct these problems, the Peveto Bill created property tax appraisal boards for each Texas county. These boards were charged with the responsibility of set-

ting all property at its full value—as residential or commercial property or as land used for agricultural purposes. Taxes could then be levied on this accurately assessed property according to the needs of the taxing entities.

It sounded good, but it hasn't worked. The biggest problem is that the people on the appraisal boards are appointed, not elected. They are not accountable to the taxpayers. So now we have a new, faceless bureaucracy to deal with. It amounts to taxation without representation.

My opponent has been on both sides of this issue, first supporting the bill in the legislature—then doing an about-face and calling it bad legislation after it was passed.

The Peveto Bill, though well-intentioned, has created problems which must be dealt with in the next legislature and as your next Lt. Governor, I will do just that. If you have any thoughts on this subject, please write me at 1213 W. 34th, Austin, 78705.

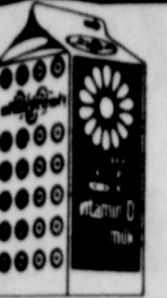

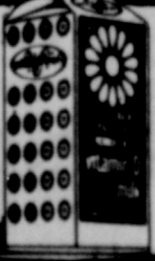

# Summerfield Saddle Shop Becoming Widely Known

Probably the most widely known place in Summerfield, Texas, today is Bill Lookingbill's Saddle Shop. Inside a modest frame building attached onto a frame home and entered by a ramp, visitors find a wide array of machinery, material, work tables and tools along with a large number of saddles and other related articles.

In fact, the shop has grown so much in recent months that it was necessary for Bill and Shara Lookingbill to have an addition erected at the back of the shop.

Bill, the third son and middle child of the late L.B. Lookingbill and his

wife, Eva, who live nearby, was born within a few hundred yards of his present home and shop in 1935 and grew up in the Summerfield Community.

He attended Summerfield Public School through the sixth grade and graduated from Hereford High School in 1954. Soon after his high school graduation he became seriously interested in hand tooling leather belts and billfolds; however, he soon became so involved in other farm and livestock activities that his hobby was pushed far back on a shelf.

Bill and Shara Latham, a Tucumcari, New Mexico native, who

was working in an auto parts store in Amarillo, owned and operated by one of his older brothers, Bradley, were married February 3, 1962. Shara's mother, Mrs. Alta Latham, lives in Friona.

When the subject of courtship comes up, Bill likes to add his bit by saying, "She asked me for our first date."

Soon after the two met, the company she was working for had a Christmas party and employees were asked to invite guests. She invited Bill, he accepted her invitation and the two have been attending Christmas parties and other functions together for more than 20 years.

During the first few years of their marriage the Lookingbills lived in Friona, Bovina and in a few nearby communities, where he ran cattle. Shara, a graduate of San Jacinto Beauty School and a licensed cosmetician, has worked at her chosen profession in Friona for a number of years. She remembers that her first employment here was with Patti Hughes, in a beauty shop on West Fifth Street.

At the present time she owns and operates Shara's Hair Salon at 613 Main Street.

The couple's three children are Sid, a graduate of Hereford High School; Tommie Sue, a Hereford High School senior; and Loren, 13, who attends a junior high school in Hereford.

Early in 1979 Bill and Shara made plans to assume operation of the Summerfield Store and Post Office. Before the final arrangements were completed, a tragic accident reversed their plans and circumstances were such that a whole new career had to be established.

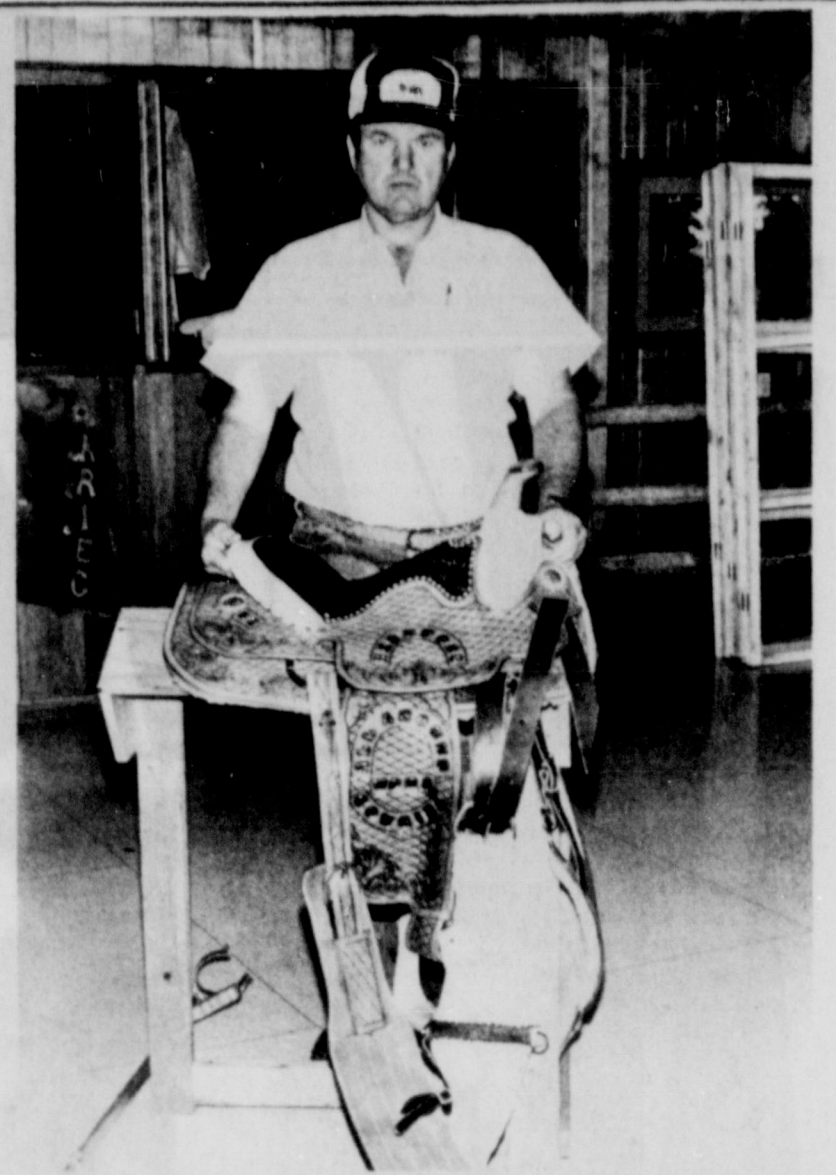
On the evening of March 18, 1979, Bill, Shara and the children were returning from a 4-H Horse Show, which Bill had helped with, when a friend, Tom Johnson, had trouble with a horse trailer.

Before the damage was repaired, another vehicle ran off the road and into the Johnson trailer. In the accident Bill received very serious injuries to both legs.

Following a long hospital stay and extensive surgery, which included the amputation of one leg above the knee, Bill was able to return home and soon began to get around in a wheel chair.

One day as Bill and Shara were returning home from Amarillo, he announced his decision to enroll at Texas State Technical Institute, Amarillo, to learn saddle making. He completed three quarters of classes over a period of two years while he was still in a wheel chair.

Later he was fitted with an artificial limb and was soon able to

learn to walk without any mechanical aids. The next step towards his goal of "getting back into a saddle" has been scheduled for September 17 in Dallas.

This will be attachment of a bone stimulator on his natural leg, in which the bone has never healed properly. He will be in a cast and will have to go in a wheel chair again for awhile.

In spite of all the problems the Lookingbills have encountered since the accident, they are optimistic about the future and feel that they have been most fortunate in the interest and support of friends, neighbors and others living in the area.

Bill smiled as he nodded agreement

to Shara's statement, "Without everyone who willingly assisted us in so many ways, we never could have made it this far."

They are active members of Temple Baptist Church in Hereford.

In addition to building plain, trophy and stamped saddles, Bill turns out chaps, breast collars, halters, bridles and just about anything else available in the most elaborately stocked tack shops across the country.

He also does repair work on saddles. Restoring antique saddles to their original state is made difficult many times due to the scarcity of

He's an amateur photographer who turns out photographs which look like they had been done by a professional and plans to keep a picture of each saddle he completes.

When asked about hobbies, he replied, "I really like to fish, but don't have much time for that any more."

Although Bill didn't mention it, he's an avid rodeo fan, too, since he

isn't able to be a participant. As the Jersey milk cows were being moved from Plainview to the Parmer County farm, Ferguson remembers that a truck loaded with cattle fell into a sewer line at Dimmitt and that they didn't get to the farm in time to be milked that night.

July 14, 1934 Ferguson and Elizabeth Massey, oldest of nine children born to the late Mr. and Mrs. Otis Massey and a native of Ellis County, Texas, were married.

Elizabeth and all nine of her sisters and brothers are graduates of Friona High School. Other members of her family were Edward, Gordon, Russell, Wayne, Stanley, Marvin, Frances, Geneva and Betty.

When the Fergusons first married, they lived upstairs in the Matthews home. One of their wedding presents was two cane bottomed chairs, which were given to them by J. A. Blackwell, owner of Blackwell Hardware and Furniture, the forerunners of Friona's present day Plains Hardware and Furniture. Blackwell was also the John Deere Implement dealer.

They still have these two chairs. Elizabeth explains, "After the cane bottoms wore out, I restrung them with binder twine."

Other furniture the couple started keeping house with includes an iron bedstead, a round oak dining table and an antique dresser, which originally belonged to Elizabeth's grandparents.

The couple's five children, Bessie, Kenneth, Treva, Fred and Doris, were all born here. Treva died before she was two and the others grew up here. During her junior year in high school Bessie was married to Ira Holt

and a year later graduated from high school at Grant, Oklahoma.

The couple belongs to Calvary Baptist Church and are very busy with its activities.



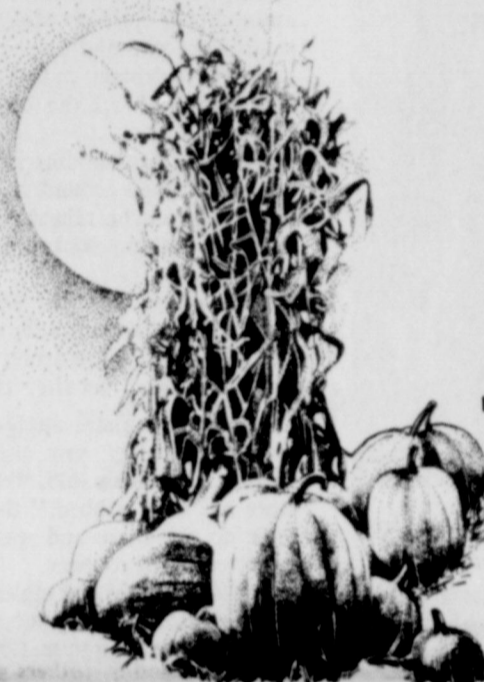

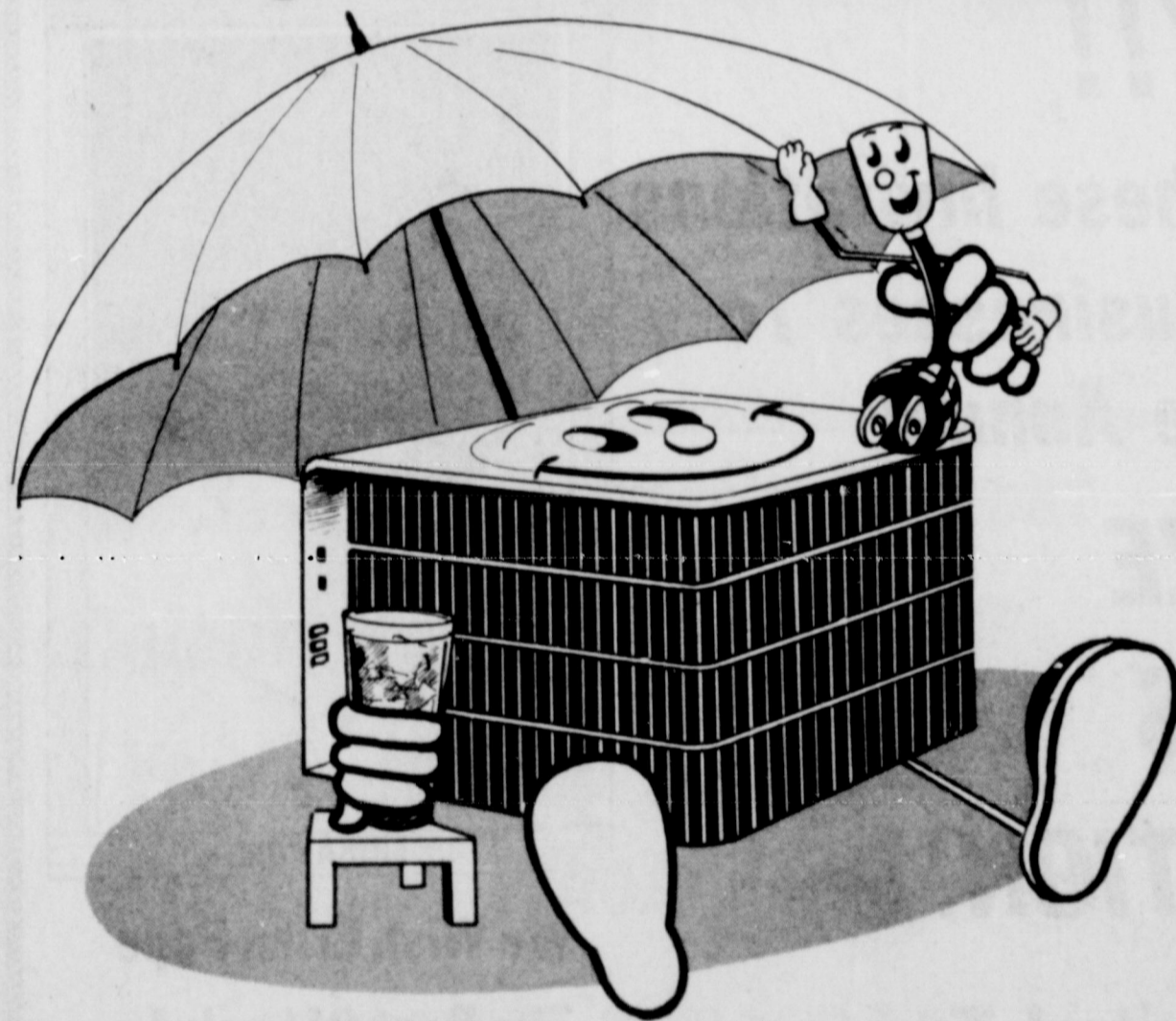

# Jarrells Began Married Life In Drygoods Business

New residents in the Hub Community early in 1950 were Mr. and Mrs. Newman Jarrell Sr., who had lived in Snyder, Texas, where they had owned and operated Jarrell Drygoods Store for all twenty-six years of their married life.

This couple had never farmed before, but after purchasing the A. H. Boatman farm, began a new career, which they pursued for the next six years.

Early in 1956 they had a new home built at 804 West Fifth Street and moved into it April 1 of that year. They have made their home at the same location more than twenty-six years. Even though neither of them are in good health and both of them are in their upper eighties, they still maintain their own home with very little assistance.

Beulah Shotts, a native Texan, was born August 9, 1895 in Montague County. She moved with her parents,

the late Mr. and Mrs. Jud Shotts, to a farm near Duncan, which at that time was in the Indian Territory. She remembers that their first home was a half dug-out on an Indian lease. Later the Shotts family lived at Frederick and Rush Springs, Oklahoma.

Newman Jarrell Sr. was born near Cottonwood, Kansas, August 11, 1893. September 30 of that same year his father participated in the opening of the Cherokee Strip in the Indian Territory and later moved his family to the headquarters of the famous 101 Ranch, which was a horse ranch located nine miles east of Blackwell. For the next five years the Jarrell family lived in a half dug-out. Then they moved to Nardin, Oklahoma, and from there to Frederick.

It was while the two families were living in the Frederick area that Newman and Beulah first became acquainted. They were married May 14, 1924 in Chickasha, Oklahoma. A year or so before Newman had started a drygoods store in Snyder, Oklahoma, where they made their first home.

At this time a drygoods store stocked everything now available at fabric marts, shoe stores, men's clothing shops, bed and bath shops, variety stores, ladies ready-to-wear stores and western stores.

Beulah remembers that one of the busiest sections of the store was the millinery department, where women were able to select a hat suitable for just about any occasion. They also sold straw and felt hats for men and children.

Jarrell's Clothing Store was located next door to a movie theater and was a gathering place for adults, whose children were attending the Saturday evening movie. The store never closed until the movie ended.

One typical Saturday evening when 17 people were in the store, a saleslady opened the cash register to make change for a one dollar bill for a customer who had purchased a 79¢ item, the customer pulled out a 45 and demanded all the cash in the register.

Newman was standing nearby and when he turned around to see what was going on, he remembers, "The barrel of that gun looked as big as a stove pipe."

The robber and his accomplice immediately ran out of the store and one of the men in the store, who was carrying a pistol, ran after them.

Another bystander stepped outside and immediately saw the deputy sheriff. After being told, "Newman's store has been robbed," the deputy took up the chase and was able to catch one of the robbers.

The two culprits had stolen guns at Weatherford, Oklahoma, and had robbed a store in Granite, Oklahoma, before going on to Snyder. The second man was never apprehended.

## Services Announce Completion Of Flood Prevention Project

Special dedicatory services on September 21 will mark the completion of a flood prevention project that involved more than 20 years of planning and construction and includes portions of six counties in Texas and New Mexico.

The president of the National Association of Conservation Districts, Milton E. "Bud" Mekelburg of Yuma, Colorado, and the Soil Conservation Service deputy chief for natural resource projects, Joseph W. Haas of Washington, D.C., will be principal speakers for the dedication of the Running Water Draw Watershed Project.

The program will be held at Site 3, the last of seven flood control dams to be completed on the flood-prone Brazos River tributary. Finished earlier this year, the dam is located south of Edmonson in northwest Hale County. Signs along US-70 and Texas-194, west and northwest of Plainview, will point the direction to the site. The Tuesday afternoon dedication will begin at 2 p.m.

The watershed project, which stretches from Clovis, N.M., to Plainview, was first conceived in 1960 after heavy flooding occurred along the watershed. Particularly heavy damage was suffered in Plainview.

The local officials then turned to

officials from the U.S. Soil Conservation Service for aid, with the agency (part of the U.S. Department of Agriculture) handling the project. SCS in 1968 estimated that the four dams in the lower portion of the project would cost \$468,040. In contrast, the bid for the Site Three dam was \$2.3 million.

Due to the length of the watershed, the U.S. Soil Conservation Service divided the project into two parts--The Running Water Draw Project in Curry County, New Mexico, and Parmer County, Texas, and The Lower Running Water Draw Project in Castro, Lamb, Swisher and Hale counties.

The upper system includes three dams, one on the main channel north of Clovis, the second on a tributary northwest of Bovina, and the third four miles northeast of Lazbuddie in Parmer County.

The lower system includes four dams, the first about eight miles west of Hart, Site Two in northwest Hale County on North Draw, Site Three near Running Water School (south of Edmonson) and Site Four, four miles west of Plainview on Slaton Draw.

The dams normally operate without manual valves, but automatically hold back flood waters

and release them at controlled rates. "If the dams ever fill to capacity, grassy emergency spillways will take the excess water around the dams," explained Jimmy Lewis, SCS district conservationist in Plainview. When water behind the dam rises above the static level, it flows through a discharge pipe into the draw channel behind the dam.

Final plans for the upper portion of the project were completed in 1966 and the lower project in 1968. The first dam was completed near Bovina in 1972.

The dam system has a life expectancy of 100 years and is designed to contain the one per cent (100-year frequency) flood.

Planning for the project was financed by Parmer, Castro, Lamb and Hale counties, the city of Plainview, and Clovis and Curry County in New Mexico. The Soil Conservation Service provided funding for the actual construction with the local sponsors securing easements for the dams and water storage. With the completion of the system, the sponsors will maintain and finance upkeep for the facilities.

Sponsors for the project, in Texas, include the commissioners courts in

Hale, Swisher, Lamb, Castro and Parmer counties; the City of Plainview, and five soil and water conservation districts, Hale County, Tule Creek, Lamb County, Running Water and Parmer County. In New Mexico, sponsors include Central Curry County SWCD, Curry County Commissioners Court, City of Clovis and Ned Houk Park Board.

# Lutheran Volunteer Workers Make Braille Books In Monthly Workshop

The Fellowship Hall of St. John's Lutheran Church at Lariat, a small town in south central Parmer County, is a very busy place several days each month.

This hall is a workshop for a branch of Lutheran Braille Workers, with headquarters in Yucaipa, California. From it many books in Braille are turned out each month.

About seven or eight workers attend each session. They are mostly Lutheran women from Parmer and Deaf Smith Counties, Texas, and Curry County, New Mexico.

Membership in a Lutheran Church or Lutheran Missionary League is necessary for a woman to become an active worker in this project.

Back in 1972 Gladys Kaltwasser attended a church convention in Louisville, Kentucky, and brought the idea home with her. Soon she had a group of volunteer workers lined up and the project was on its way.

Phyllis Schelter, wife of St. John's pastor, has visited the facility in Yucaipa and directs activities at Lariat. Supporting churches are St. John's Lutheran Church, Lariat; Immanuel Lutheran Church, Clovis; Immanuel Lutheran Church, Hereford; and Redeemer Lutheran Church, Friona.

All 145 work centers in the nation are supported by volunteer

contributions and voluntary work. There are about twenty-five such centers in Texas. The closest one is at Lubbock.

Materials, which include pre-etched zinc plates and reams of high quality paper, are shipped from Yucaipa.

As a work day begins, seven or eight women and three machines line up for an assembly line like operation and by the end of the day about 30 books have been assembled.

The first step, which is done by hand, is the arrangement of sheets of paper and zinc plates in the proper order.

Then, one sheet of paper is located between two zinc plates, which have been pre-etched, inside a cover.

Running the filled covers through a roller machine, much like an old fashioned washing machine wringer, is the next step in production.

The zinc plates are then removed and the sheets of paper are stacked in numerical order prior to being run through a perforating machine.

From the perforating machine the pages of the book are placed in a form and are permanently bound. Final step in the operation is checking, which is done very carefully, and placing in mail sacks, which are provided by the United States Postal Department.

Books which have been produced in this workshop have been in English, Korean and Greek, and are sent to many parts of the world.

Each book lasts for only about 50 readings, so a large volume of books must be printed to supply the demand for them.

A typical day begins about 9:30 a.m. and ends about 3:00 p.m. Each worker takes a sack lunch, which is eaten in the dining room of the hall at noon.

Some of the workers, who have been involved since the project first began, are very enthusiastic about the work and report that they receive a lot of satisfaction from being able to help enrich the lives of sightless persons.

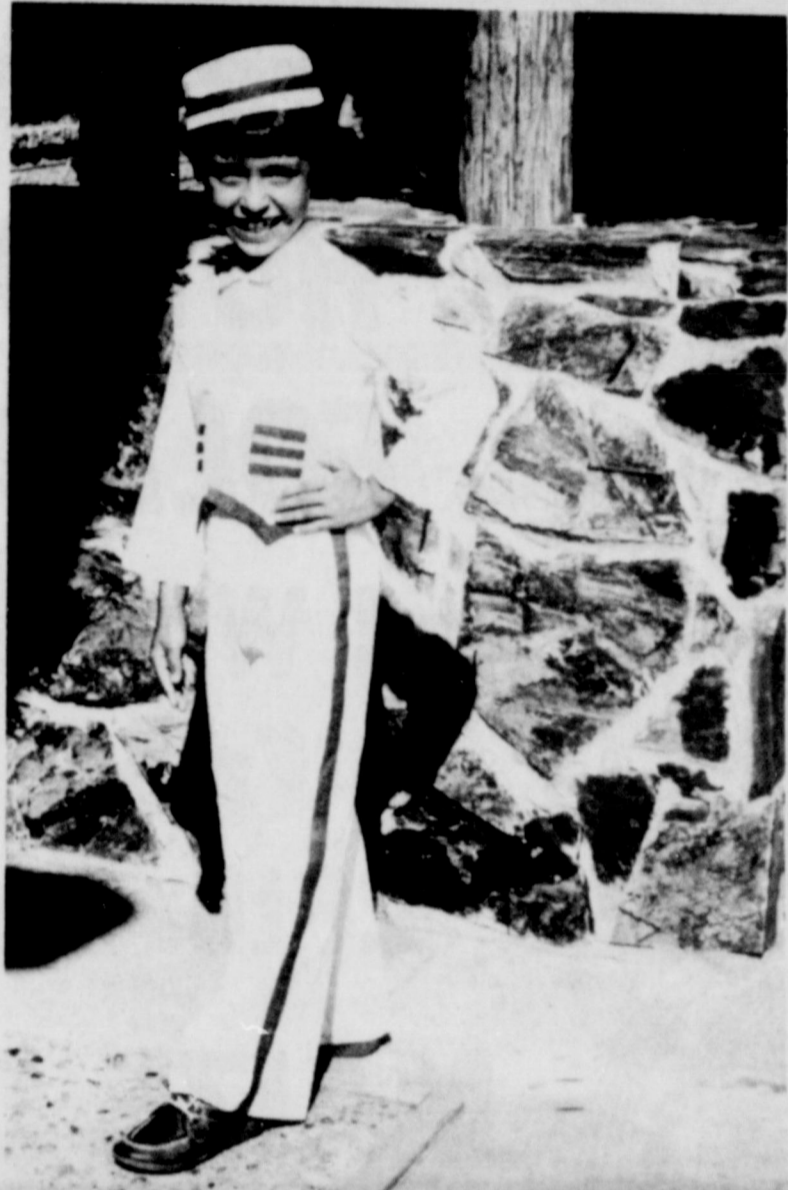

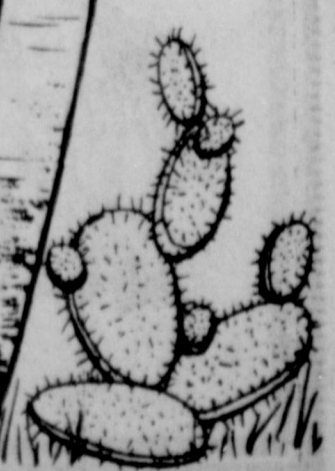

# Friona Business Ships Products Nationwide

The name Western Plateau Meat Processors, which is prominently displayed on the front of a building on the south end of Main Street, Friona, really tells passersby very little about what goes on inside the building.

This building, the former home of Crow's Meat Company, is furnished with a lot of stainless steel machinery and all products processed are made from USDA Inspected meat plants and packed under supervision of the Texas Meat Inspection Department.

As curious visitors approach the building their attention is called to containers marked "inedible," and "not for human consumption." They generally assume that this must be a processing plant for pet foods and that assumption is partially correct.

A visit with the friendly owners and operators, Gerry and Judy Nash, is a very informative experience.

The only thing Western Plateau produces is frozen food for exotic pets, zoo animals and birds of prey. This product is packaged under the trade name, "Meat-Eater Diet" and its base is horse meat, horse and beef by-products, liver, ground poultry and fine ground bone plus a long list of other ingredients.

Western Plateau has five regular employees in addition to Gerry and Judy. It also has a consulting veterinarian and a consulting nutritionist.

Gerry Nash, son of Mr. and Mrs. W.C. Nash, and Judy Laseman, daughter of Mr. and Mrs. Ernest Laseman, are both natives of Elgin, Illinois, where they grew up, graduated from high school and were married.

While Gerry attended college, he got a job picking up dead animals for pet food packing plants. After two years of college as a mechanical engineering major, he entered the pet food business on a full time basis.

For the next twenty-two years he was involved one way or another with

the supplying phase of the business, but never learned to like the long irregular hours it was necessary for him to put in.

At different times the Nash family lived at Wheatland, Wyoming; Greeley, Colorado; Oviedo, Florida and Plain, Wisconsin. An incident, which he considered a disaster at the time, turned out to be the stepping stone to his present business.

He and a partner were supplying pet food to customers over most of the eastern half of the United States and he was living in Florida. A change in some of the equipment resulted in a different look in the product they were producing and customers began to reject their orders.

At that time a zoo near Oviedo was struggling for its existence and pleading for any assistance anyone would give.

Nash said, "Here I was with all this pet food, which had been rejected by customers and had no where to go with it. After hearing a plea for assistance for the zoo, I decided to donate my surplus to them. Our company was just about finished by that time."

His contact with the zoo officials opened a new door for him. Never before had he even thought of producing frozen food for zoo animals nor realized the scarcity of such food.

The availability of beef and by-products in the Texas Panhandle caused him to investigate the possibilities of establishing such a plant in Amarillo.

He had earlier had some contact with Garth Merrick of Hereford, owner and operator of Friona Bi-Products, and owner of the building which presently houses Western Plateau Meat Processors.

After negotiating for the building and making other arrangements, operation of the plant began. Gerry, Judy and their four children, lived in

Amarillo for awhile and Jerry commuted to Friona.

Later Judy, Darron, an eighth grader in Friona Junior High School, and DeAnna, a sixth grader, moved to the former home of Mr. and Mrs. Bert Shackelford at 803 Washington.

The two older boys, Rick and his wife, Lisa, and three month old son, Justin; and Dan and his wife, Cathy, all live in Amarillo.

Present plans for expansion include the packaging of small packages of frozen meats for household pets to be sold through supermarkets. This product will be marketed under the label of "Western Plateau Pet Patties."

Marketing of Meat-Eater Diets into foreign countries is also planned. One shipment has already gone into Taiwan and negotiations are being made for importation into Canada.

Ground work is being initiated on expanding into Germany to supply European markets.

At the present time cold storage warehouses are located in Billings, Montana; Oklahoma City, Oklahoma; Minneapolis, Minnesota; Madison, Wisconsin; Tyler and Houston, Texas; Alexandria, Louisiana; Boston, Massachusetts; Harrisburg, Pennsylvania; Vineland, New Jersey; Statesville, North Carolina; Columbia, South Carolina; Orlando and St. Petersburg, Florida; San Francisco and Los Angeles, California; and Reno and Las Vegas, Nevada.

Nash reports, "Our output this year will amount to about one million pounds."

Shipments are made from the plant to warehouses by refrigerated trucks in 40,000 pound loads. Customers then go to the nearest warehouse to pick up their orders.

Western Plateau has only two competitors. They are both located in Nebraska.

those in Clovis, Amarillo, Abilene, Waco and Albuquerque.

Gerry has designed and constructed a freezer, which fits in the small plane he travels in and plugs into an outlet, to take Meat-Eater Diet samples to conventions he attends for displays.

The next convention on his agenda is the National Conference of

Zoological Parks and Aquariums, which will be held in Phoenix, Arizona, September 19-24.

Judy smilingly nodded agreement as her husband said, "I'm happy with what I have going in Friona, which is a culmination of 15 years of trial and error, and am eagerly anticipating further development of our business

and the expansion of the marketing of our products."

Within a few years there probably will be very few places where Friona, Texas isn't known as the home of the world's most extensive producers of food for exotic animals, birds of prey and household pets.

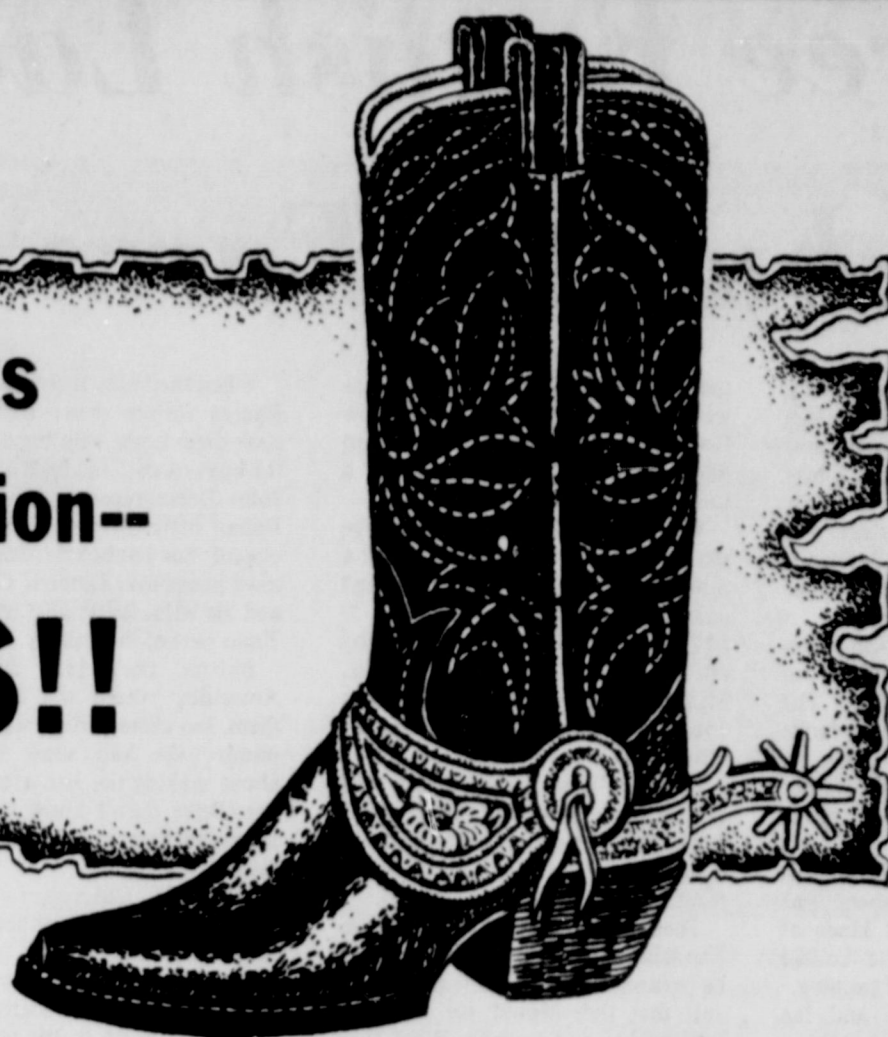

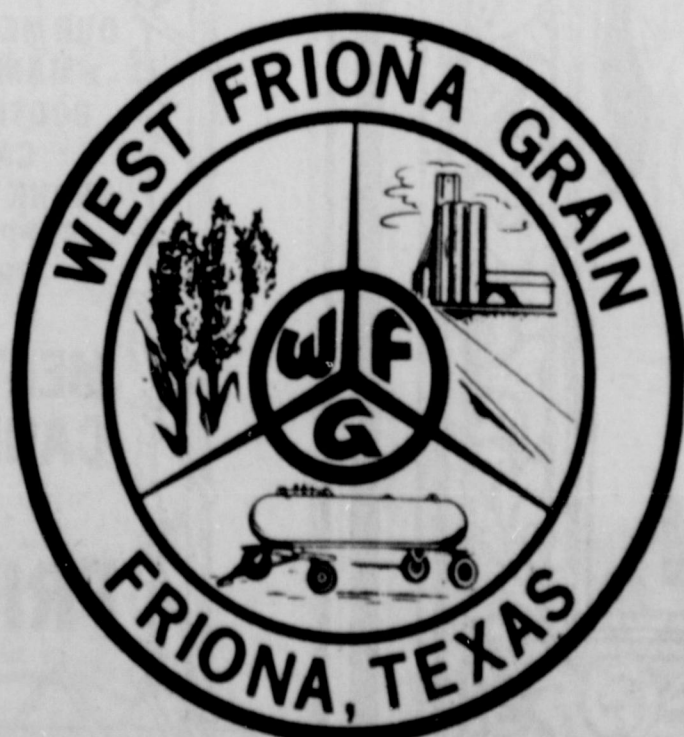

# Three English Lads Visit Lazbuddie Farm Family



**EVERYBODY NEEDS ASSISTANCE DURING HARVEST...**  
Gene Smith, a Lazbuddie farmer, always needs help at harvest time and this year is no exception. When he started corn ensilage harvest a few weeks ago, he was assisted by three visitors from England. Pictured here with Gene, who is wearing the cap, are Andrew Walters of Warwickshire; Ian Clayton of Cleveland; and Chris Merriman of Northhamshire. These three had never been to Texas before nor seen such large fields of corn, cotton, sunflowers, soybeans and vegetables.

Three years ago three young English natives began their college education at Moulton Agricultural College in Northhamshire. Chris Merriman was a local lad, Andrew Walters was from Warwickshire, and Ian Clayton was from Cleveland. Before the end of the school year these three were good buddies.

All three of them were from farm oriented backgrounds, but from different phases of farming. The Merriman family was a dairy farm; Andrew's family concentrated on beef production; and Ian's father operated a John Deere farm implement dealership.

Agricultural students in England attend classes one year; spend one year working on different kinds of farms; then return to the college campus for the final year of training.

Last year Chris, Andy and Ian decided they would like to take a holiday in the continental United States before settling down to the more serious business of going to work. None of them had ever been in America and all of them were very curious about farming here.

One of the first steps the lads took toward fulfilling their dream of

spending some time in America was writing a letter to John Deere Plow Company, Moline, Illinois, and inquiring about the possibility of a summer visit on a farm.

Very soon their plans began to take shape. Each of the three had to sell a motorcycle, car or other prized possession to finance the holiday.

The first leg of their journey was by air from London to Minneapolis, Minnesota, where they were met by a John Deere Plow Company representative.

By that time arrangements had been completed for the trio to spend some time on an Iowa farm, some on a Kansas farm, and some on a Texas farm.

Their expectation of the Texas Panhandle was that everyone would be wearing cowboy hats and boots and that they would see a lot of rattlesnakes and Indians. What they most wanted to see was some 100 degree temperatures, rattlesnakes and at least one tornado.

After a tour of the John Deere facilities in Minneapolis, which the lads enjoyed very much, a farmer from Iowa came and took them to his farm home.

When their stay there was ended, a Kansas farmer drove to Iowa and took them home with him. Places for the boys to visit had been arranged by John Deere representatives and the Dallas office had earlier contacted one of the Lazbuddie Community's most prominent farmers, Gene Smith and his wife, Betty, and arranged the Texas part of the holiday.

Before they left Dallas for Amarillo, where the Smiths met them, Ian visited briefly with Betty by phone. He had some misgivings about making the visit after learning that Betty didn't know within 1000 acres the amount of land Gene was farming.

"Now," Ian says, "I can understand why. Everything out here is so big and so far apart and everybody travels so far. In our country land is so scarce that we measure it down to the tenths of an acre and use very foot of it."

Since Chris, Andy and Ian have been visiting in the Smith home, they have learned a lot of things about growing cabbage, carrots, bell peppers, lettuce, honeydew melons as well as corn, cotton, soybeans, sunflowers, wheat and other small grains.

An exciting experience for these three has been the corn ensilage harvest. The only corn grown in England is grown in the southern part of the country and is called maize.

"Everything is so much bigger here," said Chris. Andy and Ian both agreed.

For the 130 dairy cows on the Merriman farm, where Chris grew up, 47 acres, which is divided into several pastures where rotation grazing is practiced, provides all the pasture. Other acres are used for the production of silage and small grains used for feed.

Andy's father's beef cattle herd numbers about 100 head, which is considered a large operation. During the winter months the cattle are kept under cover most of the time. When

the weather permits they are turned out to graze. They do not have large feedlots such as the boys have seen here.

Another necessity here that is unheard of in rural England is irrigation.

"One of our problems is trying to get rid of water," Andy said.

Some of the differences they noted were farm boundaries, which in their country are marked with hedgerows of thorn bushes; size of farms--theirs generally contain less than 250 acres and many of them are smaller than that; shape of farms--theirs are many different shapes and always end at the hedgerow; temperature and humidity: Ian's comment about this was:

"We're near the sea and our humidity is always high. When the temperature gets up to 80 degrees, we think we're having a heat wave."

The English lads were very surprised to learn that West Texas farmers do not name their fields. Each one in their country has a proper name.

They were also astonished at the size of tractors. The average farm tractor used by farmers in England has 80 horsepower.

Chris said, "We had never eaten a meal from a chuck wagon until we came to Texas."

The chuck wagon he was speaking of is a mobile home in which Betty takes meals to the harvest hands each day. She prepares the meals in a well equipped kitchen, which is part of Gene's shop and looks like a combination of an early day ranch kitchen and an up-to-date food preparation center.

Betty reports, "The boys are very easy to cook for and eat almost anything I serve. However, I notice that steak and scalloped potatoes are high on their preference list."

They eat very little dessert, but prefer home made ice cream to any other. They also enjoy hot homemade rolls.

# Caffey's Enjoy Retirement From Educational Field

A window box filled with red geranium blooms, a well kept front lawn and two smiling faces usually greet visitors who ring the door bell at the corner of Fifteenth and Elm Streets, just outside the city limits of Friona.

Dalton and Estelle Caffey, who live in an attractive brick home at this location, contributed much towards the education and training of a large number of students from the fall of 1947 through the 1967-68 school year.

Estelle Caffey was born near Hearne, Texas, and grew up in the same area. She was graduated from Franklin High School and attended several institutions of higher learning, including Baylor University, Waco, and the University of Texas, Austin, before her graduation from Hardin-Simmons University, Abilene with a double major, science and English, and a home economics major. She also holds a master's degree in counselling and home economics from West Texas State University, Canyon.

Dalton Caffey, a native of Jones County, was born near Anson, where he lived until his graduation from Anson High School. He attended

Hardin-Simmons University, Abilene and the University of Texas, Austin, where he first met Estelle Cadle.

His bachelor's and master's degrees in administrative education are both from Hardin-Simmons. His first teaching experience was in a rural school in Jones County, where he was principal and also coach of the girls and boys basketball teams and a boys baseball team.

After two years in this position, he returned to Hardin-Simmons, where he organized the university's first demonstration school, which included twenty regular classroom teachers and at least 100 education majors doing their student teaching.

The first year he was associated with Imperial High School, Imperial, Texas, where he served as principal and the second year he was the superintendent.

In the fall of 1947 Dalton and Estelle Caffey and their two children, Dalton Kimberly and Cynthia Ann, moved to Friona, where he had earlier accepted the position of superintendent. By this time Estelle had had eight years teaching experience.

During the twenty years she taught

here, she taught math, second grade, science and home economics.

Mr. Caffey explained her diversified teaching experience this way. "She was always available and qualified to teach whatever subject I couldn't engage another teacher to teach."

After Mrs. Caffey received her master's degree, she concentrated on teaching home economics and was a tireless worker when it came to sponsoring Future Homemakers of America, assisting students interested in receiving state degrees and other job related activities.

Mr. Caffey began a career in farming in the Hub Community southwest of Friona in 1955. The following spring he resigned his position as Superintendent of Schools and devoted full time to farming for the next twenty years.

Mrs. Caffey retired from teaching in 1968 and since that time the couple has done a lot of travelling, fishing, gardening, canning and home beautification.

Last month the Caffey's attended their 42nd annual Cowboy Camp Meeting in the Big Bend Country of Texas between Fort Davis and Valentine.

This is the original Cowboy Camp Meeting and was started by a minister named Bloys 93 years ago. The first time Dalton and Estelle attended they were guests of friends, Mr. and Mrs. Hal Burnett, formerly of Imperial, Texas, but now of Alpine.

The Burnetts were parents of two former teachers in the local school system, Lee and Margie Burnett.

"The first time we went was before our first child was born," Mrs. Caffey explained.

"Then," she continued, "We always took them when they were small and after a few years they chose attending Cowboy Camp Meeting over any vacation trip we suggested."

At the present time, their son, Dalton, a graduate of Friona High School, who holds a bachelor of arts degree with majors in English and speech and a master of arts in administrative education from University of Texas of El Paso, and is assistant principal of the Zack White Elementary School in El Paso, attends every year.

Their daughter, Cynthia Ann Cotton, is also a Friona High School graduate. She attended Texas Tech, Lubbock, where she received a bachelor of science degree and served

# River Road Turns Chieftain Luck Sour In Season Opener

The River Road Wildcats must have believed what they had been reading about being the "best team in Amarillo." They definitely turned out to be the best at executing their plays, and claimed an opening night victory over the Friona Chieftains last Friday in Amarillo.

The 21-6 win marked the first time in the relatively short history of the North Amarillo school that they have managed to win their opening game. If the Wildcats continue to show improvement, then they have a great chance at having the best season record in the school's history, with a shot at the playoffs.

And although Friona did not play badly, they just could not buy a break

when they needed one. Based on statistics, the game should have been much closer than the final score indicated. And if you could erase a couple of big penalties against the Chieftains, the results of the game could have been exactly reversed.

The Chiefs had one touchdown, a 32-yard scamper by Charlie Morgan, called back for an illegal motion penalty. That additional score would have tightened the game.

But the big back-breaker as far as the Chieftains were concerned came in the second quarter when Friona had recovered a River Road fumble deep in Wildcat territory, at the 14. But an offsides penalty against the Chiefs allowed River Road to keep the ball.

Two plays later, Allen Sanders dashed 74 yards for a touchdown, so instead of Friona being able to tie the score or take the lead, the penalty allowed the home team to take a two-touchdown lead.

River Road had scored the third time they had the ball, after a short Friona punt and a runback to the Friona 25. The Chieftains had themselves been punted into bad field position at their own five.

It took the Wildcats just two plays to reach paydirt, with Gary Martin going 18 yards for the score. The point try failed, but River Road had cracked the scoring ice for a 6-0 lead with 9:24 to play in the first half.

Mark Montoya boomed a punt

which backed the Wildcats up to their own 11-yard line, and this set the stage for the "almost" good break for Friona on the fumble recovery which was nixed by the penalty flag.

Adding insult to injury was the fact that Sanders got around end, found himself in the clear, and ran for the 73-yard touchdown. A running try for two points worked, and the Wildcats had taken a 14-0 lead with 5:34 left before halftime.

The Chieftains threatened the first time they had the ball in the second half, driving to the River Road 19 before losing the ball on downs. Morgan picked up a pair of first downs, one on a 16-yard scamper down to the RR 24 yard line.

Friona was flagged for illegal procedure to get in a hole on first down, and although four plays gained 13 yards, they had to give the ball over on downs.

The next time Friona had the ball, the team seemed again destined to score. The Chieftains took over at midfield after a high punt against the brisk south wind by River Road.

Montoya gained nine yards, and Morgan picked up a first down at the Wildcat 37. Two plays later, Morgan took the pitchout, headed around right end, and dashed into the north end zone. But there had been a yellow flag dropped at the beginning of the play.

The way Friona's luck had been running all night, it didn't take Chieftain fans long to guess who the flag was against, and the violation cost at least a 14-7 score, with Friona having the momentum.

Again, the bad breaks came in bunches, as the Chieftains fumbled the next time they had the ball, and River Road recovered in Friona territory. That set up a five-play scoring drive, and the score became 21-0 with only 5:12 left in the game.

It would have been easy for the team to have just given up, but the Chiefs proved their mettle during the last five minutes.

Following a Mike Neill kickoff return to their own 41 yard line, the team set out on a sustained drive that resulted in a touchdown that counted.

Bruce Patterson passed 25 yards to Max Perea in the middle of the drive, when the clock became as much an opponent as the Wildcats. Perea also had a ten-yard run during the drive, and Morgan chipped in with gains of eight, four and three.

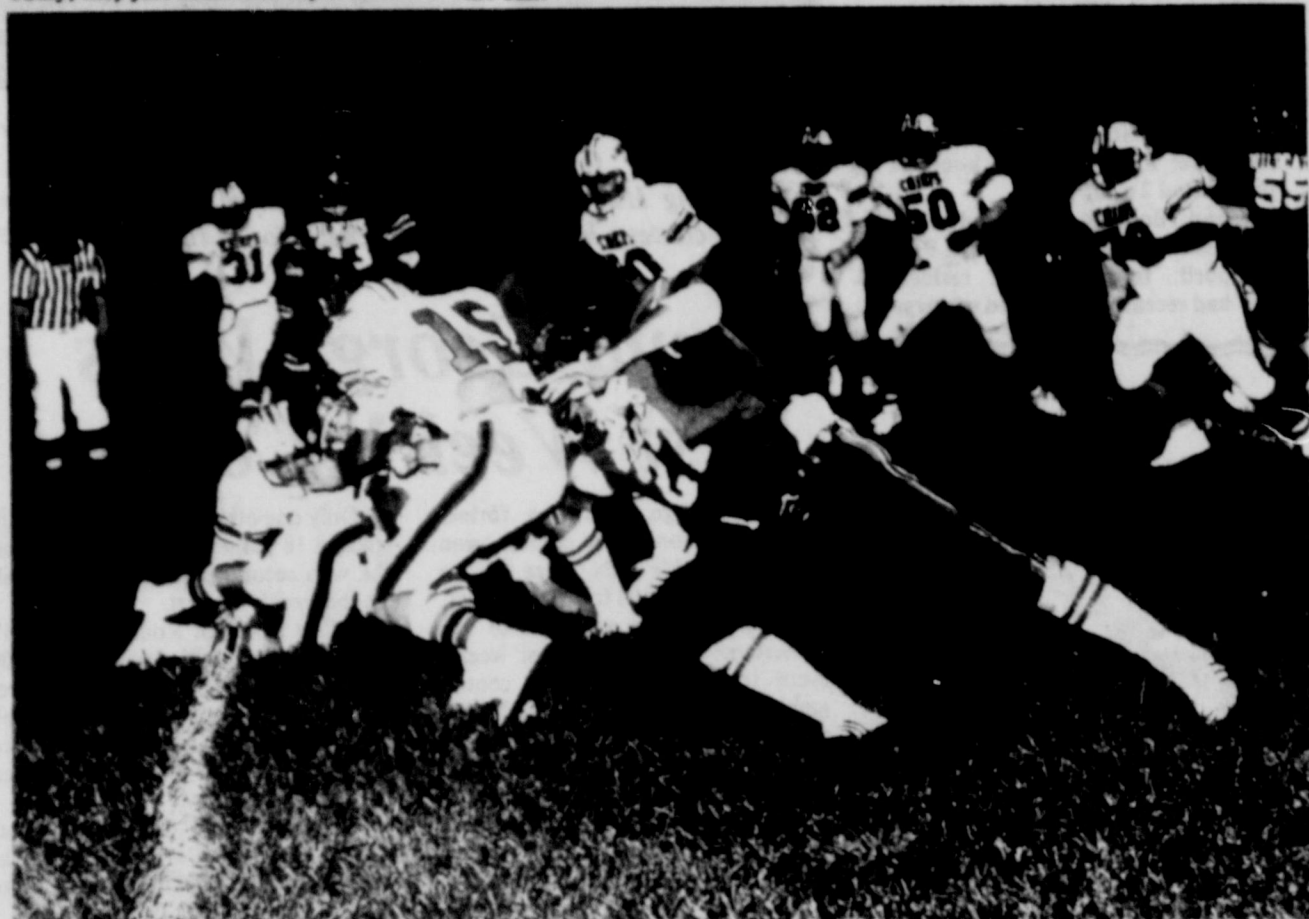
From the River Road ten, Patterson faded back, spotted split end Eloy Caballero free on the left side, and hit him with a strike in the end zone. Morgan was stopped inches short on a try for two points, but Friona had averted the shutout, and shown some character in the process.

The win was the third for River Road in the five-year history of series. Friona has won twice, including last year's 19-7 win here which was virtually a complete reversal of the results of the past Friday's results.

"We outplayed them for three out of four quarters, but that second quarter just killed us. We made some mental mistakes, and they really hurt," said Coach Tommy Moss.

The Chieftain mentor said he felt Friona was a better team than the Wildcats. "I sure would like the chance to play them again," he said.

Morgan was the team's leading rusher with 96 yards, in addition to the 32-yarder he had called back.

## U.S.P.S. Cautions Coin Collectors

The U.S. Postal Service today cautioned coin collectors and investors to check local dealers, libraries or newsstands for coin collecting publications to determine current coin prices before responding to mail-order offers that may grossly inflate the actual value of the coins.

The warning followed signing of a consent order by National Monetary Center, P.O. Box 37438, Washington, D.C., 20013. The Postal Service also is investigating several other coin promotions containing offers similar to those made by N.M.C.

N.M.C. was twice accused of misrepresenting "Morgan" silver dollars, designed by George T.

Morgan and issued between 1878 and early 1921, describing them as relatively scarce, "double minted-marked" and authorized by a special act of Congress. N.M.C. also was accused of failing to make clear that its National Monetary Centers were not connected in any way with the Bureau of the Mint or any other government agency.

The Postal Service most recently filed seven additional complaints against N.M.C. claiming the company was misrepresenting Kennedy silver half dollars minted in 1964, "Liberty Head" silver dollars minted between 1922 and 1935, and U.S. gold coins minted between 1849 and 1881 in two-and-a-half dollar, five dollar, 10 dollar and 20 dollar denominations.

The consent agreement reached with N.M.C. means the company continues to deny each of the allegations but has signed the agreement in order to avoid the cost of a law suit.

As a result, all incoming business mail held or coming in to Washington, D.C., Roslyn, New York and Glen Head, New York for the company after August 25 will be referred to a court appointed trustee. The trustee will open all mail and segregate orders or remittances for any of the affected coins and record the name and address of senders so that a disclosure letter involving terms of the agreement—and an offer to refund money—will be returned to customers in 30 days.

The trustee will continue to handle coin orders until completion of administrative proceedings to determine the truth or falsity of N.M.C.'s advertising. Both sides will present their evidence in hearings set to begin October 12 in Washington, D.C.



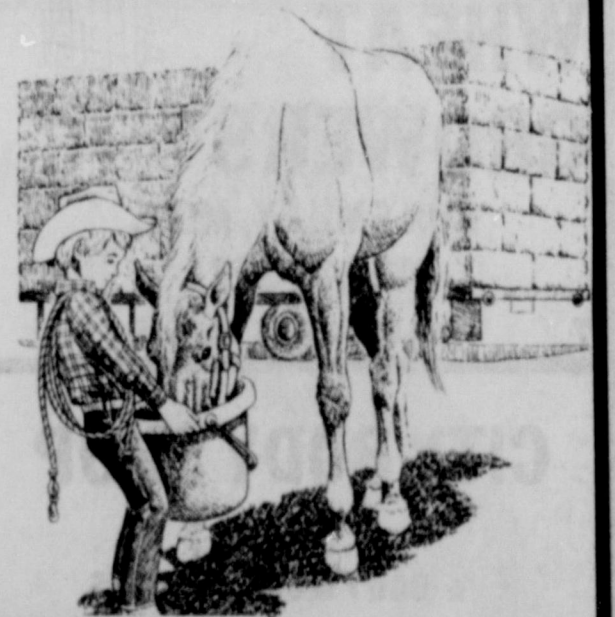

Vela Harrison and T.E. Wood, also a native of Tupelo, Mississippi, were married at Monroe, Oklahoma, November 1, 1920. Their first home was at Caddo, Oklahoma, where they lived one year. Then they moved to Childress and from there to Wellington, where their two sons, Noyle and Billy, were born.

Wood, a pioneer farmer and livestock operator, later moved his family to Anton. Noyle and Billy are both graduates of Anton High School.

The first few years T.E. and Vela lived in Parmer County, where they moved in 1954, after living at Anton twenty-two years, they lived on a different farm southeast of town. Their first home in Friona was on Fourth Street and in 1968 they built the house Vela lives in and moved in. T.E. passed away in 1974. The last few years of his life he assisted with the operation of a mail route.

When asked about her activities, Mrs. Wood replied, "Well, I really don't do much any more."

Further probing revealed that she is an active member of First Baptist Church and takes part in all events relating to her Sunday School Class and Women's Missionary Union.

She's also an active member of Friona Woman's Club and Friona Senior Citizens.

She rarely ever misses a club meeting nor a third Tuesday noon covered dish luncheon at Friendship House. She also spends a lot of time assisting with quilting projects which the Senior Citizens sponsor and is nearly always present for the weekly Thursday game sessions.

Since this isn't enough to keep a great-grandmother occupied, Vela spends her spare time sewing, crocheting, making wall plaques, gardening, growing flowers and doing good deeds for less fortunate people.



# Summerfield Pioneer Was Named Postmistress In 1927

Although Eva Lookingbill, retired postmaster of the Summerfield, Texas post office, didn't live here when the Texas Panhandle was really the wild west, her tenure spanned more than 40 years during which many many changes in mail delivery were made.

When she became Summerfield's acting postmistress in 1927 first class postage stamps sold for two cents and one of her jobs was putting outgoing mail sacks on a crane, so that a passing train could pick it up, and taking incoming mail sacks down from the same crane.

Eva Noland was the oldest of seven children born to the late Mr. and Mrs. J.A. Noland at McGregor, Texas.

Later the Noland family moved to Floyd County, from which they

moved to Castro County in 1917. Their first home was just west of Eva's present home.

Four of Eva's brothers are still living. J.B. and Mack live in the Summerfield Community; Jim lives in Amarillo; and Otho lives in Dimmitt.

After being appointed postmistress, before the title was changed to postmaster for both men and women serving in this capacity, in May of 1928, she was married to L.B. Lookingbill.

His family had moved from Wise County to Swisher County and from there to Castro County two years after the Noland family arrived.

They were married June 30, 1928 and were the first couple married in the Summerfield Baptist Church.

It was coincidental that Eva's

retirement fell on their 44th wedding anniversary. She chose June 30 to retire because the post office fiscal year ends on that date.

Eva's first employment at Summerfield General Store, which was owned by Ray Morland, who was also the postmaster, began in 1927. Soon thereafter her employer finished his term and she was appointed acting postmistress.

Later the Lookingbills built their own store, which they operated for many years, and moved the post office into this building.

The Lookingbill Store, which also housed Eva's and L.B.'s home, soon became a meeting place for residents of the community. In addition to their duties in the store and post office, the couple was often called upon when help was needed in the community and for advice and information on many subjects.

Their five children, Bradley of Amarillo; Jim of Dumas; Bill of Summerfield; Ann Clearman of Ovalo, Texas; and Fred of Minatare, Nebraska, all grew up in the Summerfield Community.

Eva said, "Since 1917, I've lived within a one mile radius of my present home."

Fire destroyed the Lookingbill Store and family's home in 1949. Until a new store and home were built, the Lookingbills lived in the old Summerfield school building.

Following Eva's retirement, L.B. was appointed Officer in Charge until a new postmaster could be appointed.

Mrs. Lookingbill reported, "That was a switch for us. He had been such

a help to me when I was postmaster and it was a pleasure for me to be his assistant."

Since L.B.'s death, Eva has continued to make her home in Summerfield. She lives next door to the store at the present time, but expects to make some changes as soon as the widening project on Highway 60 begins.

Since her retirement, this grandmother of twenty-two has kept busy pursuing hobbies, for which she had very little time for so many years. She sews for the children and grandchildren and keeps her cutting table, ironing board and sewing machine set up ready for use.

She also crochets and has completed a full bed size afghan for each of her children and each of her grandchildren, as well as many nephews, nieces and friends. At last count she had completed more than 60 and had several under construction.

She enjoys doing embroidery work and makes floor pillows and other items for gifts as well as for her own use.

She explained, "I try to keep several things going at all times, so that when I get tired of one I can pick up another and work on it awhile."

Mrs. Lookingbill travels some and always attends the graduation of each of the grandchildren. She says that visiting son Fred and his family in Nebraska and daughter Ann Clearman and her family in Ovalo, Texas adds up to a lot of miles each year.

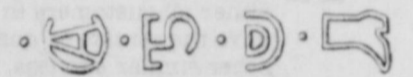

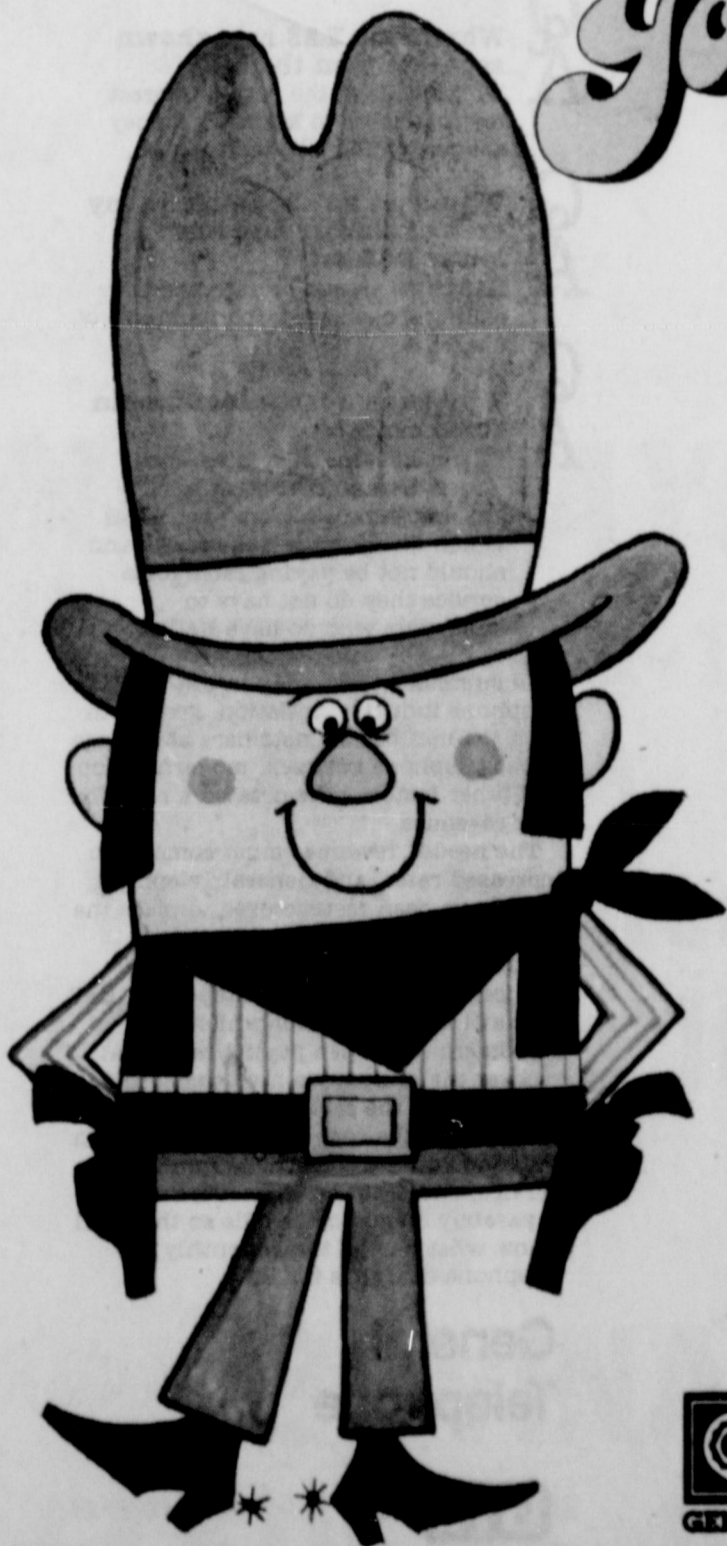

# What About EAS

General Telephone recently restructured local telephone monthly rates to (1) recover the costs of extended area service (EAS) or toll-free calling between exchanges from customers benefiting from the service and (2) to show the monthly charge for EAS separately from the charge for local service for the first time.

Prior to this restructure, customers in all exchanges had been paying for EAS service. However, the charge for EAS was not shown separately but was combined with the charge for local service and appeared only as local basic service on monthly statements.

Now only customers in communities with EAS pay for the service and customers who have the service know what it costs them each month.

The changes resulted in a number of questions from customers since the monthly charges to them were shown separately for the first time. The most often asked questions and answers follow.

Q

**What is EAS?**

Extended Area Service (EAS) is a service that expands the calling area of customers within an exchange so they can call other exchanges without a long distance charge.

Q

**What is General Telephone's position on EAS?**

General Telephone wants to meet its customers' needs and desires and will provide the service if it is in the public interest of the communities.

Q

**Is this a new service?**

No. The service has existed for a number of years.

Q

**How did an exchange get this service?**

Usually cities would determine their community of interest including one or more neighboring exchanges and EAS between those exchanges was implemented in response to public interest. The local monthly rates were increased to reflect the company's additional costs.

Q

**When EAS was established, we paid higher rates for the service. Why do I have to pay for it again?**

The rates established when the service was implemented were designed to recover the costs at that time. As communities have grown, so has the use of the EAS facilities, requiring additional costs which must be recovered.

Q

**Since we were already paying for EAS, why did General Telephone change the way costs for the service are recovered?**

EAS was established on a city-by-city basis prior to the establishment of the Public Utility Commission of Texas. Customers in cities with EAS paid for the EAS service. When the PUC assumed jurisdiction of local telephone rates, investments and expenses were recovered statewide. Cities with similar calling scopes paid similar rates. This rating technique did not recognize the additional costs of EAS. Customers in an exchange without EAS paid the same rate as customers in a city of similar size which had EAS. This resulted in the customers without EAS paying rates that helped recover the costs of providing EAS to those benefiting from the service.

In its January 1982 rate filing, General Telephone sought and the request was approved to have rates established which would have customers with EAS pay the costs associated with the provision of EAS rather than all customers paying for those costs.

Q

**How did you determine what the EAS rate should be?**

Company records show the total investment required to provide local, EAS and long-distance telephone service. In addition, investments that are required just for long-distance and EAS calling are known.

The minutes of use for an exchange for each type of call—local, EAS and long-distance—are also known.

By taking these known investments and minutes of use, it was possible to equate the revenues required to recover the respective costs. Rates were then established to recover these revenues.

Q

**What is meant by "minutes of use"?**

Minutes of use are those actual times, in minutes, which customers use our various services, i.e., interstate toll (long-distance calls between states); state toll (long-distance calls within a state); extended area service (calls between communities for which there is no long-distance charge) and local calls (calls within a single community). After toll is removed, EAS accounts for approximately 34 per cent of all usage.

Q

**Can I elect to have or not have the service?**

EAS is not an optional service—either all customers in the exchange have the service or none. There are other similar services, such as foreign exchange, which allow individual customers to have a direct line to or from another city.

Q

**What can be done to change EAS?**

Normally the local government would determine what is in the public interest in regard to EAS. However if there is a problem in determining the public interest the company will assist in developing and tabulating a survey. General Telephone is neutral on the question of EAS as long as we are compensated fairly for providing the service.

Q

**Why is the EAS rate shown separately on the bill?**

We feel it is in the public interest for customers to know what they are paying for EAS each month.

Q

**Why does an exchange in my area of similar size have a lower EAS rate?**

EAS rates are set by rate bands or calling scope based upon minutes of use/cost.

Q

**Why such a large increase in some cases?**

To some degree, increases were larger than normal because of shifting the costs from exchanges which do not have EAS service and should not be paying rates for a service they do not have to customers who do have EAS service.

In summary, deregulation of the telephone industry, inflation, growth in both the number of customers and usage of the telephone network, modernization and other factors have created a need for new revenues.

The needed revenues must come from increased rates, and General Telephone rates have been restructured to place the cost of individual services on the customers who benefit from those services—rather than all ratepayers. EAS is one of the services for which all customers have been paying rates that recover the company's investment and expenses for the service. The change in rates places the cost of providing EAS on those customers benefiting from the service, and that cost is shown separately on customer bills so they will know what part of their monthly telephone charge is for EAS.

# Ex-Cowboy Recalls "Good Old Days"

Even though most of Parmer County's real cowboys ride horses while they're working, a lot of their

travelling is done in pickups pulling trailers.

At least one Friona ex-cowboy remembers when things were vastly different. He's a native of Kaufman County, where he was born in 1895. He grew up on a farm there and learned how to work and take care of cattle.

He remembers when being a cowboy on a large ranch meant living outdoors most of every year. Wherever a cowboy went he took his bedroll with him—either behind his saddle or in a wagon, which accompanied the chuck wagon.

During the late teens and early twenties the Panhandle of Texas was really "The Wild and Woolly West," and tales of excitement here lured many young men from different parts of the country. Some of them worked a few months or years then drifted on, but one of them stayed.

Clarence (Slim) Ashcraft, 1210 Main Street, Friona, first saw the

Parmer County prairie in 1917 from the back of his saddle horse. He rode from Seymour to Friona looking for work.

His first job here was working on a ranch for Tom Galloway, who had extensive leases in the northern part of Parmer County and the southern part of Deaf Smith County. He lived about ten or twelve miles north of Friona.

About Thanksgiving the following year the snow began to fall. Before New Year's Day 1919 all the pastures were covered with snow, which had accumulated to a depth of about eighteen inches.

By the time the snow thawed in the spring, most of the cattle in the entire area had either starved or frozen to death. There were very few left for Galloway's cowboys to round up, but he immediately began a rebuilding project and was soon leasing more pasture land, including the Escarbada Ranch on the Tierra Blanca Draw.

About this time Ashcraft started doing day work and trail driving. The longest trail drive he remembers began north of town, went over near Dexter, New Mexico, then to Midland, Texas. Returning the outfit drove cattle from Midland to the Canadian River picking up extra head at several places along the way.

At that time a trail driving crew consisted of a trail boss, a cook, six or eight cowboys, a chuck wagon, a remuda containing five or six horses for each cowboy and a horse wrangler. At night one horse would be staked or hobbled near the camp ground and the next morning, after the wrangler gathered the horses, holding pens were made with catch ropes and as the horses were caught the trail boss assigned one to each cowboy.

After reporting that he had "cooked out of a wagon," Ashcraft said, "When you were out on the trail you sometimes got jobs for which you were not especially qualified."

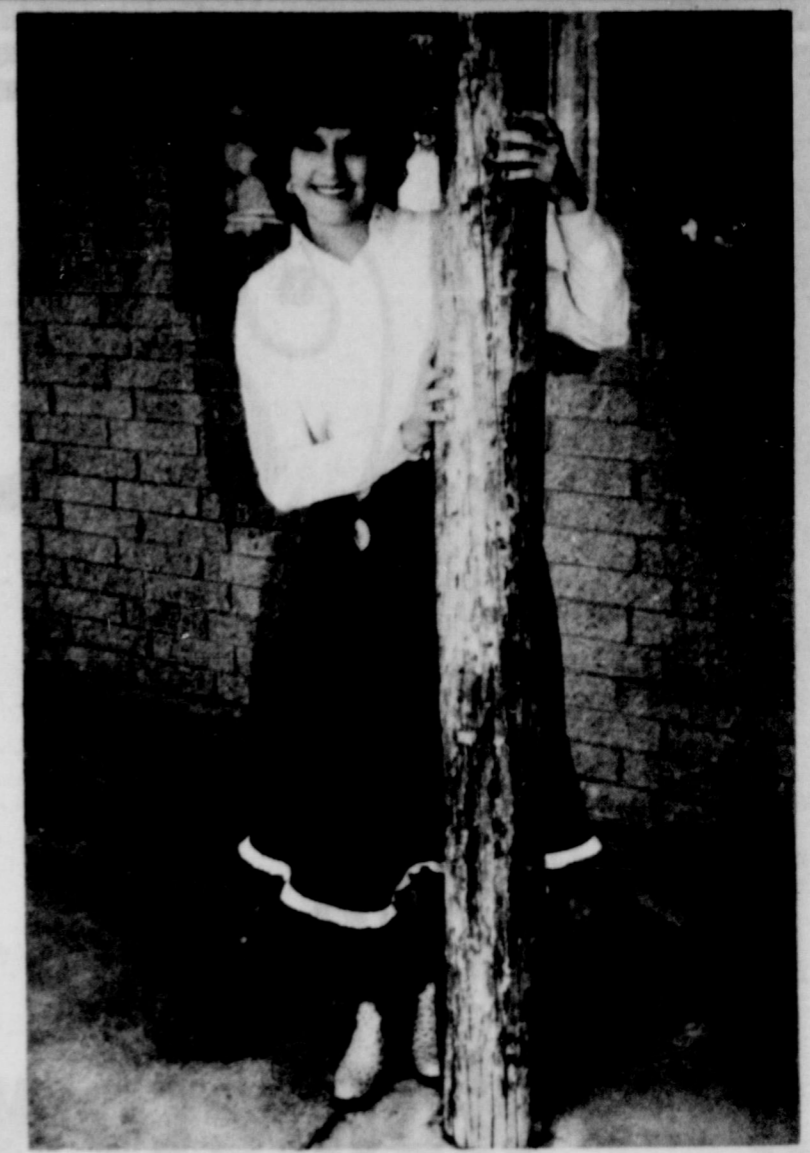
Sour dough biscuits, cooked over an open fire in a Dutch oven, beef steak, dried beans, dried fruits and gravy were usually on most menus.

He remembers one of the biggest problems a trail cook had was finding something to build a fire with. "Dry cow chips were generally plentiful," he reported, "but you had to have something else to get them started burning with."

He also remembers, "There's nothing quite like waking to the sound of pots clanking and the smell of coffee brewing."

Slim was one of eight children born to the late Mr. and Mrs. J.W. (Bill) Ashcraft, who moved here in the middle twenties. Another of the couple's sons, Elbert, came to Parmer County before Slim did. Slim and one sister, Dollie Hawkins of Lubbock are the only family members living now.

After ten years of ranch work, Slim decided to go into farming, an occupation he pursued about the same length of time. During this time

he was married to Jewell Berry, who died in 1975.

The couple's only daughter, Betty Zon, and her husband, Frank Reed, and daughter, Zonya, now live in Borger. Frank and Betty Zon are both graduates of Friona High School. Their son, Ronnie, is married. He and his wife live in McPherson, Kansas and have one daughter.

Ashcraft reports that farming conditions were not too good in the late thirties, so he once again went back to doing day work.

In 1952 he went to work as a school custodian and he and Jewell and Betty Zon moved into the house he

now lives in. For the next 22 years he continued in the same job. Then he retired. Later he worked for the City of Friona seven or eight years.

"Now," he reports, "I'm in my second retirement. About all I do any more is cook and take care of myself, do a little housekeeping and grow a garden."

His final remark as the interview was concluded was, "I may be about ready to go into my third retirement. The Bermuda grass is about to take my garden spot, so I may just retire from gardening."
