More Telephones In Sanderson Noted During Past Decade

Southwestern Bell manager. Robert Hurt reported that the number of telephones in Sanderson grew to 694 during 1969. He noted this figure compares

with 620 telephones here at the end of 1960.

"Sanderson residents also see m pretty talkative," Hurt said. "They dialed 2, 280 calls per average business day during November. " He said a circuit equipment

job in the central office was started in last 1969 and is due for completion in January. The project cost was \$32,000 and will provide circuit relief between Sanderson and Alpine.

During 1969, Sanderson gained 12 telephones.

Hurt said a record \$99 million construction budget has been set by Southwestern Bell for its San Antonio Area, of which Sanderson is a part. The area covers roughly the western half of Texas.

The \$99 million figure is for land, buildings, central office equipment and outside plant such as cable installation.






