ISTEN, TO LUKE For District Court

According to information released last week by the postal service, price increases for that service are scheduled to go up in May.

First class mail is expected to be 8¢ instead of 6¢, post cards 7¢, and air mail 11¢. All these prices are for the first ounce of mail weight.

And get this shocker! - Second-class mail, such as newspapers and magazines will go up an average of 142%, while third-class mail, which includes such items as advertising circulars and other "junk" mail will be increased one-third.

The figures we have say the increase will be about 3¢ or 4¢ per newspaper or magazine.

Being conservative - as we naturally are - and guessing the increase for our paper will be only 2¢ per copy, this will be \$1.04 per year per subscriber, average, increase in newspaper mailings.

By the time that we spend an average of 20¢ per customer in collecting the amount of the subscription, this would make the cost of collecting and dispatching the paper at \$1.24 per customer out of the county.

One good friend suggested we print in big red letters across the top of page 1 "JUNK MAIL"! This would put it in the third-class handling - what it gets anyway away from Sanderson, and would be maybe cheaper to mail.

There are some considera -. tions which we must make before we do this, but it is food

for thought! Another idea followed the labelling The Times as "junk mail", the friend said that it might also increase our circulation.

We have noticed recently the dust is boiling more and more around town. It has come to our minds that possibly the reason for this is the lack of rain that this country has endured

for the past several months. And it's no consolation by any means, but there are some places that are much drier than Sanderson and Terrell County, believe it or not.

The registration of voters deadline was extended 30 more days by the legislature. We doubt the results of this will be worth the effort, but seldom does anyone ask for our opinion on looming legislation. One might surmise that some of the powers that be presumed they might not get enough votes with the number registered and favored the extension so they could get out and be sure their "bushes" were properly beaten prior to the new deadline.

If you haven't registered, you may now with the new 30-day extension, and who knows, there may be another one!






