# Well Completed Then Abandoned

Texas Oil & Gas Corp. field a calculated, absolute open flow potential of 25,000 cubic feet of dry gas per day for its No. 2 Allison, 2,300 feet west of the depleted opener of the Mesa Grande (Leonard gas) field of Terrell County, 20 miles souther west of Sheffield.

Production was through perforations at 3,503-522 feet, which had been acidized with 5,500 gallons.

Drilled to 3,800 feet, with 2 7/8 inch casing set at 3,620 ft., it is plugged back at 3,585 ft. The Permian was topped at 64 ft. and the Leonard at 3,468

ft. on ground elevation of 2546 ft.

The project had been reported as abandoned May 4 and apparently will not be produced.

east lines of 8-A4-Mrs. A.Pride. The discovery, Hunble Oil & Refining Co. No. 1 Allison, was finaled May 11, 1963, for a calculated, absolute open flow of 4.6 million cubic feet of gas per day through perforations at 3,373-387 ft. It became depleted in July 1967 and was re-entered by Texas Oil & Gas and abandoned again June 1, 1972.

## Trash Hauling Fee Raise Initiated

Local citizens who receive water bills will notice that there is an increase in the amount listed on the bill under "sanitation". The fee jumped from \$1.00 to \$2.50 for residences and for business houses went from \$2.00 to \$4.00 with the promise of one pick-up per week for businesses and residences.

There are several residences and/or businesses in Sanderson that are not on a separate water meter and consequently do not receive a billing for the hauling of their trash, it was pointed out. The sanitation fee is printed on the water bill and collected by that source if the water customer wants to pay the fee, as there is no connection between the Terrell County Water Control & Improvement District and the Terrell County Commissioners Court, which pays the water district for collecting the sanitation fees and reporting to the commissioners the amount collected.

There is also a 50¢ charge printed on the water bill and water meter customers arbitrarily pay this amount for the maintenance of fire fighting equipment and maintenance.

The raise in the sanitation fee was a decision of the commissioners court after a study was made of the costs of the service to local people and the amount paid.


ATTENDS REGIONAL MEET

#### Oil,Gas Produced Adds To Coffers

Terrell County was one of 190 of Texas' 254 counties that produced oil and gas valued in excess of \$100,000 in a record production year for the state's No. 1 industry, according to figures compiled by the Texas Mid-Continent Oil and Gas Association.

The study by the Association also shows that production last year in Terrell County resulted in the payment of \$816,000 to royalty owners.

The state of Texas received \$490,000 in production taxes from county wells, almost all based on natural gas production.

Oil and gas producers and developers spent \$363,000 drilling six wells in the county last year, with \$115,000 of that figure lost in three dry holes, according to the figures from

Mid-Continent.

According to the Texas Employment Commission, 84 oil and gas industry employees worked in the county in 1972 and shared a payroll of \$818,-000.

#### Game Seasons For Area Are Set

Game seasons have been set by the Texas Parks and Wildlife Commission, according to a pamphlet received last week.

Deer season is November 24 to December 9, four deer, no more than two mule deer, no more than one mule deer buck, no more than two white-tail bucks, and no more than three anterless deer. There will be a special season in Pecos and Terrell Counties for white-tailed deer November 24 through December 16.

Javelina season is September 1 through January 31, with two javelinas per season in the Trans-Pecos.

All hunters are urged to investigate the laws concerning tagging deer, trespass laws, and other regulations concerning the killing of game birds and animals.





Library facilities on the south campus are equipped with the latest multi-media instruction devices, such as tape recorders and slide and motion picture projectors for self-paced instruction.

Texas' newest university is sprouting from the West Texas plains at Odessa with what its administrators describe as the most revolutionary program in higher education today.

If the experts are right, Yale, Stanford, Harvard, Rice and the rest will be studying the ultramodern campus of The University of Texas System that opens its doors this fall as The University of Texas of the Permian Basin.

Texas-Permian is the first we-year, upper-class university n Texas designed for junior, senior and graduate students. It s accepting all credits with a inimum grade of C from all ccredited colleges. But killing the credit transfer hassle isn't mough. The university is challenging students to transfer in as members of the pioneer class. A look at the completed South Campus facilities indicates that "innovation" is more an an idea. The hardware is ere, and so are the faculty, h.D.'s drawn from throughout

the United States because of their particular expertise and their desire to crash out of the aged classroom lecture technique. This faculty is composed of talented people with years of taching experience at the best universities in America.

"Each professor will virtually tailor each course to the individual," says Amstead. "The instructor will plan the course by starting at graduation day, so to speak, and determining what the student should know, be able to do. Then he'll work backward and develop course segments.

"He'll use whatever devices that will best advance the student — self-paced instruction, multi-media or even classroom lecture methods.

"We'll have mobile units designed as roving laboratories with live-in facilities to travel anywhere in the country."

Amstead said the roving classrooms will consist of 13 custom-built vans designed for a specific function, such as science laboratory, classroom-study hall, bubble-top art studio and dormitory. The units will be kept on the move for fossil hunting, life science study, onlocation art classes and even snow skiing trips.

"It's part of our philosophy of removing students from the classroom and placing them in real-life conditions," said Amstead.

Amstead says about one fourth of the classes beginning this September will utilize self-paced instruction. "That percentage will increase as we move along, to where there is less and less lecture."

Texas-Permian professors are being trained in a systems approach to learning management. A computerized faculty activity analysis system has been designed to provide each professor with feedback on learning results, so he can modify and improve on innovative techniques.

"Nothing that is implemented will be experimental, and yet we'll experiment with whatever we implement," Amstead said. "All these techniques have been proven elsewhere - on other campuses and in business and the military. They'll give the student more freedom. For example, in self-paced learning courses, students won't have to attend conventional classes. They'll be tested on a course segment when they say they're ready for it. Laboratories will be open all the time for what ever students require. If they can 'quiz out' successfully in

half the allotted time, they'll have the course wrapped up. If they need more time, they'll get it."

"Financing should be no problem to the student," said Amstead. "We have many sources of help, including scholarships, grants, loans and parttime employment. Just let us know."

The main campus under concrete-mold construction even now looks like an avant garde institution where something mind-boggling is under way. Amstead is proud as punch of it.

"We looked at 19 other modern campuses, including the U.S. Air Force Academy at Colorado Springs. And this design incorporates the best features and concepts to date."

The \$14 million main campus has three levels, each with an acre of modular classroom space, built 22 feet above the ground on a man-made mesa. The ground level will contain above-ground utilities, which eliminated the cost of digging into Permian Basin rock. Vehicular traffic and parking facilities will be on the ground, with pedestrian traffic concentrated on the second level. One will be able to walk outside but under cover to every building in no more than six minutes.

The East Texan, South Texan and out-of-stater who attends Texas-Permian will be in for a shock or two besides those encountered in the "classroom." The university is pointing at New Mexico ski slopes, a mere fourhour drive from Odessa, and a nine-hole golf course - soon to be 18 — on the 558-acre campus. The school will have the largest Olympic swimming pool of its kind in the country, which it will need if enrollment predictions click. Amstead expects 3,500 students by the third year, about 6,500 in five years and 10,000 by 1990.

Odessa's Shakespeare Globe Theatre will be one of the university's drama workshops. The theatre has been described by The New York Times and history experts as the world's most authentic replica of the London theatre made famous by Shakespeare. The theatre is directed by Charles David McCally, widely recognized Shakespearean actor and director.

Considering the preferences of today's contemporary student, Texas-Permian will have no dormitories, except for the mobile study units. Students will live near the campus in apartments and homes. "This way they'll be part of the main lifestream of the community." says Amstead. "When they are graduated from here - whether their degree is in chemistry, math, engineering, aviation management, law enforcement management, creative writing or what have you - they won't be coming out of an idealistic ivory tower. They'll be on the ground and running."

#### Improved Grasses Get Improved Result

"Our survey revealed that in the past 20 years, 5.9 million acres of land has been planted to new grasses released by the Soil Conservation Service," Edward E. Thomas of Temple, state conservationist for SCS, stated. "Statewide increased beef production is averaging 56 pounds per acre per year from these grasses.'

Thomas said 23 grasses released by SCS are being grown in Texas. Each has its own area of adaptability and is used to fill a specific conserva-

Two grasses account for a major share of the acreage planted. Buffelgrass, released by SCS in 1949, has been planted on 1.8 milion acres. Other wide ly-planted grasses include Pensacola bahiagrass, El Reno sideoats grama, and weeping lovegrass.

In addition to the increased beef production, the survey rehave increased mutton production by more than 1.1 million pounds. Smaller increases were noted for milk, mohair, wool, and goats.

Other benefits from the planted grasses include erosion control, reduced sediment damage to lakes and streams, fewer dust storms, and more abundant wildlife.

Thomas said that there were other factors contributing to increased beef production on Texas grasslands, such as better livestock, improved grassland management, irrigation, and increased use of fertilizer.

#### JULY 14, 1973 Bentsen Seeks To Retain Wilderness For Park, River

Senator Lloyd Bentsen has introduced bills to include the Big Bend section of the Rio Grande in the Wild River System and to preserve more than half of the Guadalupe Mountains National Park as a wilder-

"Despite their rugged appearance, both these stretches of West Texas wilderness are parts of ecological systems that are easily damaged and difficult to repair," Bentsen said.

He noted that the unusual rel ic forest in the Guadalupe Mountains has already suffered damage due to extensive use of the park. And the segment of the Rio Grande which flows through Big Bend National Park is susceptible to the unregulated development that often occurs in popular scenic areas.

"We must act now to insure that these natural heritages are saved, unmarred by the designs of man, for future enjoyment and scientific study," the Senator continued.

One of Bentsen's measures would designate 46,850 acres of the 77,000-acre Guadalupe Mountains Park as a wilderness, in line with a recommendation by the National Park Service.

The other proposal would bring the Rio Grande, through Big Bend Park and on south for 94 miles, under the protection of the National Wild and Scenic Rivers Act. A total of 212 miles of river is included.

Bentsen compared the lower canyons of the Rio Grande to the Grand Canyon of the Colorado and the Hells Canyon of the Snake River. And he added that the geology and biology of the proposed Guadalupe Mountains Wilderness are of considerable scientific interest

"Each of these areas represents a unique portion of the Southwest that encompasses some of the most sparsely inhabited and well preserved wilderness on the North American continent," Senator Bentsen said.

#### Restitution For Mail Fraud Victims Made

More than \$6 million wasrestored to potential victims of mail frauds during a recent nine-month period, Postmaster J.R. Hodgkins reported this

Mr. Hodgkins said he had been advised by Chief Postal Inspector and Assistant Postmaster General William J. Cotter that Postal Inspection Service enforcement activities resulted in \$6,222,660 in restitutions to those victimized by mail frauds. The report covered the first three quarters of the current 1973 fiscal year, through March.

"The report shows that it is worthwhile for those who have good reason to conclude they have been the victim of a scheme to defraud in which the mails were used to report the facts to the post office," the local postmaster comment-

"Included in the 12,000 or more mail fraud investigations completed each year by Postal Inspectors, "Postmaster Hodgkins said, "are those based on complaints from postal customers who allege failure to receive merchandise or promised refunds from mail order firms. Not all such failures or broken promises indicate a scheme to defraud, but may, in fact, be merely the result of poor business practices," he

"However, when a postal customer cannot obtain satisfaction through his own efforts," Mr. Hodgkins added, "he should not just write his transaction off as a loss. Return of his money is possible in some
