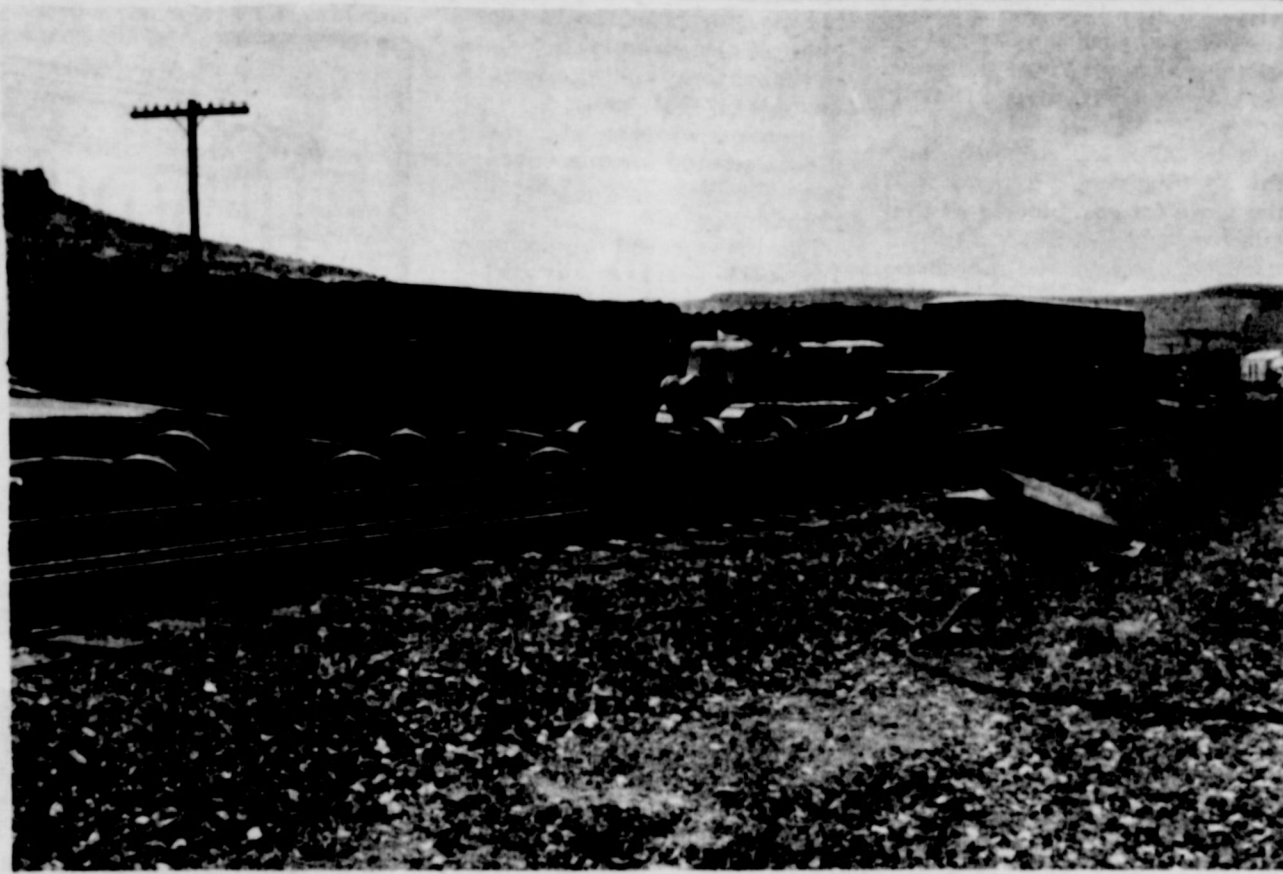
It's good news that we are hearing these days, and we are always glad to hear good news.

Commissioners Underwrite Salary Of Nurse-Medic

The acquisition of a nurse-practitioner for Sanderson and Terrell County moved one step closer to realization Friday of last week when the Terrell County Commissioners Court, in a special meeting, underwrote a necessary \$12,000.00 per year salary for the medical practitioner. The guarantee was one of the necessary steps necessary to assure the coming of the nurse-practitioner.

Troy Druse, who heads the committee that has been in contact with the officials in the initiation of the project, said that when the services of the nurse-practitioner was secured for working out of the Trans-Terrell Medical Center, she or he would work with the doctors in Fort Stockton, Alpine, and Iran that were interested in cooperating with the local practitioner to become familiar with the treatments, practices, etc., of each of the doctors and would then be available here to see patients and advise doctors or make referrals when necessary. It was pointed out that some of the routine visits of patients to doctors could be handled without consulting the doctor.

Other members of the committee are R.S. Wilkinson, Lewis Cash, Sylvestre Silvas, and Dudley Harrison.

Run-Off Election Turn-Out Is Light

The voting of the electorate of Terrell County in the Democratic Run-Off Primary election followed the pattern of the rest of the state in being light, by comparison with the potential voting strength and also by comparison with the vote turn-out for the first primary.

Terrell County went with the two winners of district contests: Robert Krueger, in the race for U.S. Representative of the 17th Congressional District; and Mrs. Susan Gurley McBee, in the race for representative of the 70th district in the Texas House.

Terrell County voters also gave Ruel Adams a decisive win in the county clerk's race 320 votes to 233 for Mrs. H.M. (Twanna) Petty.

In precinct 4, W.C. Baker got the nod for Democratic Executive Committee member by a two-vote margin over Mrs. George Escobar 55-53.

The unofficial tally of votes in the county by precincts accompanies this story.

and the condemnation of future actions of that kind or any kind of law violations should be the natural result of moral law-abiding citizens, rather than the condemnation of those who uncovered the mess! And, in defense of President Nixon: he has done a few things that are good and right! And the wrongs he has done may be different from some or all of the wrongs that we all have done, but we all stand in the same boat of "Im-perfection".

We have heard some who seem to be stacking up all of the good on one side and all of the bad on the other (based on their own opinions of "good" and "bad") and the heavier of the two sides - in their opinion - determines how they feel about him! This idea of "keeping books" by "debiting" and "crediting" bad and good gives a distorted balance, according to our own evaluations and judgements. Thank God, we are only judged by men in this manner! President Nixon's good deeds (by my evaluation) are several, as are his bad deeds (by my evaluation). And many of both affect a lot of people, maybe! But he does a lot of things exactly like you and I: he eats, sleeps, puts on socks one at a time, does some things right, and some things wrong!

And the odd part of it is, that after thinking about it quite a while before writing it, it looks just the way it did before we spent all the time thinking!

Pouring of the slab foundation for the building to house Bill's Superette is expected to be well underway if not completed by the time this is read.

Bill Rose, who is to be the owner and operator of the grocery and market, stated that he hoped to be open for business by the middle of July, but the opening would depend on the time for completion of the building and installation of fixtures, displays and merchandise.

The building on the corner of Persimmon and Oak St, north of the Turner Hotel building. The building will be 50x82 feet and facing Oak St. from the southwest corner of the intersection.

Young Construction Co. of Fort Stockton has the contract for the erection of the building.

School Board's Decisions Told

The regular meeting of the board of trustees of the Terrell County Independent School District was Monday night of last week.

The minutes of the preceding meeting and a financial report were the first items heard by the group.

Resignations were received from Willie Myers, Mrs. Richard White, and Miss Elaine Ketzler. Authorized personnel were given a raise in mileage, meals, and per diem while on official business for the school with 12¢ per mile, \$2.50 per meal, and \$20 per diem as the new rates, according to Supt. C.B. Card.

The board elected to hire an additional elementary teacher for next year; authorized the tax assessor-collector to purchase a new calculator for use in that office, and to advertise for bids on fuel, etc.

Approval was given for the media service for one year from the West Texas Education Center.

The board voted to purchase a new 60-passenger bus to replace one which will be sold when the new one arrives. Supt. Card stated. The business manager was also authorized to invest bond and local maintenance money.

The board rejected a request to teach elementary students by correspondence courses.

Library Friends Near Climax Of Facility's Use

Members attending the meeting of the Friends of the Terrell County Public Library last Tuesday evening were thrilled over the reports showing progress in so many areas and realizing the vital place the library holds in the community.

Mrs. Irvin Robbins, president, reported that for the past two months there had been 665 adult visitors to the library and 674 children. There were 945 books of fiction checked out, 394 non-fiction, 38 biographies, 533 paperbacks, 100 magazines, and three Spanish books.

The report of Mrs. W.H. Savage, memorials chairman, showed four books and \$148.50 in cash contributed by 21 persons. Figures compiled for the seven years that the library has been here showed 208 memorial books and \$1605 in cash by 208 contributors.

The record player which had been purchased for the children's story hour was exhibited; also the electric coffee percolator given by Mr. and Mrs. A. H. Zuberbueller as a memorial.

An artificial grass rug was purchased for the front porch at a cost of \$68.00. A short story index was purchased from the funds given as a memorial to the late Edward (Bado) Wheeler and a book cart from cash memorial contributions to the late Mrs. Eloise White.

The summer reading program will be from June 10 to August 10, plans to be announced later.

Slides made by Rev. David Marx at the time of the recent presentation of the placque to the Sid Harkins family have been given to the library.

Mrs. W.H. Savage, Ray Hodgkins, and Mrs. E.E. Harkins were named on a committee to purchase a sign for the library.

Mrs. R.A. Gatlin reported that the White Cross packages had been sent to Korea.

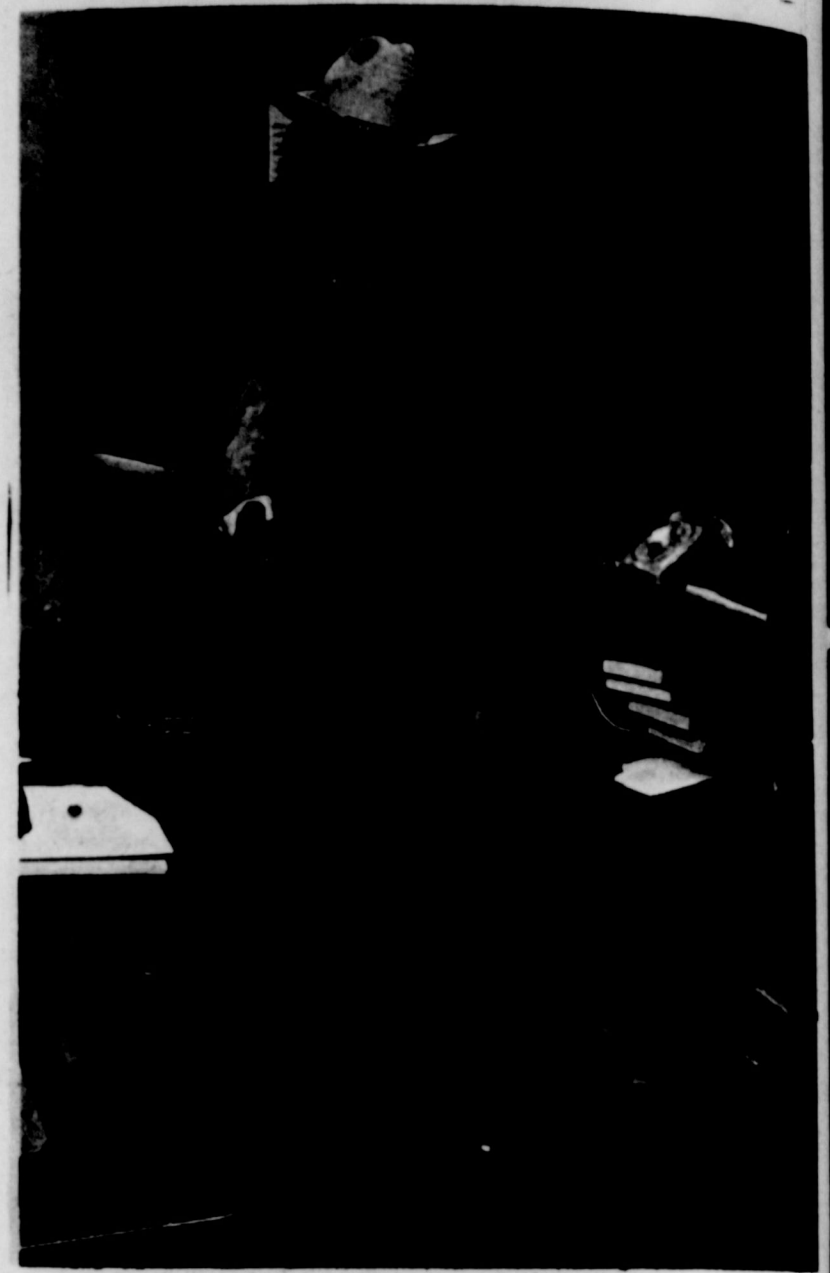

STATE CAPITAL Highlights AND Sidelights

AUSTIN, Tex. — Texas Constitutional Convention delegates, bogged down again in debate, were told that, when they finally agree, they must get out and lead the campaign for a new constitution.

Louisiana Gov. Edwin Edwards and House Speaker E.L. Henry offered words of advice, comfort, cheer and condolences to their Texas neighbors concerning the business of constitution writing.

Both had leading roles in adoption of a new Louisiana constitution early this year after a convention in 1973.

"You have got to take your document to the people, or it won't get done," Henry told the Texas delegates.

Special interest groups will reach their constituents, warned Edwards; so state officials must try to sell the new document drawn by the convention to average citizens who hold the swing votes.

At the same time, visiting Governor Edwards said it is highly doubtful the Louisiana revision would have been adopted had he not taken an active part in promoting it.

Meanwhile, Texas delegates had a bucketful of problems trying to get together on the judiciary article of their product. Merger of the Supreme Court and Court of Criminal Appeals, right of appeal by the state in criminal cases and status of county judges proved the toughest items to compromise.

Even before agreement could be reached on the judiciary, delegates plunged on into the general provisions article which promised some of the convention's highest-voltage controversies over so-called state right-to-work provisions and other tough ones.

REPEATERS ARRESTED — More than 65 per cent of arrests recorded through criminal fingerprint cards last year had prior records, the Department of Public Safety reported.

Twenty-five per cent of the 273,180 arrests were of 17-19 year olds.

Criminal arrest fingerprint cards increased 21,510 in 1973 over 1972. An average of 1,019 cards a day was submitted by 635 different Texas agencies and 18 out-of-state agencies.

OIL CONSERVED — State agencies and colleges conserved the equivalent of 75,334 barrels of crude oil during March compared to the same month a year ago, the Governor's office calculates.

Overall state agency energy consumption declined 12 per cent for the month, according to a special energy report. Electricity use dropped seven percent, natural gas 12.2 per cent and gasoline 11.9 per cent, while "other" fuel use increased 3.9 per cent. The increase was due largely to conversion from gasoline-powered machinery and vehicles to diesel-powered units.

COURTS SPEAK — Cities cannot tax rolling stock of railroads, the Texas Supreme Court held.

At the same time, the High Court concluded that a doctor could not be held negligent for failure to order x-rays to detect a small chicken bone in a baby boy's lung.

A Jefferson County man, sentenced to 75 years for heroin sale, won a new trial because his lawyer was not allowed to impeach a state witness by bringing up a prior conviction.

The Supreme Court declined to hear arguments by attorneys for Elmer Wayne Henley Jr., accused of Houston sex slayings, on immediate transfer of the trial site from

San Antonio.

The Court of Criminal Appeals upheld the conviction of Johnny Eduardo Swift, a black, for the killing of Hearn bank President H.C. Kelly, finding no racial discrimination in the grand jury commission.

A Dallas ex-policeman was turned down by the Court of Criminal Appeals in a bid for a new trial as an accomplice to murder, though the woman charged with the murder was acquitted.

AG OPINIONS — Persons over 65 are entitled to benefits of homestead tax exemption where political subdivisions have approved, though they fail to so claim during rendition period, Atty. Gen. John Hill held.

In other recent opinions, Hill concluded:

- The property tax for higher education does not expire in 1987 but extends for an indefinite period.

- Names of persons whose sentences for possession of marijuana have been commuted by the governor should be made public.

- The Department of Public Welfare is not precluded from negotiating a premium for its medical assistance program which can be expected to result in a reduction of the Medicaid reserve.

- Animal Health Commission records concerning an examination of cattle for

brucellosis are subject to inspection by the owner, but it is not mandatory that the commission authenticate the records to make them admissible in a trial growing out of herd purchase.

- The Board of Pardons and Paroles can provide counsel for indigent prisoners whose parole is to be revoked.

- Legislative pay is not dependent on attendance, but mileage compensation is dependent on actual travel.

- Cities can regulate private sewage facilities.

- Commissioners courts may issue revenue bonds under the Clean Air Act.

- Lobbyists may file activities reports for their bosses.

APPOINTMENTS — Governor Briscoe appointed Erwin A. Elias of Waco to the Texas Motor Vehicle Commission, and Rojelio P. Perez of Austin director of the new Migrant Affairs Office.

Briscoe named Sam Baxter of Marshall Criminal District Attorney for the 71st judicial district (Harrison County), succeeding Vernard G. Solomon of Marshall, who resigned.

Mrs. Mary Ann Roberts of Spring will be chairman of the 15-member 1974 state textbook committee.

Briscoe appointed 12 members of the local intergovernmental personnel act advisory committee, including Mrs. Andrea Beatty of Austin, Lila Cockrell of San Antonio, Edwin Daniel of Wichita Falls, Amando Garza Jr. of Laredo, Job L. Hammond Jr. of Amarillo, Charles Carsner of Victoria, McNeal Adams of Jasper, Frank L. Priore of Fort Worth, Vince Rachal of Houston, George K. Smith of Dallas, Nestor Valencia of El Paso and Edward Vela of Hidalgo.


