

Speakers on the Friona Chamber of Commerce's Community Agricultural Development Meeting last Friday night complimented Friona on the community's success in landing industry.

Larry Milner, Industrial Development Manager for Southwestern Public Service Company, pointed out that there are only 1500 new industrial plants located within the United States every year.

"With over 15,000 cities seeking one of these plants, I'd say that you in Friona have done your share," Milner said.

Milner, in his speech, pointed out some possible "sideline" industries which might be established to go along with the packing plant,

In discussing the by-products in a beef packing plant, Milner noted that it has been said that when it comes to processing cattle, "You use everything but the moo."

Milner mentioned such businesses as cattle feeding, trucking, rendering facilities, soap processing, dog and cat food manufacturing and pharmaceutical manufacturers as possible "frosting on the industrial cake."

. . . Jack Carrothers, manager of Friona Feed Yards, Inc., added another possible business for Friona when he pointed out that the feed yard he manages spent in excess of \$150,000 on vetrinary supplies last year.

Carrothers, in discussing the balanced rations which are used by the modern feedlots, said SCHOOL BEGINS "We pay more attention to the technical feeding of our cattle than we pay to the feeding of our children at home."

The local feedlot manager stated that packers and graders tell local feeders that our cattle, fattened with grain sorghum as the grain portion of the diet, are as desirable as any in the United States.




