## TRACTOR DEMONSTRATION AND SHOW HERE MAY 22

### FOURTEEN TRACTOR COMPANIES AND ALSO FARM MACHINERY TO EXHIBIT

A big tractor and farm machinery show and demonstration will be held in Plainview Saturday, May 22, and will be the most extensive show of the kind so far held in this section.

Fourteen tractor companies who have local agents will take part—Fordson, International, Hart-Parr, Cletrac, Case, Rumley, Moline, Queen City, Samson, Emerson-Braudingham, Gray, Holt, G. O., and Aultman-Taylor.

Also there will be a show of all kinds of farm machinery, farm electrical appliances and conveniences.

The show will be held on the vacant lot on Broadway in the morning and in the afternoon will be an actual demonstration on the open section near the cemetery.

The promoters of the show will distribute much advertising matter on the Trade Excursion next week, and an effort will be made to have a very large attendance of people from all over this section, who are interested in power machinery.

The people of Plainview should boost for and encourage the show, for it will surely be an important affair.

There will be a number of factory experts, instructors and speakers on the use of power farm machinery here.

## Special Session Legislature Will Meet May 21st

Gov. W. P. Hobby has called a special session of the legislature to convene May 21, to enact legislation to establish zones for growing cotton to fight the pink boll worm, to enact school legislation, to supply deficiencies for the support of the state government, and to consider such other matters as he may lay before the body.

**Expert Sewerage Engineers Here**  
Dr. Werenkevel of Dallas, who made the plans for the sewerage disposal system and Imhoff septic plant now being installed in Plainview, was here several days ago, inspecting the work done, and conferring with Messrs. Irick and Bawden, the contractors. The work being done is satisfactory to him.

T. E. Nolan, an expert, arrived last week to superintend the concrete work on the septic tank.

### Five Kress School Graduates

The graduates of the school at Kress this year are Aileen Kerr, Alice Boston, Ernest Skipworth, Tony Vaughn and Lois Whitlow. The graduating exercises will be held Friday night in the school auditorium. Tony Vaughn will deliver the graduation address and Aileen Kerr the class prophecy. The class song is "Two of a Kind." A three act comedy drama will also be presented by the class.

### Official Salaries Increased

At a recent session of the commissioners court the salary of the county judge as ex-officio county school superintendent was raised from \$400 to \$600.

The salary of the sheriff was increased from \$500 to \$1,000 a year. The county treasurer will be allowed 2 per cent on money received and paid out.

### Wheat Crop Two-Thirds 1919

The federal crop estimate bureau says the winter wheat acreage was 34,165,000 bushels May 1, its condition 79.1 per cent of normal, and the indicated yield is 484,647,000 bushels, or 33.8 per cent less than in 1919.

### Syndicate Ships Hogs

The Texas Land & Development Co. shipped two carloads of fat hogs to the Fort Worth markets Friday.

## PHILOS WIN TROPHY CUP FOURTH TIME

Defeat Euglos in Debate at Wayland College—A Unanimous Decision

The champions of the Philos won the silver trophy cup in the inter-literary society debate at Wayland college tonight, defeating the Euglo debaters by a unanimous decision of the judges.

This is the fourth time the Philos have won the cup.

The question for discussion was "Resolved, that school teachers should affiliate with the American Federation of Labor." The Euglos had the affirmative side, with Frank Fellows and Rufus Brazele representing them. The Philos had the negative and was represented by Grayson Tate and Judson Covington. Each of the boys did his work well.

## WILL LAY HEAVIER RAILS ON BRANCH LINE

Eighty-Pound Rails to Be Laid From Plainview to Floydada—Will Spend \$180,000 on Line

The Santa Fe railroad has announced that it will relay its Plainview-Floydada branch with 80 pound steel and spend not less than \$180,000 on this line during the fiscal year. Among the other improvements is an extension of yards and the erection of a large cotton platform at Floydada. The main line is equipped with 90 lb. steel while the Floydada branch has been using 65 pound steel. The new steel will admit of the running of heavier types of engines of the Santa Fe, so badly needed on this line during the fall and winter months, when farm products movement was unusually heavy.

## Jowell Resisting Extradition

Austin, May 8.—The case of ex-parte Mel B. Jowell, from Hale county, was filed today in the court of criminal appeals. Jowell alleges he is being illegally restrained of his liberty by the sheriff of Swisher county under a writ of extradition issued by the governor of Texas for his return to the state of Montana. The record shows Jowell is charged with grand larceny in Montana.

District Attorney A. C. Hatchell and Attorney A. B. Martin left this morning for Austin to appear against and for Jowell. The little son of Mr. Hatchell also went with his father.

## PLAINVIEW TRADE EXCURSION WILL BE NOTABLE EVENT OF THE YEAR

### Possibly Fifty Cars, Brass Band, Entertainers, Speakers—Will Boost for Plainview as Trade Center.

The big Plainview Trade Excursion will leave here early Tuesday morning, and it is going to be a humdinger, too.

A meeting was held at the city hall last night, attended by a representative from practically every business house in the town, to hear reports from committees and lay final plans for the excursion, which will include three days, as per the schedule printed below.

Paul Barker of the route committee reported the route agreed upon, and urged the necessity of moving on schedule time.

Sidney Miller of the advertising committee reported it had prepared several hundred large circus posters to be put up along the route, with "Plainview Trade Excursion with the Big Band Coming May —." Messrs. Bradley and Barrow are now out putting up these large sheets and distributing other advertising matter. Four large banners have been prepared for each car, as follows: "Modern Stores and Large Stocks in Plainview," "Trade in Plainview; It Pays," "Plainview, the Logical City to Do Your Trading," "Plainview, the Home of 300 Progressive Merchants." He also stated that enough soft crush hats for each one who goes have been ordered, with proper lettering. The slogan of the trip will be "Trade in Plainview." The chautauqua committee will also distribute advertising matter. Each merchant and business firm will distribute advertising matter and souvenirs.

Dr. Green of the entertainment committee said two male quartettes will go along beside the band, and there will also be clowns and negroes to give an entertainment at each stop. Orators will also make short snappy speeches.

The finance committee reported it had secured almost \$1,000 for the expense of the excursion. A list of the contributors will be published in the News. Only a very few business men have refused to contribute.

The excursion will be very inter-

## REPUBLICANS ELECT STATE AND DISTRICT DELEGATES

Will Not Nominate Ticket in Hale County—F. L. Brown, Chairman

The republicans of Hale county met at the court house May 1st, and elected W. A. Watson and O. O. Reed as delegates to the state convention to be held in San Antonio and John W. Alexander and W. A. Eastridge to the district convention in Amarillo. The delegates were not instructed for any presidential aspirant.

The republicans decided not to nominate a ticket in Hale county this year—and will let the democrats have full sway for at least another two years.

F. L. Brown presided over the convention as county chairman.

## 1.55 Inches Rain Fell Here During the Past Week

The rainfall of the past week totaled 1.55 inches in Plainview, as follows: Wednesday .03, Friday .43, Saturday .04, Sunday .45, Monday .40, and last night .20.

The rains fell in showers all over the county, and in some places near Hale Center amounted to five inches.

These rains help the wheat a great deal, though the dry weather of recent weeks cut it short considerably. Some farmers estimate the average yield for the county will be twelve to fifteen bushels to the acre.

The rains also put the ground in good shape for the row and hay crops. Everybody is happy over prospects for another good crop year.

## Made Trip Over Route

G. V. Smith, secretary of the Junior Chamber of Commerce, and Fred Blockson returned today from a trip over the entire route of the Trade Excursion.

They report rains everywhere and considerable mud, though of course the roads will be dry and good by the time of the excursion, if there is no more rain.

The people everywhere are very optimistic over prospects of good crops, and they are also interested in the visit of the Plainview boosters next week.

Mr. Smith says good crowds will greet the Plainview people at each town.

## Carranza Government Overthrown

Reports from Mexico say the revolutionists have overthrown all the states except three in the Southern part and have taken the City of Mexico. President Carranza fled on a train toward Vera Cruz, but was captured and is now held as a prisoner.

Carranza's son-in-law and many of his party were executed, so reports declare.

The revolution succeeded in less than a month after it began, and there has been very little bloodshed.

Of course its a disgrace, but nevertheless true, that the people of Texas are paying more for moving pictures than for the education of a million school children.

The trouble with Secretary of Labor Wilson and his assistant, Mr. Post, they are badly tainted with socialism and Bolshevism. President Wilson should fire both of them.

Gov. Edwards of New Jersey is the candidate of the liquor interests for the democratic presidential nomination, and purposes to put a "wet" plank in the platform at the San Francisco convention. He will clash with W. J. Bryan and Bryan will win.

Emma Goldman, the anarchist who was deported several months ago, writes that she longs to be back in "the dear old U. S. A." as she does not like Russia. Then why did she persist in preaching anarchy in this country? The bug-house is the proper place for her kind.

## An Additional Money Crop

This drawing is from a photo of a thoroughbred Angora Goat with wool 36 inches long.

Farmers always have been permitting weeds and small undergrowths to be a source of expense and annoyance to them when by the use of a few goats they can be turned into real money. The U. S. Department of Agriculture says goats do best in weeds and underbrush. There is a great deal of land of that description in this section.

In 1915 the U. S. imported 432,000 goat skins and over 10 million pounds of Mohair (goat's wool). Goat meat sells in retail stores at the same price as mutton and grade Angoras yield 5 pounds of wool per year, worth 80 cents per pound.

Bucks like the above can be secured to grade up the common or garden variety in a short time to a highly profitable basis. This bank believes that a few high-bred goats will add materially to the wealth of this community.

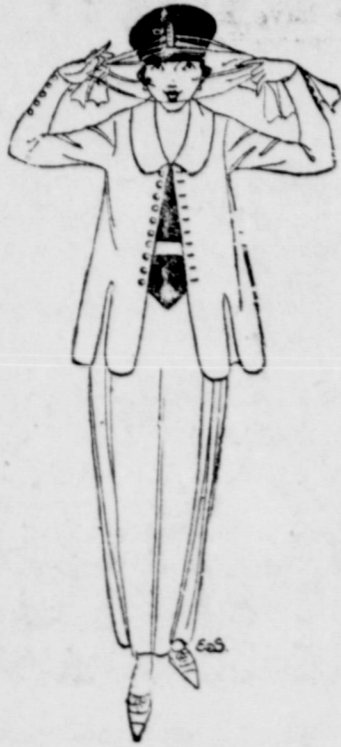

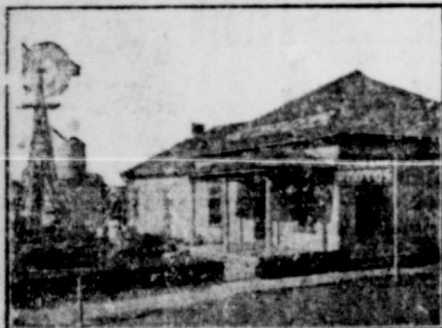

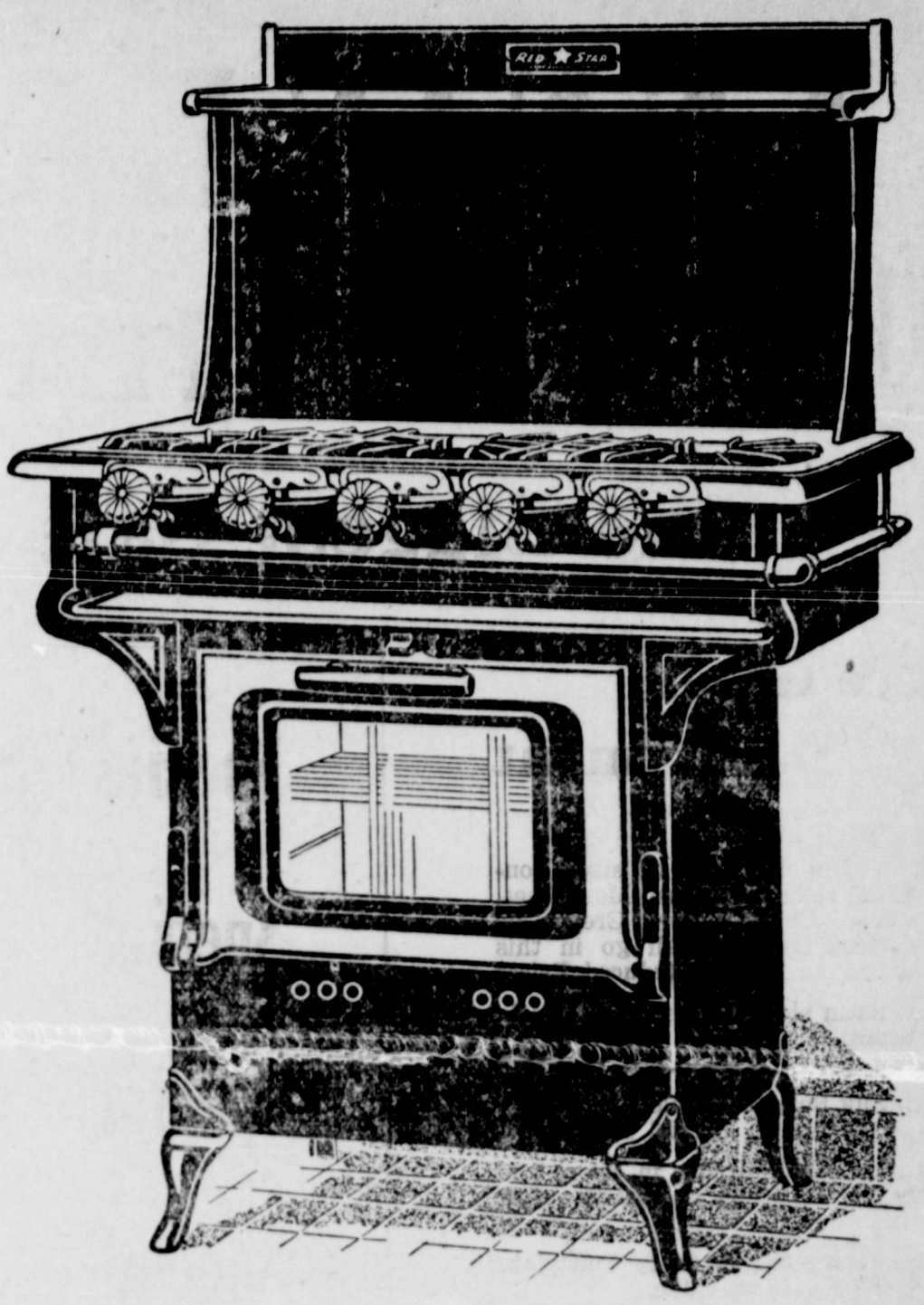
