MORE MEN SIGN FOR TRADE TRIP

Second Day's Work on Part of Committee Yields 158 Men and 85 Cars For Three Day Jaunt

NO ONE IS BARRED
Persons Whom Committee Unable to See Asked To Get Names On Dotted Line Right Now

With 158 signers and more than 85 cars pledged to make the Trade Trip next April, the committee completed the second day's work on the proposition feeling that it met with the well nigh unanimous approval of the business men of Sweetwater.

Only four business men out of the number solicited refused to make the trip.

The committee wishes it distinctly understood that no one is barred and that if they have been unable to get in touch with anyone who desires to go to be sure and get their name on the dotted line, either at the Board of City Development or one of the committee members.

Appreciation for the co-operation shown was expressed by A. H. Herring, chairman of the committee, Thursday.

"On behalf of myself and the committee, I wish to thank everyone for the cordial co-operation shown us. Owing to limited time and the fact that all business men were not in when we called, we have not been able to see all who may wish to make this trip. No one is barred. Sweetwater needs all the men and all the cars possible so as to make this Trade Trip one that will be a long time remembered. I hope to see 100 cars in the line on the three days of the Trade Trip," Mr. Herring said.

ROBERTSON NET CHAMP

Finishes First in Boys' Tennis Finals at High School

AMARILLO, Texas, March 21.—A "bungalow" cotton gin with all the architectural beauty of a bungalow will be erected in Amarillo soon.

In taking out a permit for the gin which will cost \$8,000 H. N. Green said that the gin would resemble a bungalow in every particular, and would be a beauty spot in any residential section.

Old Fashioned Hen Loses Caste When Hatchery Arrives

The old-fashioned setting-hen and even the small incubators are now facing their greatest competitor in years, at least in Nolan County. This competition is offered in the form of a Sweetwater Hatchery, and from the appearance of things the hatchery is getting the big end of the business. Although this hatchery has been in existence less than seven weeks its business has already reached enormous proportions.

Beginning with a 10,000-egg capacity the hatchery has been forced by increase in business to add two new incubators, making a total capacity of 20,000, and the business is now such that an additional 40,000 capacity will be made at the beginning of the next season.

Fourteen thousand chicks have been hatched to date and 20,000 eggs are in the incubators, while 2,000 others are awaiting their place.

Present indications point to an unusually large number of spring chickens this year.

John Goroni, Go-Between With New York Whiskey Peddlers, Implicated in Daugherty Scandal

WASHINGTON, D. C., March 21.—An amazing recital that devolved into the investigation of Jesse Smith, Daugherty's friend, a man who acted as go-between for New York bootleggers, today told the Senate committee investigating Daugherty that he paid \$200,000 to two men with "influence in Washington."

The witness declared he paid this amount to get withdrawal permits for liquor.

The go-between was John Goroni, who is alleged to be the partner of Owen Murphy, for permits for liquor which Orr sold at \$15 per case.

PLURALITY 2 TO 1

Late Returns From Georgia Indicate McAdoo Carried the State Overwhelming Plurality

ATLANTA, Ga., March 21.—Wm. G. McAdoo "native son" a 2 to 1 victory over Senator Oscar Underwood, of Alabama, in Wednesday's Democratic primaries in Georgia, complete returns showed today.

With complete returns in from practically every county, McAdoo had 93,646 popular votes to 49,947 for Underwood.

McAdoo won 322 county units to 84 for Underwood. The county unit controls the state convention which nominates delegates to the party convention.

TO STAGE HUNT

More Than One Thousand Dogs Entered at Leeray

RANGER, Texas, March 21.—More than 1,000 dogs will be assembled at Leeray, an abandoned town for the annual hunt of the Texas Fox and Wolf Hunters' Association.

The Oil Belt Hunters' Association is host to the State Association and preparations for the hunt which will be held for a week after April 1, are now under way.

"This will be one of the biggest hunts ever held in America, the big men of the hunting associations from all over the United States will be here," said John F. Thurman, director of the Association.

At a meeting of the directors of the Oil Belt Association, Cisco, representatives from Cisco, Ranger, Eastland, and Breckenridge Chambers of Commerce were present and pledged financial support.

DEATH AT ROBY SINCLAIR SMOKES IN FAMILY ROW AS SENATE TOILS

A. Martin Dies in Price Barber Shop Following Shooting on Steps of Courthouse Friday

DAN STEVENS SURRENDERS

Was Father-in-Law of Slain Man—Reported Attention to Wife's Sister Cause of Shooting

ROBY, Texas, March 21.—A. Martin, 24, died in Price's Barber Shop here this morning following a shooting affray on the steps of the courthouse.

His father-in-law, Dan Stevens, 63, surrendered to Fisher County authorities following the shooting.

Only one shot was fired. A large caliber revolver was used. Martin got over to Price's Barber Shop, where he died. His body is being held. No funeral arrangements had been made late this afternoon. He lived at McCaulley.

Dan Stevens lived at Royston. He was an old and respected citizen of Fisher County. Some two months ago Martin married Stevens' daughter. According to reports, Martin had been attentive to a younger daughter of Stevens.

The shooting was not unexpected, according to reports from those intimate with both principals. It happened about nine o'clock Friday morning.

BERGDOLL WARY

Notorious Draft Dodger Requests a Body Guard on Return Trip to Face Draft Evasion in U. S.

EBERBACH, Germany, March 21.—Official of the U. S. Government requested a guard to accompany him if he is to return home and face draft evasion.

OIL MAGNATE WINS RESPITE

Martin W. Littleton, Counselor For Millionaire, Pleads For Client—Senate May Take Vote

WASHINGTON, D. C., March 21.—Harry F. Sinclair today won respite from the Senate oil investigation committee which had called him to testify. After a heated argument of two hours between the committee and Martin W. Littleton, counsel for Sinclair, the committee postponed Littleton's demand that Sinclair be excused from testifying further. Adjournment was taken until tomorrow when a decision will be made.

A majority of members of the committee indicated early that they would vote to compel Sinclair to submit to an examination.

Littleton presented a lengthy legal argument to the committee that it did not have the power under the constitution to compel his client to testify.

The committee as a whole did not seem impressed by Littleton's argument, but upon the request of Senator Spencer, Republican, let the matter go until tomorrow. Spencer wanted more time to consider the matter.

Senators Walsh, Dill, Adams, Kendrick and Ladd, pronounced themselves unqualified in favor of forcing Littleton to submit to an examination of Sinclair.

Littleton did not seek to keep from going to the stand on the ground that the committee "should not force my client under the odium of such a plea."

Through it all Sinclair sat on the sidelines smoking a cigar and unconcernedly watching the proceedings.

ASK LONG TERMS

Munich Prosecutor Requests Varying Periods of Imprisonment for Ludendorff and Hitler

MUNICH, March 21.—Prison terms ranging from one year and three months to 8 years were demanded for General Ludendorff, Adolf Hitler and their fellow conspirators of the Beer Cellar Putsch of last November by the State prosecutor today.

Coming up before the State the prosecutor asked the following sentences: Hitler, eight years; Ludendorff, two years; Kreibel Toehner and Dr. Weber, six years; Brueckner Wagner, one year and three months.

Treed Boy

DALLAS, Texas, March 21.—A 12-year-old boy wanted by George Preston, county juvenile officer, for a number of petty thefts, led the officer up a tree in a wild chase here. He was finally captured when he dropped from a limb into the Trinity river. Preston rowed into the water with a boat and fished the boy out.

Blasted Home

DALLAS, Texas, March 21.—James H. Thompson has filed suit here against the Trinity Portland Cement Company, demanding \$25,000 damages which he alleges resulted from blasting the company did near his home. In his petition Thompson claims the plaintiff's wrecked his home for which he wants \$5,000. For personal damages, he asks \$20,000, claiming the blasting endangered the lives of his family.

Snubbed!

CHICAGO, Ill., March 21.—Mabel Normand has been snubbed by the Illinois Federation of Women's clubs. Mabel stopped over in Chicago to tell her story of the shooting of Courtland Dines at the now famous New Year's party. The Illinois clubwomen had asked her to address them. When she did appear however, Mrs. George Palmer, president of the Illinois Federation of Women's Clubs, said she could not address her organization. "I am of the opinion that the majority of Illinois clubwomen do not wish to see Miss Normand or her films," Mrs. Palmer said.

LaFollette Leads Hiram Johnson In Dakota Primary

FARGO, N. D., March 21.—Senator Robert M. LaFollette is runnerup in the North Dakota Republican primary. He outdistanced Senator Hiram Johnson by more than 3,000 votes. President Coolidge won a minority over the two Senators, holding a margin over LaFollette by more than 14,000 votes.

With all but 8 of the State's 2958 precincts counted the vote stood: Coolidge, 47,947; LaFollette, 34,096, and Johnson 30,233.

The final count will change this result but little politicians declared.

Marrison Garnett, the Coolidge man was chosen Republican national committeeman for the party by an overwhelming vote.

R. A. Kinser, his nearest opponent, was beaten more than 2 to 1.

LOANS ARE MADE

Recently Organized Building and Loan Association Makes First Loans—Two Houses Start

The first loans to be made by the recently organized Sweetwater Building and Loan Association were passed upon by the auditing committee this week and two more homes are under construction or will be shortly.

Loans approved by the association include one for Bryan Buck, who is building a five-room home with garage on Lamar Street, and for I. Lee Lusk, who is building a home on Locust Street.

Since the stock is sold on the partial payment plan, making it an ideal investment for savings. As these payments come in, more and more funds will be available for home building. Membership in the association is required before loans are made, in addition to other security.

Only Free Employment Agency To Be Operated by State

AUSTIN, Texas, March 21.—A free employment agency for farm laborers, the only agency of its kind to be operated by the State, will be established in San Antonio by the State Department of Labor, according to Commissioner Myers.

The recruiting of general farm laborers by the agency will be continued until the next cotton season. The old market house San Antonio was chosen as the best location.

ASK AUDITORIUM AS A MEMORIAL

Plan Meets With Enthusiastic Approval at Joint Meeting American Legion and Business Men

SUGGESTS JAIL AS SITE

Urged That County Bastile Be Removed From Public Square—Need for Auditorium Stressed

Many times in the past, various campaigns have been launched in this thriving city whereby beneficial results have been obtained but it is doubtful if ever in the history of Sweetwater has a movement taken form that will prove of more real and everlasting benefit to the entire community than the preliminary plans of the Oscar McDonald Post of the American Legion, sponsoring a move to erect a memorial in honor of Nolan County boys who died fighting in France.

Members of the Legion met with nearly a score of representative business men Thursday night at the Hotel Wright to discuss ways and means of consummating plans on foot.

Rev. L. G. Morony, in explaining the object of the meeting, called attention to the fact that the Legion had already adopted a resolution to erect a flagpole on the courthouse plaza. It had later been suggested, he explained, that building a more suitable edifice would serve as a home for the local Post, an appropriate memorial and at the same time provide Sweetwater with a community auditorium.

It was pointed out that the auditorium would be equipped with a cornerstone containing the names of Nolan County boys who fought, bled and died on foreign soil and that the flagpole would be placed on the site. Without exception, the auditorium project met with enthusiastic approval. The business men lauded the Legion in sponsoring such a move and enthusiastically offered their support, both moral and financial.

James H. Beall Jr., as chairman, expressed the sentiment of the Legion when the requested suggestions from the business men present by way of assisting the local Post in furthering the plan. He called on every man present and each in turn urged the necessity of an auditorium, stressing the vital need of a convention hall—the one and only thing needed to make of Sweetwater the convention city of all West Texas. None of the speakers overlooked the sentimental angle, on the contrary, they stuck doggedly to the original point at issue, yet preferred to work with the entire community's interest at heart.

R. M. Chitwood was roundly applauded when he said, "I heartily endorse the Legion's plan to erect a memorial for the boys who died 'over there' and suggest that it be an appropriate home for the Legion that may also be used as a convention hall. (applause). I would also suggest that that unsightly county jail be removed and the memorial placed there." (deafening applause).

The consensus of opinion was to erect the memorial by means of floating a bond issue. It was believed that the American Legion would receive the approval of a majority of tax payers, in such a move.

After lengthy discussion of a general nature, the Legion appointed a special legal committee to investigate the legality of the bond issue. This committee was composed of J. H. Beall Jr., chairman; R. D. Cox Jr., C. E. Mays and J. C. Babb. A general investigation committee also was named, which included John A. McCurdy, Roy Scudday and Rev. L. G. Morony. The latter committee will meet today.

At the same time a citizens committee was appointed from the business men to co-operate and assist the Legionaires in sponsoring the move. Mayor Joe H. Boothe was named chairman with Geo. McKnight, Rufus Wright, M. B. Howard, Hubert Toler, Prof. Barnett, Judge A. S. Mauzey, R. M. Chitwood, Judge H. R. Bondies and L. J. Geer. This committee is prepared to meet and consult at any time with Legion committees.

LET THEM HEAR

While Congress has been engaged for several months in the pursuit of real or mythical dragons assumed to be threatening the public welfare, many things that gave promise of actual benefit to the country have remained undone. The failure to act upon the issue of tax reduction, has been as a last straw to the patience of the public with the way all things else are subordinated to partisan politics, to the promotion of individual ambitions to succeed in the November elections.

When the public receives the bill resulting from the negligence of congress in this regard it will find that it amounts to several hundred millions of dollars—a heavy price to pay for allowing the nation's legislators to play a partisan game instead of a constructive one. In addition, a measure which was considered vital to the welfare of the nation's industry and its government has had to wait. The hue and cry of running down the guilty, exposing the malfeasance of department officials, and purging the capitol of scandals seem to have produced a panic in quarters where above all else there should be poise, judgment and common sense, and the resulting disorder gives promise of outlasting the summer.

It would be a challenge to the capacity of a nation for self government if such things could endure without bringing a deep and compelling protest from the country. The failure of the tax reduction measure to bring any relief to this year's group of taxpayers is now the thing that is

making this complaint vocal. The people are beginning to find out what the exactions of the tax collector are doing to them and their prosperity. One out of every eight dollars they earn in their labors, professions or business is needed to pay the bill of direct taxation. This does not include the indirect taxation resulting from the high customs tariff in force—a charge that is borne chiefly by the poor and those of moderate means. It is told that the only reason there has been such an outcry against excessive income taxes has been that these are paid directly and can be seen as well as felt. But the indirect taxes are distributed among every class of the population in the form of higher rents, costs for services and prices for everything that is purchased. Once this is thoroughly understood the urge for a reduction of all kinds of taxation will overcome all opposition.
