## Hot, Dry Spell Still Undaunted

The hot, dry spell has continued unabated the past week, with temperatures 94 or over every day. Although the official recording station in Friona has logged just five days over the 100-degree mark, there have been ten other days when it topped out at 97 or over (four 99s), and other thermometers in the area may have shown 100s many of the other ten days. For the month of July, there has not been even a trace of moisture in Parmer County's official gauge. The 26 consecutive days without even a trace is the longest of the calendar year, and unless something blows in moisture-wise over the next few days, we may well log the first month with no moisture. The month of April might as well have been considered moisture-less, since only .04

inch was measured on April 7, and a trace on the 17th. The last time the local rain gauge was tested was on June 29, when .74 inch was measured.

### Save Water! Pray for Rain!

By now you have received your latest water bill. City manager Paula Wilson says that some people might be surprised at the amount of their water bills. Extra hot and dry weather has caused Friona water usage to increase to between 1 1/2 and 2 million gallons every day. Normal usage, Wilson says, is around one million gallons a day. Residents are urged to conserve water as much as possible during this stretch of withering heat and drought.

The year's total rainfall stands at 11.79 inches, probably above average, but the summer months are taking their toll on the area's rowcrops, which badly need some help.

The asphalt melted and all the streets were running with liquid tar. "The heater went out on the city swimming pool and the water stayed so warm that nobody noticed any difference. Birds left their nests to sit under lawn sprinklers and just let their eggs hatch out by themselves in the heat. "In the morning, you'd step outside to go to work at 7:30 a.m. and break into a sweat that wouldn't quit until 11 o'clock that night. It was too hot to go out to the box to get our mail in the middle of the day, so we waited until after dark to bring in the day's mail. "The cows at the new dairy farm over in Hereford were giving condensed milk. Folks who had a few chickens, were feeding them crushed ice to keep 'em from laying hard boiled eggs. One farmer had some acres planted in popcorn and lost the whole crop when it got so hot that it all popped in the field. "Somebody got the idea to punch holes in the bottom of an empty coffee can and pour water in it so the children would know what rain looked like. When it finally did come a rain, an old fellow was walking across the street, and it shocked him so much that he passed out when the first drops of rain hit him in the face. The EMS guys had to throw two buckets of dust on him before he came to." Okay, this has all been pretty silly stuff, but we might as well laugh about it while we sit around fanning ourselves.

"Why, it was so hot that summer, we ate raw hot chili peppers just to cool off the old innards. We could put a jar out on the back

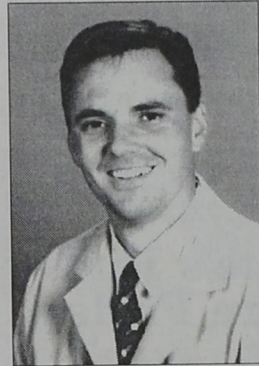
## DR. DICKSON BEGINS AUG. 1 New Hospital Addition Is Nearing Completion

The new addition to Parmer County Community Hospital is nearing completion.

So much so that the Friona Clinic division was looking toward the possibility of moving at least one of the doctors' offices into the new addition over the weekend.

Dr. Jeff Dickson, Friona native, will begin his practice on Wednesday, August 1, so the clinic was needing a new office anyway. Dr. Dickson has trained as a family practitioner (see below).

Bill Neely, PCCH administrator, said Thursday that there are still several things that need to be completed. "This move may take more than a day or two. It is a tremendous job. There is a lot of equipment to be moved, plus there will be

some new equipment and furniture. It will not be an easy task," Neely said.

The hospital administrator asked for the public's understanding during the period that the move will be taking place. "It may be a bit inconvenient (for hospital patients) for awhile. But we are as anxious and excited as the community seems to be, to get into the new facility," he added.

Dr. Jeff Dickson is a 1987 graduate of Friona High School. He received his B.S. degree, Magna cum laude, with a biomedical science major from Texas A&M University in 1994.

Dr. Dickson received his M.D. degree from the

University of Texas Southwestern Medical School of Dallas in 1998.

He completed his residency at the Methodist Medical Center of Illinois at Peoria, 1998-2001, where he also completed his family practice residency.

The Friona native received his Illinois medical licence in 2000-2001, and his Texas license in 2001-2002.

He has also completed advanced life support training in the following fields:

\*Advanced cardiac life support; \*Pediatric advanced life support; \*Neonatal advanced life support, and \*Advanced trauma life support.

He holds memberships in the American Academy of Family Practice, and the American Medical Assn.

Jeff's wife is the former Becky West of Orange. The Dicksons are parents of five children: Ricky, 15, who will be a sophomore at Friona High School this fall, along with Joey, nine, Rachel, seven; Jacob, four, and Matt, 23 months old.

The new doctor is a third generation resident of Friona. He is the son of Randy and Joyce Dickson. His grandparents also were Friona residents. They were Weldon and Juanita Dickson and Ollie and Charles Rogers, all of whom are now deceased.

## Weeds and Old Cars Are Targeted By City

If you have old, abandoned vehicles in your yard, or weeds so high kids can get lost in them, it is time to clean up. Or pay a fine. Or both.

The city has stepped up enforcement of Friona's junk vehicle and weed ordinances. Violators will be sent a letter and have ten days to fix the problem.

After ten days, citations will be issued which will result in a fine in Friona's Municipal Court. And the city has the option to mow the weeds or move the abandoned vehicles and "charge the expenses incurred to the owner of the lot."

According to Article 3, Section 13-30 (c) of the city code: ".....it shall be unlawful for the owner of any lot or premises in the City to permit or allow weeds, tall grass, rubbish, junk, brush or any other unsightly, objectionable or unsanitary matter ...to accumulate or remain on such lot or premises."

The ordinance defines unacceptable weeds as those that are twelve inches or more high.

Section 13-12 of the city code says, "the presence of any junked motor vehicle on any private lot, tract or parcel of land, or portion thereof, occupied or unoccupied, improved or unimprov-

ed, within the city of Friona shall be deemed a public nuisance...."

Any wrecked, dismantled, abandoned motor vehicle in your yard or on your property that does not have valid license plates and inspection stickers is a violation of the city ordinance.

Property owners who rent their property can be held liable for the actions of their renters. Any questions about the ordinances or your property you can call city hall at 250-2761.

## 65 YRS AGO-AUG. 28, 1936

Last week we thought the hot weather was over here for this season, when the mercury descended to a very comfortable degree and our cool nights returned, but we were reminded that we know nothing of what "old Man Weather" will do when the mercury climbed back to 98 degrees on Monday and Tuesday and caused us to get "all het up" again.

## 50 YRS AGO-AUG. 23, 1951

Wickard, REA Administrator in Washington, wired the cooperative at Hereford that approval of the \$454,000 loan had been granted in its entirety.

## F. Mendez Gets 40 Yr. Sentence

Frank Mendez, Jr., 44, was sentenced to 40 years in prison last week for the New Year's murder of Sandra Jenkins, 24, in Friona.

The jury trial began Tuesday, July 17, in Judge Gordon Green's 287th District Court in Farwell.

After two days of testimony, the case went to the jury about 2:15 p.m. Thursday afternoon. After three more hours of deliberation, the jury returned a guilty verdict.

The jury then returned to deliberation about 6:15 p.m. for the punishment phase. A sentence of 5 years to life in prison was available for jurors in the murder case.

At 10:00 p.m. Thursday night, the jury returned and assessed a sentence of 40-years to Mr. Mendez after determining that the murder was not pre-meditated. In addition to the prison sentence, Mendez was fined \$10,000.

He will be transferred to the state prison in Huntsville, Texas, as soon as the necessary paperwork is completed.

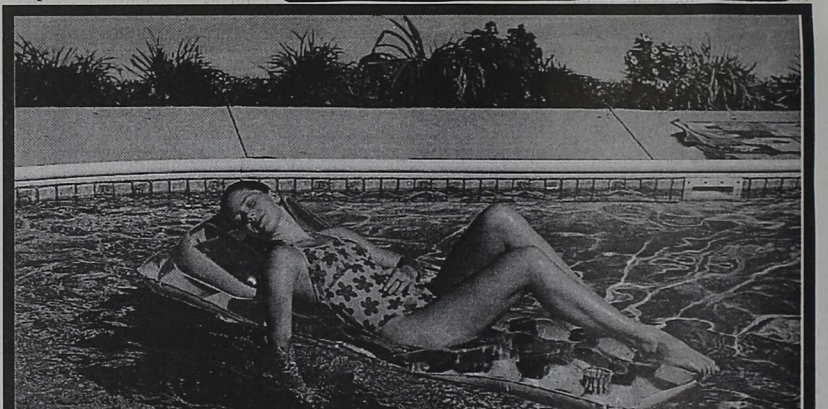

# Jamie Herring Pushes For Stem-Cell Research

## Friona Native Writes To George W. Bush

Friona native Jamie Herring has written Pres. George W. Bush regarding the stem cell research question. We felt that our readers would like to read Jamie's letter, and then might want to write to their congressman with their feelings on the issue.

Dear President Bush:

I have been watching the debate on stem cell research for some time now, and I feel it is my responsibility to let you know the impact this can have on not only my life, but that of many, many others.

I have been a quadriplegic for 17 years now, a result of a motorcycle accident at age 16. I have never been the type to sit back and let the challenges of life keep me from reaching my goals.

I am one of the lucky ones to have an extensive support system of family and friends throughout the years, but I've seen many who are much less fortunate.

I have also received support of government agencies to allow me to receive an education, live independently, and become a productive member of society despite my disability. I am thankful for all of this, however, there is much that needs to change in a system that discourages people like me from working for fear of losing critical health benefits.

The government spends

millions of dollars yearly to keep persons with disabilities at a state where they can live, however, to many it is just an existence because the government does not take into consideration the whole picture when it comes to cost of care for someone requiring 24 hour assistance, medication costs, etc.

It is nearly impossible to go beyond a state of poverty for most people with disabilities because of the high costs of care and disincentives for change created by government along with society's general discriminatory attitude towards those who are not "normal."

My question is this: Why not promote research that will someday eliminate costs for both people who suffer from certain diseases and disabilities and the government which provides services for these people?

I realize it is a moral issue, however, at what point does government take a stand and realize that embryos that are to be discarded will never produce life except to give back millions and millions of people their own. These are people who currently are merely existing day by day in poverty because their ailment controls their whole life.

I question how moral it is to not encourage such research when it is there,

ready for new discovery and eager to save many people from suffering. Why not allow one embryo out of six, or even ten, many that will be discarded anyway, to be put to good use, potentially allowing for both new life and the saving of life in existence and that in the future?

I believe it may be much more about money than morality. I fear that big companies who benefit by people being sick, insurance companies, for example, control this issue as well as many others.

As I was finally squeezed out of my insurance because premiums had increased to over \$1,000 monthly, and my father struggled to make ends meet, my health has suffered because of the lack of benefits on Medicaid.

### Clinics Are Set For Aug.

Immunization clinics offering vaccines that give protection against several childhood diseases are scheduled for August throughout several Panhandle communities.

Protection will be against polio, diphtheria, lock-jaw (tetanus), whooping cough (pertussis), measles, rubella, mumps, HIB (Haemophilus Influenzae Type B) and varicella (chicken pox).

The Texas Department of Health is charging fees to help with the cost of keeping the clinic open. The amount of money charged will be based on family income and size, and the ability of the individual or family to pay, however, no one will be turned away if not able to pay.

The vaccinations will be administered at the Texas Department of Health WIC Office, 607 Main Street, Friona, Friday, August 17, from 9-11:30 a.m. and 1-3:45 p.m.

Vaccinations will also be available at the Emergency Medical Services (EMS) Office, 109 East Third Street in Bovina, Monday, August 13 from 10 a.m.-12 noon and 1-3 p.m.

Even after I gained employment and received coverage through an HMO, benefits have still been limited, again controlled by big business and government. It seems that these institutions do not encourage wellness of all people.

Despite my support and successes, it has been a struggle the whole way. I have only recently become employed after six years of constant job search and much rejection, even though I am highly educated.

My story is not uncommon. I am a strong person, however and can live this way, as a quadriplegic, the rest of my life if I must.

What pains me is seeing my friends around me dying from diabetes and hearing about young people who have not had the support I have had, living miserably and depressed in nursing homes because of their disability.

How moral is it to discourage any kind of research that will potentially offer them a life?

I have not had the opportunity to produce children because of my disability, my age 33 may never allow it, I can only dream of a time when I might be able to hold my hand up and touch the faces of my nieces and nephews.

If embryos help others to have such happiness through children, why can't those being discarded be allowed to grow into cells, nerves, organs, etc., so that others can also achieve such happiness? If I produce an egg that is then fertilized and grows into an embryo, who has the right to tell me it

cannot be used for research? The potential for eliminating many diseases is endless. What is the government waiting for if it doesn't have to do with money? If morality is the holdup, why not ask those who believe that stem-cell research on discarded embryos is immoral what the purpose of scientific intelligence is?

Is it not to discover cures, advances in medicine, advances in technology, and promote life? Did scientific testing and advances not make it possible to create life by alternative methods for those who cannot conceive? I see nothing immoral about offering all of human-kind the same chances at life.

I am but one small voice against many. The government has the power to make

sure opportunities exist for the whole.

If I walk again, it's only about me, but if millions walk again, it's about everybody.

If those arguing morality were suddenly diagnosed with Parkinson's, Diabetes or suffered a paralyzing injury, they too would become quite selfish. If one of their children suddenly developed a life-threatening illness, they too would become adamant about research to find a cure. Make it fair to the whole. It's in government's hands.

# Lariat's Paul Crume Wrote Of Life In Parmer County

Early in 1958, I discovered the newspaper columns of Paul Crume.

I had moved to Dallas from Hillsboro and became a fan of Mr. Crume's daily column, "Big D" which appeared on the front page of the Dallas Morning News.

It was a must-read for thousands of newspaper readers. I remember thinking what a great job it must be to get paid for writing a column every day.

It was a long time later that I realized writing is not the easy task most people think. Writing entertaining social and political material under a daily deadline can be a stressful occupation.

He wrote his column from 1948 until 1975 and was considered the most quoted newspaper columnist in the state of Texas and the most reprinted by other papers in the Southwest.

His writing talent moved to the front page of the Dallas Morning News in 1952. Not bad for a boy who grew up in Lariat, Texas.

His father, Charles Crume, sold his mountain farm in Arkansas and moved the family to Lariat, Texas, about 1919. He covered the distance from Arkansas to Lariat in a covered wagon with five boys and a girl and a wife.

Paul Crume was seven years old. The year was 1919. He grew up in the suburbs of Lariat he once wrote. Much of his writing over the years was about his growing up years and the characters he knew in Parmer County.

He graduated from the University of Texas in 1936. Two of his journalism classmates were Walter Cronkite and Lady Bird Johnson. After graduation he had planned to go to New York to get a newspaper job.

One of his college professors, Walter Prescott Webb, told him to stop off at the Dallas News on the way. He did not know that Webb had called Ted Dealey at the News and told him one of his real college journalism stars

was coming by for a visit. Dealey hired Crume and except for four years as a Navy officer during World War II, he worked at the Dallas News until his death in November, 1975.

I became aware of Paul Crume's connection to Parmer County when I moved here six years ago. Crume's sister, Mary Lou Taylor, still lives in Friona. A niece, Judy Gurule, also lives in Friona.

Paul Crume was one of my early idols. I liked him. I read his columns. I respected him and was in awe of him because he wrote a column on the front page of a major newspaper like the Dallas Morning News.

A book entitled "The World of Paul Crume" features 250 of the 8,000 columns Crume wrote in his lifetime.

In the future we will be reprinting a few of Paul's columns, especially the ones that pertain to Lariat and Parmer County.

The column below, "Witch's Sabbath in Bovina, Texas" appeared in the Dallas Morning News on May 25, 1975, six months before his death at the age of 63.

If any old-timer knows if there was such a place as Barney's Dance Hall & Soda Pop, I would appreciate knowing more about it.

## Witch's Sabbath In Bovina, Texas

It seems that witches are coming back into fashion after a couple of hundred years. So, if you see a well-dressed young woman walking through the downtown and carrying a broom, think nothing of it. She is merely taking care of her transportation.

The prevalence of witches right now, however, raises the question of whether we the public are getting authentic witches. Anybody can claim to be a witch and carry a broom. She cannot necessarily take the hair of an enemy and rub it against her pet cat and send him to his grave. Probably, Ralph Nader should start an inves-

tigation to find out whether the consuming public is getting the best quality witch for its money. There are some very inferior witches who loaf on the job half the time.

Luckily, the ordinary householder can test his witch if he likes. All he has to do is truss it up, the witch, from shoulder to ankles and throw her in the swimming pool. If she floats, she is a witch. If she sinks, you may as well walk off and forget her; you don't have a witch of value at all.

I learned all this from a close study of Matthew Hopkins, a great English witch-hunter of the sixteenth century, who executed all his witches on the basis of this evident.

Later, people gave him the same kind of bound-up trial, and he floated, and they chopped off his head for being a sorcerer.

As a child, I actually had very small experience with witches. Getting caught by your dad was bad enough.

As a teenager, I believe I once observed one witch's coven. It was called Barney's Dance Hall and Soda Pop and was located several miles outside Bovina, Texas, where it wouldn't disturb the town's morning prayer.

It was a long, unfinished hall, the studs still bare to the sight, with a three-man handstand at one end and an office and ticket-taking structure at the other. Here a kind of Witch's Sabbath was held every day of the week except on the Sabbath, which was a closed down day in our country.

People cavorted around in unrestrained orgies of the fox-trot and ducked out occasionally to sample hell's brew out of a fruit jar with one of Barney's pops as a chaser.

It was a witch's Sabbath, all right, according to the dictates of Bovina, Texas.

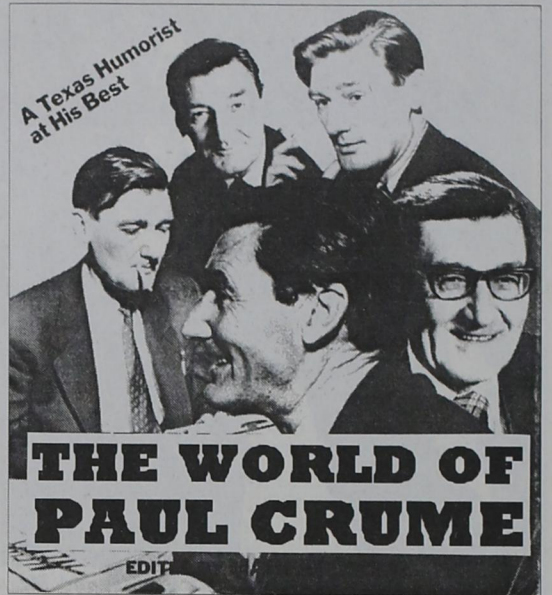
As early teenagers, we were not permitted to join the witches and the warlocks on the floor, but a rude stair led up over Barney's office to a small balcony from which you could watch.

This was for free except that Barney charged you an outrageous price before you could go up. He charged a dime a bottle for Cokes.

When I look back at it, I think Barney's place was a coven. Covens are supposed to be run over by snakes and hellhounds. There were plenty of snakes around Barney's place. When a booted man went out to get some hell's brew, he would often kick a rattler away from his feet.

Barney also had a three-legged wolfhound, who was probably a hellhound, though he traveled incognito on a pallet outside Barney's office.

As for Barney, he was thin, knothheaded, and equipped with a thin white goatee. He might have been The Goat.

## Congressman Larry Combest Reporting Home: *Improving Veterans' Access To Health Care*



One of my top priorities as your representative in Congress is to ensure that our veterans are treated fairly. One of the best ways to help our veterans is to ensure that they receive the health care that they have earned and need.

Recently, I have become a cosponsor of H.R. 11367 the "Veterans Prescription Access Improvement Act," which will improve health care delivery in rural areas, ease access to prescription drugs for veterans and reduce the burden on crowded VA facilities.

H.R. 1136 would provide veterans with the option of having medication prescribed by their local private physicians.

Under current law, only veterans who are permanently house bound or in need of "regular aid and attendance" are allowed to obtain prescriptions from their private physicians. All others must go to the nearest Veterans Administration (VA) facility and see a VA doctor before a prescription can be written or approved, even though their local private physician may be just minutes away. Likewise, to acquire the cheaper drugs provided by the VA, a veteran will often undergo duplicate exams by a VA doctor, even after having already been seen by a private physician.

Last year, the office of the Inspector General of the Department of Veterans Affairs (IG) made a key recommendation on how the Veterans Health Administration could reduce the cost impact of providing prescription drugs to Veterans, make additional resources available for veteran health care and enhance the delivery of prescription services to veterans.

The IG found that many veterans' visits to VA clinics or hospitals were primarily for the purpose of receiving a prescription order. Veterans often see their local doctors and have prescriptions written, but the medication cannot be filled by the VA without an examination by a VA physician.

This simple change in the law, under H.R. 1136, would ease the burden faced by many rural veterans who must travel long distances to VA facilities to receive a prescription. In West Texas,

many veterans in smaller towns and rural areas must drive up to 200 miles round trip to obtain a prescription from a VA doctor. I have heard from many of my constituents who are concerned about this inconvenience and financial burden.

This bill provides that prescriptions would still be filled by the VA, but this flexibility would give all veterans the choice of paying for a visit to their local doctor's office as an alternative to making a trip to a VA facility. Veterans would still have to pay for the private physician visit, but it would be more practical and cost efficient than having to drive to the closest VA health care facility.

The recent investigation by the IG supports the need for this legislation. Their report found that "the costs of re-examining the Veteran in order to fill privately-written prescriptions are significant

and could be reduced by a more streamlined process.

In allowing the VA to fill prescriptions written by private physicians, the IG determined that the VA could save over \$1 billion a year by eliminating waste and inefficiency.

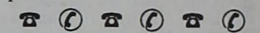
Besides saving tax dollars, H.R. 1136 would enable the VA to be more responsive to the many men and women who have served our country. It will provide veterans the option of obtaining their prescriptions from a physician outside the VA who, in many cases, has cared for the individual veteran for decades and knows the patient's medical history. Regardless of who writes the prescription, the VA pharmacy system would fill the prescription order.

Currently, VA medical centers and clinics are filled with patients who must wait extended periods to see a VA physician. H.R. 1136 will

reduce the backlog at VA facilities by allowing patients to choose an alternative method of care.

The VA's drug purchasing power, which enables it to provide low cost prescription drugs to veterans, will not be diminished, because the VA will still purchase and provide the prescription drugs. In fact, it is expected that the VA's purchasing power will increase since more veterans will likely take advantage of the VA's pharmaceutical benefit if the process is made easier by the enactment of this bill.

We owe our veterans more than we can ever repay. We have a duty to ensure that they are taken care of in their time of need. I am proud to be a cosponsor of this common sense legislation that will enable our veterans to have the access they need to receive the best care possible.

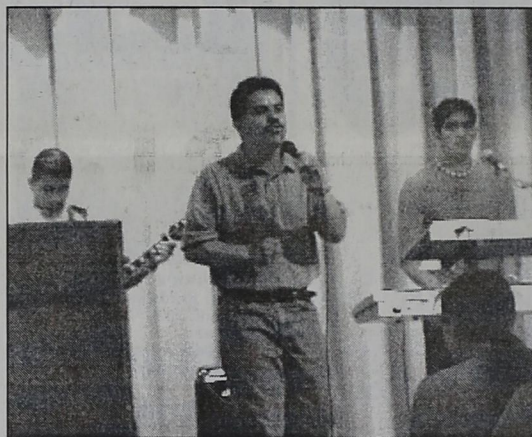

#### Taking Early Retirement? Brush Up On Rule 72(t)

If you've ever thought about retiring early, then you know there's one major concern you'll need to address: money. Will you have enough? And where will it come from?

Barring a disability, you can't start collecting Social Security until you're 62. When you retire early, it would be extremely helpful if you had a source of income to tide you over until you reach that age. But if you tap into your IRA or 401(k) before you're 59-1/2, won't you have to pay a 10 per cent penalty on the distributions you take out.

Not necessarily. According to Section 72(t) of the Internal Revenue Code, you may be able to tap into your IRA or 401(k) before age 59-1/2 and still avoid the penalty. How? By taking the funds in a series of "substantially equal periodic payments."

This somewhat "jargon" phrase simply means you've got to withdraw about the same amount of money at least once a year. You have to make these withdrawals for at least five years, or until you've reached age 59-1/2, whichever is longer. So, for example, if you start taking these payments at age 50, you'll need to continue them until you're 59-1/2. If you don't start taking the payments until you're 57, you have to keep going until you're 62.

How much can you withdraw? Unfortunately, you can't just choose the amount you think you'll need. Typically, IRS regulations require that the size of the payments be based on your life expectancy--or on the joint life expectancy of you and your beneficiary--and a given interest rate.

Clearly, it's a good thing to avoid the 10 per cent penalty, which could amount to thousands of dollars over time. Nonetheless, just because you can access your IRA or 401(k) without paying a penalty doesn't mean you should. Why? For one thing, even though your withdrawals may not incur any penalties, they will trigger income taxes. This could be especially costly if your tax bracket doesn't drop in retirement.

Even more importantly, your IRA or 401(k) provides tax-deferred growth for your retirement savings. The longer you leave these funds alone, the greater your accumulation will be. That added growth will be very helpful later on in your retirement, when you really do need the money.

One more point to consider: When you have a 401(k), you still have to separate from employment before you can take money out, even using the Section 72(t) provision. With an IRA, you can start making 72(t) withdrawals at any time.

In any case, weigh your decision carefully. You worked long and hard to build up your IRA or 401(k). Don't be in a hurry to dismantle them.

## YOUR EYES

### Minor To Major Eye Injuries

Do you play a sport? Do you like to do woodwork? Do you use a lawn trimmer? These are just a few of the things that cause eye injuries. Eye injuries are common, especially when something hits the eye. These injuries can lead to a corneal abrasion, a bleeding in the eye, retinal detachment, penetration of the eye, or the eye actually rupturing. Some injuries heal with no after-effects, but others result in impaired vision or loss of the eye.



Sharp objects often cause laceration of lids and the eye itself, leaving foreign bodies in the eye. Car mechanics rarely wear eye protection. They are continually exposed to flying metal fragments. Running into a sharp twig is a frequent cause of eye injuries to both adults and children. Shattered eyeglasses also put people at high risk.

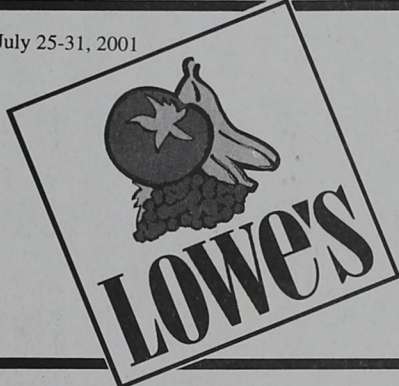
Every year, high-speed items such as BBs from a BB gun cause a large number of accidents. Large items also cause injuries. Getting hit with a racquetball, falling on the ground, airbag impacts and wood from a table saw can all cause an injury serious enough to make someone lose most or all of his/her sight. 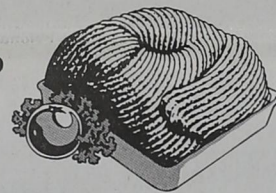

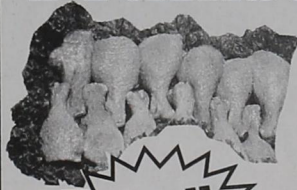

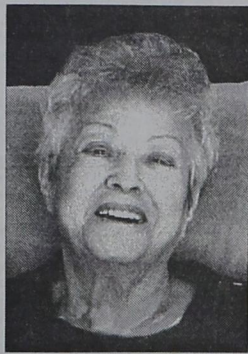
Burial was in Friona Cemetery, under the direction of Ellis-Blackwell Funeral Home.

He served as a tail gunner on a B-17 during World War II and was stationed in England with the United States Army Air Corps.

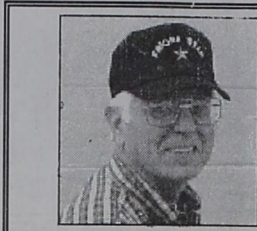
