The major change during Bill Leonard's 20 years as Gray County Juvenile Probation Officer has been the 'enactment of the Texas Family Code, which went into effect in July 1973. The Family Code was enacted in response to a new concern for children's legal rights and rising public awareness of the problem of child abuse and neglect.

The first major administrative change was the shifting of responsiblity for abuse and neglect cases from county juvenile probation offices to the state Department of Human Resources. Leonard said Thursday

"Child abuse has been withus for ages... but it's been well publicized lately ... and the publicity has brought to light' some hidden cases.' Leonard said he thinks the change of responsibility for abuse and neglect cases is a good development.

These people (department workers) are/ specially trained to deal with these kinds of cases. This leaves for the county probation officer the

supervision of what Leonard calls "a multitude of sins," which includes cases of runaway, truant, or delinquent children, age 10 to By law, it's technically impossible for a child under

15 to commit a crimemisdemeanor or felony-- and what would be criminal offenses for an adult are known as delinquent acts for

children. Leonard said most of the delinquency he deals with are cases of theft. However, he said he often receives drug abuse cases, usually involving marijuana. He said the average age of child offenders fluctuates but "15 or 16 year olds are the ones that seem to get caught.' Once caught, however, the child has under the Family Code what amounts, according to Leonard, to full due process.

Before the Code, it was common practice to ask the , child defendant and his parents to sign a waiver for a right to an attorney. Now anattorney-- usually court appointed -- is required for all court appearances. A child,

present if he wants to make a statement after he is caught. But he has to be fully informed of his right to have an attorney present. This reading of rights to a child is much extended version of the Miranda warning issued to adults upon arrest.

If a child is detained, a detention hearing must be held within two days, and again in ten days, if the child is still under detention. Leonard said that the judge should have no prior knowledge of the child before the disposition hearings. But he said that it's his responsibility to prepare a background brief on the child for the first hearing. The second court appearance, the ajudication hearing, is a full court trial, with prosecutor, attorneys, and, if requested, a jury. No bond is posted for a child, said 'Leonard. Parents have the responsibility to bring the child to court," he said. "And I find most parents are very sincere in trying to meet their responsibility. If a child is found guilty of a delinquency, there is a



"If they stay out of trouble for a certain period after 18." said Leonard, "then they have a right to have their files sealed, so that they will have no record to carry around with them. According to Leonard, his office received about 200 referrels in 1978, screened by the probation officer to about 100 cases. Leonard estimates that he presently has 30 children on probation, with five new court cases scheduled and six to eight old cases pending.

Leonard said he has to screen cases carefully to see if they fit the law of the Family Code. It's a thick book he says he has to consult every day. Adam's folly

It is a shame we didn't have a genius forty years ago as Transportation secretary. From his chair - borne vantage point in the bureaucracy he could have told the airplane engine makers to come up with the jet engine. Just think what that would have done for the military in the World War II effort, not to mention instant 747s for transportation.

All the slow, tedious elements of technolgical progress could have been circumvented by a command from on high for the industries to get together with the government agency and jump into the future via a government sponsored symposium.

But then, we didn't have a Brock Adams as Transportation secretary in 1938. We have him today and he has just called for a joint research venture between the government and the auto industry to develop a radical new power source for cars.

"I'm talking about re - inventing the car and coming up with a superior vehicle for the future."

Adams told the Economic Club of Detroit: "Events in Iran and the announcement of rationing by American oil companies reinforce my belief that the curtain is quickly dropping on the age of the internal combustion engine as it is, and the fact is, we have no replacement."

"It's time for industry and government to stop butting heads on everything and to start working together for the future," Adams said. He urged leaders of the big four auto companies to join him at an "automotive summit conference" in Washington to begin planning the development of an all new propulsion system for automobiles.

The secretary expressed concern that the industry was not moving ahead on its own with new engine technology.

Heads of the auto firms were startled and cagey but polite in their reaction to the proposal and statements made by Adams. It was indi-

WASHINGTON (NEA) - Like the laundry soaps periodically repackaged with a label proclaiming "all new ingredients inside," the national legislature that convenes here this month will be widely identified as the "new" 96th Congress.

But just as the detergent too often turns out to be merely a minor variation of the same old formula, the 96th Congress will differ little from its recent predecessors.

A wave of institutional reform during the past decade has produced numerous substantive changes, but the task remains largely unfinished. In some cases, the initial reforms have produced unexpected harmful results.

In the past, most of the pressure for improvement has come from outside groups and individuals because the legislators have been instinctively protective and defensive in rebuffing criticism of their institution.

But one of the most significant developments of the past few years,

In Candor lies our hope especially in the House of Representatives,

has been the increased willingness of the lawmakers themselves to publicly discuss and debate their problems: Two notable recent examples of the trend

are "A House Divided" a television documentary produced by Capital Cities Communications, Inc and last year's resignation speech by Rep. Otis G. Pike, D-N.Y., one of the most respected members of the House.

Pike's candor and insight make his farewell address a truly remarkable document. Talking about the unhealthy symbiotic relationship between special interest groups and his colleagues, he says:

"The parade of daily fund - raisers in the Democratic Club or the Republicans' Capital Hill Club in Washington - whereby the unions, corporations, trade associations and lobbyists are systematically though legally milked - is just ... nauseous.

In the television documentary broadcast in late December, Rep. Leon E. Panetta, D-Calif., is refreshingly honest in

describing what too many of those donors demand in return for their money:

"I got approached by a lobbyist from (maritime union) who said ... we gave you \$2,000 in your last campaign (and) we expect a vote for this bill ... They said we don't have to talk substance, we gave you the money and we expect (you) vote."

Another participant in the Capital Cities program, Rep. David R. Obey, D-Wis., also talks frankly about the army of approximately 15,000 lobbyists permanently encamped in this city:

"You are harrassed by one issue group ifter another. You get so many interest groups who couldn't care less if I vote for World War III as long as I vote for their pet projects ... then they are happy as clams." On another crucial issue, Pike is both eloquent and indignant:

"The day - to - day operations of the House, the time we spend, the hours of our lives are to a large extent controlled by a small group of procedural nit - pickers ... "No congressman minds working hard on important issues - Lord knows there are enough of them around - but this congressman is weary of wasting his time on drivel."

On the same subject, the documentary cities "a dawn - to - dusk workload too exhausting for even the most dedicated and ambitious representative" and last year's record - breaking 1,540 votes in the House, many on trivial issues.

"There is no way," concludes Obey, "that any human x ind can absorb enough information to be intelligently informed on all those issues.

Pike acknowledges that "people expect a good deal from their public servants" but rejects the notion of "being expected to put in a full day's work in the office every day and a full night's appearance on the banquet or meeting circuit every night." Tradition - bound institutions like the

House invariably are reluctant to accept change, but there's hope for needed future improvements if other lawmakers will join Panetta, Obey and Pike in a candid discussion of the issues.

As is all those potential foreign foes weren't enough to worry about, the Army is now encountering a threat within its very own ranks to the expedient accomplishment of its mission to defend the nation.

Women soldiers - thsre are now some 56,000 in a total uniformed force of 769,000 - and men soldiers have developed an interest in each other that is not in the line of duty. In fact, as the brass sees it, it interferes with duty.

Bureaucracy's new dimension Months went into the study

Its conclusions have the approval of 41 federal departments and agencies including the White House and the General Accounting Office. So the Congressional

Joint Committee on Federal Printing and Paper Sizes has delivered itself of an official recommendation.

The dimensions of stationery used by agencies of the federal government is to be increased from 8 by 101/2 inches to 81/2 by 11, conforming to the letterhead size most common in private enterprise. It will also, by the committee's reckoning, give bureaucrats 11 percent more actual paper and 15 percent more text space per page to get their messages across.

This is not a change to be rushed into. however. The new size will not become effective until it is anticipated that existing stocks of the old stationery are used up -Jan. 1, 1980.

WALL STREET JOURNAL OPEC's announcement of a phased 14.5 percent increase in the price of crude oil over the next nine months was a shock to Washington. But it need not have been. OPEC is behaving in much the way it could be expected to behave if its pricing decisions are analyzed in economic, as opposed to political, terms.

The OPEC nations, acting in what they see as their own best interests, are trying to maximize their oil revenues within the context of their long - term economic needs. It makes some sense for the consumer nations to argue that their attempts will be defeating in that the increases will bring about a world economic slowdown. However, that is simply a way of saying that the proposed price increases might not stick - a real possibility - if supply and demand come into balance at some price level below the one OPEC is seeking to establish.

OPEC obviously thinks it can get the higher prices because of the sharp drop in Iranian oil production during that country's political crisis. Had there not been such a production decline, the oil producers might have had to endure a continued erosion in their real returns because of surplus production capacity and the reduced value of the dollar. To interpret OPEC's deliberations in anything other than these hard - headed terms is to chase will - o' - the - wisps.

The U.S. will not change OPEC's policies by political jawboning as it hopes to do with the pricing policies of American industry. It can, however, change OPEC's policies by operating directly on the world oil you an enemy of the government that you were long taught to uphold.

That is, you are constrained to take defensive action to prevent the legitimate side of the law from robbing you worse than the illegitimate side is likely to do.

That places you under stress. On one hand, you look at the government to provide for the common defense and domestic tranquiltiy of society, and on the other hand you are trying to fight it off. This situation leads to strange tactics. For example, Orange County resident

government for \$10. However, since not many people know such a handbook exists, Kaysing himself is issuing the book, promoting same, and isn't a bit adverse to making a buck by doing so. The value of the book is that it lets you

know what law the IRS Intelligence Division (since renamed Criminal Investigation Division) is relying on when it seeks information from you.

If the income tax law were clearly written, the law - abiding citizen would have no trouble obeying its requirements, But its a jungle. So, in defense of your own interests, you have to rely on the law of the jungle. In other words, you are better prepared to keep what you have earned if you know your enemy, if you understand what the IRS regulations permit the special agent to do and what they forbid him from doing.

Kaysing, officed at 177 Riverside, Suite F. Newport Beach, makes the point that even the IRS concedes that all citizens have the right to refuse to show their records to the IRS although they must produce them after being summoned. As proof, he cites page 34 of the publication, which reproduces item 267.41 of the Internal Revenue Manual. The item states, in part:

"Neither can he - she (i.e. the taxpayer) refuse on the grounds of the Fourth or Fifth amendments, to appear in response to a summons requiring hm to testify or produce records. He - she must make the appearance, after which he - she may refuse, on Constitutional grounds, to SHOW sections or to answer specific questions." (Emphasis added.)

Patriotic individuals may be surprised to learn that the manual instructs special agents to search military service records to get the goods on a taxpayer. Within limits, the IRS agent is also authorized to tap Social Security files. Family conversations are not sacrosanct, even between husband and wife, if a child is present who is old enough to understand what is going on.

If the object is terror, the handbook serves a useful purpose. From Kaysing's point of view, the object is to divest the IRS of the power to instill fear. "When sombody can make you afraid, he has power over you," he said

In an earlier booklet title "Tax Wars," Kaysing relayed other advice: This pointed out that the IRS agent is expected by his superiors to generate a certain dollar volume for each hour of work. "If you can run up his time, he may want to get rid of you," the counsel stated. Then followed a catalog of time - consuming moves. The main point was, do everything by mail because it take the bureaurcracy longer to write a letter than it does you.

The tax rebels that I have met are loval persons. Tactics as suggested in the advice quoted, go against their own inclinations. Their central thought is that the income tax should be repealed, that surely we can have a national defense and tolerable civil order without continuation of what rapidly is becoming a financial gestapo. Typically they believe that misgovernment must be resisted in order for true government to be maintained.

It pays to save energy

By WILLIAM STEIF Would you like to save \$300 on the federal

income tax you must pay next April? That's a dumb question, isn't it? Everyone would like to reduce that tax by \$300.

To do it, you have to spend money -\$2,000. But that \$2,000 will bring returns beyond the original investment, in the form of lower heating bills. You'll also be more comfortable and enhance the value of your home.


The Energy Tax Act that President Carter signed recently makes the tax saving available and you don't have to spend as much as \$2,000. You can get a 15 percent tax credit on energy - conservation spending anywhere up to \$2,000

For example, if you've spent \$500 any time between April 20, 1977, and Jan. 1 of next year on storm windows, you can take a 15 percent credit for that expenditure - \$75 - and deduct it from what you owe next April 15. Minimum allowable credit is \$10, so even if you've only spend \$67 on energy conservation in your home you can save \$10.

The Internal Revenue Service, which administers the energy credit, has just published a "fact sheet" detailing the rules. It says the credit can be applied only to a "principal residence" - the place you and your family live primarily, no vacation homes.

You can get the credit even if you rent. The qualifying item must be installed between April 29, 1977, and Dec. 31, 1985 (you can take the credit for the year in which the work was done). A credit can be carried over through 1987. Among items available for credit are:

- Exterior storm or thermal windows and doors.



- A furnace replacement burner reducing the amount of fuel used.

- A device making flue openings for heating systems more efficient.

- Such energy - saving gadgets as electrical or mechanical furnace ignition systems that replace gas pilot lights, automatic setback thermostats, and meters displaying the cost of energy usage. Here are some of the things that DON'T count: carpets, draperies, wood paneling, exterior siding, heat pumps, wood or peat fueled heating systems, swimming pools used to "store" energy, greenhouses.

You must be the first person to use the energy - saving item to qualify for a credit; the item must be expected to remain in use at least three years.

Co-op owners and condominium owners are treated as sharing the co-op's or condominium's energy saving spending; that is, if a co-op or condo owner contributes an amount to the building's energy - saving plan, 15 percent of that amount can be claimed as a credit on the individual's tax return. Co-op or condo owners who spend individually for energy saving in their units can treat the spending just as any other home owner in their tax returns

You may want help in deciding how to make your home more efficient. Under the new law, electric and gas utilities must inform customers about feasible conservation improvements and estimated cost and energy savings of each recommendation. The utilities also are supposed to provide lists of lenders, contractors and suppliers.



Legislature, public termed on same wave length

Clements pledges cooperation

AUSTIN, Texas (AP) -Gov elect Bill Clements thinks he's on the same wave length with most Texas legislators, as he was with Texas voters on Nov 7

"I think that most of the legislature understands that most of them were elected by the same people that elected me,' Clements said in an interview with the Associated Press. "They feel a responsibility to be responsive to what I am talking about. There is not one set of voters out there who elected me and another set who elected the legislature. These are one and the same people.

"You would be amazed how many legislators have told me they fully understand that."

Clements, who talks fast and moves fast, does not take office until Jan. 16 in what may be the most eleborate gubernatorial inauguration in several decades. But he has been busy since the general election votes were counted in a small 10th floor office of a downtown office building.

Day after day, and some nights, there has been a constant stream of visitors and job hunters to the small office

with the predominantly Democratic Legislature is simple follow the aggressive personal contact method that was so successful when he was Deputy Secretary of Defense in Wash-

ington. 'I have met with four groups that constituted more than 100 members of the Legislature.' he says proudly. "In addition I have met with a large number of committee chairmen and people like that on a one-on-one basis ... I intend to develope these personal relationships

with the legislators and be fully sensitive to their needs and their responsibilities to their own constituents ... I represent all the people of the state. I'm where this whole process comes together as being the highest elected official statewide and I intend for us to have a legislative program that is responsive

Clements will make an inaugural address on Jan. 16 and present his proposed state budget about Feb. 1. But there will be not big unloading of his entire program at one time. 'We've got several months before we end up with definite

answers to these questions and I'm not going to cut off the process half way through or even before it starts," he said. The big issues of the session

are easy to point out. "You have to put tax reduc tion No. 1 and no. 2 undoubtedly is the issue of improving the quality of our education.

Between those two there is the school finance problem, a separate issue but a part of both.' Next, Clements says, are our relations with Mexico. He has plans to meet with Mexican President Jose Lopez Portillo at a date to²⁶be announced later. and discuss three subjects that also are of interest to the Texas Legislature.

'Illegal aliens, that's a problem that's got to be solved." he said. 'There's not any question whatsover that Texas has a role to play in this. For us to be in default and abrogate our position is absurd

Clements favors a return of some form of the old bracero program where Mexican workers would be admitted under temporary work permits. President Lopez Portillo and I are in complete agreement on this," he said. "By Mexico and Texas agreeing to this putsenormous pressure on Washington and puts aside this non-

sense of an amnesty program put forth by President Carter." Another matter to be discussed would be the border drug traffic. And third would be Mexico's

new oil and gas reserves. "It is absolutely necessary

that we now commit to market some reasonable amount of Mexico's gas and oil for our energy requirements in the United States and allow us here in Texas to conserve our national resources in a technical and reasonable basis."

"Talking with Mexico about these three main things would set the tone for what the United States does at the national level," Clements declared

Clements says he is not only optimistic of his relations with the legislature, but he is not

afraid of the strongly entrenched Democrats either.


"I feel strongly that the people of Texas have spoken. they have said what they want in approving the tax relief

amendment by 85 percent.

If the Legislature in its wisdom sees fit to do otherwise and violates the will of the people and does not carry it out to the letter and the spirit, I will veto it.

Clements says he pays no attention to speculation the Democratic legislators might pass a state spending bill early so they would have time left to override any gubernatorial veto

"I'm not afraid of that," Clements says with a smile. "I see no sign of that.



sible conflict of interest resulting from natural gas production on South Texas property recently inherited by his wife. After being sworn in by Chief Justice Joe Greenhill of the Texas Supreme Court, Nugent told an overflow hometown crowd, "I had certain financial holdings which raised the question of a conflict of interest when Gov. Briscoe first notified

me of my appointment. "As of this time, I have sold those holdings which presented a conflict of interest or have them under a binding contract of sale, which will be closed as expeditiously as possible," he added.

"Responsibilities of this agency are too important for there to be a public question about the freedom of a member of this commission to make a de-

cision that could involve a personal interest Nugent said those holdings represented a "very minor portion of my income.

They included, he added, "a very small" amount of energyproducing land and some stock in companies under the jurisdiction of the commission. Nugent's appointment must still be confirmed by the Texas. Senate, which convenes Tuesday. He said, however, that he

anticipates no problem being confirmed Nine candidates are competing in Saturday's special election to replace Nugent. The ceremony was attended

by more than 300 persons, including Briscoe, House Speaker Bill Clayton, Newton, the other two railroad commission members and a host of legislators and state officials.







buy and more to finance. The Federal Home Loan Bank Board reported Thursday the average interest rate in December on newly purchased houses was above 10 percent for the first time in history.

The average price for both new and used houses also hit an all-time high - \$67,600 for new ones and \$58,000 for those already lived in.

The average home buyer paid a 10.02 percent interest rate for new houses in December, up from 9.87 percent in November,



It is true that young women who have a hysterectomy need to have hormone replacement if the ovaries were also removed. The amount you need is an individual matter and has to be determined in each case. Irrespective of this, a sensible diet and exercise program is an important way of helping to prevent becoming overweight after a hysterectomy at any age or after the ovaries cease functioning with the normal change of life.

Fame helped star

get into Congress

WASHINGTON (NEA) As a football star for the San Diego Chargers and the Buffalo Bills, Jack Kemp som times could be found studying the philosophical tracts of Ludwig von Mises - instead of the playbooks of coaches Sid Gillman and Lou Saban.

"I enjoy the polemics of the clear-cut debate between the liberal principles and the conservative ones," he used to explain. Now he is a congressman

from upper New York state and prominently mentioned for candidacy on the na-tional ticket of the Republican Party in 1980 or 1984. Kemp was a quarterback (1957-69), and a good one leading Buffalo to two American Football League championships (1964-65).

But as early as 1964, Kemp was out traveling for the presidential candidacy of Barry Goldwater. The quarterback had been lured into politics when he was with the Chargers by Herb Klein, a former press aide to California's Richard Nixon. His football career virtually finished because of injuries, Kemp was persuaded to run for Congress in 1970 in the Buffalo area, where his name meant something. He still had two years to go on a no-cut contract with the Bills. He wonders even to day if the team would still have to honor it if he decided to play again.

In his politicking, Kemp, 43, doesn't shun the jock identification. In fact, he alludes to it in almost all his speeches.

His first congressional race was extremely close. A local telecaster, Irv Weinstein, asked Kemp what he would do if he lost the election. Kemp answered flippantly, "I'll probably come back to the Bills. There are still six games left in the

season. That night, the TV station ran a picture of him in a somber business suit, with Weinstein's voice-over intoning, "Candidate for **Congress Jack Kemp today**



Wurmbrand asserts the ban will not stop his organization's support to the Russian







The Yankee' southpaw easily outdistanced another baseball star. Pete Rose of the Philadelphia Phillies, who finished second with 94 votes after setting a modern National League record by hitting safely in 44 consecutive games for the Cincinnati Reds last season.

slugger who beat Guidry for the American League's Most Valuable Player Award, was third with R

three times, finished fourth; with 26. He was just ahead of rookie running back Earl Campbell of the Houston Oilers. the National Football League rushing leader with 1,450 yards.

Auto racer Mario Andretti (13), marathon runner Bill Rodgers (12), Dave Parker of the Pittsburgh Pirates (9), Triple Crown jockey Steve Cauthen (8), and tennis star Bjorn Borg (7) completed the top 10 finish-

last year Guidry's winning percentage of 893 was the best ever for a 20-game winner and his earned run average of 1.74 was the lowest by an American League left-hander since Dutch Leonard's 1.01 in 1914. The Yankee left-hander also had nine shut-

outs, tying the AL record set in 1916 by Babe Ruth Guidry started the eseason with a 13-game winning streak. and for the first half of the year was the only dependable

pitcher his floundering team had. Fifteen of his 25 victories, which included the division clincher in the single-game playoff against Boston, came after New York losses.

He pitched the pennant clincher in the championship series against Kansas City and resumed his stopper role in the World Series, winning the third game against Los Angeles after the Yankees had dropped the first two contests

The slim southpaw set a club record with 248 strikeouts in 2732-3 innings, breaking a Yankee mark that had endured for 74 years since Jack Chesbro anned 239 in 1904. He finished second in the AL in strikeouts. trailing only California's Nolan Ryan; who had 260.





View from the plains

Goose count gives hunters encouragement

By J.D. PEER **Texas Parks & Wildlife** CANYON - Texas goose hunters have perhaps their best opportunity of the season as a recent aerial goose count tallied twice as many birds as last year, according to personnel of the Texas Parks and Wildlife Department.

Over 54,300 geese were spotted by plane during the December survey, with most of the birds found in the Oldham-Deaf Smith-Randall county area of the Panhandle.

TUSCALOOSA, Ala. (AP) -

"Nearly 39:000 Canada geese in the Hereford area with over were using the lakes and grain fields in this area which includes Hereford, Friona and Vega,' said Max Traweek, P&WD waterfowl biologist. We also found several thousand geese south of the

Hereford area toward Dimmitt and Lubbock." he continued. Other concentrations numbering over 3,000 birds were

found north of the Canadian River in the Dumas, Fritch and Spearman communities. A larger-than-normal number of snow geese were also counted

1,000 of the white birds intermingled with the dark or Canada geese.

The waterfowl season for Texas, which includes both ducks and geese, will continue through Jan. 21. Conditions during the recent survey found cold temperatures and plenty of ice. Most of the geese were utilizing the large man-made

reservoirs, since most of the natural of playa lakes were frozen over. More water was available for

the birds than last year with the geese feeding on winter wheat. waste corn and milo, which is readily available in the Texas High Plains.

The total number of dark or Canada geese should increase on the High Plains as this area of northwest Texas is the southern-most wintering grounds for the shortgrass geese.

The local populations of geese could shift from lake to lake due to winter conditions and available food. Waterfowl regulations and information are

available at license vendors and all P&WD offices throughout the state



One name heard for top farm job

WASHINGTON (AP) - Former Lt. Gov. Jim Williams of Florida is the administration's top candidate for the No. 2 job in the Agriculture Department. according to informed sources. Williams was said by the sources Wednesday night to be in the final process of being cleared by the White House for the \$57,500-a-year post of deputy secretary

One of the sources said Williams "is the only name we hear" for the job.

Both sources, who asked not to be identified, said the decision is up to President Carter and that Agriculture Secretary Bob Bergland has not been deeply involved in the selection. They did say the secretary gave Williams an enthusiastic endorsement

Williams lost a bid for the gubernatorial nomination in the Democratic primary in Florida last fall

The deputy's job has been vacant for a year, since the resignation of John C. White to become chairman of the Democratic National Committee.

A number of names were considered in the last year for the post, but no nomination was announced by Carter. At least one candidate dropped out after deciding not to divest himself of business interests as required by the president, the source said.

Another candidate asked to be removed from consideration for personal reasons and because of the high cost of living in Washington. It was also disclosed that he had been arrested by District of Columbia police two years earlier on a

charge of sexual solicitation. The charge was later dropped.

The sources said that one of the reasons for Bergland's support is that Williams has "a solid background" in agriculture and "is from the South." One of the unwritten guidetines has been that since Bergland is from Minnesota, the job of deputy secretary should be filled by a southerner.

The sources said they did not know when Carter might officially send Williams' nomination to the Senate because a number of other appointments are stacked up for similar action

Officials who work closely with Bergland say the vacancy has meant a heavy load for him the last year and that, as one said, "he needs somebody in there to take part of the heat, a kind of chief of staff."

WASHINGTON (AP) - It may be next week before Agriculture Secretary Bob Bergland feels well enough to return to work

Bergland was ordered by doctors to go home Wednesday and take it easy for at least "a couple of days" to recover from a sore back resulting from excessive exercise over the holidays.

An aide, Tom Sand, said Bergland was released late Wednesday from Bethesda Naval Hospital, where he was Xrayed and given medication to use at home.

'If there is no improvement, he'll return to Bethesda for further tests," Sand said.

The X-rays "showed nothing except he does, in fact, have a spine," Sand said.



But Holmes scholar William Baring-Gould later decided that the fictional sleuth's actual birthday was January 6, 1854. In 1893 Doyle wrote a story in which Holmes died. But by then Holmes had become so popular that the author wrote another story and brought him back to life. Even today, on the eve of his 125th birthday, die-hard Holmes fans prefer to imagine that their hero is alive and retired in. England.
