Lions run over Badgers

The Ozona Lions got off to a winning start in district play Friday night.

Ozona defeated McCamey 64-19 at Lion Stadium.

"We played a good game on offense. It was one of those games where anything called seems to work. It was how we wanted to start district play," said Coach Kyle Freeman.

Offensively, the Lions had 548 yards rushing and 24 yards passing for 572 total yards of offense.

Junior Kobe Rodriguez scored four touchdowns for the Lions. He also had 250 yards rushing on 16 carries.

Senior Tommy Fay had 136 yards rushing on five carries and two catches for 24 yards. Senior Chance Johnson had 70 yards rushing on 12 carries and a touchdown.

Quarterback Jadon Perez had six carries for 58 yards and two touchdowns. He was also 2-5 for 24 yards passing.

Freshman Sebastian De La Cruz scored his first varsity touchdown. He had two carries for 34 yards.

Senior Francisco Rivera was perfect on extra-point attempts.

Defensively, the Lions held the Badgers to 257 total yards.

Senior Brandon Meza had 14 tackles for Ozona. Freshman Alec Lara had 11 tackles.

Edgar Damian and Caleb Martinez each had eight tackles.

Senior Aiden Fierro had an interception, four tackles and one forced fumble.

The Lions (3-3 overall, 1-0 in district) will face Eldorado (2-6 overall, 0-2 in district) this week. The Eagles lost to Anthony, 61-0, last week. They also lost to Christoval 37-0 in their first district game.

Fresh beef from brazil: incomplete review means too much risk for too little reward

Because the U.S. cattle herd has been safe from foot-and-mouth disease (FMD) since 1929, I am concerned by the Aug. 1 announcement from U.S. Department of Agriculture (USDA) that we are considering the importation of fresh beef from Brazil, a country that has an active vaccination program against FMD.

We hold other trading partners to standards that require their cattle herds to be free of a disease, and not just vaccinated against it. We should not relax our requirements for Brazil.

Foot-and-mouth disease is not a threat to human health,

but it is devastating to the livestock species that are susceptible to it. Ranchers in countries, such as Brazil, mount huge expensive animal health campaigns to control the disease and work to eradicate it. Our major trading partners, Canada, Australia and New Zealand, are FMD-free.

Thankfully, we were able to eradicate FMD from U.S. herds nearly 100 years ago. It is disappointing that USDA moved forward with its decision to allow the importation of fresh beef from Brazil before the Government Accountability Office (GAO) had completed its audit of the procedures USDA used to formulate its rules for importation.

A bill that passed Congress at the end of last year — a bill that TSCRA helped to get passed — included language that required audits and site inspections of packing facilities in Brazil and included language

that required USDA to outline the process for their audits.

At the time, this language was touted as a great victory for the U.S. cattle industry. Now, we have to ask why USDA is going forward with allowing fresh beef to be imported from Brazil and not fulfilling the requirements of the bill.

TSCRA has very clear policy on trade and protection of the health of the cattle herd. A 2014 resolution states we oppose the "importation of live cattle, beef, and/or beef products into the U.S. from foreign countries with histories of significant chronic animal diseases

and lack of strict animal disease control and eradication measures."

TSCRA supports "independent scientific and legal analyses of USDA proposals, risk assessments, and supporting information, when necessary, to substantiate risk levels of imported live cattle, beef, and/or beef products and assure the protection of the U.S. cattle industry."

TSCRA expects "that slaughter, processing, transporting, and other facilities and equipment used to export foreign live cattle, beef, and/or beef products into the U.S. be sub-

ject to equivalent, or greater, inspection and sanitation requirements applicable to U.S. inspected facilities and equipment."

And the association "requests that the USDA continue to take all reasonable and appropriate measures to protect the U.S. cattle industry from the introduction of foreign animal diseases, and communicate to foreign countries that wish to export live cattle, beef, and/or beef products to the U.S. to commit to enhanced efforts to control and eradicate animal

Texas has a record-breaking 15 million people registered to vote ahead of the November election, the Secretary of State's office announced last week.

This year's figure amounts to 78 percent of the voting-age population and more than 1.3 million additional registered voters from four years ago, according to the news release.

However, voter turnout in Texas has been lacking. Only seven primary states had lower turnout in the major-party primaries held earlier this year.

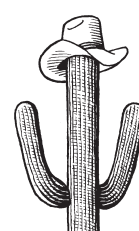
In Texas, about 7 percent of adults cast ballots in the Democratic primary and 14 percent of adults cast ballots in the Republican primary, according to records compiled by the United States Election Project, barely topping Arizona for eighth-to-last in voter turnout.

Every two years, American voters have the opportunity to tell our leaders how they're doing and what they want to see from their government. The right to vote is a privilege, and it's our responsibility to take advantage of it.

Whether you vote during the early voting period or on Election Day, one thing is important: that you vote.

As President Franklin Roosevelt said, "Nobody will ever deprive the American people of the right to vote except the American people themselves, and the only way they could do this is by not voting."

We're so full of ourselves.

There's no better sign that we are falling apart than the current state of the language in this country. We used to live in far simpler times where we said what we meant and meant what we said. We took a writing style that was colorful and interesting and have sterilized it to the point that a cowboy, cowpuncher or saddle stiff is now "a temporary member of the bovine management workforce." No wonder we don't understand each other any more, we're not speaking the same language. Abbott, Patrick, Straus call for action by Child Protective Services

AUSTIN — Texas' top three officeholders on Oct. 12 instructed the Texas Department of Family and Protective Services to improve the protection of children at risk of abuse.

With recent data showing the agency is struggling to see children in a timely manner, Gov. Greg Abbott, Lt. Gov. Dan Patrick and House Speaker Joe Straus sent a letter to Department of Family and Protective Services Commissioner Hank Whitman, calling for immediate action to more quickly help vulnerable children.

"Protecting children from abuse is going to be a top priority in next year's legislative session, but there is a need for action right now," Straus said.

The letter instructs Whitman to:

- Develop a plan to hire and train more special investigators;
- Develop a plan to ensure

that DFPS has the caseworkers to handle the increase in cases and to prioritize hires in the most critical regions of the state;

- Develop a plan to address a shortage of foster homes and residential providers;
- Reinforce a culture of accountability within CPS; and
- Build upon ongoing efforts to enhance partnerships with faith-based communities.

The 85th Regular Session of the Texas Legislature will convene on Jan. 10.

REGISTRATION BREAKS RECORD

Texas Secretary of State Carlos H. Cascos on Oct. 13 announced the number of registered voters was 15,015,700, an all-time high number for the state.

The last day to register in time for the Nov. 8 election was Oct. 11.

The 15 million-plus number reported by Cascos is about 78 percent of Texas' estimated voting age population of 19,307,355. Voting age population estimates include Texans who may not be eligible to vote, such as non-citizens or convicted felons who have not yet fully discharged their sentence.

Cascos said the number of registered voters reported is preliminary, and likely will increase a bit as last-minute applications continue to be processed during the next few days.

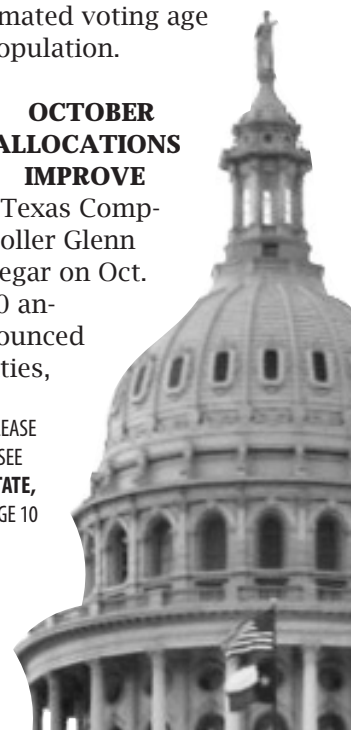
According to figures compiled by the Secretary of State's Elections Division, in 2012, the last presidential election year, Texas had 13,646,226 registered voters, or 75 percent of voting age population. In 2008, the number was 13,575,062 or roughly 77 percent of the

voting age population. More recently, ahead of the 2016 primaries in March, Texas had 14,238,436 registered voters, or 74 percent of estimated voting age population.

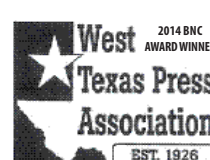

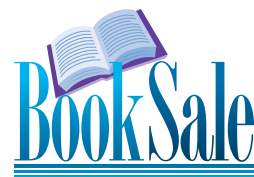

What if the F-bomb of nutrition is actually its best kept secret?

What if the "F-bomb" of nutritional conversation, "Fasting" was actually one of human nature's best-kept secrets in the pursuit of optimal health and wellbeing? Most people believe they fast intermittently 10 to 12 hours between supper and breakfast, while they sleep.

However, the body does not enter into a fasted state for about 12 hours after its last meal. To be in the fasted state, it must be relying on endogenous sources of energy (like glycogen, fat and protein stored in the body) rather than the recently consumed food being processed in the digestive tract (exogenous sources).

Intermittent Fasting (IF) refers to the pattern of eating which cycles between fasting and eating, usually fasting for a period of 16 to 24 hours and eating only during an 8-hour window each day, or simply having a single daily meal at a convenient time.

In retrospect, our hunter/gatherer ancestors didn't have the accoutrements of modern food storage, procurement and availability - no grocery stores, refrigerators or year-around food availability. Theirs was a life of intermittent and extended periods of fasting for weeks-on-end from one meal to the next. Their progeny, our ancestors evolved with this pattern of eating for 2.5 million years. Intermittent and periodic fasting is actually more "natural" than eating 3, 4, 5 and 6 meals per day.

According to Kris Gunnars of AuthorityNutrition.com, "There are several different ways to do intermittent fasting. All of them split the day or week into "eating periods" and "fasting periods."

"The 16/8 Method: Also called the Lean gains protocol, it involves skipping breakfast and restricting your daily eating period to 8 hours, for example from 1 pm to 9 pm. Then you "fast" for 16 hours in between.

"Eat-Stop-Eat: This involves fasting for 24 hours, once or twice a week, for example by not eating from dinner one day until dinner the next day.

"The 5:2 Diet: On two non-consecutive days of the week, only eat 500-600 calories. Eat normally the other 5 days. More details here.

"By making you eat fewer calories, all of these methods should make you lose weight as long as you don't compensate by eating much more during the eating periods." Changes occur in your

body when it's in a fasting state.

Human Growth Hormone (HGH) levels increase as much as five times.

Besides enhanced healing, fat loss and lean body mass gains

are but a few of the scientifically backed benefits.

Insulin sensitivity recovers and the body's insulin levels decrease dramatically which make body fat more accessible to be converted to energy.

When in the fasted state, cellular repair processes like autophagy, where cells consume and eliminate old and malfunctioning proteins that collect within the cells. Genes relating to longevity and disease prevention are changed and bolstered.

Chris Gunnars says, "These changes in hormone levels, cell function and gene expression are responsible for the health benefits of intermittent fasting. When you fast, human growth hormone levels go up and insulin levels go down. Your body's cells also change the expression of genes and initiate important cellular repair processes. Intermittent fasting may boost metabolism slightly, while helping you eat fewer calories. It is a very effective way to lose weight and belly fat."

Finally, IF helps make eating healthy, simpler and less time-consuming with less meals to plan, purchase, prepare and clean-up after... and, it'll save you on your grocery bill.

IF isn't for everyone, however. Pregnant women and people with eating disorders should consult their caregivers before beginning any new nutritional plan.

Intermittent Fasting is just one approach in a litany of nutritional strategies that will enhance your health and wellbeing. Periodic Water and Dry Fasts will be discussed in a future article.

Just Eat Real Food (JERF), be moderately active, get plenty of sleep and give your body a break from constantly processing micronutrients and storing fat in your body... if it works for you.

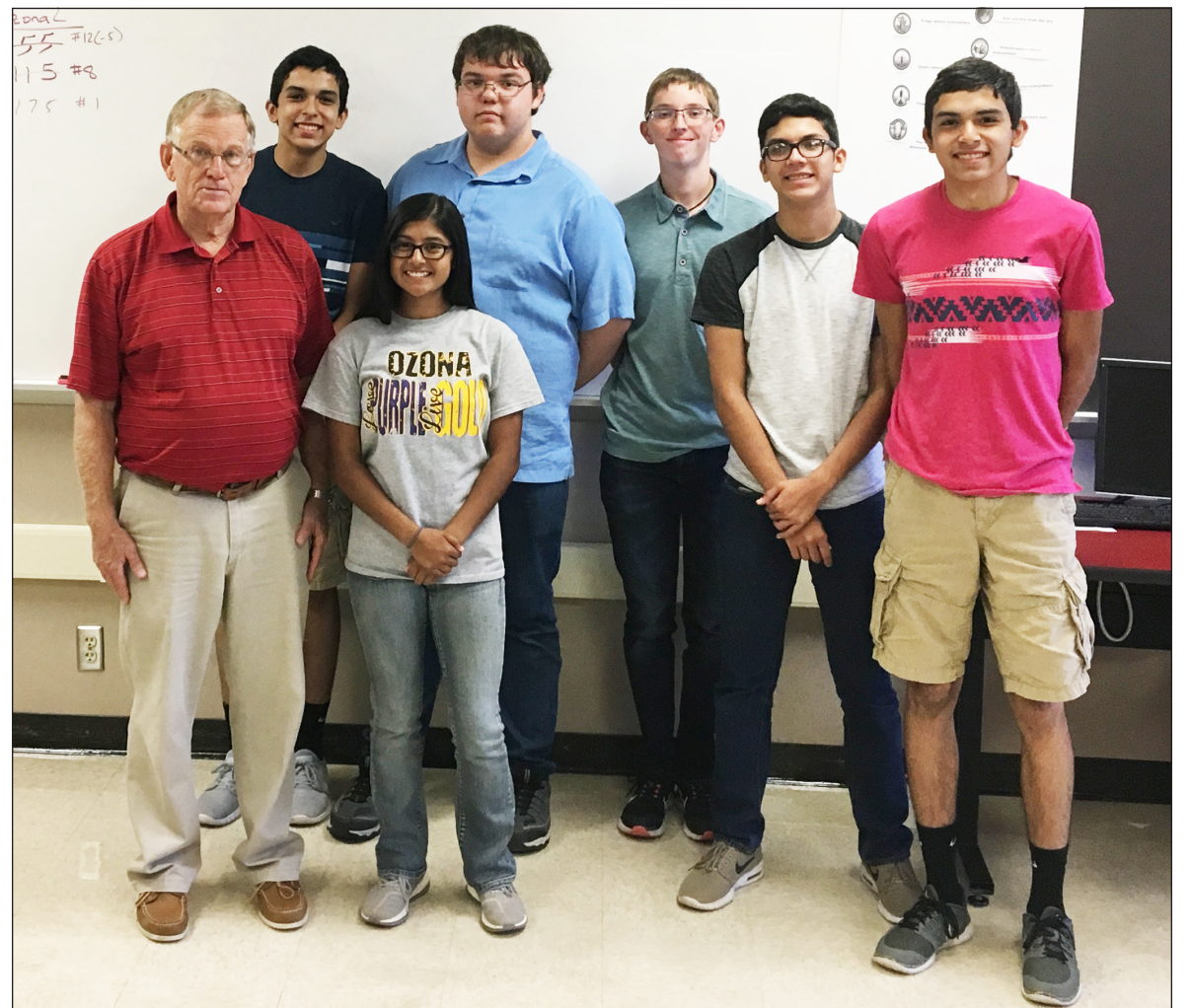

The last day to apply for a ballot by mail is Oct. 28. Crockett County Voters can request ballots by mail through the Crockett County Clerk's Office, also located in the courthouse annex. For more information, call (325) 392-2022.

The Office of the Texas Secretary of State reminds voters who do not possess and cannot reasonably obtain a form of approved photo ID that they now have additional options when voting in person.

Currently, Texas voters who do not possess and cannot reasonably obtain one of the seven forms of approved photo ID have additional options when casting their ballots. As provided by court order, if a voter does not possess and is not reasonably able to obtain one of the seven forms of approved photo ID, the voter may vote by (1) signing a declaration at the polls explaining why the voter is reasonably unable to obtain one of the seven forms of supporting documentation.

Supporting documentation can be a certified birth certificate (must be an original), a valid voter registration certificate, a copy or original of one of the following: current utility bill, bank statement, government check, or paycheck, or other government document that shows the voter's name and an address, although government documents which include a photo must be original and cannot be copies. If a voter meets these requirements

and is otherwise eligible to vote, the voter will be able to cast a regular ballot in the election.

The seven forms of approved photo ID are:

- Texas driver license issued by the Texas Department of Public Safety (DPS)
- Texas Election Identification Certificate issued by DPS
- Texas personal identification card issued by DPS
- Texas license to carry a handgun issued by DPS
- United States military identification card containing the person's photograph
- United States citizenship certificate containing the person's photograph
- United States passport

With the exception of the U.S. citizenship certificate, the approved photo ID must be current or have expired no more than four years before being presented for voter qualification at the polling place.

Voters with a disability may continue to apply with the county registrar for a permanent exemption to showing approved photo ID (which now may be expired no more than four years) at the polls. Also, voters who (1) have a consistent religious objections to being photographed or (2) do not present one of the seven forms of approved photo ID because of certain natural disasters as declared by the President of the United States or the Texas Governor, may continue apply for a temporary exemption to showing approved photo ID at the polls.

Why are you running for the CCCCSD Board of Trustees?

I am running for CCCCSD Board of Trustees in order to help not only my children, but all students of CCCCSD to get a quality education. I believe too often people get onto school boards for self-serving agendas or to try to influence a certain aspect or department of a school. Neither of these are reasons I have chosen to run for a position on the CCCCSD Board. When a school superintendent I used to work for found out that I was running he told me, "always vote in the best interest of those kids and you will never be wrong." My goal is to always have that advice in mind when making decision concerning CCCCSD.

What is the most important issue facing CCCCSD and what is your plan to resolve it?

I believe that most people would think that consistent positive scoring on state testing would be an issue not only facing CCCCSD but most school districts in general. I believe that by improving these key issues, CCCCSD will not only have strong test scores, but also stronger staff and students.

What unique contribution will you make to this board?

The unique contribution I would bring to the board would be my experience as a teacher and coach for nine years, three of which I spent as an employee of CCCCSD. While serving in the education profession, I had the unique opportunity to see how a school district and board worked before running for a position on a school board. Pharr, Texas man killed in I-10 accident

A Pharr, Texas was killed in a multi-vehicle accident Monday night on Interstate-10.

Jonas Aldaba Vasquez, 35, was pronounced dead at the scene by Crockett County Justice of the Peace Evelyn Kerbow.

Vasquez was driving an 18-wheeler tractor-trailer when his vehicle struck the rear of a Toyota Tacoma causing the tractor-trailer to skid until it struck the guardrail and overturned, according to a report from the Texas Department of Public Safety.

Wilmar Estuardo Marroquin, 31, of Guatemala, was treated and released with non-incapacitating injuries, the report stated. Marroquin was driving a Mitsubishi vehicle that was also involved in the accident.

The accident occurred around 9 p.m. near the 337 and 338 mile-markers, about 27.2 miles west of Ozona.

It was investigated by DPS Trooper Duy Nguyen. Crockett County Sheriff's Office, Crockett County EMS, the Ozona Volunteer Fire Department, TxDOT and other DPS Troopers assisted.

counties, transit systems and special purpose taxing districts would receive \$650 million in local sales tax allocations for October.

The amount to be allocated, based on sales made in August by businesses that report tax monthly, is 5.5 percent greater than in October of the previous year.

"The cities of San Antonio, Dallas, Fort Worth, Plano and McKinney saw noticeable increases in sales tax allocations," Hegar said, but "the cities of Houston and Midland saw significant decreases in sales tax allocations."

SCHOOL BUS SAFETY IS URGED

The Texas Department of Public Safety on Oct. 13 urged drivers to comply with laws prohibiting the passing of school buses.

During National School Bus Safety Week, Oct. 17-21, DPS Highway Patrol troopers will watch for drivers who pass any school bus that is stopped and operating a visual signal, either flashing red lights or a stop sign. Drivers who violate the law could face fines as much as \$1,250.

Texas law requires a driver traveling in either direction to stop when approaching a school bus that is stopped and operating a visual signal. The driver may not proceed until one of the following occurs: the school bus resumes motion; the operator is signaled by the bus driver to proceed; or the visual signal is no longer activated.

DSHS ISSUES ZIKA REMINDER

The Texas Department of State Health Services on Oct. 14 issued a public reminder that Zika testing is available for pregnant women who cross the border with Mexico.

DSHS encouraged those women to discuss testing with their health care providers. Under U.S. Centers for Disease Control and Prevention guidelines, Zika testing is recommended for any pregnant woman who has traveled to a country with ongoing Zika transmission, including those who regularly cross the U.S.-Mexico border.

Testing for Zika antibodies is now a part of routine prenatal care during the first and second trimesters in pregnant women with an ongoing risk of Zika exposure.

diseases that may be a chronic problem in their country."

USDA says that due to the FMD vaccination protocols followed by Brazilian ranchers the risk of FMD being brought into this country in fresh beef is very low.

Nevertheless, a risk remains, and for a small reward.

We imported more than 570,000 metric tons of beef from Australia in 2015, and almost 300,000 metric tons of beef from New Zealand that year. We imported 285,036 metric tons from Canada in 2015.

Until we have a trade agreement with Brazil, fresh beef imports from that country will be limited to less than 65,000 metric tons. At the most, we could expect 5.5 percent of our imported beef to come from Brazil. Are we willing to

risk the health of the U.S. beef herd on such a small amount?

The slightest risk, no matter how small, is not worth getting FMD in this country.

I encourage TSCRA members and ranchers to call on your members of Congress to take action on this issue before the end of the year. Apparently, USDA did not get the message. It makes sense to delay importation of fresh beef from Brazil until the GAO audit is completed.

TSCRA supports trade with other countries, but we do not want to forego science and expose the rest of this industry to a risk we already fought almost 100 years ago. It was expensive then; it would be devastating now.
