Items Stolen Last August Recovered

Lynn County sheriff's officers this week recovered more than \$8,000 worth of goods stolen last August from a storage house owned by Wayne Hatchel, north of Tahoka, last August 4. Investigation led officers to a location in Slaton where the items were found, and a deputy said seven Slaton juveniles were involved in the burglary.

The case will be turned over to juvenile authorities, he said, and the stolen goods will be returned to the owner. Among the items recovered were a 9-inch Panasonic TV monitor, two power amps, police lights, ten speakers, including some up to 18 inches in diameter, and other electronic equipment.

More irrigation pipe thefts were reported, plus other burglaries in rural areas during the last week. Valton Stephens of Tahoka reported that sometime within the last week or so a barn 10 miles northwest of Tahoka was burglarized, with stolen items including a red Lincoln welder. Bobby Joe Smith of Rt. 4, Lubbock, reported theft of 700 feet of pipe from a trailer at a location about six miles northwest of New Home within the last month. The pipe was valued at \$1860. The owner reported he had located some of the pipe and that it had been cut up into short

Also damaged was a parked 1979 Chevrolet El Camino owned by Rufus Gerner of Tahoka. Total damage was estimated at \$5500. The case was turned over to county juvenile authorities.

Also investigated by police Sunday was a collision at 1900 N. Main involving a 1977 Chevrolet pickup driven by Fidel Garcia Jr. of Tahoka and a 1977 Ford driven by Janie Mitchell Milton of Tahoka. No injuries were reported.

On Friday, police investigated a burglary of a vehicle. J.C. Thomas Payne of 1201 N. 6th reported that someone had stolen a Regency programmable scanner and adapter valued at \$163 from his vehicle parked at his residence.

Texas Tech Journalism Student Lynn County taxpayers will pay increased property taxes this year due to state mandated programs and loss of tax base, officials said, explaining that eight of the 11 taxing entities in the county have raised property tax rates.

"The increase in eight of the county's taxing entities is due to the loss of oil values, no new properties in the area and the cost of mandated programs that must be met," said Dovie Miller, chief appraisal officer of the Lynn County tax appraisal

In Tahoka a person whose home is valued at \$40,000 paid \$615.43 in taxes last year and will pay \$643.57 this year, a difference of \$28.14 to school, city, county, hospital and water districts.

Tahoka's city tax increased from 47.40 cents per \$100 valuation to 51.17 cents while the school tax remained constant at 72 cents, she

The Lynn County Hospital tax increased from 16.756 cents per \$100 valuation to 20 cents, an increase of about three cents. The Lynn County tax remained constant at 26

Tahoka Mayor Jim Solomon said the city tax rate is still one of the lowest rates in the area and it has been three years since the last increase.

"Taxes is not a dirty word since they are necessary to run city operations on a cost effective basis. We all hate higher taxes, especially the elected officials held accountable to the public for the spending of these tax dollars. I believe an evaluation of our tax rate relative to the surrounding community show Tahoka to be very efficient in our operations," Solomon said.

The mayor cited as the primary reasons for the city tax hike in Tahoka increased health insurance rates for city employees, workers'

compensation and general operation

City taxes go into the general fund which pays for city operations, including police and fire protection, he said.

Wilson also have a tax increase this year. According to Mrs. Miller tha city tax rate rose from 79 cents per \$100 valuation to 83 cents and the school district rate climbed from 80 cents per \$100 to 85 cents, causing the tax for an average home, which is valued at \$19,100, to increase \$28.43

O'Donnell's city tax remained

the same at the rate of 86 cents per \$100, but its school tax increased from 79 cents to 80 cents, causing a home valued \$28,000, to increase


