## Book Recounts Children's Remarks From New Home Teacher's Career

Children say the funniest things, and LaVonne (Scooter) Sharp of New Home has published a book recalling many of the sayings she got a chuckle out of during her 30-year teaching career, mostly with New Home Independent School District. The book, entitled "Oh, See the 'Pretty,' Well, Let's Jump Into It" has sayings of children (and some notes from parents) that Mrs. Sharp saved throughout the years.

Among her favorites is this story, related to her by Cam Johnston in 2004:

*The class was discussing lungs and that they were under your sternum and covered with your skin. Cam said, "We can't see them." Merritt Mitchell said, "But when you get married, your husband can see them!"* (page 57 in the book)

These and other amusing anecdotes have been saved on scraps of paper by Mrs. Sharp since she began teaching in 1962. She kept a notebook of the sayings, and decided after she retired that she would publish a book of these delightful and funny stories from the children whose young hearts and minds were so special to her.

"The superintendent of New Home called me in 1962 when a teacher quit in September, and I began teaching that year - I taught for two years before I earned my certification," she recalls. "I started in first grade, and taught second and fifth grades, and I started the kindergarten class here," said Mrs. Sharp.

She officially retired in 1996, but has remained active in the New Home school system, substitute-teaching full-time for several years before deciding to quit - again.

"Then, I went back again and taught Junior High and High School English, and then they needed a special education teacher. I continued teaching until the first of this year, when my health has forced me to quit," said Mrs. Sharp.

She says the title of her book comes from a saying she and her sister had as children.

"My sister and I were playing on the bed, jumping up and down and throwing the quilts up in the air, and I said, 'Oh, see the pretty, and she said 'Well, let's jump into it!' We were

actually supposed to be making the bed," she says with a smile. She painted a watercolor of the scene, which has been reproduced on the cover of her book.

The book spans the years from 1962 to 2004. The names of children making the remarks are included, but the parents' notes included in the book have only initials, such as the following note (spelling reprinted as in the original note):

*Mrs. Sharp: Please give J. his medicine when it is time. It tell you on the bottle. He took it at 7:00 Am. Thank you. A.S. (P.S. The doctor said the worms would not be coming back.)* (page 53)

Or this note from a parent: *D. had a flea Her throat hurted and stomach.* (page 52)

"I've had such a good time putting this book together, remembering all the things the children said. I wish I had kept more of them," said Mrs. Sharp.

She had 200 books printed, which are available at her home or by mailing a request to: LaVonne Sharp, P.O. Box 197, New Home, TX 79383. The books are \$8.95 each (plus \$1.50 each for shipping and handling).

While Mrs. Sharp's health has forced her to retire from teaching, she remains vitally interested in the students at New Home ISD. For 30 years, she and Laverne McAllister have made ceramic leopards (the school's mascot) for every senior for graduation, and she plans to continue to do that again this year.

"Next year's seniors will be my last first graders that I taught, so I hope I can do it until then - but sometime I guess I will have to stop," she said with a note of regret in her voice.

Here's one more child's story, from page 20 in the book:

*A little boy had done something very, very bad. His mother told him to go upstairs and call on the Lord and tell him what he had done. The child went upstairs, shut the door and stayed about two minutes. He came back downstairs. His mother said, "Well did you call on the Lord?"*

*"Well, yes, but I couldn't get him. But, I got Mrs. Lord, and I guess it's all over Heaven by now!"*

## Fleeing Driver Arrested After High-Speed Chase

A 39-year-old Midland man led officers from the Dept. of Public Safety, Lynn County Sheriff's Dept. and Tahoka Police Dept. on a high-speed chase which eventually covered 11 miles before being stopped and arrested four miles south of Tahoka on U.S. 87 Tuesday.

The chase started seven miles north of Tahoka just about 5:15 p.m. Tuesday when DPS Trooper Wanda Raney stopped Joe David Neff of Midland, driving a 2003 Chevrolet 2500 pickup, for speeding. Officer Raney said she conducted a field sobriety test to determine he was intoxicated, but that when she turned away briefly, the man ran back to his pickup and fled south.

DPS Trooper Bryan Hoard scattered spikes on the highway under the overpass at U.S. 380 and U.S. 87 and Neff's pickup had its left front tire blown out by the spikes. He continued south, however, for four miles before the tire shredded to the rim, and after officers boxed him in, he drove across a west bar ditch and almost a mile into a field until he hit a fence line. Sheriff's deputies in pickups were able to follow him into the field.

Trooper Raney said that Neff then hid in mesquite trees for about 10 minutes before coming out about 5:50 p.m. with his hands up and surrendering to officers, some of whom had shotguns ready.

He was charged with driving while intoxicated, a misdemeanor, and two felonies, evading arrest by a motor vehicle and assault on a public servant.

Trooper Raney expressed thanks to the sheriff's department and police department (which blocked off exits into Tahoka to keep Neff from coming into the city) for their assistance. She added that DPS troopers also appreciate the county's purchasing pickups for the sheriff's office because these trucks can go into terrain inaccessible to DPS cars.

"The availability of these pickups helped us on Oct. 21 with a vehicle fire and again Tuesday," she said.

Tahoka Police arrested two people during the last week, one on a warrant for violation of the open container law, and one for possession of drug paraphernalia.

Jailed during the last week were seven persons, two for application to revoke probations on burglary warrants, one on a Lubbock warrant for theft by check, and others

for evading arrest plus assault on public servant plus DWI first offense, and possession of drug paraphernalia.

Forty-one persons were in jail as of Wednesday, with 16 of these held for Lubbock County.

During the month of November, dispatchers at the sheriff's office answered 217 calls, including 100 for the county, 90 for Tahoka Police Dept., 13 ambulance calls, two fire calls and 12 calls for O'Donnell police.

## Hospital Officials Negotiating For New Doctor Here

Plans to have a third family practice physician set up practice at Lynn County Hospital starting next summer were discussed by the Lynn County Hospital governing board at the group's regular monthly meeting Tuesday evening.

Dr. Robert Eaker, an O'Donnell native who is finishing his training, is scheduled to join Doctors Donald Freitag and Griffith Thomas with offices in the clinic at the hospital. Some details of this arrangement still have to be worked out, according to hospital administrator Dan Powers.

After comparing rates of Lynnwood Assisted Living Center with rates of similar facilities in the area, the board voted to increase Lynnwood monthly rates by three percent. Lynnwood currently is full, with 22 residents.

Powers also reported that a recent team of examiners from the state had high praise for Lynnwood and its manager, Susie Sosa, and indicated the facility is one of the best the team had visited anywhere.

Board vice-president Jerry Ford presided in the absence of president Billy Tomlinson. Members present included Ford, Dalton Wood, Mike Rivas, Virginia Griffing and Joan Knox. Member John Hawthorne was absent.

Also present were Powers and the hospital's chief operations officer, Jimmy Morris.

- 20 million adults have a disability which limits their mobility. (Okay, so I am one of those. Either I have one leg shorter than the other or one leg longer than the other, I'm not sure which).

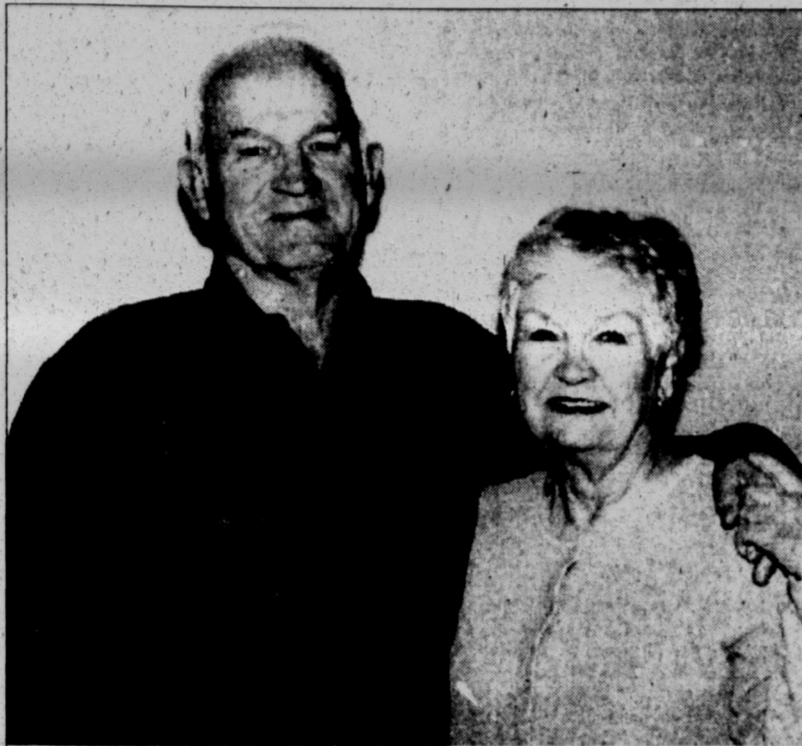

**Recount Shows Ricky Smith Retains DA Title**

District Attorney Ricky Smith of Lamesa will keep his title as District Attorney of the 106th Judicial District, after an official recount of ballots proved Smith had more votes than challenger Brian Kingston of O'Donnell.

The recount was conducted last Tuesday in Lynn, Gaines, Garza and Dawson counties, with recounted numbers showing Smith to win with 6,249 votes to Kingston's 6,206.

Kingston had filed a recount request with the secretary of state's office after the Nov. 2 election showed Smith with a 49-vote margin district-wide. The recount narrowed the margin to 43 votes, with both candidates picking up more votes in Dawson, Lynn and Garza counties. In Gaines County, Smith picked up four votes and Kingston dropped two votes.

Recount totals are: Lynn, Smith 909; Kingston 1308; Garza, Smith 997; Kingston 811; Gaines, Smith 1754; Kingston 2221; Dawson, Smith 2589; Kingston, 1866.

Memorials may be made to the Sweet Street Baptist Church.

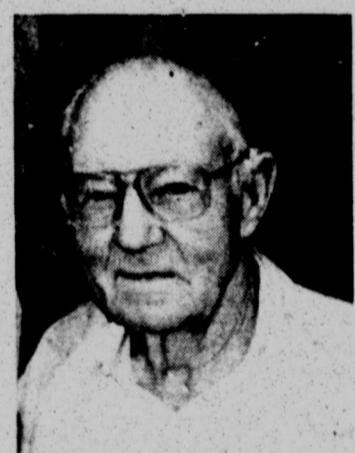


**Frances E. Dunagan**

### Order Windbreak Trees Now From Lynn Co. SWCD

Seedlings for conservation windbreak will be available at the Lynn County Soil & Water Conservation District on March 3, 2005, and orders are now being taken. Landowners and individuals in Lynn County are encouraged to purchase the one year old seedlings before preferred stock is sold out.

One gallon Live Oak trees, 4-5 feet tall, will be available next week.

Each year thousands of regionally adapted seedlings are grown from seed at the Texas Forest Service West Texas Nursery in Lubbock. The Agency's primary objective is to produce and sell quality seedlings at a price landowners can afford, allowing them to plant large quantities of trees for windbreaks.

Windbreaks are trees and shrubs systematically planted adjacent to field, homesteads, or feedlots as a barrier to reduce or redirect the wind. They create permanent, natural protection and habitat for wildlife, reduce erosion and increase land value and aesthetics.

Wildlife packets for habitat establishment also are available. Each of the four wildlife packets contain 100 bare root trees and shrubs which cater specifically to the habitat needs of quail and pheasant, deer, turkey, or squirrel.

Windbreak trees available this year include Afghanistan Pines, Italian Stone Pines and Eastern Red Cedars. These trees sell for \$2.00 each or \$55.00 for a box of 30 trees.

Hardwood trees available include Amur Honeysuckle, American Plum, Catalpa, Desert Willow, Green Ash, Lacebark Elm, Old Fashion Lilacs, Nanking Cherry, Red Buds, Russian Olive, Sand Cherry, and Sand Plum. These trees sell for \$1.00 each or \$30.00 for a bundle of 50 trees.

Larger trees in two and five gallon containers and perennial plants in a one gallon container will be available some time in March.

### TDA To Mail Ballots For Dec. 7 Boll Weevil Vote

Cotton farmers and landowners with cotton production are eligible to vote in a Dec. 7 referendum that will determine whether to continue a boll weevil eradication program in the southern High Plains/Caprock Boll Weevil Eradication Zone.

Eligible voters in the Southern High Plains/Caprock Boll Weevil Eradication Zone should receive an official ballot by mail after Nov. 18. A postage-paid return envelope will be included. Completed ballots must be postmarked on or before Dec. 7 to be counted. Producers who planted cotton in 2004 but do not receive a ballot should contact TDA at (512) 463-4879.

In addition to deciding if an eradication program should be continued in the zone with a maximum annual assessment of \$12 per land acre of irrigated cotton and \$6 per land acre of dryland cotton, including skip rows, voters will elect a board member to serve on the state-wide board of directors for the Texas Boll Weevil Eradication Foundation Inc.

TDA received one nomination for this position before the Nov. 5 filing deadline. The name of Joe Alspaugh of Lubbock County will appear on the ballot as a board nominee. Alspaugh has grown cotton for 33 years.

The Southern High Plains/Caprock Eradication Zone consists of approximately 1.2 million acres of cotton in all of Cochran, Hockley and Lubbock counties; and parts of Crosby, Dickens, Garza, Lynn and Terry counties.

period of warm, dry weather was needed to improve field conditions. Cotton lint already was stringing from open bolls, and farmers were concerned that additional precipitation could add to quality and yield losses. A lack of seed cotton had

caused many gins in the area to shut down temporarily. Many modules were waiting in the fields, but attempting to remove them was proving a major impediment due to the soft, wet soil.

### Cotton Market Weekly

Cotton futures settled with small losses Wednesday on trade selling in quiet dealings ahead of the long Thanksgiving holiday break. Traders will be looking for leads when the market reopens next week.

Cotton trading on the New York Board of Trade was closed Thursday and Friday for Thanksgiving. According to market observers, dealings were lethargic for the most part on Wednesday as many traders already had left for the break, the year's longest such holiday for the cotton market.

Due to the holiday, USDA released its weekly export report on Friday. The department reported net U.S. export sales of 236,200 bales in the week ended Nov. 18 which were three percent lower than the previous week but 71 percent higher than the four-week average. Major buyers included China, Mexico and Turkey.

Export shipments of 149,100 bales were 18 percent higher than the previous week and 34 percent higher than the four-week average. Primary destinations included Mexico, South Korea, and Turkey.

On the spot cotton scene, Texas, Oklahoma and Kansas producers sold 18,601 bales online in the holiday-shortened week ended Nov. 24 compared to the previous week when 34,911 bales were traded. Prices received by producers selling their cotton online ranged from 36.72 to 38.34 cents per pound versus the previous week's range of 38.54 to 39.75 cents per pound.

Meanwhile, cotton consumption for October was viewed as friendly by the market, sources said, but had no bullish effect on prices. U.S. textile mills used cotton on a seasonally adjusted annualized rate of 6.42 million bales in October compared to 6.2 million bales used in October 2003, the National Cotton Council reported. The council also revised its September 2004 figure down to 6.42 million bales from 6.45 million in its original report.

In other news, little headway was made in harvesting the U.S. crop during the week ended Nov. 21, according to the National Agricultural Statistics Service. The Agency reported the U.S. cotton crop is 72 percent harvested compared to 72 percent one year ago and the 80 percent five-year average. Work is finished in Louisiana but well behind normal in Texas. Only 45 percent of the Texas crop there had been harvested versus 59 percent last year and the 66 percent average.

Wet weather continued to plague West Texas over the past weekend, but sunny skies prevailed over the Thanksgiving holiday. Soils remained saturated, and a prolonged

## Symptoms For Reye's Syndrome Listed

Reye's Syndrome is a very serious disease that people should know about. Some people develop Reye's Syndrome as they are getting over a viral illness, such as the flu or chicken pox. Reye's Syndrome usually affects people from infancy through young adulthood; however, no age group is immune. Although Reye's generally occurs when someone is recovering from any viral illness, it can develop 3 to 5 days after the onset of the illness. Its main targets are the liver and brain, it is non-contagious, and too often is misdiagnosed as encephalitis, meningitis, diabetes, poisoning, drug overdose or sudden infant death.

Early diagnosis is crucial. An individual should be watched during the next 2 to 3 weeks following a viral illness for these symptoms, usually occurring in this order:

- Relentless or continuous vomiting
- Listlessness (loss of pep and energy with little interest in their environment)
- Drowsiness (excessive sleepiness)
- Personality change (such as irritability, slurred speech, sensitivity to touch)
- Disorientation or confusion (unable to identify whereabouts, family members or answer questions)

• Combativeness (striking out at those trying to help them)

• Delirium, convulsions or loss of consciousness.

Reye's Syndrome should be suspected in anyone who vomits repeatedly. Phone your doctor immediately if these symptoms develop. Voice your concern about Reye's Syndrome. If your physician is unavailable, take the person to an Emergency Room promptly. Two liver function tests (SGOT, SGPT) can be done to determine the possibility of Reye's Syndrome. There is a 90% chance of recovery when the syndrome is treated in its earliest stages by physicians and nurses experienced in the treatment of Reye's.

Studies have shown that using aspirin or aspirin-containing medications to treat the symptoms of viral illnesses increases the chance of developing Reye's Syndrome. If you or a member of your family have viral illnesses, do not use aspirin or aspirin-containing medications. In fact, you should consult your physician before you take any drugs, particularly aspirin or anti-nausea medicines, to treat the flu, chicken pox or any viral illness. Anti-nausea medicines may mask the symptoms of Reye's Syndrome.

The National Reye's Syndrome Foundation (NRSF), the U.S. Surgeon General, the Food and Drug Administration and the Centers for Disease Control and Prevention recommend that aspirin and combination products containing aspirin not be taken by anyone under 19 years of age during fever-causing illnesses.

Aspirin is a part of the salicylate family of medicines. Another name for aspirin is acetylsalicylate; some drug labels may use the words acetylsalicylate, acetylsalicylic acid, salicylic acid, salicylate, etc., instead of the word aspirin. Currently, there is no conclusive data as to whether other forms of salicylates are associated with the development of Reye's Syndrome. Until further research has answered this question, the NRSF recommends that products containing any of these substances not be taken during episodes of viral infections.

### Know The Indicators Of Sexual Child Abuse:

- Physical Indicators - headaches, stomach aches, and overall not feeling well; pain in anal or genital area; pregnancy or sexually transmitted diseases
- Behavioral Indicators - sudden change in behavior; changes in relationships with adults; withdrawal from friends and family; depression, low self-esteem, or self-critical.

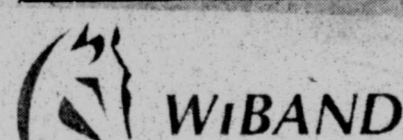

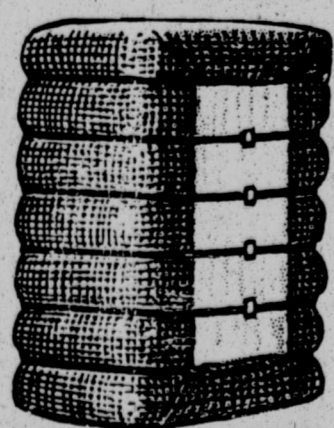
