

Tahoka Chamber of Commerce to support LCHD Bond Election

embers of the Tahoka Area Chamber of Commerce met at noon Monday at the Life Enrichment Center to hear a presentation from Lynn County Hospital CEO Stace Holland about the upcoming May 10 bond election for voters to consider. If approved, the \$28 million bond will be used to build a new hospital and to renovate a portion of the current hospital as a 20-bed nursing home facility that connects to the hospital and Lynnwood Independent & Assisted Living Center.

James Craig, President of the TACC, and the other Chamber members present at the meeting, indicated that the Chamber would encourage voters to approve the bond election, citing the proposed project as an investment in the future of the community, providing expanded healthcare and new job opportunities.

Holland told the group that building a new hospital would take advan-

tage of Medicare funding that pays 101% of costs incurred for Medicare patients, which is revenue that could help to pay off the 30-year bond earlier than anticipated, and he explained the short-term and long-term benefits and opportunities the project could bring

The proposed project would double

the size of the current facilities, which were built in the early 1970s, and bring the hospital into compliance with current codes and regulations while adding more patient services, including surgery/OB services, a new ER with dedicated staff, in-house CT, MRI and mammography services, expanded laboratory services, outpatient treat-

· Assessments: The first major change is the reduced number of High School End of Course (EOC) tests needed to graduate - the requirement

went from 15 required tests to five EOC tests.

Changes in testing, graduation course plans

to impact student coursework at Tahoka ISD

"Students now only need to pass the English I, English II, Algebra I, Biology and US History end of course exams to qualify for graduation," explained TISD Assistant Superintendent Jenni McLelland, "These five tests will typically be given during students' freshman and sophomore year. depending on their course sequence. Students then have two years to re-take the tests if needed," she added.

 New Graduation Requirements: HB5 does away with the old 4 by 4 plan. The new requirement includes the Foundation plan (22 credits), plus five endorsement options (totaling 26 credits), and then an optional Distinguished Plan.

The goal of HB 5 is to allow students to specialize in a certain area of study, enabling students not planning to go to college to graduate with the skills needed to go straight into the workforce, and providing those planring to enroll in a college or university the skills and knowledge necessary for success in an institute of higher learning," said McLelland.

All students must initially add en-


Join us in the MS Walk, May 3rd Dear Editor,

MS, known as Multiple Sclerosis, is a chronic disease affecting tissues of the brain and spinal cord, resulting in degenerative physical disability. Signs and symptoms of MS include muscle spasms, muscle weakness, tingling and prickling sensations, depression, mood swings, fatigue, changes in vision, chronic pain, psychological changes and loss of cognitive ability. Doctors are unsure of what causes MS, but genetic and environmental factors, such as stress, smoking and lack of vitamin D, are believed to create an elevated risk of developing the disease. MS affects more women than men, and it is currently incurable. MS can also affect families financially as well as medically. Most drugs prescribed for MS can range from hundreds of dollars to thousands.







This permit will not authorize a discharge of pollutants into waters in the State. TCEQ received this application on October 17,

The wastewater treatment facility is located approximately two miles south of Highway 380 and 0.25 mile east of Highway 87. The effluent disposal site is located approximately 1,200 feet south of the plant site, between Highway 87 and the Atchison Topeka and Santa Fe Railroad, approximately 2.23 miles south of Highway 380 in Lynn County, Texas 79373. The wastewater treatment facility and disposal site are located in the drainage basin of Double Mountain Fork of the Brazos River in Segment No. 1241 of the Brazos River Basin.

The TCEQ Executive Director has completed the technical review of the application and prepared a draft permit. The draft permit, if approved, would establish the conditions under which the facility must operate. The Executive Director has made a preliminary decision that this permit, if issued, meets all statutory and regulatory requirements. The permit application, Executive Director's preliminary decision, and draft permit are available for viewing and copying at Tahoka City Hall, 1612 Lockwood Street, Tahoka, Texas. WHEREAS, the Board of Directors (the "Board") of the Lynn County Hospital District (the "District") has, among others, the power to issue bonds for the construction and equipment of hospital buildings and nursing homes in the District (including the rehabilitation, renovation, improvement and repair thereof); and

WHEREAS, the Board hereby finds and determines that it is in the public interest to call and conduct a bond election at the earliest practicable date to authorize the issuance of general obligation bonds to construct these capital improvements within the District; and

WHEREAS, the Board hereby finds and determines that the bond election should be held for the construction of a new hospital and the renovation of its existing hospital building into a nursing home; and

WHEREAS, the Board hereby finds and determines that the construction of the new hospital and the renovation of the existing hospital building into a nursing home are so related that they should be submitted as a single proposition; and

WHEREAS, the Board hereby finds and determines that the new hospital and the nursing home are necessary to provide long term health care services to meet the needs of the District in accordance with Section 1054.113, Texas Special District Local Laws Code, and to meet its responsibility of operating all hospital facilities and for providing medical care for the District's needy inhabitants, as required by Section 1054.101, Texas Special District Local Laws Code, and Article IX, Section 9 of the Texas Constitution; and

WHEREAS, the Board has determined that May 10, 2014, would constitute an appropriate date for such an election; and,

WHEREAS, the Board also has the authority pursuant to Chapter 31, Texas Election Code, to enterinto a contract for election services with Lynn County; and

WHEREAS, the Board also has the authority pursuant to Chapter 271, Texas Election Code, to enter into joint election agreements with the other political subdivisions also holding a general or special election on the same date.

IT IS, THEREFORE, ORDERED BY THE BOARD OF DIRECTORS OF THE LYNN COUNTY HOSPITAL DISTRICT THAT:

Section 1. Call of Election; Date; Eligible Electors; and Hours. A special election (the "Election") shall be held on Saturday, May 10, 2014 which is seventy-one (71) or more days from the date of the adoption of this order (the "Order") within and throughout the territory of the District at which all resident, qualified electors of the District shall be entitled to vote. The Board hereby finds that holding the Election on such date is in the public interest. The hours during which the polling places are to be open at the Election shall be from 7:00 o'clock a.m. to 7:00 o'clock p.m.

Section 2. Voting Precincts; Polling Places; Election Judges and Clerks. On Election Day, the boundaries and territory of each Hospital District Election Precinct shall be comprised of the territory of existing Lynn County Election Precincts with polling places as follows:



Clerk. The Joint Early Voting Clerk shall appoint the Deputy Early Voting Clerks.

Early voting in the Election by personal appearance shall be for the period permitted by law, which shall begin on Monday, April 28, 2014, and continue through Tuesday, May 6, 2014. During the period that early voting is required or permitted by law, early voting shall be conducted on the dates and at the times designated by this Order. The Main Early Voting Polling Place shall also remain open on the day of the Election during the hours the polls are required to be open for voting by the Election Code.

Section 6. Conduct of Election and Joint Election Agreement. The Election shall be conducted by election officers, in accordance with Chapter 1054, Texas Special District Local Laws Code, the Texas Election Code and the Constitution and laws of the State of Texas and the United States of America. An electronic voting system, as defined and described in Title 8 of the Texas Election Code, shall be utilized for the Election.

Pursuant to Chapter 31 of the Texas Election Code, the Board orders that this Election be conducted under the terms and conditions of an Election Services Agreement between Lynn County and the District.

Pursuant to Chapter 271 of the Texas Election Code, the Board orders that this Election be conducted under the terms and conditions of an Agreement to Conduct Joint Elections (the "Joint Agreement"), which agreement shall be presented to the Board for its approval. Chapter 271 of the Texas Election Code provides that the authorities of two or more political subdivisions that have ordered elections for the same day in all or part of the same territory, may enter into an agreement to hold the elections jointly in election precincts that can be served by common polling places, and the Board is expressly authorizing this action.

Section 271.003 of the Texas Election Code provides that voters of a particular election precinct or a political subdivision may be served in a joint election by a common polling place located outside the boundary of the election precinct or political subdivision if the location can adequately and conveniently serve the affected voters and will facilitate the orderly conduct of the elections. To the extent that any polling place for any election precinct used by the District in the conduct of the Election is located outside the boundaries of the election precinct or the District, the Board specifically finds that the polling place selected by the Joint Agreement is convenient and will adequately serve the voters of the District.

Section 7. Delivery of Voted Ballots, Counting, Tabulation, Canvassing of Returns, Declaring Results. In accordance with the requirements of the Election Code, the Election Officers shall make and deliver a written return of the Election. The Board shall canvass the returns and declare the results of the Election.

If a majority of the resident, qualified electors of the District voting at the Election, including those voting early, shall vote in favor of the Proposition, then the issuance and sale of the bonds shall be authorized in the maximum respective amount contained therein, and the bonds shall be issued and sold at the price or prices and in such denominations determined by the Board to be in the District's best interests

Section 8. Appointment of Custodian of Records. To the extent not otherwise provided for in the Election Services Agreement, or in any Joint Election Agreement, the Board appoints Stace Holland, an employee of the District, as the Custodian of Records ("Custodian") to perform the duties related to the conduct and maintenance of records of the Election as required under the Texas Election Code during the period beginning the third day after the approval of this Order and ending not earlier than the fortieth (40th) day after the day of the Election. In particular, the Custodian shall accept and maintain records regarding campaign expenditures that may be filed with the District.

The Custodian shall maintain an office open for Election duties for at least three hours each day, during regular office hours, on regular business days during the period designated in this section. The Custodian shall post notice of the location and hours of her office as required by the Texas Election Code. The Custodian shall maintain in her office the documents, records and other items relating to the Election and shall be the person designated to receive documents on behalf of the District that are required by the Texas Election Code.

Section 9. Election information to be provided in Spanish. The President of the Board and all other election officers appointed by the Board responsible for the preparation of notices, instructions, orders, ballots and other written material pertaining to the Election shall cause each such document to be translated into and furnished to voters in both the English language and the Spanish language in order to aid and assist voters speaking Spanish as a primary or an alternative language to properly participate in the election process. In addition, the President of the Board and other responsible election officers are hereby authorized and directed to make available to the voters having the need

of an individual capable of acting as a translator and speaking both English and Spanish languages who will assist Spanish speaking voters in understanding and participating in the election process.

Section 10. Notice of Election Publication and Posting Requirements

Publication of Notice of Election

Notice of the Election, containing a substantial copy of this Order, shall be published one time in the English and Spanish languages, in a newspaper published within the District's territory at least 10 days and no more than 30 days before the Election and as otherwise may be required by the Texas Election Code.

Posting of Notice of Election

Notice of the Election, containing a substantial copy of this Order, in both the English and Spanish languages, shall also be posted (i) on the bulletin board used by the Board to post notices of the Board's meetings, (ii) at three (3) other public places within the District, and (iii) on the District's Internet website, if the District maintains an Internet website, no later than the 21st day before the

A copy of this Order, in both the English and Spanish languages, shall be posted in a prominent location at each polling place on Election Day and during early voting by personal appearance.

Miscellaneous

Section 11. Outstanding Debt Service of the District. As of September 1, 2013, the total outstanding amount of all bonded indebtedness of the District is \$0.00, consisting of \$0.00 in principal and \$0.00 of interest.

Section 12. Tax Rate of the District. The ad valorem debt service tax rate of the District for the year 2013/14 is \$0.00 per \$100 taxable assessed valuation. The estimated debt service tax rate of the District if the bonds were authorized and issued at the time of this Order under current market conditions is \$0.50/\$100. However, the District anticipates receiving Medicare reimbursements for the Hospital/Nursing Home project which would permit the District to reduce the debt service tax rate to approximately \$0.34/\$100.

Section 13. Authority of the Chief Executive Officer. The Chief Executive Officer of the District shall have the authority to take, or cause to be taken, all actions reasonable and necessary to ensure that the Election is fairly held and returns properly counted and tabulated for canvass by the Board, which actions are hereby ratified and confirmed.

Section 14 Taxes May Be Imposed Taxes sufficient to pay the annual principal of and interest on the General Obligation Bonds may be imposed.

Section 15. Maximum Maturity. The District anticipates that the maximum maturity of the general obligation bonds will be thirty (30) years, but will not exceed forty (40) years.

Section 16. Preamble Incorporation. The recitals contained in the preamble hereof are hereby found to be true, and such recitals are hereby made a part of this Order for all purposes and are adopted as a part of the judgment and findings of the Board.

Section 17 Inconsistent Provisions All orders and resolutions, or parts thereof, which are in conflict or inconsistent with any provision of this Order are hereby repealed to the extent of such conflict, and the provisions of this Order shall be and remain controlling as to the matters ordered herein

Section 18 Governing Law. This Order shall be construed and enforced in accordance with the laws of the State of Texas and the United States of America

Section 19 Severability If any provision of this Order or the application thereof to any person or circumstance shall be held to be invalid, the remainder of this Order and the application of such provision to other persons and circumstances shall nevertheless be valid, and the Board hereby declares that this Order would have been enacted without such invalid provision.

Section 20. Notice of Meeting. The Board officially finds, determines, recites and declares that written notice of the date, hour, place and subject of the meeting at which this Order is adopted was posted on a bulletin board located at a place convenient to the public at the District's administrative offices for at least 72 hours preceding the scheduled time of the meeting, that a telephonic or telegraphic notice of such meeting was given to all news media who have consented to pay any and all expenses incurred by the District in connection with providing such notice, both as required by the Open Meetings Law. Chapter 551, Texas Government Code, as amended, and that such meeting was open to the public as required by law at all times during which this Order and the subject matter thereof was discussed, considered and formally acted upon.

Section 21. Authorization to Execute The President of the Board is authorized to execute and the Secretary of the Board is authorized to attest this Order on behalf of the Board, and the President of the Board is authorized to do all other things legal and necessary in connection with the holding and consummation of the Election.

Section 22 Effective Date This Order is effective immediately upon its passage and approval.

Changes impact student coursework at TISD ...

(Continued from page 1) dorsement courses to their graduation plan, depending on the job or field of study that they plan to pursue. The five endorsements created by HB 5 are: (1) STEM (Science, Technology, Engineering, and Math), (2) Business and Industry, (3) Public Services, (4) Arts and Humanities, and (5) Multidisciplinary endorsement. Electives for an endorsement track are to be taken in a coherent sequence, with the goal of developing a specific skill set.

The 'STEM Endorsement would be for those students intending to go into a career in technology, medicine, engineering, etc. Business and Industry Endorsement would be for those planning a future in agriculture, architecture, construction, business and industry, hospitality, transportation, manufacturing, marketing and finance. Public Services includes careers related to education and training, health sciences, government and law enforcement; Arts and Humanities would be courses leading to careers in fine arts, history, world languages, and English Literature. The fifth category, Multidiscipline, is for those students that are undecided and covers an overall basic plan.

"Students will have an option to change their plan after consulting with parents and the school counselor, should they choose to decide to go in a different direction," McLelland explained. "The plan they choose, however, determines the coursework and skills covered in that particular field of study," she added.

Tahoka ISD is already in the planning stages for offering new courses that would lead directly

to the workforce upon graduation, including courses in welding, Certified Nurses Aides (CNAs), EMT certification, and other certification courses including cosmetology, daycare providers, and Microsoft Operating Systems (MOS).

An optional Distinguished Plan that includes Algrebra II is also offered. Students who graduate in the Distinguished Plan are eligible for the top 10% Automatic College Admission at some univer-

• Community and Student **Engagement Evaluation:** Each district must annually evaluate district and campus performance in community and student engagement and assign a performance rating of Exemplary, Recognized, Acceptable or Unacceptable.

This evaluation requirement is a school/program evaluation that every district conducts for their own district, with input from community, parents and students. TISD sent out a survey that allowed input to rate the following eight catego-

1. Community and Parent Involvement (Parent/Teacher Organizations, Open House, 6th and 9th Orientation, Extracurricular Activities, Parent Portals, Facebook, Weekly e-Newsletters, etc.)

2. Fine Arts (Music, Band, One Act Play, Art, etc.)

3. Wellness and Physical Education (PE, Athletics, SHAC committee meetings, Anti-Bullying prevention, Blood Donation site, School Reach Bullying/Suicide hotline, Drunk Driving Simulation, Pregnancy related services, Career/ Technology courses, Health Fair, Vision and Hearing Screening, etc.)

4. 21st Century Workforce (CTE courses, AVID, College and Career Fairs, Dual Credit courses, Certification courses, First Generation College Students group, etc.)

5. Second Language Acquisition (Spanish courses, English Language Learners opportunities for parents and students, Migrant program, etc.)

6. Digital Learning Environment (One to One Laptop Initiative in HS/MS, online coursework, online credit recovery, online staff development, Facebook, Parent Portal, Student newscasts in Elementary and MS, Project Share,

7. Dropout Prevention (Credit Recovery programs, Student Clubs, Mentoring programs, Pre-K, Coun-

seling/guidance programs, etc.) 8. Gifted and Talented Services (AP, Honors, and Dual Credit courses, Teacher Training in GT, Field Trips for GT, etc.)

"An additional area in the evaluation is Compliance, which wasn't on the survey because it is an area that school administrators will complete based on our compliance with State and Federal mandates," explained McLelland.

"Administrators met to look at the data collected and decide how we felt our campuses and district should be rated - Exemplary, Recognized, Acceptable, or Unacceptable in each of the above categories. Each campus is now in the process of scheduling campus Site Based Decision Making (SBDM) committee meetings so that the committees can look at the data and approve/change/modify the campus ratings. Then we will have a District SBDM meeting to finalize our TISD ratings and submit them to TEA in June of 2014. This self-rating will become a part of our overall Accountability Rating, along with many other factors like assessment scores, attendance, and discipline," she added.

School officials will work closely with students and parents to inform them of the new changes and educational opportunities *available through the high school coursework plans, assessment tests, and evaluation process.

Does this apply to you?

If you own tangible personal property that is used to produce income, such as the equipment or inventory owned by a business, it does.

What is a rendition?

A rendition is a report to your county appraisal district that lists all of the taxable property that you owned or controlled on Jan. 1 of this year. This often applies to furniture, fixtures, equipment or inventory owned by a business.

What are the advantages of filing?

- You give your opinion of your property's value.
- You record your correct mailing address so your tax bills will go to the right address.
- If your property's value depreciated, you can file a report of decreased value.

What is the deadline?

- The last day for filing renditions is April 15.
- An automatic extension to May 15 is available if requested in writing by the April 15 deadline.
- The chief appraiser may grant an additional 15 days to an owner who shows good cause in writing.

REMEMBER!!

Filing is your responsibility. If you render late, don't render or file an incomplete or false rendition, you may face a 10 to 50 percent penalty.
