

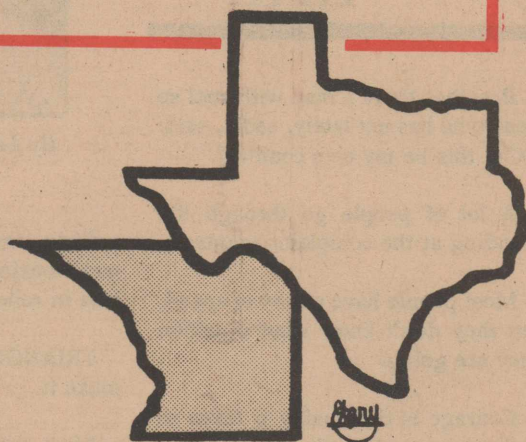

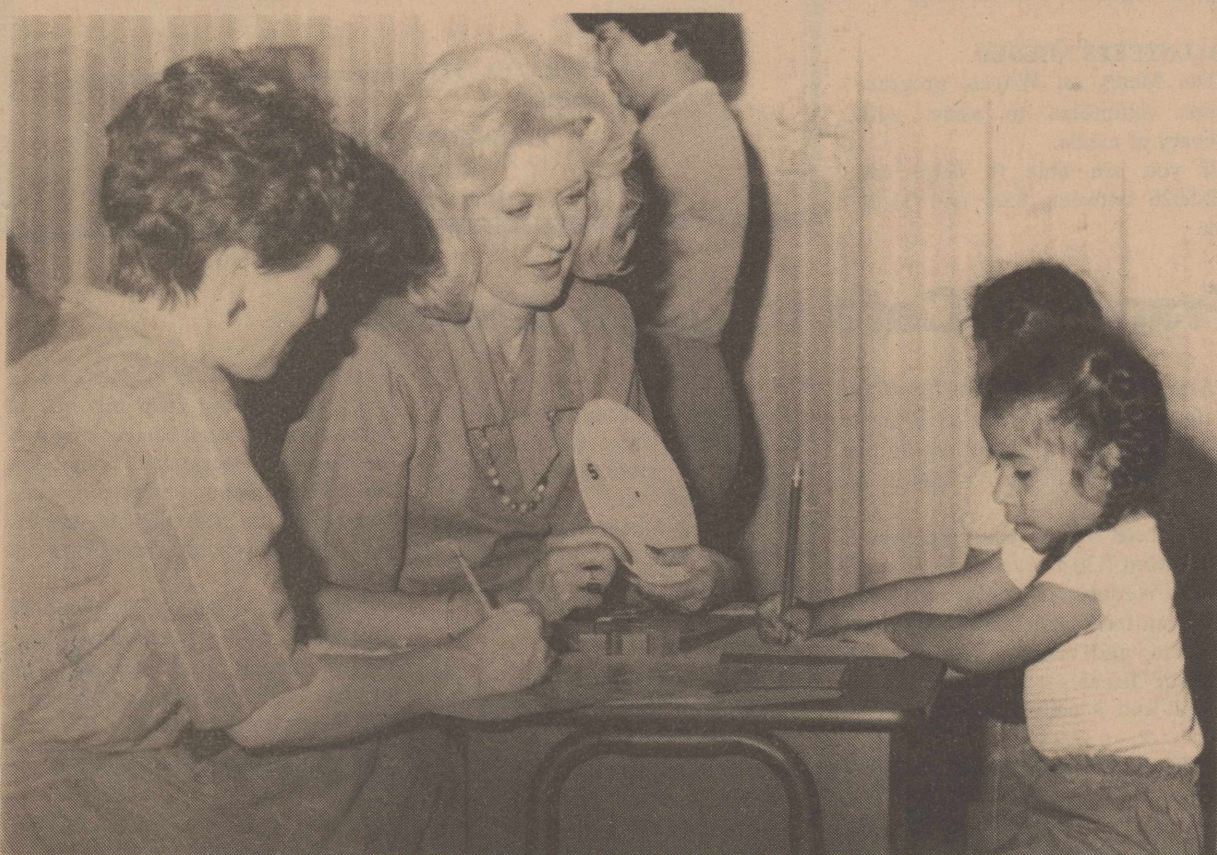

## Athletes honored at banquet

The contribution of high school athletes was recognized by the community during the 1986 All Sports banquet and awards ceremony April 22 at the Civic Center.

The delicious feast of roast beef, mashed potatoes, cole slaw, green beans, corn and peach cobbler provided the honorees and guests with a short time to talk before the program started. Providing background dinner music were pianist Marilyn Chalmers and soloist Janet Henry. The music helped set the evening's theme of individuality and achievement with songs such as "My Way", "Let It Be Me", "That's Life", "You'll Never Walk Alone", "Impossible Dream" and the theme song from "Exodus".

The entertaining program opened with a prayer from First Baptist Church minister Jim Gray. Gray urged the students to use "athletics as a character builder. Have guidance in life and through life."

Booster Club president and master of ceremonies Jerry Lay then explained that the purpose of the club was "to build enthusiasm for local athletes".

Special recognition was extended to Booster Club officers Jesse Fierro, vice president; Terry Adams, secretary; and Veva Vargas, treasurer. Lay presented plaques to Fierro, Adams and Vargas for their hard work throughout the year. Booster Club activities take place throughout the year, starting with a hamburger supper, Lay said. "We provide hospitality rooms for track and tennis teams, a chili supper, a Halloween Carnival fajita booth..."

Lay then paid tribute to Ozona

athletic director Rip Sewell, who will be inducted into the high school "Hall of Honor" in Houston this summer for his 30 plus years of contribution to the coaching field. Sewell received a standing ovation from the audience.

"I am honored to have been selected to the Hall of Honor," said Sewell. "I urge all the other coaches here to stick with the field. I could not have done this without the support of my wife, Ellen, of 36 years."

The boy's all-district team, coached by Sewell, won its third trip to the regional tournament. Those on the all-district team included: Diron Holt, Ty McKinney, Brett Hood Will Seahorn and Copie Davis. Recipient of the Fighting Heart Award was Brett Hood who "stayed late and worked hard".

The program was briefly interrupted by the presentation by senior David Adams of a letter of appreciation from the Class of 1986 to Ozona Lions Booster Club. Jerry Lay, president, accepted the letter and also presented Renfro with an honorary Ozona Lion's jacket.

Tennis coach Jerry Tucker then recognized the contributions made by the junior varsity tennis team.

## Teachers form opposition group

Despite a last minute cancellation by Democratic gubernatorial candidate Dan Crowder, local teachers and administrators held a meeting April 28 in the high school auditorium at which time they organized opposition to the re-election of Governor Mark White.

Band director Kelly Glaze served as moderator of the organization. Approximately 38 teachers, Principals Jim Payne, Jack Probst, Bob Wallace and Walter Spiller, and Assistant Superintendent Ted Cotton and Superintendent Garland Davis attended the meeting. Reports on teacher political rallies in Austin were heard, as well as an explanation by Davis on the teacher appraisal process.

The organization hopes to become more than just a political opposition group. Discussion was held on the future election of officers. Nominating committee members were selected, and building representatives from each school were selected. Junior high school teacher Sherry Scott was chosen as chairperson in charge of rules and bylaws for the fledgling group.

The group plans to continue its local emphasis, and presently will not be affiliated with any national organization. The immediate focus of the teachers is to secure opposition to Mark White. They urge everyone to register a token vote of opposition to White in the Democratic primary May 3.

## Primary election May 3

There are four candidates asking for the nomination for U. S. Representative, District 21. Terry M. Lowry, Pete Snelson, David Hunsicker and Joe Sullivan all want the post which has been vacated by Tom Loeffler.

The race for governor has a field of six. Asking for the nomination are Sheila Bilyeu, A. Don Crowder, Mark White, Ron Slover, Andrew C. Briscor III and Bobby Locke.

Jim Hightower and Noel S. Cowling are asking for the nomination for Commissioner of Agriculture.

Saturday, May 3, will decide the immediate political future of some candidates while leading others into the November general election. Absentee voting in the Crockett County Democratic Primary came to an end Tuesday at 5:00 p.m. with 273

ballots cast as of 1:30 p.m. Despite the number of contested local slots, the amount of absentee votes cast is about normal according to County Clerk Debbi Puckett.

Crockett County has 2,608 registered voters with 825 in Precinct 1, 411 in Precinct 2, 643 in Precinct 3, 705 in Precinct 4 and 24 in Precinct 36.

The polls will be open from 7:00 a.m. until 7:00 p.m. May 3. The law library at the courthouse, site of the absentee election, will also be the location for Precinct 1 voters. Stella Valadez is election judge in that precinct. Precinct 2 ballots will be cast at Ozona Junior High School with Arlene Clayton as judge. Voters in Precinct 3 will vote at the Civic Center where Bobbie Fatout is election judge. Precinct 4 voters will make their preferences known at the

Ozona Primary where Concha Zapata is election judge. Precinct 36 voters will cast their ballots at the WTU Power Plant with J. A. Carroll as judge. Jean Connor is absentee election judge.

Incumbent commissioner B. W. Stuart of Precinct 2 is challenged by Billy Carson and Jerry L. Hill. In Precinct 4, incumbent Jesus (Chuy) Castro faces B. R. (Jody) Conaway and Carlos Lopez.

Candidates for Justice of the Peace are incumbent Raymond Davye, Jerry Lay and David H. Weant.

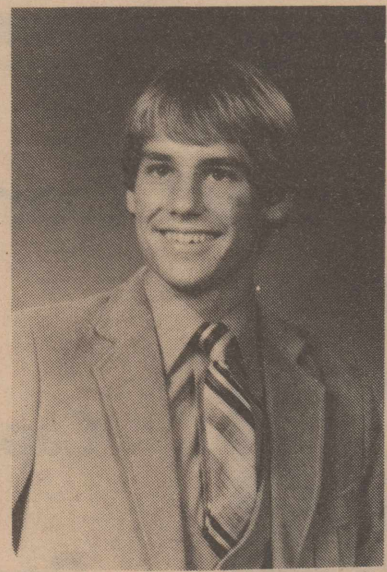
Running without opposition are County Judge A. O. Fields, District and County Clerk Debbi Puckett and County Treasurer Jim Dudley. Another Crockett Countian on the ballot who is unopposed is Brock Jones who asks re-election as District Judge, 112th Judicial District.

## Payne qualifies for track Nationals

Junior Angelo State University student Larry Payne has qualified to compete in the Division II NCAA finals in the 400 meter relay event. The meet will be held May 20-24 in Los Angeles.

Payne, the son of Mr. and Mrs. Jim Payne, has qualified to compete in the Nationals for the third year in a row. Payne missed qualifying for the 200 meter relay team by .02, finishing with a 21.40 time instead of the 21.38. He has previously qualified in the 100m and 200m dash, the 1600m and the 400m relay.

The 1982 graduate of Ozona High School ran track here. "He plans to be a coach and teach science following graduation," said Payne, OHS principal.

Tucker, who finished third in the editorial writing contest at the district level, did not place in that category at the regional contest in Odessa.

Michael Glaze received a fourth place (first alternate) finish for his entry in the newswriting contest. Glaze also placed second in editorial writing at the district level.

Glaze won a first place award at the district UIL competition in news-

Tucker will compete against 12 other regional finalists in the May 9 state UIL competition in Austin, journalism teacher Jackie Shacklette explained. "He (Tucker) did pretty darn good for a freshman - for anyone," said the journalism UIL sponsor.

"I'm going to take advantage of the opportunity," said Tucker. "I might never get a chance to go again."

Tucker's prize winning feature article was about a "Garage Sale to Benefit Famine Relief in Africa".

## Repair shop opens

Former Halliburton employee Terry D. Goins has moved to Ozona from Amarillo to go into the shoe and boot repair business.

The new business, which opened April 21, is located in front of Dale's Electric at 1108 Ave. J. Store hours are from 8:00 a.m. to 6:00 p.m. Monday through Saturday.

Goins, who plans to marry next month, attended Texas State Technical Institute in Amarillo for three years to perfect his leather working abilities. "The work is easy for me. I haven't had to try to do it. It is just like a big hobby," said Goins.

The shop will not only do shoe and boot repair, but will also do saddle repair and custom make boots, starting at \$325 a pair.

"I like this part of the country. I first became familiar with Ozona when I worked in Sonora for Halliburton," said Goins.

The business means that a person must be comfortable with operating several different machines. In the small store, a stitcher, finisher, patching and top machines line various walls. Lasts or wooden feet are available in all sizes, and leather material comes in different colors and styles.

"I really like this work. I had to try this more relaxed style of living," said Goins.

May 5 is opening day for Franco's Cafe says proprietor Arthur Franco. The San Angelo native is leasing the establishment formerly known as Norma's.

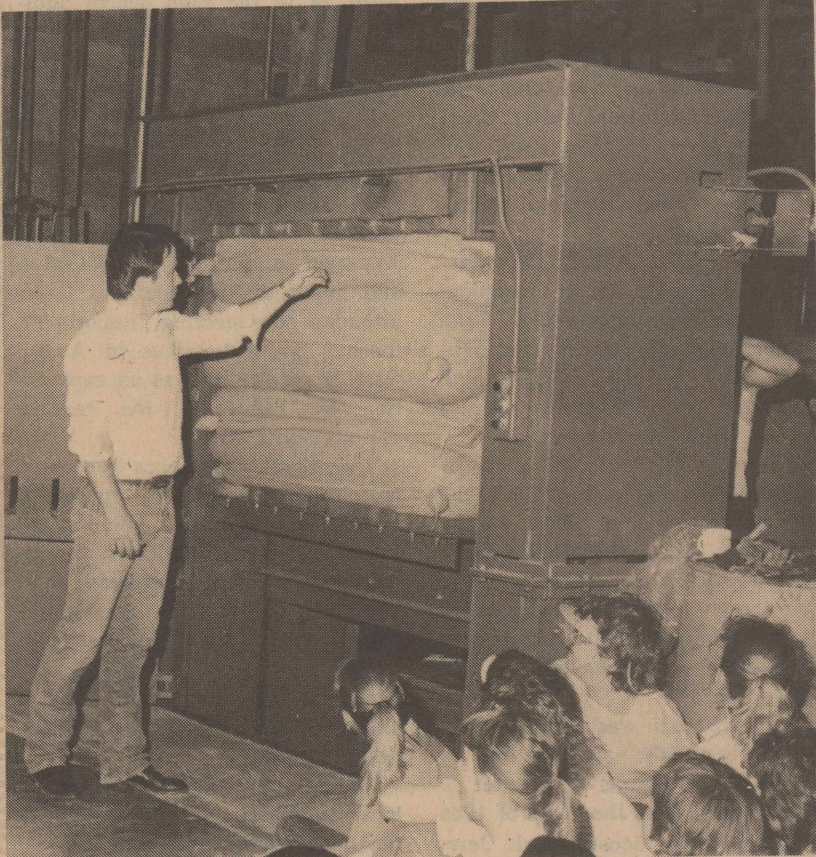

## Sixth graders have conservation tour

The Crockett Soil and Water Conservation District and the Crockett County Extension Service sponsored the second annual conservation education field day tour for the 6th grade students of Ozona April 23. The purpose of the tour was to give the students a basic understanding of what our renewable natural resources are and how they must be properly cared for to sustain our current way of life. As future leaders of our land, another purpose was to impress upon them that they will be the ones taking care of our natural resources.

The morning portion of the tour consisted of taking the students to the Bill Baggett ranch where they were presented subject matter on range, wildlife and soils.

At the range stop, the students learned how grass grows, the need for proper grazing use and deferred grazing, brush control and water consumption of brush and grass, and a hands-on demonstration of water infiltration on various types of grass cover and bare ground.

The soils stop consisted of learning the characteristics of soil and potential erosion problems, how soil is formed, and applicable conservation practices for conserving soil.

Subject matter presented at the wildlife stop included basics of deer antler development and aging of deer, important habitat for game and non-game wildlife species with management implications, and wildlife laws and regulations.

The students were then taken to the fellowship hall of the Methodist Church where they were fed a barbecue lunch provided by the Crockett Soil and Water Conservation District.

After lunch, the students were taken to the Ozona Wool and Mohair warehouse where they had the

opportunity to see a sheep being shorn. Brian May presented a talk on wool and mohair as it relates to Crockett County and Texas and gave students a chance to see and feel several different wool and mohair samples. Rachel Hall then gave a presentation on the processes wool and mohair go through to become a finished clothing product.

The entire day was enjoyed by all

who attended and plans are to continue this event annually. Much appreciation is expressed to the Ozona school officials for their continued support, Bill Baggett for the use of his ranch, the personnel in the area of the Soil Conservation Service, Extension Service, Texas Parks and Wildlife Department and others who contributed to this educational activity.

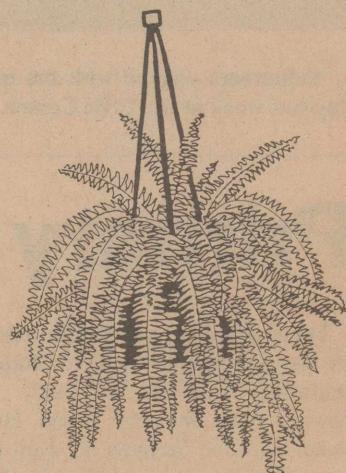

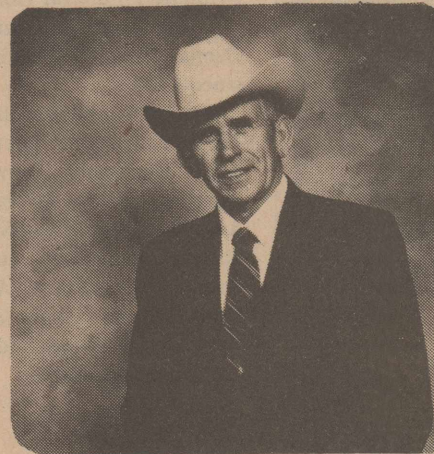

## California couple thrilled with hospital

Diana Crombie a retired medical transcriber and her husband John who is a partial paraplegic never dreamed that way out here in the wild west of Texas there would be a small town with such an excellent hospital and staff. Diana was hospitalized last Monday after an accident that happened near their recreational vehicle parked at a local RV park.

She injured her back after reaching for her husband's wheel chair in the aftermath of high pressure water pipe bursting. She fell on her back causing injury to the extent that hospitalization was needed. The Crombies were on their way to San Antonio to visit kinfolks when the accident caused a delay in their time schedule.

Diana who has had much experience around medical facilities during her career, and her husband who is a retired from a missile manufacturer in California are from Aptos, California. John Crombie who was injured in an auto accident said "I am partially paralyzed from the waist down and have been in out of many hospitals for 9 months and I have yet come across a facility where the service is so great. The staff has just been wonderful trying to be as helpful as they can to me while my wife is in their care."

Diana who has been involved with medical centers during her career said "the R.N.'s and their assistant are really on the stick and everyone in this community should be proud of their professionalism and especially their human attitude toward patients and family. I just couldn't believe how spotless the facility is, and for the life of me we will never understand who people drive all those miles when they can receive excellent care right here in their back

yard".

Mr. and Mrs. Crombie both were mighty glad that the hospital was here. "It really has saved us a lot of time and money!" said Diana. "You just would never believe how sorry the care is in most of these big metropolitan hospitals where you are nothing more than just a name and

number on a chart."

The Crombies wanted to thank everyone who has been so kind and especially the excellent care that Dr. Owensby and the R.N.'s and their assistants have given her and to remember that the people of Crockett County couldn't ask for a better facility and staff.

## Yarborough elected T.A.B.C. officer

## Clinic screens 138 children

The Ozona Community Center, in conjunction with the Crockett County Schools and the Region XV Education Center, held its fourth annual screening clinic Wednesday and Thursday, April 23 and 24.

The screening clinic involves children four and five years of age. There are three basic areas tested in the clinic. The children are tested in the areas of vision, hearing and

language, which consists of gross motor, fine motor, concepts, and communication skills. When all areas are completed, there is a final evaluation of the child's progress with recommendations made for any additional help the child may need before entering the public schools.

On Wednesday, April 23, 72 children were pre-registered for the 1986-87 school year with 66 four year

olds screened on Thursday, April 24.

The clinic was administered by a few primary teachers, the primary aides and secretary, the school nurse, and the Public Health nurse, but the bulk of the work was handled by volunteers from the community. The clinic was considered a huge success because of the good turnout and the participation of the volunteer workers.

**A Preacher's Pondering**

The other day at a grocery checkout in a near-by town, I saw two young men wearing earrings. I know that it's "old hat" - these guys wearing earrings - but I still can't get used to it. I laughed. I couldn't help it. I was laughing, but it really is pathetic. Let me tell you why.

One of these fellows had on a dog collar. It was a thick black collar with metal spikes on it. I didn't see his tag, so I don't know if he was registered or not, nor do I know if he has had his rabies shot. But his ears looked like a Christmas tree. He had one ring in the lobe of his ear, another hung from the outer rim of his ear.

The other man (I think it was a man) had really long hair, but around his ears it was pulled tight so one could see, yep, you guessed it, his earrings.

This pair was quite comical! People were staring at them. I suppose that men who wear earrings know that people will stare at them. They didn't seem to mind, they were out in space somewhere I guess - but their earrings sure were noticeable.

**Gas well completed**

The University 31 multipay field of Crockett County gained another Strawn detrital gas producer with completion of the J. Cleo Thompson, Dallas, No. 2 Henderson 8-10, 15 miles southwest of Ozona, for a calculated, absolute open flow of 5,400,000 cubic feet of gas daily, with gas-liquid ratio of 874,713-1. Gravity of the condensate was 52.2 degrees.

Production was through perforations at 8,511-668 feet, which had been acidized with 12,000 gallons.

Drilled to 9,075 feet and plugged back to 9,071 feet, 4 1/2-inch casing was set at 8,958 feet.

It is located 990 feet from the north and 1,090 feet from the east lines of 8-SL-T&StL Survey.

**Renfro gives inside look at NFL**

The 1986 Ozona All Sports Banquet honored student athletes for their varied achievements and pro-

vided an interesting inside look at the National Football League through the eyes of Dallas Cowboy wide receiver Mike Renfro.

Renfro told the near capacity crowd at the Civic Center April 22, that he realized he "had a God-given talent when he was a high school sophomore." The 31-year-old fleet-footed wide receiver grew up in the world of athletics. His father, Ray Renfro, played for the Cleveland Browns and served as coach of the Dallas Cowboys until his retirement from the world of pro football in 1972. His father presently owns a readymix concrete company in Fort Worth.

"I hit the ground in a football family. My father expressed an interest that I participate in sports," said the 180 pound runner. "I realized that I wanted to play football professionally. I wanted to be a fine, successful person, even if I was not the smartest academically."

Renfro faced adversity, particularly when he played for TCU. "I was on an athletic scholarship, and we won four games during the four years I played. This is a big world we live in, and there are many challenges you will face. I wish you all a road that will ensure that you will be successful."

Renfro was drafted following his graduation in 1978 by the Houston Oilers coached by Bum Phillips. "We made the playoff the next three years. Bum would take a chance on the players who were free agents - the rebels and renegades." Phillips was fired in 1981, but Renfro remained with the Oilers for two more seasons, before being traded to Dallas in 1984.

Last year, the Cowboys did not "play up to Dallas standards. We hope to get back to where we belong," said the 10-year pro-football veteran. "The NFL is a strange road to pursue. Whatever you pursue, do the best you can," he challenged. "There are many other things in life. Find the avenues and be the best at what you do."

Further insights into the life of a professional athlete were afforded

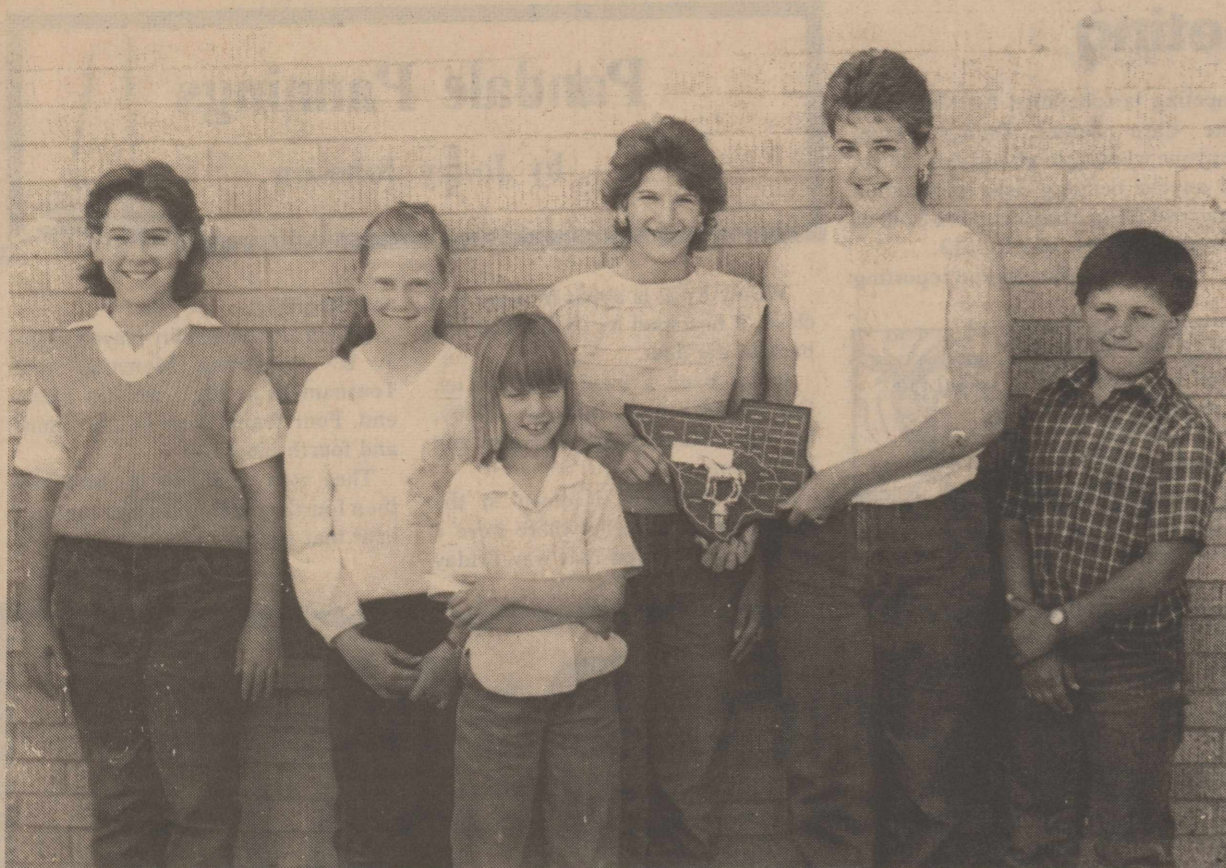

and Saturday.

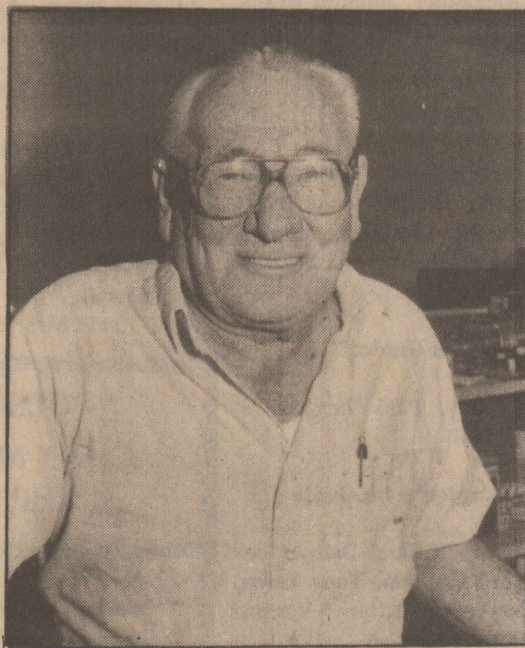

when Renfro answered questions from the attentive audience. "I am fortunate to be able to play this game. I want a Superbowl ring. The NFL lifestyle consists of a seven month job. 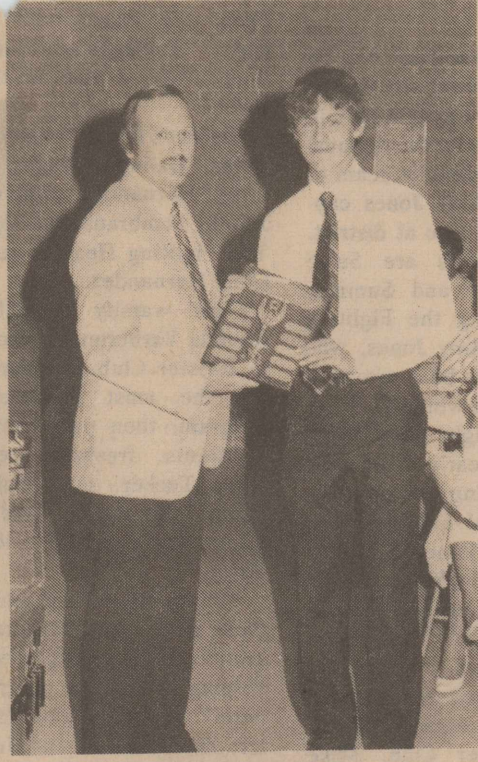

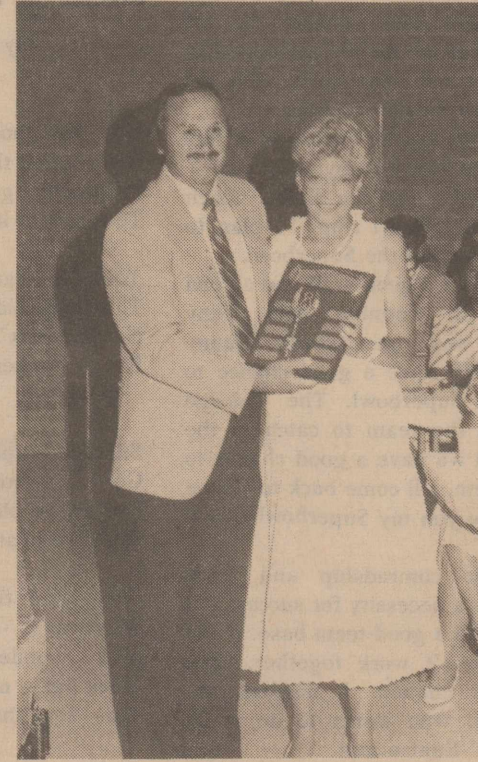

### LABELS AND TAGS TELL THE STORY ON TEXTILES

The hang tags and labels on clothing and household fabrics can help you make decisions about the quality of a potential purchase. Ignoring this information means you may wind up paying more than you should for an item that won't last, or that you can't care for properly.

Laws designed to protect both consumers and producers have been on the books for over 25 years. Basically, the regulations require that textile products (with a few exceptions) be labeled with fiber content identified by generic name, the actual percentage of each fiber used in descending order of the amount present, the manufacturer's name or other identification and the name of the country of origin if it's imported.

The generic name of a fiber is the commonly accepted name for natural fibers. These are names like cotton and wool.

Generic names for man-made fibers include nylon, polyester, and acrylic among others. Many producers also provide other informa-

tion about the fiber like a trade name such as "Orlon", or "Fortrel" polyester, or the fiber variety, such as Pima cotton or Merino wool.

If more than one fiber is used, the percentage by weight of each fiber must appear on the label. So, for example, a blouse may be 60 percent cotton and 40 percent polyester.

The label must also identify the manufacturer by name or a number that allows the consumer to find out who made the product.

Selected textile products, such as children's sleepwear and some home furnishing must also have labels indicating whether or not they meet the flammability standard.

Care labels permanently attached to textile products were first required in 1972 and then amended in 1984 to clarify the terminology and make the labels more accurate. These labels tell the consumer what kind of laundering or dry cleaning is necessary to keep the item in good condition.

## Lake Woebegon Days

A Book Review By T. C. Tucker

With his second book, a national best seller, Garrison Keillor has gained widespread recognition and enough dough to start his own bread factory. Since September *Lake Woebegon Days* has been part of the ranks of best sellers. The only other book still on the list from that month is *Texas* (James Michener), and it has not had as much time at number one as has Keillor's work.

The novel proves to be a humorous book, immediately tickling one's funny bone with an account of his teenage encounter with near-death.

During the next couple of chapters though, the novel runs low on gas as Keillor relates the history of the town of Lake Woebegon. These accounts are easy-going tales, but fail to show the idealistic spark of humor in

them. What does make the book interesting is the way the author tells it. The novel carries on as if one were sitting on the porch listening to Keillor narrate his tales while smushing June bugs under his shoes.

After one makes it through the dull chapters, the novel picks up once more, relating hunting season and the "Last Hunter", and throwing tomatoes as a young boy at his sister.

The book has remained on the list due to the way the novel never deals with the same specific topic for one long period. Keillor's *A Prairie Home Companion* has gained popularity. It too is easy-going, a radio show where many of the Lake Woebegon tales were first born; where many still live.

I am writing this letter to help clear up potential confusion Ozona residents may feel because of the growing number of "charities" soliciting their support to fight cancer.

Unfortunately, some of these organizations are cashing in on the public's fear of cancer, taking advantage of its generosity and capitalizing on the names and reputations of established, well-regarded organizations and institutions like the American Cancer Society and the National Cancer Institute.

To set the record straight: The American Cancer Society is a national, volunteer nonprofit health organization with no affiliation with any other cancer-related, nonprofit fund-raising organization. The Society's programs are carried out locally by an elected board of directors. Local volunteers contribute their time and energy to sponsor educational programs, assist cancer patients and raise the money needed to continue our fight against cancer.

Every year, the American Cancer Society conducts its annual Cancer Crusade during April, which President Reagan has designated as Cancer Control Month. A proliferating number of dubious cancer charities also schedule their fund-raising drives and mail solicitations during March and April.

Some of these groups have similar-sounding names which may confuse the giving public. Others misuse the words "National" or "American" in their titles when their programs are actually conducted in specific local areas. Those headquartered in Washington, D. C., may be incorrectly linked in the public's mind with the government-funded National Cancer Institute, thereby gaining them an "official" sanction they don't deserve.

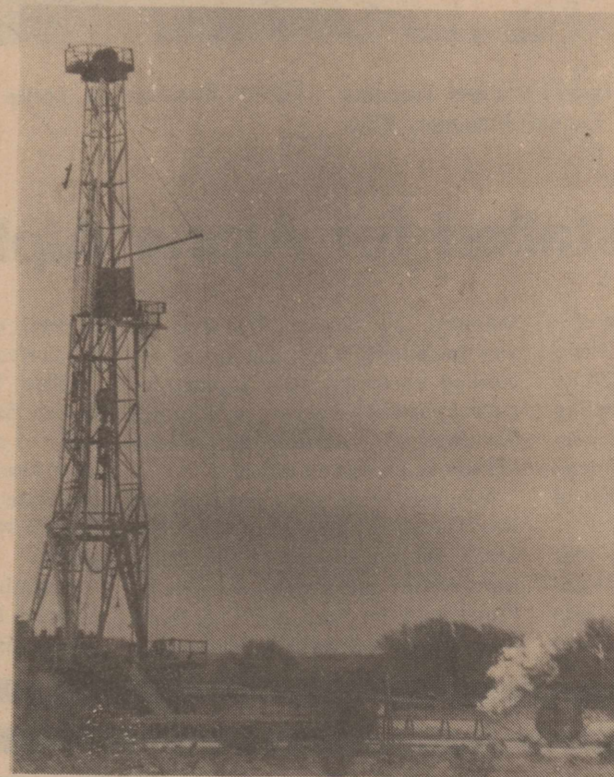

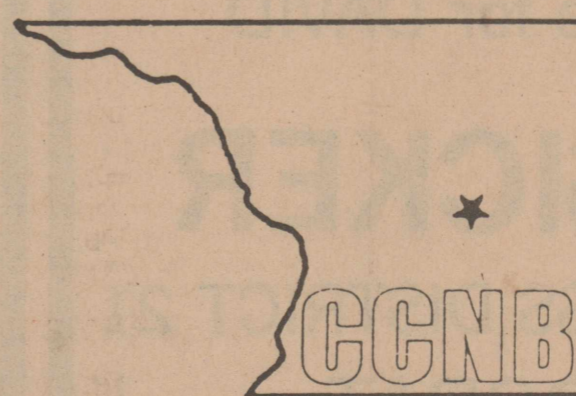
