# **Plane crash** claims two

An Air Force pilot and an airman were killed in Crockett County on the afternoon of May 23 when their RF-4C jet crashed on the John Foley (Meadows) ranch 30 miles west of Ozona

Clayton Kennedy was working cattle in a nearby pasture when he saw a large fireball caused by the accident. The crash occured during a training mission from Bergstrom Air Force Base near Austin.

Victims of the 3:30 p.m. crash were Captain Mitchell A. Kfoury, 34, the pilot; and Airman 1st Class Russell A. Hunziker, 24, both stationed in Austin. The plane struck near a shallow, dry creekbed called Live Oak Draw, about three miles from Fort Lancaster.

Kfoury, a pilot instructor, is survived by his wife, Suzanne, and three sons. Hunziker is survived by his wife, Tina.

According to Bergstrom public affairs officer, Airman 1st Class Donald Swinsoe, Hunziker was aboard the fatal flight as a reward for outstanding contribution to his job. Several planes had flown over the area, according to nearby rancher B. B. Ingham. One plane flew so low that "I rushed out of my house sure the plane would hit it," said Mrs. Ingham.

The pilot flies low, about 1,000 feet, as if it were a regular training mission. "They have several flight routes...and go on a low level to take pictures of various areas, towers and bridges," said Swinscoe.

Metal debris from the plane was spread over approximately 1,000 feet. Early investigators at the isolated crash site included Ozona DPS Troopers Sgt. Kenneth Hailey and Dale Taylor, Foley, Sheriff's Department personnel, volunteer firemen and Goodfellow Air Force Base personnel.

The RF-4C serves as a long range multi-sensor plane used for allweather reconnaissance missions. Completion of the investigation of the crash is expected to take about six months. A board of officers from Bergstrom and Goodfellow will not make public the results of a preliminary investigation.

Expansion and continuing growth have helped the Circle Bar Truck Corral business complex provide service for all parts of the traveling public.

The Circle Bar Truck Corral originally opened August 1977, and this phase of the business has been joined by the opening of a motel in January 1978. A convenience store opened in early 1980, as did a 50 spot mobile home park for the benefit of the growing number of employees. The newest phase of the complex, a 96 spot recreational vehicle park, including its own swimming pool and three laundromats, will open June 1.

Under the ownership of Crockett County rancher Tom Mitchell, the truck stop provides a resting and refueling place for truckers traveling between El Paso and San Antonio.

General manager Jeffrey Stuart noted recently that the complex had grown from employing 70 persons when first opened to more than 100

Stuart started out as warehouse manager for the complex when it opened. Aside from the refueling aspect of the truck stop, mechanics also service the large 18 wheelers.

A sidelight to the operation of the business end of the operation has been the Circle Bar racing team, headed by driver Chet Fillip and crew chief Cory Fillip. For five years, the team raced in the Indianapolis 500. "The team presently races stock cars and is based in Kanapolis, N.C.

The racing team has qualified for all 20 races it has entered this year. Despite some mechanical difficulties encountered by the team, the drivers. are "getting ready for the major races now.'

"We have a little town here. Approximately 40 families live here. If we had a post office, we would be a town. All facilities here are open 24 hours. Getting help is the hardest aspect of my job." said Stuart, who divides his efforts between work and presidency of the T-ball little league program.





Telephone service was interrupted in part of the Ozona, and electricity and telephone service outages were also reported in the rural areas.


The Crockett County Road Department personnel reported widespread damage, especially to outlying county roads.

### LTA sign-up ends May 30

The sign-up for the Long Term Agreement (LTA) with the Agricultural Stabilization and Conservation Service began May 19 and will continue through May 30. The LTA program allows land owners to draw up to \$3,500.00 a year for a three to five year contract.

# **Rangeland restoration is District's primary objective**

#### By George Peacock Jr.

One of the primary objectives of the Crockett Soil and Water Conservation District is to assist ranchers in restoring their rangeland to its highest productive potential. To accomplish this, the development of some type of long range plan by the rancher is necessary.

The first step in developing this plan is for a rancher to inventory his pastures and compare the range plants present to the potential plants that would grow on that soil type. Certain plants dominate an area of land because they are best adapted to that soil, temperature, rainfall, elevation, exposure, and other ecological factors such as natural fires and grazing. This mixture of plants best suited to a particular site is referred to as the climax plant community for that site. Most generally, this is the most productive state of any plant community.

Through man's influence in this country over the past decades, most of our plant communities have deteriorated far below this highly productive state. Any type of disturbance such as continuous overgrazing, extended drought periods, or wildfires during hot, dry summer months can change the potential plant community from desirable, highly productive grasses to low producing grasses and often permits invasion of moisture robbing woody plants.

Once a rancher has completed his resource inventory and determined how his range condition compares to the climax plant community, he can then develop a plan to restore his range back to its highest productive potential. To accomplish this, a planned grazing system or some type of growing season deferment must be incorporated into the plan. Basically, managing animals to graze plants at the proper time and to the right intensity will stimulate plant growth, especially the desirable grasses. This managed grazing, coupled with proper resting of plants, will increase the vigor of the more desirable plants and allow them to better compete with less desirable plants for sunlight, moisture and plant nutrients. The plants that are best adapted and most competitive will begin to dominate the site once again.

Our grasslands developed under grazing conditions. Large herds of bison and other animals would graze an area of grassland and then migrate to another. This provided the grazed area with a rest period. Grazing and rest cycles stimulated the grasslands and kept them productive. 





### Rachel's reviews By Rachel O. Hall

A new diet book called Fit for Life has been confused with the Texas Agricultural Extension Service "Fit For Life" weight control program. There is absolutely no connection between the two. The Fit for Life book written by Harvey and Marilyn Diamond, published by Warner Books, is based on untested theory. Nutritional advice does not meet the RDA for calcium, and if followed bya damage the health of the dieter according to A&M nutrition and health specialists.

The authors base their advice on the concept of Natural Hygiene. According to this theory, the body has three natural cycles: appropriation, or eating and digesting (noon to 8 p.m.); assimilation, or absorption and use (8 p.m. to 4 a.m.), and elimination of body wastes (4 a.m. to noon). The authors attribute weight gain to the buildup of toxins from eating foods in inappropriate combinations and at inappropriate times in the body's natural cycle. Conversely, one loses weight by eating foods in appropriate combinations during each of the body's three cycles so that the body's natural energy will remove excess weight.

The authors claim that since the body is 70 percent water, the appropriate diet must be 70 percent water, hence the best diet is one composed of 70 percent fruits and vegetables and 30 percent concentrated foods (everything else). And since eating two concentrated foods together will neutralize stomach acid and cause the foods to rot in the stomach, protein and carbohydrate foods cannot be eaten together.

Based on this theory, the authors prescribe a diet as follows: only fruit and fruit juice before noon, fruit and salad for lunch, vegetables and either a starch or a protein food for dinner. Nuts and nut butters, pasta, bread and grains are allowed in the lunch and dinner meals, but all dairy products except butter are off limits.

The authors do state that approximately 10 percent of users of this diet will experience some initial discomfort (diarrhea, bloating, running nose, etc.) but this is ascribed to the body doing its job of removing toxins. But the most serious problem with this diet is the lack of a significant source of calcium.

Fortunately for the public, the restricted eating patterns and unrealistic calorie reductions proposed by this diet will prove to be too much to maintain. Contrary to the authors' claim, diet requires unrealistic changes in eating habits that will be difficult for most people to follow. This is fortunate since it is extremely unbalanced nutritionally and its use could increase the incidence of osteoporosis.




