#### **Howardwick death** ruled as a suicide

The death of a Howardwick woman from a gunshot wound has been ruled a suicide, Donley County Sheriff Butch Blackburn said this week.

Forensic results from a Department of Public Safety laboratory confirmed recently that 53-year-old Karla Bartek took her own life on Wednesday, October 8, the sheriff said.

Authorities received a call of a gunshot wound in Howardwick at 425 Janny after 10 a.m. Upon arrival, Sheriff Butch Blackburn found the body of Bartek in the front yard of the home with one gunshot wound to the head. A .380 semi-automatic pistol was found with the body.

Preliminary results of an autopsy found no other signs of trauma, leading officers to believe there was no physical altercation before her death.

# Christmas **Bazaar to** be Saturday


The second annual Clarendon Christmas Bazaar is set to welcome more than 20 vendors to the Donley County Activity Center this Saturday, November 22.

# Woman faces two felonies

A Clarendon woman is facing felony charges from a June 26 accident that resulted in the death of a longtime local businessman.

Gina Canon was arrested last Friday, November 14, and charged with intoxicated manslaughter, a second degree felony, after medical experts agreed that C.W. "Dude" Cornell died from injuries he sustained in the accident.

Canon also was charged with intoxicated assault, a third degree felony, because Cornell's passenger, Ruth Hancock, was also injured.

Donley County Sheriff Butch Blackburn said Canon was arraigned by County Judge Jack Hall on Friday with a total bond set at \$60,000. She was released from jail after posting bond Saturday.

Cornell, a former county commissioner, died July 7 at the age of 86 while being treated in an Amarillo hospital for injuries he sustained 11 days earlier. Reports show that Cornell had been eastbound on US 287 in Clarendon on June 26 when his vehicle was struck from behind by another vehicle driven by the 34-year-old Canon.





So the government continues to betray our trust, invade our privacy, and abuse our rights, and we keep going back for more?

Sure we do. After all, the alternative - taking a stand, raising a ruckus, demanding change, refusing to cooperate, engaging in civil disobedience - is a lot of work. What we fail to realize, however, is that by tacitly allowing these violations to continue, we not only empower the tyrant but we feed the monster. In this way, as I point out in my book A Government of Wolves: The Emerging American Police State, what starts off as small, occasional encroachments on our rights, justified in the name of greater safety, becomes routine, wide-ranging abuses so entrenched as to make reform all but impossible.

First, the government lures us in with a scheme to make our lives better, our families safer, and our communities more secure, and then once we buy into it, they slam the trap closed. Doesn't matter whether you're talking about militarized police, private prisons, red light cameras, DNA databases, surveillance cameras, or zero tolerance policies - they all result in "we the people" being turned into enemy #1.

In this way, the government campaign to spy on our phone calls, letters and emails was sold to the American people as a necessary tool in the war on terror. Instead of targeting terrorists, however, the government has turned us into potential terrorists, so that if we dare say the wrong thing in a phone call, letter, email or on the internet, especially social media, we end up investigated, charged and possibly jailed.

This criminalization of free speech, which is exactly what the government's prosecution of those who say the "wrong" thing using an electronic medium amounts to, is at the heart of Elonis v. The United States, a case before the U.S. Supreme Court this term.

If you happen to be one of the 1.31 billion individuals who use Facebook or one of the 255 million who tweet their personal and political views on Twitter, you might want to pay close attention, because the case has broad First Amendment implications for where the government can draw the line when it comes to expressive speech that is protected and permissible versus speech that could be interpreted as connoting a criminal intent. We would do well to tread cautiously in how much authority we give the government to criminalize free speech activities and chill what has become a vital free speech forum. If free speech is not vigilantly protected, democracy is more likely to drift toward fear, repression, and violence. In such a scenario, we will find ourselves threatened with an even more pernicious injury than violence itself: the loss of liberty. In confronting these evils, more speech, not less, is the remedy.

# **Consider the importance of marriage**

That is to say, divorce has substantial negative effects on a child's mental, physical, and spiritual health, as well as a child's academic success, success in work, and success in relationships.

Mind you, these negative effects are not limited to the first 18 years of a child's life, but reach well into adulthood. Furthermore, in a recent work, "For Richer, For Poorer: How Family Structures Economic Success In America," Robert I. Lerman and W. Bradford Wilcox have convincingly shown that the retreat from marriage, and thus the traditional family, is having harmful effects

compared to peers with otherwise similar characteristics. For instance, men enjoy a marriage premium of at least \$15,900 per year in their individual income compared to their single peers.

4. ... Growing up with both parents increases your odds of becoming highly educated [leading] to higher odds of being married as an adult. Both the added education and marriage result in higher income levels. ... Men and women who are currently married and were raised in an intact family enjoy an annual "family premium" in their household income that exceeds that of their unmarried peers who were raised in non-intact families by at least \$42,000 (Lerman, 3).

What do these studies tell us? Divorce is disastrous, and marriage matters.

Vaccine Approved for This Meningitis Type The FDA recently approved the first vaccine to help protect the body against a particular type of meningitis, serogroup B, caused by the bacteria Neisseria men-ingitidis. Meningitis is an infection of the lining of the brain and spinal cord which may lead to serious illness requiring immediate treatment. Meningococcal vaccines currently available only protect against other strains of the bacteria. This is the first vaccine to protect against serogroup B. Trumenba (meningococcal group B vaccine) received an accelerated approval by the FDA to help protect against the four serogroup B strains that are likely to be found in the US. Trumenba is only approved for use in persons ages ten through twentyfive at this time. The clinical studies conducted in the US, Europe, and Australia included over six thousand participants. The studies showed that the vaccine worked by inducing an immune response by measuring a particular response called the serum bactericidal activity. The side effects of this vaccine that have been reported in the clinical trials included swelling and pain at the injection site, headache, watery stools, and muscle pain.
