10 Indicted By Crockett Grand Jury

Judge Charles Sherrill of Ft. Stockton impaneled the grand jury for the April term of 112th District Court here Tuesday and ten indictments were returned.

John F. Bailey was indicted for forgery and passing. He had not been apprehended at the time of the indictment.

Ed Bright and Don Bright, brothers, were indicted for burglary in connection with the robbery of the Catholic Church the night of Jan. 31, 1969.

Wayne Brown was indicted for the same offense. He waived a jury trial and was tried before the judge, receiving 2 years in the state penitentiary.

An indictment for forgery and passing was returned against Louis Donald Brown.

Two indictments were returned against Carlos Robledo Castillo, both for burglary. The first indictment was in connection with the burglary of South Elementary School the night of March 21, and the second with the burglary of the Armando Reina place the same night.

An indictment was returned against Felipe Garcia and Calletano Lombana for theft in connection with the theft of personal items belonging to Cleophas Cooke from a pickup on the night of Dec. 8, 1968. A second indictment for theft was returned against the two men in connection with the theft of a Marlin thirty-eight rifle which also belonged to Cooke.

Historical Survey Committee Members From Area Towns In All-Day Meeting Here Today

County Historical Survey Committees from 16 area counties arrived in Ozona this morning for the Regional Meeting of County Historical Survey Committee being held today at the Civic Center.

After the morning session, luncheon was served to visitors at the center, with John Held catering. Sixty-four luncheon reservations had been received by the Monday night deadline.

On tap for the program is State Archaeologist Curtis Tunnell, who was slated to discuss the significance of archaeology in a well-balanced historical preservation program. Dr. Tunnell has been an Ozona visitor often in the past few years while working on the Fort Lancaster project.

Miss Diana Files, a staff member of the Texas State Historical Survey Committee, will speak on Museum Development and Operation. Miss Files is Museum Consultant for the state committee.

A slide program which highlights tourist attractions on the nearby Texas Travel Trail is expected to create a great deal of interest among members.

Pending legislation affecting historical preservation, placement of historical markers, and the 1969 program will be discussed by various state committee staff members.

Location, on a 320-acre lease, is 1,235 feet from the south and 467 feet from the west lines of 2-SL-T&StL. Elevation is 2,207 feet.

Vaccination Of Pets Scheduled Friday Afternoon

All pet owners are reminded of the mass dog and cat vaccination scheduled for this Friday afternoon, April 11, at the South Swimming Pool. A veterinarian from Sonora will be available from 2-6 p. m. to vaccinate pets against Rabies. A nominal charge will be made for each animal vaccinated.

Dr. Joe David Ross, DVM, of Sonora advises that all pets not vaccinated with the live virus serum in the past three to four months should receive a booster shot or the full vaccination because of recent outbreaks of rabies in the vicinity of Ozona.

County officials urge all pet owners to take advantage of the opportunity to protect their animals by having them vaccinated at this time. Pet owners are also encouraged to have collars on their pets so tags can be attached following vaccination.

County agent Pete W. Jacoby and Vocational Agricultural Teacher Jimmy Davee, along with 4-H and FFA members will assist with the day's program.

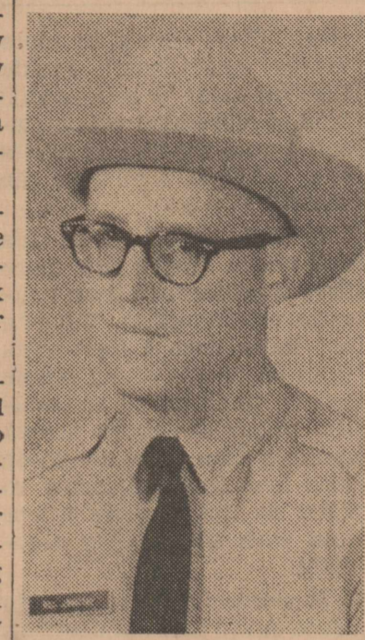

County Ranchers To Receive Near Million Dollars In Incentive Pay

Crockett county wool and mohair producers will divide nearly one million dollars in incentive payments on the sale of the county's 1968 crop of wool and mohair from the flocks of sheep and goats owned by ranch operators of the county.

High point man for the year was Lion Ernest Rios with 82 points to his credit. Rios was outstanding in the high jump and ran the hurdles. A leg injury suffered a couple of weeks before the district meet interfered with his performance.

His father brought him here for medical treatment. He was hospitalized and released Sunday afternoon.

payment rate on the government price support program was received at the local ASCS office this week. The wool support price will be 65.4 percent of the price received by the grower, less marketing expense, and the mohair incentive pay will be based on a 71.2 percent support level. Cliff Elder, ASCS office manager announced. Producers will receive \$1.06 per hundred pounds live weight on unshorn lambs sold last year.

The wool incentive pay level was but a fraction of a percentage point below last year's figure of 65.8, indicating an almost level nationwide price for wool last year with the year before. Mohair, on the other hand, showed an improved price return to the grower, the 1968 incentive figure dropping from the previous year's 86.8 percent to 71.2 for the 1968 marketing year.

The total payment, being disbursed this week from the local ASCS office, to Crockett county ranchers will be \$931,664 against last year's \$993,494.

The incentive price support percentage was based on a national average price of 40.5 cents per pound for wool and 45.2 cents per pound for mohair. The 1967 national average was 39.8 cents for wool and 40.9 cents for mohair. Price received by Crockett county ranchers for wool last year averaged 47.2 cents per pound against the national average of 40.5 cents.

Sharing in the distribution of checks being mailed out at midweek are 118 mohair producers and 168 wool producers (these figures overlapping, of course, since many ranchers run both sheep and goats.)

Crockett county ranchers sold a total of 1,972,752 pounds of wool last year, the lowest volume of production since 1962. Mr. Elder pointed out. The county's wool clips brought a total of \$934,411 against the previous year's 2,119,601 pounds which brought \$889,886.

Last year's mohair clip totalled 828,101 pounds against the previous year's 985,686 pounds. County ranchers received \$398,819 for their 1969 mohair clip against \$439,679 for the previous year's crop.

He was born Sept. 25, 1903 in San Angelo and had been a resident of Ozona all his life.

Survivors include his wife; two stepdaughters, Mrs. Manuel Camarillo of Ozona and Mrs. Nilo Avila of Mexico; one stepson, Frank Trujillo of Oklahoma City, Okla.; three brothers, Simon Longoria of Ozona, Manuel Longoria of Nebraska and Enrique Longoria of Coahoma; two sisters, Mrs. Lupe Munoz of McCamey and Mrs. Paula Mancha of Lamesa.

Ozona Family Injured In Boat Wreck on Lake

Mr. and Mrs. Jack Wilkins and son, Steve, are in fair condition at Shannon hospital in San Angelo where they were transferred Monday from a Del Rio hospital after being the victims of a boating accident on Amistad Lake late Saturday.

Park rangers who investigated the accident said the 18 foot boat driven by Wilkins collided with a rock cliff some 35 miles upriver from the dam.

Following the collision Wilkins was unconscious and had Mrs. Wilkins pinned to the floor of the boat. Thirteen-year-old Steve was unable to revive his father or free his mother. He managed to attract a passing boat, thirty minutes to an hour later, by giving a Boy Scout distress signal.

An unidentified couple from San Antonio were in the passing boat and had gone some distance before the woman realized that the boy was giving a signal for help. They circled around and returned to the wrecked boat.

Although young Steve was bleeding profusely from head and facial cuts, he managed to help the San Antonio man transfer his father and mother into the rescue boat. Upon reaching the shore, the family was taken by ambulance to Val Verde Memorial Hospital where they were treated for shock, multiple cuts and bruises and Mrs. Wilkins for a broken ankle.

Mrs. Wilkins underwent surgery for the broken ankle bones Tuesday morning at Shannon Hospital.

Midland Youth Dies In Holiday River Accident

A holiday outing ended in tragedy for a group of Midland people Saturday morning when a youngster in the group, Joel D. Woodall, 15, was found dead floating in shallow water where the group was camping on the Pecos river near Pandale.

He was brought to the hospital by a Janes ambulance and a local physician pronounced him dead and indicated he had suffered a broken neck.

The father said the boy had been fishing near the place where the body was found. His fishing gear was nearby. When attempts to revive him failed, the ambulance was called.

Reports were received here Monday that an autopsy, requested by the father, revealed that the boy's death was the result of a broken neck.

Local officials said the boy apparently slipped on the slippery bank and received the blow that resulted in his death before going into the water.

Services were held Tuesday in Midland under the direction of a Midland funeral home.

ONE FOR OUR SIDE

By now you have probably read about the recent rally in the Orange Bowl in Miami, Florida. Just a few short weeks prior to this "Rally for Decency" a member of a singing group had appeared on stage in Miami, disrobed and made obscene gestures. This rally was an answer by teen-agers and adults together. Thirty thousand of them.

They were hosts to entertainers of the magnitude of Anita Bryant, Jackie Gleason and the Lettermen, a singing group. The performers were entertained by the warmth of a crowd gathered to enjoy an afternoon of decent performances. A number of teen-agers gave short talks on, of all things, God, parents, patriotism and brotherhood.

Placards carried messages of hope for this nation and the world. One proclaimed: "Down With Obscenity". The adults lent moral and financial support. It was one of the few times that we have heard of such a united adult-teen-age gathering. It was a refreshing change, proving that the so-called generation gap is not so wide a chasm as some might think. It is a gap, but it can be bridged. The difference between father and son, mother and daughter, are not in the strictest terms any worse today than those of earlier eras. Each generation thinks that its youngsters are more incorrigible and unruly than those of the past.

Tony Butala, of the Lettermen, was quoted as saying of the rally: "I think it's

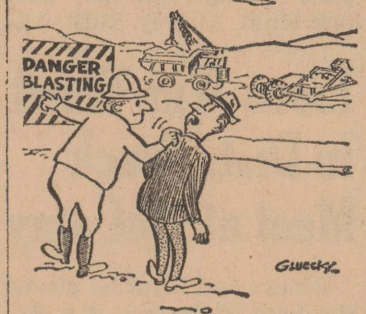
great; there should be more things like that." Jackie Gleason said: "I believe this kind of movement will snowball across the United States and perhaps around the world."

It could well be that this will occur. There are more decent performers than neurotic exhibitionists. There are more decent teen-agers than there are young people lost in the maze of sensuality. There are more decent parents than there are those who love their offspring so little as not to care where and with whom they associate.

It seems ironic to have to come out in favor of decency. But the way things have been going, it pays to state the case for even the obvious virtues.

It's almost like basketball has turned into a participant sport instead of spectator sport. Everybody wants in the act. — Karens (Tex.) Tribune.

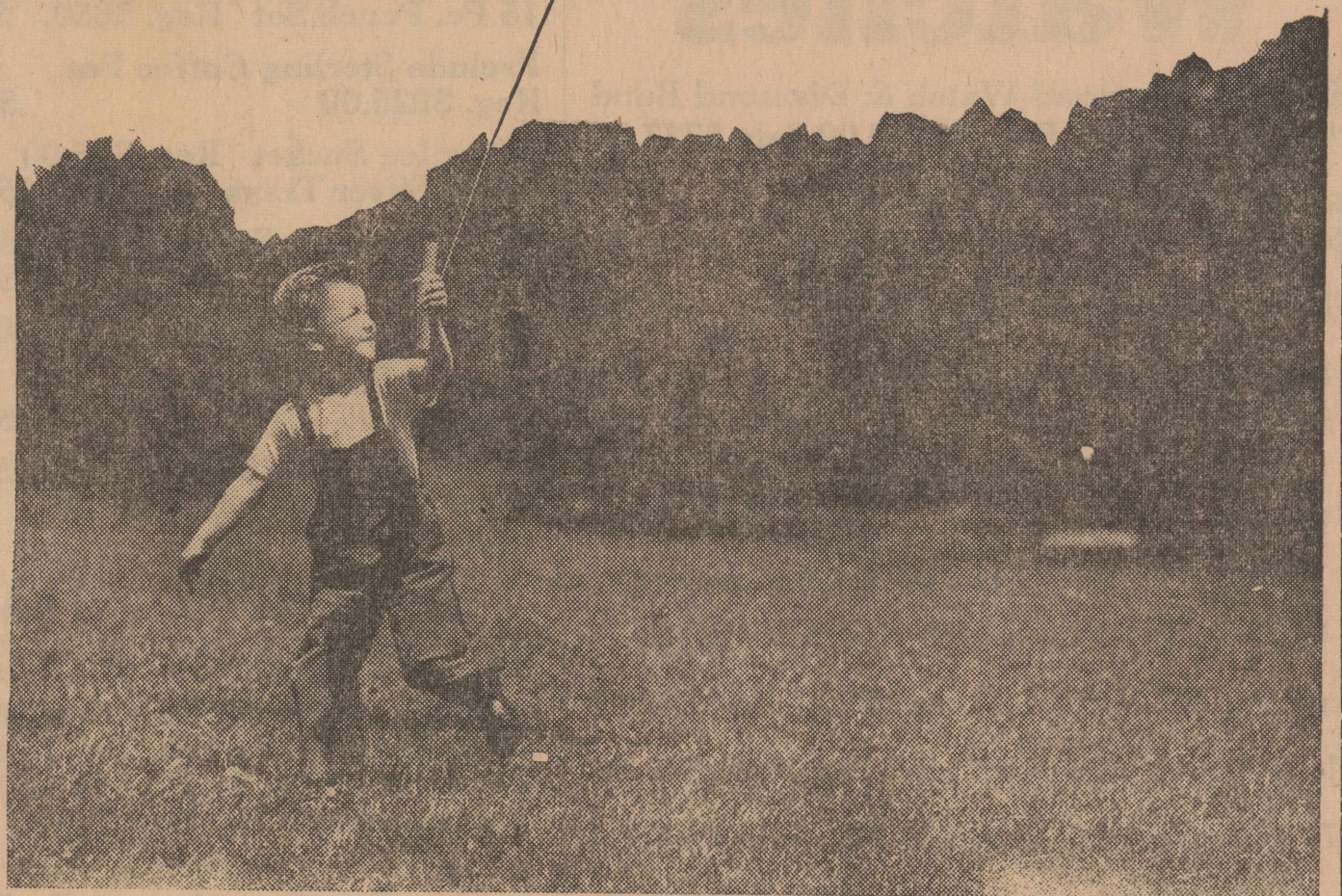
Flimsy as a Kite

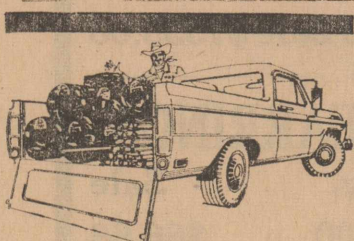

It originally was drilled by Continental Oil Co. as the No. 2 C. T. Harris, and as 1/2-mile south outpost to the now depleted opener of the Lula (Devonian) field. It was abandoned June 17, 1951. No tests or shows were reported in the Permian, however, it did set pipe for completion attempt in the Devonian in open hole at 8,709-680 feet.

Location, on a 320-acre lease, is 660 feet from the south and 1,980 feet from the east lines of 15-3-WCRR. Elevation is 2,440 feet.

The dual opener, the No. 1 Continental-Harris, was finished Feb. 25 from the Pennsylvanian for 192 barrels of oil at 8,552-56 feet; and March 10 from the Fusselman for 122 barrels of oil, plus 338.4 barrels of water, through a 1/2-inch choke and perforations at 8,940-46 feet. No shallow shows or tests were reported.

The Ozona (Canyon sand

gas) field was extended 1/2-mile southeast with completion of Delta-Suburban, Odessa, No. 1-E Friend, three miles southeast of Ozona for a calculated, absolute open flow of 2 million cubic feet of gas daily, with gas-liquid ratio of 19,800-1. Gravity of the liquid was 68.6 degrees.

Production was through perforations at 6,374-392 feet which had been fractured with 24,000 gallons and 40,000 pounds of sand.

Location is 1,980 feet from the north and 660 feet from the west lines of 90-GH-GC&SF.

Third Producer From San Andres On Vaughn Ranch

The Holt multipay field of Crockett County gained its third San Andres gas producer and a 2,100-foot west-southwest extension to that pay with completion of C. Gary Garlitz, Midland, No. 2-83 Isabell Vaughn, 15 miles northwest of Ozona, for a calculated, absolute open flow of 775,000 cubic feet of dry gas per day.

Production was through perforations at 1,402-410 feet which had been washed with 250 gallons of mud acid and acidized with 2,780 gallons.

Top of pay was picked at 1,402 feet on derrick floor elevation of 2,605 feet. The Seven Rivers was topped at 750 feet; and the Grayburg at 1,160 feet.

Drilled to 1,460 feet, where 3 1/2-inch casing was set, it is plugged back to 1,452 feet.

Location is 1,420 feet from the north and 2,540 from the east lines of 83-OP-GC&SF.

The field has one Canyon gas and five Ellenburger oil wells.

Recipe of the Week From Kitty's Kitchen

Gypsy Hash

2 large cans corned beef hash
1 large onion minced
1 small clove garlic, mashed
½ cup dairy sour cream
2 eggs well beaten
¼ cup dry red wine
¼ teas. fresh-ground black pepper
¼ teas. nutmeg
Fine bread or corn flake crumbs.

Blend well all of the ingredients except the final crumbs. You may need to add a little salt, but the corned beef is likely to be salty enough. Spread in a fairly shallow greased casserole and top with a thin sprinkling of crumbs. Bake 20-25 minutes in a 350-degree oven, or until the center is firm to the touch. Serves 6.

Baked Fruit Casserole

1 cup graham crackers crumbs
½ cup chopped pecans
½ cup brown sugar (packed)
3 tbs. orange juice
1 tbs. grated orange rind
½ cup white raisins
2 apples, peeled, cored and sliced
2 peaches, peeled and sliced
Mix all ingredients lightly and spread in a rather shallow casserole. Bake 30 minutes in a moderate oven, 375 degrees. Serve warm with whipped cream or hard sauce.

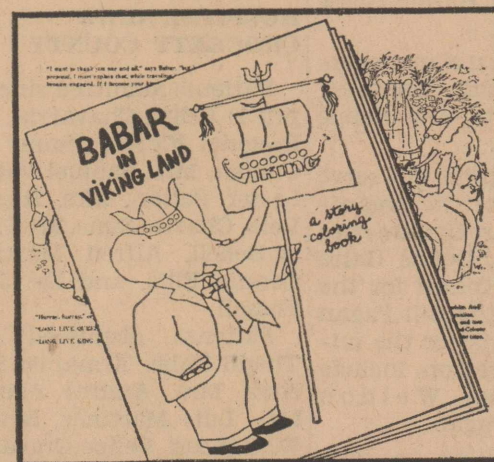

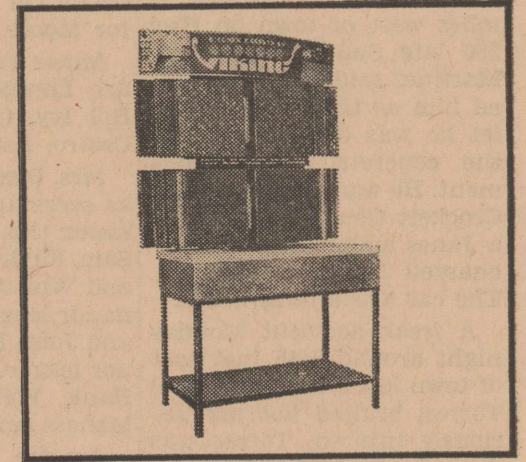
