District Candidates Will Speak Here Monday, July 19

The district candidates will speak in Silvertown Monday evening, July 19, it has been announced. There are six men seeking the district offices, two the judge's office and four in the race for district attorney. For several weeks they have been appearing at different places in this district for joint speaking engagements. In the campaign, it is said, and each of the candidates is representing his claims for his respective office on merit alone. Judge R. C. Joiner is asking for re-election as district judge and Ovas Clements, present district attorney is running against him. Judge C. D. Wright, present judge of Briscoe County, W. E. Hufflines, present county attorney of Floyd County, Meade F. Griffin, present judge of Hale County, and E. S. Rowe, present county attorney of Lamb County are the four contestants for the district attorney's place. This is the first time in the history of the county that Briscoe county has been represented in the race for a district office and from all indications it appears that Judge Wright has a mighty good chance of being the next district attorney.

The candidates will speak in Silvertown on Monday afternoon July 17, in Lufkin Tuesday, July 20, in Lockney the 21st, in the 22nd, and close the Floydada campaign Saturday the 24th at Plainview.

WHAT'S DOING IN WEST TEXAS

Littlefield—Captain Arthur P. Duggan, president of the West Texas, C. of C., will make his first tour of West Texas territory during the month of August. As planned at present he will open his tour at Big Springs August 9th and will visit the recreational sections of West Texas and eastern New Mexico. He will visit the Davis Mountain section and attend the district convention in Marfa August 12th, then will swing west to El Paso and go into eastern New Mexico to attend the district convention of the West Texas Chamber of Commerce in that district August 16. FATHER OF MRS. WILLIAMSON DIES

Chris Dillon, 78 years old, father of Mrs. J. W. Williamson, who lives on one of the Joo. Burson places west of town, died early Tuesday morning after suffering for about ten days with kidney trouble. Mr. Dillon came to the United States from Germany when he was seven years old under very extraordinary circumstances. He left the old country with his large family but in some way he and his father became separated from the rest of the family on the emigrant boat and he had never heard from any of his relatives up to the time he died. He came to Silvertown from Floyd County about the first of the year, having lived there a number of years. Burial was at Floydada Tuesday afternoon, the Rev. Tibbs, Baptist pastor there, conducting the funeral services at the cemetery. Roscoe Fort, Shot Allard, Scott Smith, Mr. Mallow and Booley Moore from Silvertown assisted in the burial.

Pecos—The Pecos Valley will celebrate here July 20 with a big all day jollification. The celebration is in honor of the successful fight for the appropriation for Red Bluff dam on the Pecos River. Congress recently appropriated two million dollars for the project and President Coolidge has signed the bill. This project will reclaim half a million acres of land and is expected to bring a big period of development to the Trans-Pecos country. A barbecue will be prepared for twenty thousand persons and it is expected that many will be here on July 20. Pecos invites West Texas to join in the celebration.

Lubbock—Lubbock will be host to the Texas Commercial Executive Association July 22-23-24. More than one hundred special executives from all Texas will hold here their convention and school.

M.—The eastern district of the West Texas Chamber of Commerce will meet here August 16. Attendance is anticipated.

Lamesa—William A. former secretary of the Chamber of Commerce has resigned his duties as secretary of Lamesa Chamber to succeed T. Watson, resigned.

San Antonio—Porter A. Whaley, former manager of the West Texas Chamber of Commerce, has arrived in San Antonio to assume his duties as secretary of the local organization.

Amarillo—The greatest wheat crop in years is now being threshed on the plains. The Santa Fe Railway reports that there is a great scarcity of cars to handle the crop despite the fact that they had concentrated eight thousand cars in anticipation of the needs. Increasing use of combine harvesters and threshers has speeded up the movement of grain and swamped the railway service.

JUDGE WRIGHT IS CONFIDENT HE WILL BE IN 2ND PRIMARY

Judge C. D. Wright, the only candidate for Briscoe County for a district office since the district has been established, feels confident that he will be in the second primary for the office of District Attorney of the 6th Judicial District. He has been campaigning the district thoroughly and reports that he has met with a great deal of encouragement from practically every community. He closed last week's campaign in the south west corner of Bailey county, 120 miles from Silvertown and during the week worked Fockney, Plainview, Oton, and Sadan. Judge Wright says that he is putting in most of his time outside of his own county as he has been assured by friends that it is unnecessary for him to solicit personally the voters of Briscoe County as he will easily carry the county by a huge majority. Judge Wright came to this plain country 25 years ago and is qualified by training and experience to fill the office of district attorney. He has served four years as county attorney and served four years as Judge of Deaf Smith county and four years as Judge of Briscoe county. He has always taken an active part in the civic and social affairs of the community, a friend and staunch supporter of the schools and a leading member of the Presbyterian church. He stands for strong enforcement of the law without fear or favor.

He says this will be done if the route shows a justifiable amount of business.

GOODRICH PUTS TIRE PRICES BACK TO LEVEL OF 1924

A generous reduction in tire prices just announced by The E. F. Goodrich Rubber Company, has restored the price levels of two years ago, according to Super Service Station, local Goodrich dealer. "This is much more than a cut thrown out to attract a few backward tire buyers," says Mr. Summers. "Comparison of the new price list with prices on the great majority of sizes and types in 1924 shows how completely any so-called 'inflation' has been squeezed out of tire prices. In a majority of cases, the new prices match the prices of two years ago." If all who want a daily route next winter, when the nights are long, and while they are busy gathering crops, will subscribe for a daily paper, or the county paper, and two or three good weekly papers, there will be no trouble in getting a daily route.

DR. WILLIAMS TALKS ABOUT DAN MOODY

Dallas, July 8.—Declaring that Dan Moody, Attorney General and candidate for governor, was always "the personification of industry, as well as the sole of honor and the slave of duty," Dr. W. N. Williams, former editor of the Christian Courier for many years, and for 10 years at the head of the schools of Taylor County, Texas, in a letter just made public, gives interesting sidelights upon Moody's early life. Writing to the Rev. W. F. Reynolds of Dallas, Dr. Williams stated: "In reply to your letter of June 19 asking me for a statement concerning Dan Moody's record as a student in the public schools of Taylor, Texas, while I superintendent thereof, I beg to say:

"As the head of the Taylor public schools for 10 years I witnessed Dan's school work in the primary department, grammar school and high school, and wish to say that he was a model pupil in department and stood well as a student. And, in memory, I can see him running to school for fear of being tardy nearly every morning, because he had been kept busy to the last minute milking, delivering milk, and driving the cows to the pasture. Indeed, when I remember how hard Dan worked before and after school and that he did not get to play as other children, I wonder how he made the good grades he did in school. But he was always the personification of industry, as well as the soul of honor and a slave of duty.

"And I may add that after knowing Dan Moody 28 years I regard him as the finest type of virile young American Christian manhood the Nation has ever produced. He is clean, capable, courageous and absolutely dependable. I hope to get back to Texas in time to vote for him."

ULTRA CONSERVATISM

Silverton is suffering from a case of ultra conservatism. Ultra means "extreme" and conservatism means "aversion to change." Too many people here are perfectly satisfied to let things rock along as they always have. But Silverton and Briscoe County are in the path of progress and development. It is inevitable. The old must give way to the new. We must stay up with the times. Even China is giving up the worship of its ancestors and taking hold of civilization from the west.

Columbus could not get the backing of conservative nations in his "mad undertaking" to prove the world round. When Lee suggested that 13 weakly states break away from English tyranny, before the Continental Congress 150 years ago, it was not the conservative thing to do, but since that time these United States have accomplished more than the "Ultra conservative" nations have in so many centuries. They have dared to do—and have done it.

Robert Fulton's first steamship was called "The Folly" by conservatives. The Wright brothers were considered fanatics. Henry Ford was unable to sell his original stock to conservative bankers. A conservative banker advised a citizen of our county that he was throwing his money away to pay \$200 for four sections of land in Briscoe County, a few years ago.

We are going to have to exercise a little more faith in our country and community and risk a little more and step a little faster or we will be left behind by our neighboring communities.

WHAT ABOUT THE LIGHTS

It is understood that certain members of the City Council objected to an editorial that appeared in the News of last week. It is possible that we were not thoroughly informed as to why the council has not made a deal with the Texas Utilities Company to furnish street lights but we are willing to be informed. The columns of the News are open to any one for a discussion of matters that effect the common good of the community. We do know that Silverton is still a city of darkness and that we need street lights and that the Utility Company is ready to make an additional investment of some \$1500 so that we may have the lights. We are like the little child now. We don't care where Santa gets his presents to put in the stockings—just so we get the lights.

If You Favor Fergusonism

It is reasonable to infer that you approve the policies for which Jim Ferguson has stood for in the past, and this would mean that

(1) You are for red liquor with all the poverty, sorrow, discord and evil consequences that follow its sale, for Ferguson was ever against prohibition.

(2) You are opposed to the right of women to a voice in governmental affairs, for Ferguson was against woman's suffrage.

(3) You are in sympathy with Kaiser Bill and tyranny, for in a speech in Dallas, April 10, 1917, Ferguson denounced selective vice legislation urged by President Wilson.

(4) You think it right for an official to take public money out of a bank where it is earning interest, have it placed in a bank which he is part owner and then borrow it himself. Records show that Ferguson did that.

(5) You think it right for men to beat their honest debts, for Ferguson says the people do not owe bond money used in building roads, as per his speech, Wichita Falls, Texas, June 15.

(6) You favor the expenditure of the people's money by public officials for their own private use; for according to our brave and patriotic former Attorney General Crane "Ferguson spent \$10,000 of the people's money to buy groceries, flowers, auto tires and a ukelele." He also said in a speech in 1918: "I want to ask laboring people how they like to be paying for chicken salad for the governor while they live on bacon, paying for auto tires while they walk. If Jim is the friend of the laboring people, God save them from any more such friends."

To put it on no higher plane, you could not afford to follow Ferguson in repudiation of public debts, for your merchant and banker would fear, and properly, that you might apply the same principle to your private obligations.

No, no, you tenants and laboring men, you are not in favor of these ugly things, and will demonstrate the fact in the coming election by forever discarding Fergusonism and placing in the Governor's chair a man who knows and dares to do his duty. Proposed Amendment To the Constitution

Senate Joint Resolution No. 9

A Joint Resolution relating to the amending of Article 16, Section 58, of the Constitution of the State of Texas, abolishing the Board of Prison Commissioners; providing for the supervision and management of the Prison System, under such laws as may be provided for by the Legislature. Be it Resolved by the Legislature of the State of Texas:

Section 1. That Article 16, Section 58 of the Constitution of the State of Texas, be amended so as to hereafter read as follows:

Section 58. The Legislature shall have full power and authority to provide by law for the management and control of the Prison System of Texas; and to this end shall have power and authority to place the Prison System under the supervision, management and control of such trained and experienced officer, or officers, as the Legislature may from time to time provide for by law.

Section 2. The above Constitutional amendment shall be submitted to a vote of the qualified electors of this State at a general election to be held November 3, 1926, at which election all voters favoring said proposed amendment shall write or have printed on their ballot the words "For the amendment of Article 16, Section 58, of the Constitution, abolishing the Board of Prison Commissioners." And all those opposing said amendment shall write or have printed on their ballot the words "Against the amendment of Article 16, Section 58, of the Constitution, abolishing the Board of Prison Commissioners."

Section 3. The Governor of this State is hereby directed to issue the necessary proclamation for said election and have the same published as required by law.

Section 4. The sum of \$5,000.00, or so much thereof as may be necessary, is hereby appropriated out of the funds in the Treasury of the State, and not otherwise appropriated, to pay the expenses of such publication and election.

Notice is hereby given that an election will be held on the 31 day of July 1926, at Rock Creek School House, in Common School District No. 4 of this county as established by order of the County Commissioners Court of date the 15 day of April, 1911, which is of record in book designated "Minutes of Commissioners Court," Vol. 2, on pages 178-9 to determine whether a majority of the legally qualified property tax voters of that district desires to tax themselves for the purpose of supplementing the State School Fund apportioned to said district and to determine whether the commissioners court of this county shall be authorized to levy, assess and collect annually a tax of and at the rate of 100 cents on the \$100 valuation of taxable property in said district for said purpose.

To the Voters of Briscoe County
Believing the time has passed when voters will go to the polls and blindly cast their vote without knowing the position of those who aspire to office, I hereby give my position on some of the many prominent questions before the County and Commissioners' Court of Briscoe County.

First—As to law enforcement; if elected County Judge, I will enforce the law without fear or favor to any one. I believe those in mature years should be held to a more rigid discipline than tender youth, who oft' times are influenced by those, who, through mercenary motives, have built pitfalls into which youth is decoyed.

I favor good roads, and good schools and pledge myself to use every effort consistent with the financial conditions of our County, and citizens to maintain the same, but I believe we have reached the point when a halt must be put to the wild and extravagant expenditure of the people's money.

While \$90,000 of taxes have been collected, over \$4000 is delinquent, because the people are unable to meet the burden heaped upon them, and a conservative estimate shows some 40 per cent of this \$90,000 was borrowed to pay their taxes. Good business judgment would dictate that if we are to maintain our public institutions, that we reduce our taxes to the ability of our people to pay; otherwise, means the bankruptcy of our people and the collapse in the near future to both our schools and highways.

I am opposed to the building of roads or other improvements by County warrants, and think that all expenditures of public money should be left to a vote of the people.

If you believe the platform above set out to meet your views I would appreciate your vote and influence in the coming elections.

the Comanches, near the scene of the memorable battle, a town was laid out, and the founders, mindful of the historic interest of the place, named the new town "Quanah." A committee of citizens was sent to the lodge of Chief Quanah Parker to tell him of their action. Tradition says that the old Chief heard them in silence; then, after the picturesque manner and language of his race, he blessed the town named for him:

"May the Great Spirit smile on your town; may the rains fall in season, and, under the warmth of the sunshine after the rain, may the earth yield bountifully; may peace and contentment be with you and your children forever."

The growth of Quanah has been in many ways a fulfillment of the old Indian's blessing. Peace and contentment have been won by the faith and courage of her citizenship. There is no better town in all West Texas in which to live and bring up a family.

Mine is a town of splendid public schools, affiliated with Texas' higher institutions of learning. The many churches bear witness that my people are a religious, God-fearing people.

My home-town is a big-hearted town—her many benevolent and charitable organizations are ever ready to give aid to the suffering and sorrowful.

My town is so well managed by her city councilmen that there is no better kept town in Texas. The principal streets are paved and lined with shade trees, beautiful homes and well-kept lawns are a source of pride with us and indicate our faith in the stability of the town's property values.

Quanah is a well balanced town, in the heart of a fertile farming country, it is supported by thirteen wholesale houses, three railroads, and railroad shops, an oil mill, cement plaster mills, compress, and its many retail establishments, that in a business way make it really cosmopolitan.

Proposed Amendment To The Constitution
Senate Joint Resolution No. 7
Proposing an amendment to the Constitution of the State of Texas by amending Section 33 and Section 40 of Article 16 of the Constitution of Texas so as to permit officers of the National Guard, the National Guard Reserve, and the Officers Reserve Corps of the United States, and enlisted men of the National Guard, the National Guard Reserve, and the Organized Reserves of the United States to hold public office in Texas.
Be it resolved by the Legislature of the State of Texas:
Section 1. That Section 33 of Article 16 of the Constitution of the State of Texas be amended so as to read as follows:
"The accounting officers of this State shall neither draw nor pay a warrant upon the Treasury in favor of any person, for salary or compensation as agent, officer or appointee, who holds at the same time any other office of position of honor, trust or profit, under this State or the United States; except as prescribed in

this Constitution. Provided, that this restriction as to the drawing and paying of warrants upon the Treasury shall not apply to officers of the National Guard of Texas, the National Guard Reserve, the Officers Reserve Corps of the United States, nor to enlisted men of the National Guard, the National Guard Reserve, and the Organized Reserves of the United States."

Section 2. That Section 40 of Article 16 of the Constitution of the State of Texas be amended so as to read as follows:
"No person shall hold or exercise, at the same time, more than one civil office of employment, except that of Justice of the Peace, County Commissioner, Notary Public and Postmaster, officer of the National Guard, the National Guard Reserve, and the Officers Reserve Corps of the United States, and enlisted men of the National Guard, the National Guard Reserve, and the Organized Reserves of the United States, unless otherwise specially provided herein. Provided, that nothing in this Constitution shall be construed to prohibit an officer, or enlisted man of the National Guard, and the National Guard Reserve, or an officer in the Officers Reserve Corps of the United States, or an enlisted man in the Organized Reserves of the United States from holding in conjunction with such office any other office or position of honor, trust or profit, under this State or the United States."

Section 3. The foregoing Constitutional amendment shall be submitted to a vote of the qualified electors of this State at an election to be held on the first Tuesday in November A. D., 1926, at which all ballots shall have printed thereon:
"For the Constitutional amendment permitting officers and enlisted men of the National Guard and the National Reserve Corps of the United States, and enlisted men of the Organized Reserves of the United States, to hold other offices or positions of honor, trust or profit under this State or the United States," and:
"Against the Constitutional amendment permitting officers and enlisted men of the National Guard, and the National Guard Reserve, and officers of the Reserve Corps of the United States, and enlisted men of the Organized Reserves of the United States to hold other offices or positions of honor, trust or profit under this State or the United States."

Each voter shall scratch out one of said clauses on the ballot, leaving the one expressing his vote on the proposed amendment.

Section 4. The Governor shall issue the necessary Proclamation for said election, and have the same published as required by the Constitution and laws of this State. The expense of publication and election for such amendment shall be paid out of proper appropriation made by law.

Proposed Amendment To The Constitution
House Joint Resolution No. 9
A resolution, proposing an amendment to Art. 7 of the Constitution of the State of Texas by changing Section 3, eliminating the provision authorizing the Legislature to create special districts and making an appropriation therefor.
Be it resolved by the Legislature of the State of Texas:
Section 1. That Section 3, Article 7, of the Constitution be so changed as to read as follows: (creating new section.)
"Section 3. One-fourth of the revenue derived from the State Occupation taxes and poll tax of one dollar on every inhabitant of the State, between the ages of twenty-one and sixty years, shall be set apart annually for the benefit of the public free schools; and in addition thereto, there shall be levied and collected an annual ad valorem State tax of such an amount not to exceed thirty-five cents on the one hundred (\$100.00) dollars valuation, as with the available school fund arising from all other sources, will be sufficient to maintain and support the public schools of this State for a period of not less than six months in each year, and it shall be the duty of the State Board of Education to set aside a sufficient amount out of the said tax to provide free text books for the use of children attending the public free schools of this State; provided, however, that should the limit of taxation herein named be insufficient the deficit may be met

by appropriation from the general funds of the State and the Legislature may also provide for the formation of school districts by general laws; and all such school districts may embrace parts of two or more counties, and the pass laws for the assessment and collection of taxes in all said districts and for the management and control of the public school or schools of such districts, whether such districts are composed of territory wholly within a county or in parts of two or more counties, and the Legislature may authorize an additional ad valorem tax to be levied and collected within all school districts heretofore formed or hereafter formed, for the further maintenance of public free schools, and for the erection and equipment of school buildings therein; provided that a majority of the qualified property tax paying voters of the district voting at an election to be held for that purpose shall vote such tax not to exceed in any one year one (\$1.00) dollar on the hundred dollars valuation of the property subject to taxation in such district, but the limitation upon the amount of school district tax herein authorized shall not apply to incorporated cities or towns constituting separate and independent school districts, nor to independent or common school districts created by general or special law."

Sec. 2. The foregoing constitutional amendment shall be submitted to a vote of the qualified electors of the State at an election to be held throughout the State on the first Tuesday after the first Monday in November, 1926, at which election all voters favoring said proposed amendment shall write or have printed on their ballots the words, "For the amendment to the Constitution of the State of Texas, eliminating the provision which authorizes the Legislature, to create special school districts," and all those opposed shall write or have printed on their ballots the words, "Against the amendment to the Constitution of the State of Texas eliminating the provision which authorizes the Legislature to create special school districts."

Sec. 3. The Governor of the State is hereby directed to issue the necessary proclamation for said election and to have same published as required by the Constitution and existing laws of the State.

Sec. 4. That the sum of two thousand (\$2,000.00) dollars, or so much thereof as may be necessary, is hereby appropriated out of any funds in the Treasury of the State of Texas not otherwise appropriated, to pay the expenses of such publication and election.

Proposed Amendment To The Constitution
Senate Joint Resolution No. 10
Proposing an amendment to the Constitution providing for taxation of school lands owned by counties.
Be it resolved by the Legislature of the State of Texas:
Section 1. That Article 7 of the Constitution of the State of Texas shall be amended by adding after Section 6 thereof 6a, which shall read as follows:
Section 6a. All agriculture or grazing school land mentioned in Section 6 of this Article owned by any county shall be subject to taxation except for State purposes to the same extent as lands privately owned.
Section 2. The foregoing constitutional amendment shall be submitted to a vote of the qualified electors of this State at an election to be held on the first Tuesday after the first Monday in November, A. D., 1926, at which all ballots shall have printed thereon "For the Constitutional amendment providing for taxation of all agriculture or grazing school land owned by any county to the same extent as land privately owned."
Section 3. The Governor shall issue the necessary proclamation for said election and have the same published as required by the Constitution and laws of this State. The expense of publication shall be paid out of proper appropriation made by law.

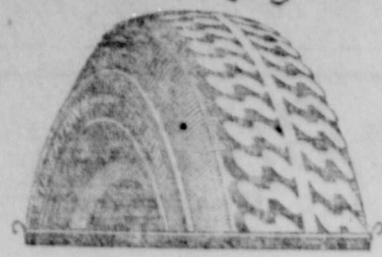
