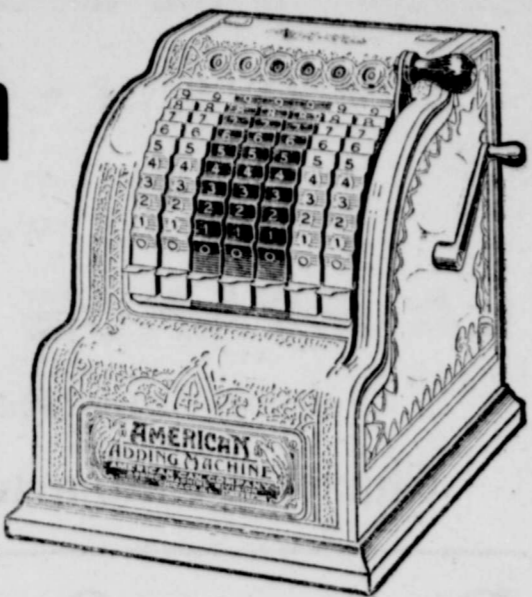

### WONDERFUL CALIFORNIA GRAPHICALLY DESCRIBED FOR THE SIGNAL.

Dinuba, Calif., 1-26-1914.

Dear Signal:

I have been forcibly reminded lately of my first year in Scurry county, in 1890.

Rain! did you say? It is almost a daily occurrence and the ground is so full it refuses to take in more. The result is overflows and no trains today over the Southern Pacific on account of washouts. The Scurry county people never would cry "enough", but California will milder if we do not get sunshine soon. We are all smiling though in anticipation of the harvest. Visions of yellow orange groves, vineyards of purple grapes, olives, peaches and apricots. Green pastures of alfalfa waiving its welcome to dairy cow and swine. With such prospects of material wealth and good things to eat, why should we not have visions of things beautiful and comforting.

We note that our friend Baker has entered the race for representative and wish him success. The ideas he advances in his platform indicates an interest in his state and a farsightedness that reaches even to California, where the women vote, education is compulsory and water conservation a necessity.

The Lick Observatory has a station on the summit of Mt. Whitney, 15,000 feet elevation, where observations are made in an effort to determine whether or not the planet Mars is inhabited. I have thought of making a trip up there (only about 50 miles from here) and see if I could gaze over a few years into the future and see what of its promise. Also to view Death Valley just Eastward from Mt. Whitney, a land of desolation, which overshadows all of the desert creations of the world. It is said the heat in summer ranges from 100 degrees at midnight to 125 in the shade during all hours of the day. The sun's burning rays scorch like a furnace flame, shooting its rays into the quivering air as it beams down over the summit of Funeral mountains that rise along the Eastern rim. The lowest level of this valley is 280 feet below sea level.

'Tis said this valley has one supreme glory spread over it, the great sky at night, when darkness "draws her veil across the face of desolation," countless stars in glorious splendor sparkling and twinkling in the deep blue dome of heaven, shuts out the awful visions of the day and presents an atmosphere of Telescopic clearness seen no where else in the world. There is a marvelous diversity of California scenery presented in comparing this valley and Yosemite. The first a cursed land, a burned and twisted spectacle of disaster and desolation. The latter hardly needs description, for the world, by pen and camera, has been made familiar with its features. Abundant life is exhibited in valley and summit, where trees and flowers wave in the breezes and the voice of waters breaks the silence. Storms that have recently visited the Pacific coast have done considerable damage to San Francisco's drives and piers and damaging smaller vessels and shipping interests. We are expecting great things for California when the Panama Canal is opened for traffic and the Alaskan railroad is built, but we are not bidding for more laborers, the army of unemployed is too large already. We hope Scurry county will "bloom" with hog, hominy and cotton this year and with overflowing exchequers spend some of it in coming to see the sights in California in 1915.

### FULL VALUE RENDITIONS FOR TAXES REQUIRED

Tax Assessor Joe Merritt is now engaged in taking property renditions for taxes. In this connection, the attention of the people is called to the following press item sent out last week from Austin. Attention to this ruling may save somebody a lot of trouble.

The announcement reads as follows:

Austin, Texas, Jan. 24.—The State Tax Board has adopted resolutions notifying county tax officials that they must assess property in Texas at its full value or suffer the penalty of law. By order of the board the State Tax Commissioner, A. L. Love, is mailing a copy of the resolution to each County Tax Assessor and to all County Judges advising that the law must be complied with, and if it is not the matter will be reported to the Attorney General for suit against negligent officers.

It is stated in the resolution that there were "flagrant" violations of the law in 1913, and that it will not be tolerated this year."

### Our Weekly Sermonette

By Rev. M. T. Tucker

#### CHRIST IN EVERYDAY LIFE

TEXT: "For me to live is Christ and to die is gain."—Phil. 1:21.

In this statement Paul sums up his entire attitude toward Christ and the meaning of Christianity to him. It seems to me that this should be the experience of every Christian. Two things are stated. First the condition of life here, and second, what he expects to be hereafter. But it should be noticed that the hereafter depends upon the condition here.

#### I—WHAT CHRIST MEANS IN THIS LIFE:

Paul said: "For me to live is Christ." Again he said, "It is no longer I that liveth, but Christ liveth in me." From these we reason:

1. That Christ is the author of life. He created all things, says John in his gospel and "without Him was not anything made that hath been made"—Jno. 1:3. Every good thing comes from Him. Every time we get up in the morning, we ought to thank Him for our existence.

2. Christ should be the law of life. It was so with Paul and should be so with all who claim to be his followers. And to the extent that Christ is not the law of life, death will not be a gain. It is sad to see so many who do not recognize this. If Christ is the law of life, we must order our conduct after the example and teaching of Christ. How about it reader? Do you allow Christ to direct your actions? If so, you must not "forget the assembling of yourselves together." That is you must come to the house of God to worship. There are many who claim to be Christians who rarely ever attend church. They hold no relation to any public worship of their church. Then we must let Christ direct our liberality. Christ said it is more blessed to give than to receive," again the Bible says, "a tithe is the Lord's." Yet we withhold our means and refuse to let Him direct us there. He says: "Let everyone of you lay by him in store on the first day of the week according as God hath prospered him and so let him give." This requires not only that we give God his part of our means, but we must take it to the Lord's house on the first day of the week." Then we must let him direct all our conduct.

3. Christ should be the joy and comfort of life. Why should his children be chasing the phantoms of the world for joy? Why should we be giving ourselves to questionable amusements, games, dances, drunkenness, card playing, vain shows, society extravagances, etc. If Christ is what we claim he is and if His religion will do for life what we teach? Shame on the Christian who by his conduct says to the world, "You must go to the Devil's amusements for pastime." Christ affords all the comfort we need, if we make him first in life. Christ said in the sixth chapter of Matthew, "Seek ye first the king-

dom of God and his righteousness, and all these things shall be added unto you." That is, all these worldly goods and amusements that are good will take their place.

#### II—RESULTS OF THIS:

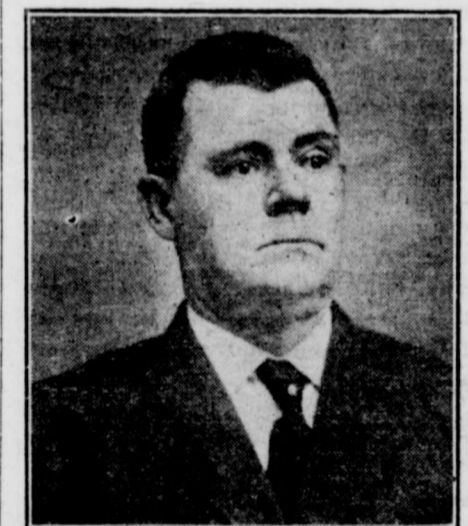
If the former things are true, to die will be gain.

### Our Weekly Sermonette

By Rev. M. T. Tucker

#### CHRIST IN EVERYDAY LIFE

TEXT: "For me to live is Christ and to die is gain."—Phil. 1:21.

In this statement Paul sums up his entire attitude toward Christ and the meaning of Christianity to him. It seems to me that this should be the experience of every Christian. Two things are stated. First the condition of life here, and second, what he expects to be hereafter. But it should be noticed that the hereafter depends upon the condition here.

#### I—WHAT CHRIST MEANS IN THIS LIFE:

Paul said: "For me to live is Christ." Again he said, "It is no longer I that liveth, but Christ liveth in me." From these we reason:

1. That Christ is the author of life. He created all things, says John in his gospel and "without Him was not anything made that hath been made"—Jno. 1:3. Every good thing comes from Him. Every time we get up in the morning, we ought to thank Him for our existence.

2. Christ should be the law of life. It was so with Paul and should be so with all who claim to be his followers. And to the extent that Christ is not the law of life, death will not be a gain. It is sad to see so many who do not recognize this. If Christ is the law of life, we must order our conduct after the example and teaching of Christ. How about it reader? Do you allow Christ to direct your actions? If so, you must not "forget the assembling of yourselves together." That is you must come to the house of God to worship. There are many who claim to be Christians who rarely ever attend church. They hold no relation to any public worship of their church. Then we must let Christ direct our liberality. Christ said it is more blessed to give than to receive," again the Bible says, "a tithe is the Lord's." Yet we withhold our means and refuse to let Him direct us there. He says: "Let everyone of you lay by him in store on the first day of the week according as God hath prospered him and so let him give." This requires not only that we give God his part of our means, but we must take it to the Lord's house on the first day of the week." Then we must let him direct all our conduct.

3. Christ should be the joy and comfort of life. Why should his children be chasing the phantoms of the world for joy? Why should we be giving ourselves to questionable amusements, games, dances, drunkenness, card playing, vain shows, society extravagancies, etc, if Christ is what we claim he is and if His religion will do for life what we teach? Shame on the Christian who by his conduct says to the world, "You must go to the Devil's amusements for pastime." Christ affords all the comfort we need, if we make him first in life. Christ said in the sixth chapter of Matthew, "Seek ye first the king-

dom of God and his righteousness, and all these things shall be added unto you." That is, all these worldly goods and amusements that are good will take their place.

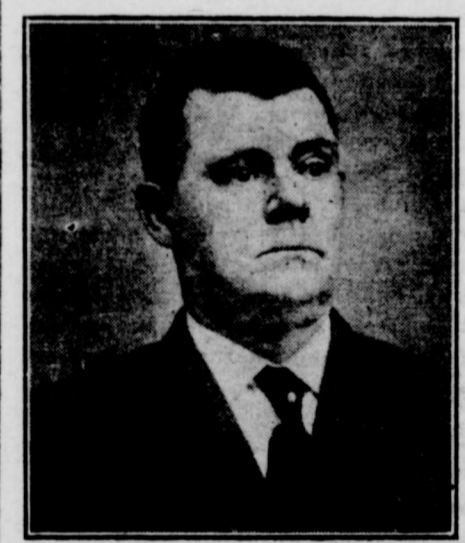
