

Directory assistance operators are still giving out numbers these days ... but now they're asking for numbers, too, according to E.O. Cambern, general manager - West Texas Division Operations for General Telephone.

Some customers are finding the operators' requests surprising, Cambern said, and are asking why. The reason, he explained, is a change effective August 1, 1982, which allows General Telephone to charge customers for calls to directory assistance.

There has been considerable media coverage of the new directory assistance charging, Cambern explained, but apparently it was not understood that the new charge would require operators to ask for the customer's telephone number.

The plan now in effect for General Telephone is the same plan Southwestern Bell had approved by the Texas Public Utilities Commission in June,

Cambern said, "Each call to directory assistance is recorded, and after ten calls from their number, charges will be made and will appear on their monthly bill. Calls are recorded during the billing period as reflected on customer statements.

Those calls that are recorded are calls placed from residences, businesses and mobil telephones. Businesses with PBX trunks are allowed ten calls per trunk. Customers may obtain two separate numbers each time directory assistance is required. Calls will also be recorded if the number requested is not listed or is a nonpublished number.

Cambern urged customers to: \*First check their directories before calling directory assistance for numbers.

\*Make a note of the number if a directory assistance call is required and record the number in their directory. This will help the caller avoid exceeding the 10-call per month allowance on directory assistance calls.

Charging for directory assistance will help to keep basic monthly rates lower than they would be without the charge, Cambern said. He added that studies show approximately 9 percent of the total directory assistance users make nearly one-half of all calls to directory assistance.

Cambern also said calls for which no charge would be assessed for calling directory assistance are those made from coin telephones, hospitals, by certified handicapped persons who cannot use a telephone directory and calls for long distance directory assistance in the customer's area code which are offset by a long distance call to a number within their area code. Long distance directory assistance for numbers outside the customer's area code are not subject to the charge.

Handicapped persons may be exempt by providing a certified statement of their handicap. The statement may be from a doctor, state agency or a service agency which deals with their handicap. The statement must be delivered to General Telephone's business office, and when received, the customer's records will be noted.



## FREE EDUCATION AND THE **UNDOCUMENTED WORKER**

On June 15, 1982, The Supreme Court ruled, 5-4. that Texas and other states must provide free public education for the children of undocumented workerspeople in this country illegally.

Our current Lt. Governor, Mr. Hobby, was happy with the decision, praising it as the "only rational decision" the court could have made.

On the contrary, I think it was a wrong decision that defied both law and logic.

One of the principal un-derpinnings of an orderly society is that one should not benefit from breaking the law. All around the world. thousands of people stand patiently in line at our embassies, waiting for legal entry into this country. By its recent ruling, the Supreme Court told these people that, if they are smart, they will ignore our immigration laws. find some other way to enter. and then there's a good likelihood all manner of taxpayer-supported benefits

will be open to them and their families

We can all feel sympathy for people driven to emigrate by desperate economic conditions. And I believe we should be compassionate to-ward the children of undocumented workers who are here through no fault of their own. We have been told we must educate these children and we will: it is our duty.

But I am deeply concerned about the effect this will have on our school systems and the quality of education. We have only a certain amount of desks and dollars with which to address the problems of educating Texas children.



# Cuba's cobalt may be wartime necessity for United States

COLLEGE STATION -In the event of a drawn-out, non-nuclear war, American strategists might have to take a covetous look at Cuban reserves of high-priced cobalt, a useful material in building military aircraft and electronic weapons, concludes a study by a Texas A&M University System think tank.

A diplomatic arrangement for gaining access to cobalt deposits on the Caribbean island would be preferable, but the mines might have to be secured in some way by force of arms, study coauthor Dr. Richard Thomas says in the Texas A&M magazine Quest: Research and Scholarship at Texas A&M University.

We certainly are not suggesting an immediate invasion of Cuba," said Thomas, director of the Center for Strategic Technology, operated by the **Texas Engineering Experiment** 

"But in a war, it would be difficult to imagine the United States allowing a Soviet satellite to exist 90 mies away, especially one that contains such a large amount of this important wartime material.

Besides being a critical material in building airplanes and electronic weapons, cobalt is also useful in strengthening steel for tanks, ships, and other military hardware, Thomas said.

# **EXTENSION EXTRAS**

The Food and Drug Administration has asked more than 100 manufacturers and distributors of "starch blockers" to discontinue marketing them until scientific testing confirms the safety and efficacy of these weight management products.

Starch blockers are prepared from raw beans, such as kidney and northern beans, and possibly other unknown ingredients. The products have been advertised and sold nationwide with claims that they block or impede starch digestion and thus help in weight control and weight reduction by preventing absorption of carbohydrates.

Users of the products have complained to FDA of nausea, vomiting, diarrhea and stomach pains. Persons with diabetes should not depend on starc. blockers in calculating their diets.

FDA has been refused specific information by manufacturers about the exact chemical composition of starch blockers. Information supporting claims of safety or effectiveness in weight control or weight reduction has not been provided to FDA. FDA is also concerned about the safety of long-term use of starch blockers. because of the lack of adequate safety testing data.

FDA, by letter, has asked the firms to discontinue marketing starch blockers and to provide the agency specific information about their manufacture and distribution. If the companies fail to comply within 10 days, FDA will then consider regulator actions against the products and companies.

# **News Items**

The Social Security Administration is responsible for insuring that payments due under the supplemental security income program are made timely and in the proper amount. Payments are made monthly based upon average income over each calendar quarter. In addition to income, many other factors must be considered indetermining eligibility and payment amount. Some of these factors include resources, living arrangements and continuing disability. Persons receiving SSI payments are required to report immediately to their nearest Social Security office any changes in their eligibility status. Changes in status include any changes in the immediate family's earnings or other income, property or liquid resources, marital status and address or living arrangements. In addition, changes in alien status or residence can affect SSI eligibility. Social Security should also be notified if a beneficiary can't manage his or her own funds or if a beneficiary dies. Disabled or blind recipients must notify So-

take a job or become self-employed or if their condition improves.

If an SSI recipient fails to report any changes within 30 days after the end of the quarter in which the change occurs, a penalty deduction of from \$25.00 to \$100.00 may be imposed against future SSI payments and may lead to referral for legal prosecution. Changes can be reported by mail or by coming to or calling the nearest Social Security Office.
